INSTRUCTIONS

GENERAL

ALL photographic work must be submitted under the substansive case caption when it relates to an investigative matter. Include FBIHQ file number when available. All other photographic processing forms (including FD-482) are obsolete and should not be used. The FD-523 is to be utilized for all photographic processing work forwarded to FBIHQ except employee identification and/or credential cards. Requests for official FBI identification and credential cards must be submitted on form FD-464, Attention: Property Procurement and Management Section.

The FD-523 may be filled out in legible hand printing. The following information is set forth to assist in properly filling out this form.

1. ENCLOSED PHOTOGRAPHIC WORK RELATES TO:

All photographic work submitted should be checked as Current Investigation, Mug Shot Program, or OTHER in appropriate block. If "OTHER" is checked a short description of what it is should be stated under item #4 (Remarks).

2. ENCLOSURE(S):

Film To Be Processed - Check appropriate column for Color, Black and White film, alongside the size of the film. Also, indicate the number of sheets or rolls or cassetts in the quantity column. Slides refers to EXTACHROME ONLY, DO NOT SEND KODACHROME.

Movie Film Or Microfilm - Check appropriate block for size and quantity. DO NOT SEND COLOR MOVIE FILM.

Negatives To Be Printed - Check appropriate block for size; Color or Black and White and quantity submitted. If 135mm negatives are to be printed, indicate by frame number, do not cut up into individuals frames. The same applies to any roll film.

Other - Enclosures to be copied e.g. photographs, documents, objects, etc.



On November 18, 1978, U.S. Congressman LEO RYAN was assassinated at the Jonestown, Guyana, settlement of People's Temple. The same day, over 900 members of People's Temple, including its founder, JIM JONES, participated in a mass murder at Jonestown. It is publicly known that People's Temple, Disciples of Christ, originated in Indiana during the mid-1950s, traveled to California during the mid-1960s, and established an agricultural mission in Guyana during the early and mid-1970s. People's Temple dissolved during January, 1979, as a result of the assassination of a U.S. Congressman and the mass murders of over 900 people at Jonestown, Guyana (1)

In March, 1979, during the course of an investigation conducted by the FBI into the assassination of Congressman Ryan, 15 crates of evidence were received from Jonestown. Included in that evidence were two statements from People's Temple member who returned to the United States prior to the mass murders at Jonestown and is currently residing in this country.
