

ADVISED HE FIRST RECALLS HEARING THESE CONVERSATIONS AROUND MAY, 1978, AND WAS ATTRACTED TO THEM BECAUSE OF THEIR LENGTH AND THE FACT THEY SPOKE IN CRYPTIC LANGUAGE. BOTH OF WHICH ARE CONTRARY TO FCC RULES. HE STATED IT WOULD FREQUENTLY BE ASKED, "OSL", WHICH IN HAM RADIO LANGUAGE MEANS. "DO YOU UNDER STAND?" SOMETIMES THE RECEIVING PARTY WOULD BE GONE FOR A PERIOD OF TIME AND THEN RETURN TO THE RADIO AND REPLY, "0 SL", INDICATING THE MESSAGE WAS UNDERSTOOD. (  $\chi$ 

FURTHER STATED THE CONVERSATIONS WERE GENERALLY ABOUT PURCHASES OF RICE. MEDICINE OR MACHINE SHOP SUPPLIES. HE NOTED THEY APPARENTLY WERE PURCHASING LARGE MACHINE SHOP EQUIP-MENT SUCH AS GRINDERS AND MILLING MACHINES. IT WAS ALSO MENT LONED THAT THEY WERE STORING FOOD UNDERGROUND.
