Synopsis: WILLIAM ELIAS STEPP continues to reside at 3019 Winterhaven, Dayton, Ohio. STEPP continues to be the owner of the Billy the Kid Race Cars, 822 Webster Street, Dayton, Ohio. STEPP attended a birthday party July 2, 1974, at the Godfather Lounge, 24 West Monument Street, Dayton, Ohio. Several local hoodlums of the Dayton, Ohio, area attended this party also. Dayton, Ohio, Police Department has received information from source of unknown reliability that STEPP is believed to be involved in car theft and narcotics activity. FBI Dallas unable to determine reason for [redacted] visit to Denton, Texas, in February, 1974. BOTH WILLIAM ELIAS STEPP AND [redacted] SHOULD BE CONSIDERED ARMED AND DANGEROUS.

The following investigation was conducted by SA

AT DENTON, TEXAS:

On June 18, 1974, [redacted]

[redacted] at Denton Municipal Airport, advised that the airport is a non-controlled field and pilots do not file any flight plan through the office. [redacted] stated that if a pilot intends to fly out of Denton into Mexico, he is supposed to file flight plans through Flight Service Station in Fort Worth, Texas, notifying that agency to inform the U. S. Customs Service. [redacted] stated it is not unusual for pilots to ignore these requirements, particularly when one is involved in illegal activity.

On June 18, 1974, Detective [redacted] of the Denton Police Department advised that some fellow officer, who makes frequent coffee stops at the Union 76 Truck Stop, was sufficiently indiscreet in conversations with personnel concerning investigation that [redacted] was conducting and the flow of information to [redacted] has stopped. [redacted] indicated that he will not be able to obtain information from former sources at the truck stop.

[redacted] said he did learn that [redacted] activities back around February and March, 1974, were concerned with locating and buying Diesel fuel with which to supply the many trucks that stop at his place. [redacted] expressed his opinion that [redacted] was buying up black market Diesel fuel. [redacted] said he had learned the rumor was not true that some Denton police officer was attempting to put up a huge sum of money, along with [redacted] learned that the officer, in association with [redacted] is [redacted] [redacted] for the Denton Department. [redacted] said he knows for a fact that [redacted] has no large sum of money.

[redacted] said [redacted] had formed a company or association and [redacted] was to be included and [redacted] was trying to supplement his income with the part-time work that he could get through [redacted] again expressed his opinion that [redacted] could only be of advantage to [redacted] as an armed bodyguard. At any rate, the news of [redacted] association with [redacted] got back to the Chief of Police, WAYNE AUTREY, who promptly informed [redacted] to disassociate himself from the venture with [redacted]

[redacted] has learned no additional information concerning WILLIAM ELIAS STEPP and [redacted]. He never did learn why [redacted] had come to Denton from Dayton, Ohio, back in February, 1974, unless they were just visiting. [redacted] reiterated that [redacted] and several of his employees are from Dayton.

On July 19, 1974, Detectives [redacted] assigned specifically to narcotics and dogs investigations for the Denton Police Department, advised they have no information which would indicate that [redacted] is involved, in any way, with narcotics.

AT FORT WORTH, TEXAS:

On June 18, 1974, [redacted] Flight Service Station, Federal Aviation Administration, advised that flight plans are maintained for a period of fifteen days only, after which they are destroyed. He would not have any record of flight plans for air traffic back around February and March, 1974.

On July 26, 1974, Detective [redacted] Dayton, Ohio, Police Department advised that within the past two weeks he had an occasion to have a conversation with WILLIAM ELIAS STEPP, also known as BILL STEPP, at the B. G. Pancake Restaurant located North Main Street, Dayton, Ohio. This meeting was not planned and had nothing to do with official police business. Detective [redacted] advised that during the conversation with BILL STEPP he stated that he was not being officially sponsored by the Chrysler Corporation any more in his race car activities as Billy the Kid Stock Car Racing. BILL STEPP did state that he was getting some money from the Chrysler Corporation to help in his activities as a stock car driver. Detective [redacted] advised that BILL STEPP related to him that he was not involved in any type of illegal activity as he was attempting to remain "clean" in his activities in the Dayton area. BILL STEPP related to Detective [redacted] that he was spending the majority of his time involved in race car activities throughout the midwestern United States.

On July 29, 1974, Detective [redacted] supra, advised that on July 2, 1974, a private birthday party was held for WILLIAM ELIAS STEPP in the Godfather Lounge, 24 West Monument Street, Dayton, Ohio. The arrangements for the birthday party were made by [redacted]

From the dates of August 15 - 27, 1974, spot checks were made of the residence of WILLIAM ELIAS STEPP, 3019 Winterhaven, Dayton, Ohio, and his place of employment, 822 Webster Street, Dayton, Ohio, without observing any known vehicles of local hoodlums in the Dayton area.

Review of public source material for Dayton, Ohio, area shows that WILLIAM ELIAS STEPP continues to reside at 3019 Winterhaven, Dayton, Ohio.

On August 22, 1974, Detective [REDACTED] Dayton, Ohio, Police Department advised that information has come to the attention of the Organized Crime Unit, Dayton, Ohio, from a source of unknown reliability that WILLIAM ELIAS STEPP and [REDACTED] are alleged to be involved in stolen car activity in the Dayton, Ohio, area. Detective [REDACTED] also stated that STEPP is also believed to be involved in narcotics activity in the Dayton area as a supplier.

Detective [REDACTED] reiterated that the information that he has received regarding the activity of BILL STEPP and [REDACTED] is from a source of unknown reliability and he is not completely sure whether the source is furnishing correct information. Detective [REDACTED] advised that his department will institute an investigation into this matter in order to determine if the source of this information is accurate.

Detective [REDACTED] also advised that [REDACTED]

[REDACTED] may also be involved in narcotics activity for STEPP. Detective [REDACTED] advised that allegedly BILL STEPP is receiving narcotics from the northeastern section of the United States.

On August 28, 1974, review of public source material for Dayton, Ohio, area discloses that Air City Motors is located at 5700 West Third Street, Dayton, Ohio, and has phone number 268-6111. It should be noted that at this location it is outside of the city limits of Dayton, Ohio, and in Montgomery County, Ohio. The 1973 suburban directory for Dayton, Ohio, discloses that [REDACTED] are associated with Air City Motors. [REDACTED] resides at [REDACTED] and has a wife by the name of [REDACTED]
