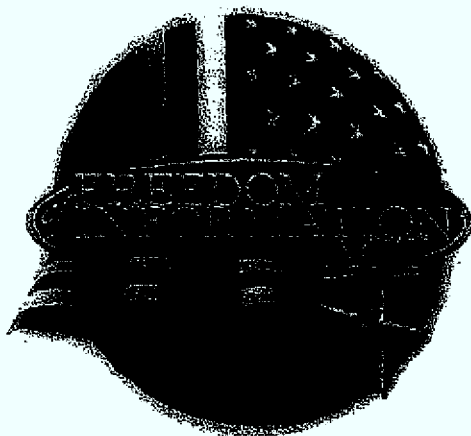

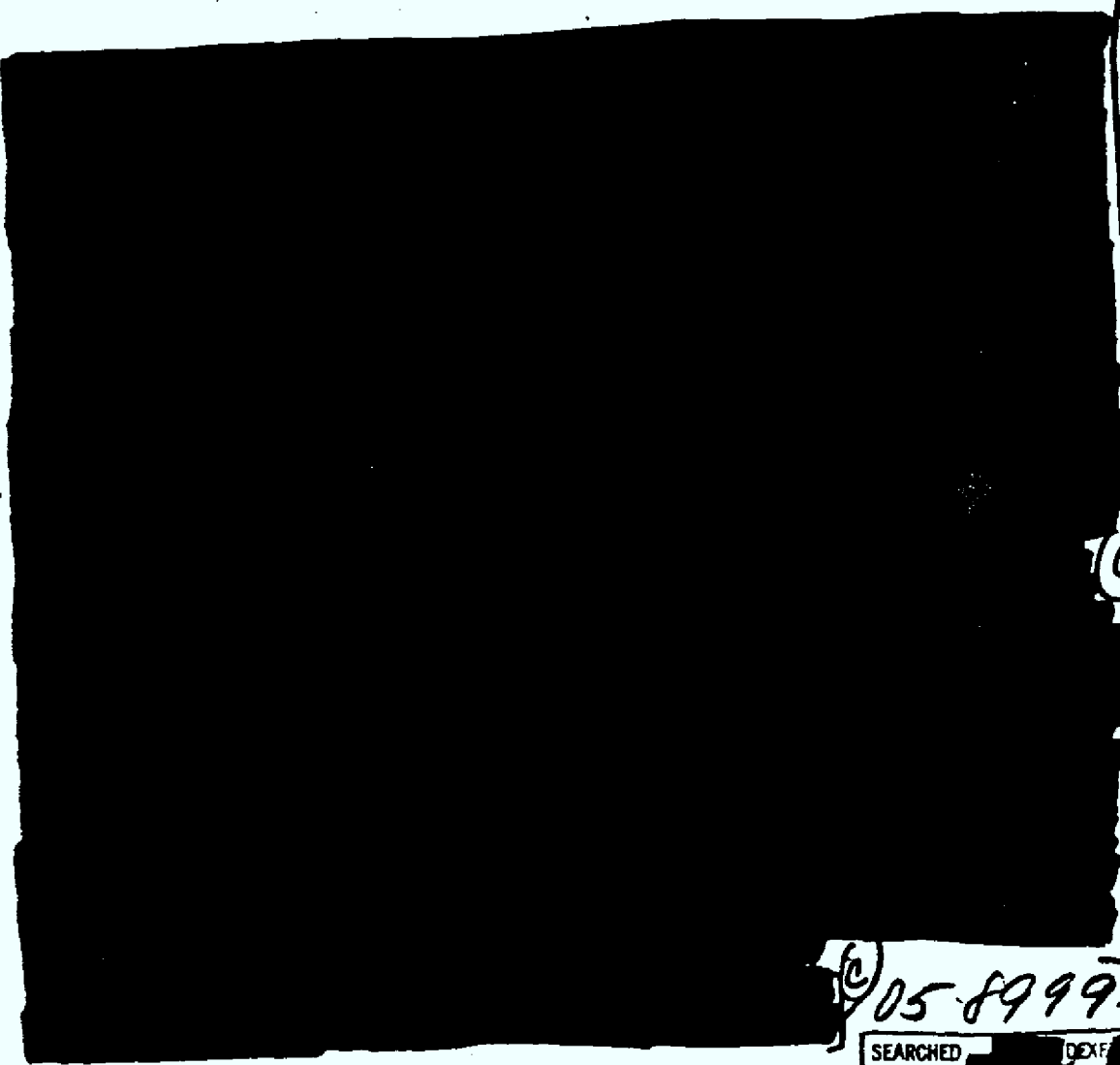

Malcolm's Followers Try To Carry On

By KENNETH GROSS

James Shabazz tells a parable of a chicken that blindly runs here, there and everywhere after its head is cut off.

Shabazz is James X, former secretary and confidant to Malcolm X, black nationalist leader assassinated in February.

Like the headless chicken, the groups that Malcolm once led, still grope for leadership. They appear to be near extinction.

The problem is, not lack of volunteers. There simply appears to be no one capable of winning the support that the charismatic Malcolm commanded.

Soon after the 39-year-old leader was shot down at a rally, his older sister, Mrs. Ella Mae Collins, of Boston, said she would take charge of the Organization for Afro-American Unity, the political arm of Malcolm's movement.

No Activity

But there has been no activity heard from the group since Malcolm's death.

Malcolm's widow, Betty, also has been in seclusion.

The glass doors of the New York Mosque in suite 128 at the Theresa Hotel in Harlem are still painted mourning black. The room, where Negro youths once flocked to see Malcolm is often empty.

One of the reasons for the inactivity has been the preoccupation of Shabazz and other leaders with legal problems. Police investigating the assassination repeatedly have brought in the leaders for questioning and administrative problems have piled up.

Shabazz recently attended a Militant Labor Forum meeting to try to get support for Reuben Francis, 32, free in \$10,000 bail on a charge of wounding one of Malcolm's assassins after the attack on Feb. 21.

This rare public appearance pointed up another of the problems preventing organizational development: security. There is still fear that Black Muslim "enforcers" may attack black nationalists.

Determined to Go On

Still Shabazz is determined to continue Malcolm's work.

"He works at it," said a prominent Negro familiar with the group, "but there is no one who will replace Malcolm. The membership was always only a hard core of maybe 20 people. There were others who listened and followed, but they were never dedicated to anything except Malcolm X."

The group is debating whether to join the civil rights movement, as Malcolm apparently intended to do, or maintain a militant policy. There has been no decision.

"When I am ready, I will make a statement to the press about my plans," Shabazz said, "But I am not ready and have no comment."

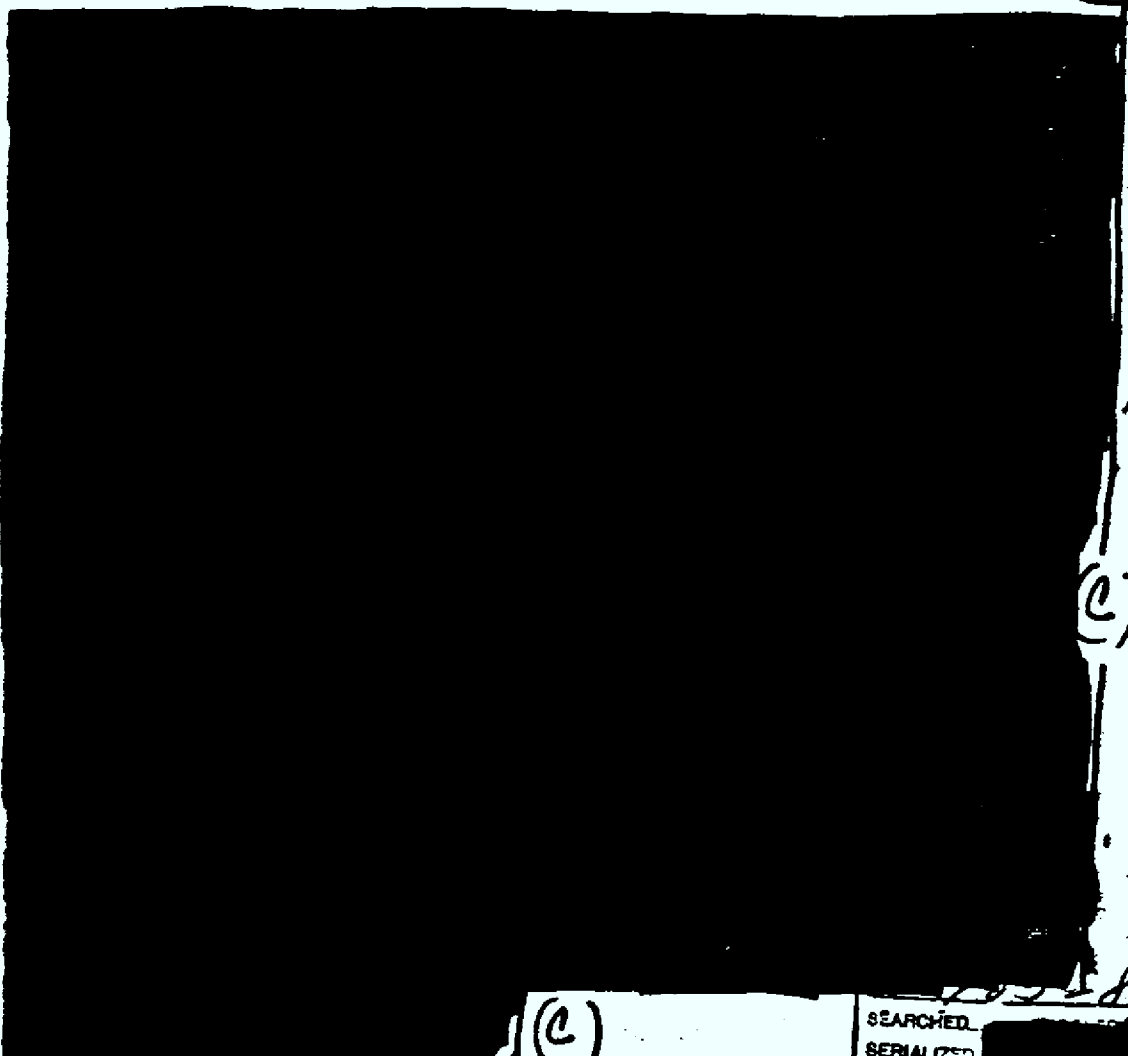

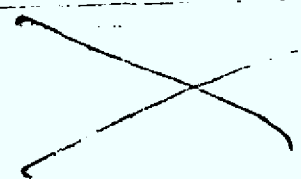

—ROBERT WILLIAMS— Can he get color unity sought by Malcolm X?

Monroe, N.C. civil rights leader chased out of this country now works with Afro-Asians to topple world jim-crow.

By RALPH MATTHEWS JR.

Robert Williams? Fugitive Leader.

For many he is a question mark. Some think he is the most logical successor to the late Malcolm X as the voice of the colored American underground.

Others deem him a true revolutionary, who unlike Malcolm X, matched deeds with words.

There are parallels between their careers. In 1961, Robert Williams fled Monroe, N. C. to avoid arrest. The charge: kidnapping.

FIGHT FIRE

Details are hazy. Williams was leader of Monroe's NAACP. There had been trouble brewing between blacks and whites there. Williams urged his fellow towns - people to fight fire with fire.

During a civil rights demonstration, Williams and companions were charged with kidnapping a white couple and holding them as hostages.

The charges were brought by white law officers and their validity has always

been in doubt. A court trial for all the Monroe defendants save Williams (early this year) found them innocent.

WENT TO CUBA

Robert Williams' innocence, perhaps assumed, is still in doubt because he ended up in Cuba as a political exile.

Both Williams and the late Malcolm X have reached the same conclusions about solving America's race problems although their motives and surface philosophy may differ.

Since Williams ended up in Castro's Cuba he has been termed a revolutionary Marxist, a totally - committed Communist.

Friends back home doubt that Williams is completely anything except "an angry black man."

The Cubans embraced him joyously as the Arabs and Africans welcomed Malcolm.

Malcolm's stay abroad convinced him that the only way Americans could free themselves was with outside help from the darker nations.

It was this premise which lead him to form the Organ-

ization for Afro - American Unity on his return.

Given shelter by the Cuban Communists, Williams has absorbed many of the tenets of revolutionary socialism without compromising his original position as a black man angry about U.S. treatment of his people.

SELF - DEFENSE

Williams, as his Monroe activity indicated, holds that if someone hurts you, you hurt them.

In urging "self - defense" for colored Americans, he was far ahead of Malcolm who began this "hard line" policy after his break with the Muslims.

Williams goes a step further than Malcolm. To topple segregation, he would also "strike out." When Robert Williams says fight racists, folks back home in Monroe know he isn't joking.

SUPPORT MOVEMENT

Williams and the late Malcolm were both convinced that the Africans and Asians could and would supply the diplomatic, economic and

military pressure, if necessary to back up the U. S. civil rights movement.

This is part of the reason why Robert Williams, as the photographs on this page show, is welcomed in such places as Red China and in Cuba.

The Peking government regards him as a symbol of the racial struggle in the U. S. They approve of his tough approach to solution.

But before Robert Williams' potential as a civil rights leader can be truly

measured, he still must make his peace with that North Carolina court of law.

He said last month he would be willing to stand trial on the original charges but he would want the matter of his escape to avoid North Carolina justice 1961 style cleared up.

MAO'S EAR

Meanwhile, he is the single most powerful colored American at the international level. He has the ear of Castro and China's Mao Tse Tung, powerful adversaries, which is more than our own State Department can claim.

Will this fugitive return? Could he get colored Americans to work with Africans and Asians?

History shows that every black man who has tried to wean the colored masses away from the American rulers has met disaster.

GRAVEY BROKEN

Marcus Garvey's Back to Africa movement left him a broken man. Broken, many claim, because the white power structure and some colored put the skids under him.

Malcolm's OAAU meeting was the scene of his assassination. Some claim his murder was plotted, not by fellow Muslims, but by more

shadowy forces like the CIA

If Williams is acquitted and begins his program to seek color unity among colored people here and abroad, the question is "Would he be stopped like Malcolm?"

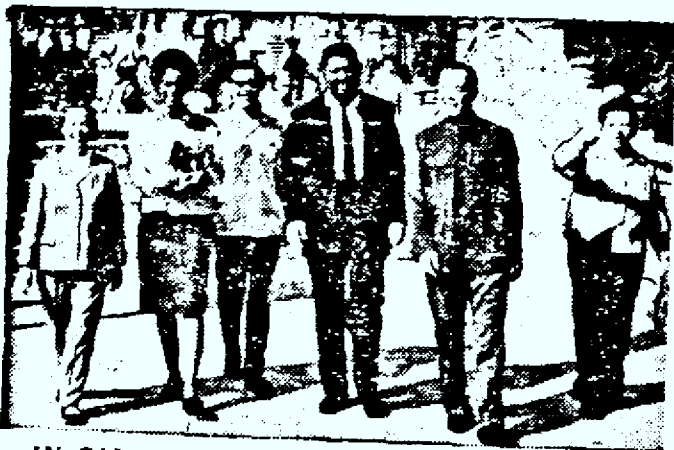

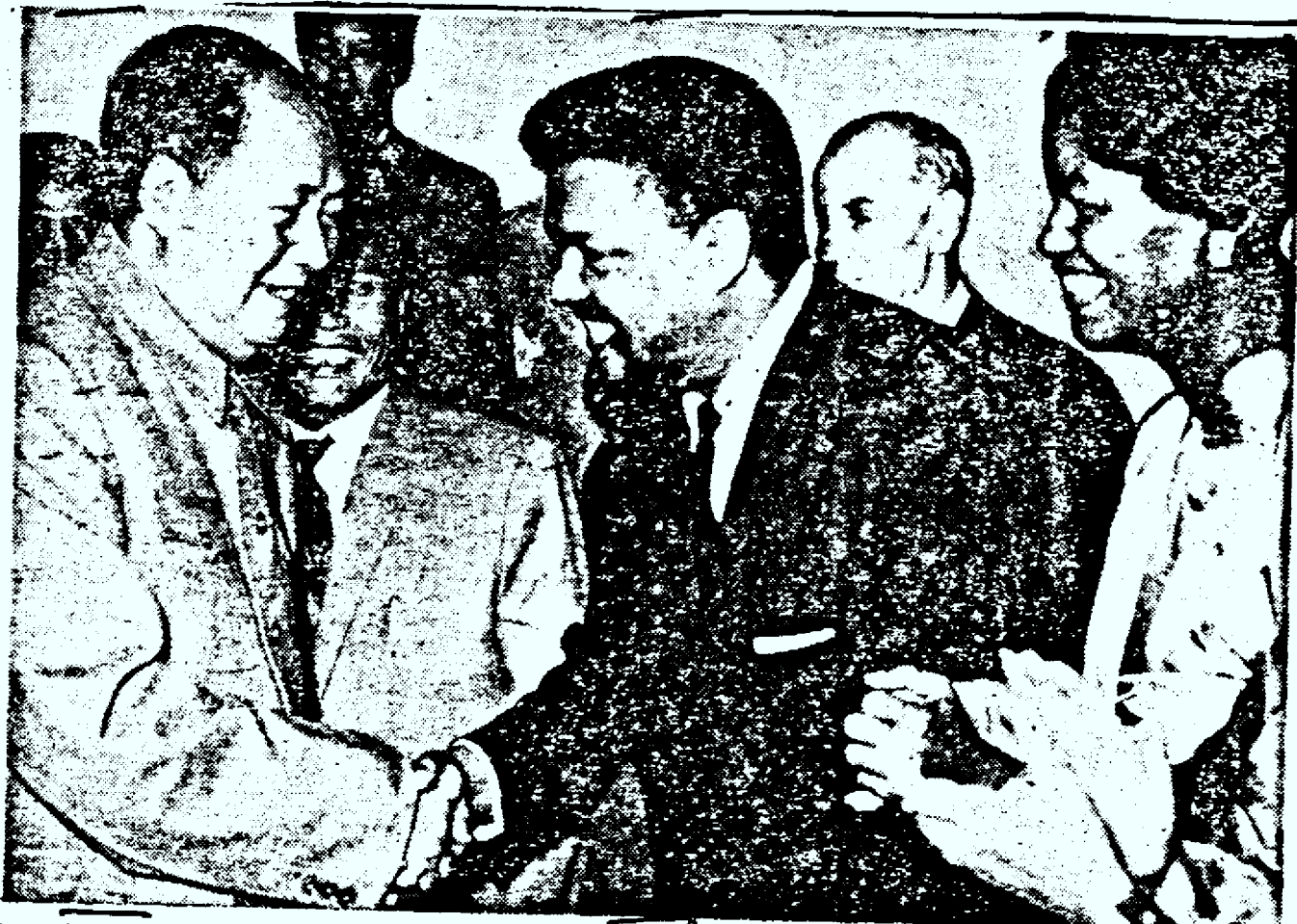

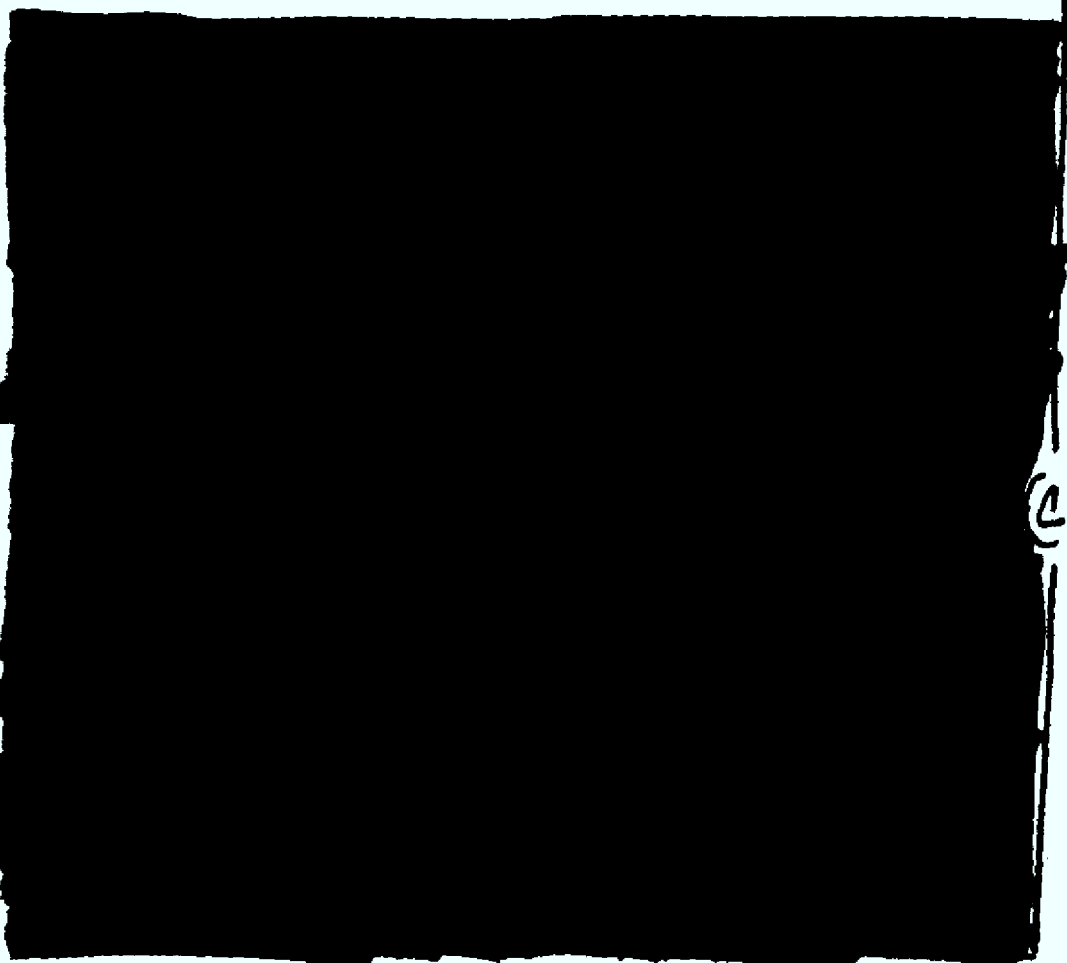

Malcolm X Was 'Citizen of World' — Author Killens at Memorial

Approximately 750 persons — many of them white — heard

Malcolm X
*105-8999**

famed John Killens hail the late black nationalist leader Malcolm X Shabazz as a "citizen of the world ... one of the most articulate men in the 20th Century..."

The occasion was a special Chicago memorial service for the militant leader who was shot down in New York on Feb. 28 as he addressed about 400 of his followers in a ballroom.

The Chicago service, held in the Tabernacle Baptist Church, was sponsored by the Chicago Committee for the Educational Fund for the Children of Malcolm X, headed by Dr. T. R. M. Howard, a veteran civil rights leader and former Mississippian.

Others participating on the memorial service included Ossie Davis, playwright who delivered the eulogy at Malcolm's funeral in New York; Lawrence A. Landry, chairman of ACT; Mrs. Val Gray, a dramatic reader; and Nahas Rogers.

Davis read his eulogy by special request. Mrs. Gray drew a standing ovation for her rendition of excerpts from "Trumbull Park," a novel by the late Frank London Brown, and from "For My People."

Dr. Howard, a prominent physician and surgeon, said Malcolm X died penniless, leaving his widow, Betty X, and their four children with no means for a livelihood. She is expecting a fifth child in the fall.

"In the short span of his illustrious life, brother Malcolm DID overcome," Killens declared.

Malcolm, a former top aide to "Black Muslim" leader Elijah Muhammad before bolting the organization, died at 39.

Chicago columnist Irv Kungnet, on whose television program Malcolm appeared on several occasions, sent \$50 to the educational fund for the slain black nationalist leader's children. Dr. Howard announced during the service.

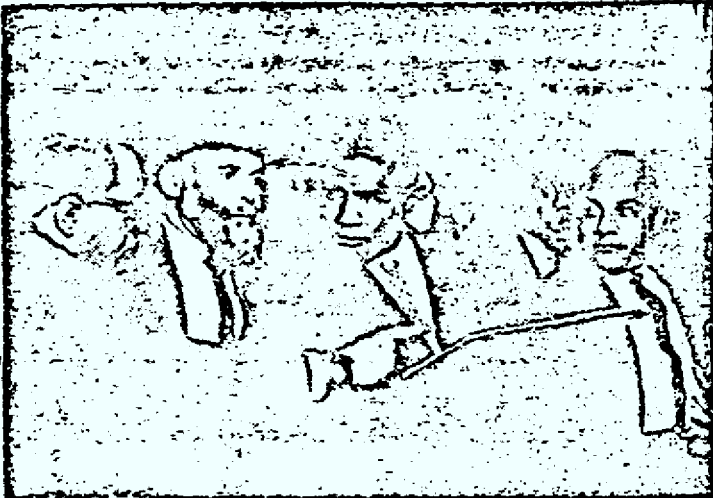

"Report to the March 11, 1965 NEC on the Vietnam March

[REDACTED] The March on Washington preparations have passed the first critical stage and it looks like the first explicitly anti-war national student demonstration will definitely take place. This is a big step forward from the 'peace' demonstrations of previous years. More important, the YSA will play a leadership role in many areas in mobilizing people to go on the march. The call is one we have endorsed and can politically support. We are getting the chance to show that we are not a 'sectarian' group as we have been slandered in the past.

"Our tour speakers are distributing buttons and calls and are helping to persuade people to go on the march. The SDS has maintained its policy of allowing all groups to sell and pass out literature on the march. This is the first time such a large march has had this explicit policy.

"The policy for signs according to SDS is that SDS will silk screen signs for the march and will ask everyone to carry these signs. The slogans are not yet determined, but there will be a spectrum of different slogans such as 'Withdraw Troops' and 'Negociate' etc. These signs will not even say SDS. SDS is encouraging people to bring signs indicating their schools and cities so that the march will reflect clearly a broad geographical representation. We had encouraged SDS to allow organizations to bring signs with their organizations with them, but we do not consider this key. If the SDS slogans are not pro-Johnson and if SDS continues to stick to its present policy concerning literature sales, the march will certainly have an anti-Johnson and militant tone and will be more free than former marches. We will co-operate with the sign policy of SDS so long as the slogans chosen are in agreement with the line of the call. In areas where sympathy demonstrations are being held we will push for an 'everybody bring your own signs' policy with any signs being drawn up by sponsoring organizations to reflect the line of the call.

"As soon as definite information on what the slogans will be comes out, we will notify the locals.

b7c [redacted] Reports on the progress of local March on Washington Committees have come in from around the country. In some areas committees have been formed which welcome all tendencies and which are signing up people for the March on the basis of the call. Such is the case in Philadelphia, Detroit and Minneapolis. Ann Arbor has reported that SDSers are willing to sell our pamphlet at their literature tables. In Boston arrangements have been made for us to send [redacted] to a large number of schools in different parts of New England. In some areas there has been some trouble with Stalinists, Social Democrats or PLers trying to exclude us. Berkeley reports that the DuBois Club is doing what it can to make this march reflect their own pro-Johnson views. A general rule seems to be that
