MALCOLM'S PLANS IRK MUSŁIMS HERE

He is Denounced as His Return Is Awaited

The New York representatives of Elijah Muhammad's Black Muslim movement are awaiting with concern the return of Malcolm X from Mecca, Saudia Arabia, where the deacctor was endorsed by the World Muslim Council.

Henry X and Joseph X, she New York representatives of Elijah Muhammad's movement, have denounced Malcolm as a "self - serving hypocrite consumed by a passion for personal power" over America's 20 million Negroes.

In a recent letter from Mecca to a New York friend, Malcolm said he would open an official Muslim Center in New York with the support of the World Muslim Council. The council, he wrote, had promised to send certifled teachers, and to provide 15 scholarships for Americans to study at the Islam University in Medina, Saudi Arabia.

The World Muslim Council, founded in 1962, is the supreme religious body in the Muslim World, and is governed by a constituent body of 23 leading scholars from the major Muslim countries. Its headquarters is in Mecca.

Would Halt Attacks

Reflecting the movement's concern over Malcolm's return, Henry X and Joseph X said: "We only want Malcolm to stop attacking Elijah Muhammad, as he did from Mecca when he called him a religious faker.
If he doesn't, we will fight him as hard as he fights us."

They said Malcelm's personal reputation was based on a strong supporting movement that enabled him to speak with authority.

"Now that this support has been removed," they said, speakpeen removed," they said, speaking of the Black Muslims, "we
shall see how successful he
will be. He now stands alone.
We are convinced he will fail
because his success depended on
the strong support we gave
him."

At the same time they confirmed that Elljah Menainmed's son, Wallace, had defected to join forces with Malcolm.

Henry X and Joseph X said they had vorked under Mal-colm's orders for 12 years while he was hullding up the Black Muslim movement, which he succeeded finally in projecting onto the national scene.

S. Year Eco tomic Plan

Henry X is assistant minister to James X of Newark, who wal appointed by Elijah Muhammad to take over he New York Mosque when Malcolm broke with him last winter. Joseph X is Elijah Muhar imad's appointed administrator for the New

York area. Henry X and Joseph X said Elijah Muhammad was launching a three-year economic program to improve the lot of the Americar, Negroes. This program consists o' a savings plan that would create funds to purchase farm land, food storage warehouses, and businesses.

They said the movement had established a b uslim Chamber of Commerce that now had about 100 small businessmen as members.

The two said that Malcolm, while giving public lip service to Elijar. Muhammad's orders had constantly ignored instruc-tions and used his "undeniable bratorical and organizing tal-ents" to gain a personal na-tional reputation.

They said it was Malco'm who Injected the political concept of "black nations ism" into the Black Muslim provement, which they said was essentially re-ligious in nature when Malcolm became a member.

"Malcolm abundoned the re ligion to become a political so-clologist," Henr / X charged.







Source also advised that this MMI member further remarked that Malcolm X is currently in Africa contacting various African governments and representatives of various other governments in Africa, such as the Chinese Communists, in an effort to get Longy for the OAAU. This money will then pass through the CANU to the MMI where it cannot be taxed since the MMI is a religious group.

Other sources familier with MMI and GAAU activity were contacted during September and October, 1964, but they could furnish no information confirming the above information.



Malcolm X and the Red Chinese

CAIRO—Malcolm X, whom the Chinese Communists call the "chairman of the Afro-American unity organization," spent a considerable amount of his time in the presence of international Communist propagandists here.

Not only did he endorse the rioting back home, but he publicly called for retalisation against the white community. He said the time had come to meet "violence with violence; an eye for an eye and a tooth for a tooth."

He prepared a series of inflammatory anti-U.5. documents here on the pretest of presenting them to the recent meeting of the Organization of African Unity, and it was reported across the world that he attended the conference. This is nonsense. He did not get near the parley. He was not accredited to it.

Malcoim X was not at any of the conference sessions. I was informed that it "is ridiculous" and "undignified" to think for a moment that anyone such as Malcoim X would be heard by the African counterpart of the Organization of American States.

Malcolm X's activity here was strictly a propaganda operation which he set up at the Hotel Semiramis, where some newsmen gathered. He made certain that his violent anti-U.S. distribes were put in the hands of the Chinese Communist correspondents planted here by the New China News Agency.

But when Malcolm X wanted to be with his pro-Communist friends he came over to the Hotel Omar Khayam, a former palace. I vouch for this personally. I was there when he met Mrs. Shirley Graham DuBois, widow of the late Dr. W. E. DuBois, in the lobby. When the aged Dr DuBois died recruity, he was a member of the Communut Party. U S A, and had switched his catterning to Chana

The Hotel Omar Khayam was also the headquarters of the violently anti-U.S., pro-Communist Ghanaian delegation to the African States' conference. On Thursday, July 18 delecim X and his frequent companion, Mrs. DuBois, met for hours in the garden restaurant of the hotel.

for hours in the garden restaurant of the hotel.

Mrs. DuBois and her late husband spent much time in Peking. They were frequent guests of Mao Tse-tung. Dr. DuBois delivered many anti-U.S. speeches which were broadast across the world by the powerful Chinese mainland hadio.

Mrs. DuBois has long been active in world Communist circles. Her background is important here to show the strange inter-weaving of characters now attempting to infiltrate and agitate the Negro communities of the U.B.

Mrs. DuBols knew the Castro brothers. Fidel and Raoul, in Mexico as fer back as the late '40s. She nov is associated with the pro-Communist "Precomwats." a publication allegedly devoted to the Negroes.


In the past few years she has been a prolific witter in diffuse of the pro-Communist dictatorial state of Ghana.

Intelligence arents of several countries now are easer to learn just her Black Nationalist leader Molcolm X nade contact with such Communist activists as Mrs. DuBois Of considerable interest is the source of Malcolm X's funds now that the Muslims under Elijah Muhammed have decigated wit on him.

Malcolm X has been making expensive and extensive trips across Africa. I ran into his trail in several cities—especially in Badan, Nigeria, where he delivered spreches so anti-U.S. so incendiary, that they could be printed only on aspectos.

Malcolm X Warns Police Of Tactics, Says Harlem Negroe's Are Armed

CAIRO, Egypt (NPI) — Black | racial problems. nationalist leader Malcolm X declared here last week that Negroes in New York's Harlem district are the best armed Negroes in the world, and warned that there could be a racial explosion unless the police change their tactics in dealing with them.

Malcolm X, attending the summit conference of African leaders here, advocated recently that Negroes, in the South in particular, arm themselves against attacks by racists.

"There are probably more armed Negroes in Harlem than in any spot on earth. If the people who are armed got involved in this, you can bet they'll really have something on their hands."



In Pittsburgh, Cleveland, Philadelphia and elsewhere, the broad sentiment was that whatever civil rights progress the Negroes have made has come through their relentless marches, sit-ins, mass picketings and other demonstrations, and that now is no time to stop.

In Cairo, the sharpest criticism of all came from Black Nationalist Leader Malcolm X. who snapped; "I'd die before I'd tell Negroes to restrain themselves,"

He repeated the ancient Biblical demand, "an eye for an eye, a tooth for a tooth, a life for a life!"
