PHALANX of left-wing Negro activists, led by the Rev. Milton Galamison and Jesse Gray, appear to be on a collision course with Dr. Martin Luther King. Allied with the Galamison-Gray bloc are the globe-trotting Malcolm X and other militants who want to use New York as the base for an all-Negro political party. From Inside their nawly organized coalition, known as

From Inside their nawly organized coalition, known as the Federation for Independent Political Action, comes word, that they want to run Mr. Galamison for Mayor and Mr. Gray for a seat on the City Cannell this Fall on a straight Neare ticket.

They are realists, so they, of course, have little hope of polling heavily for their front runner, who now is specializing in school boycotts. But they believe they can roll up enough votes to put themselves in a bargaining position in the future—and possibly get Gray on the City Council.

They unveiled their organization during a little-noticed, all-day parley Dec. 19 after issuing a call for "Black independent political action."

"With independent political power, the black revolution can holdly move forward in advancing the interests of the masses," their statement said. The conferences created an interim action committee of eight men including Mr. Galamisson. Gray Halrolm X and John Henrik Clarke, editor of Freedomways, founded by Mrs. W.E.B. Dubois.

This condition's effort to hunch an all-Negro political machine runs contrary to the broad philosophical concepts of Dr. King and other national Negro and liberal leaders now directing the vast civil rights offensive.

The latter will make this quite apparent during a unique national parley a week hence at Riverside Church, Beginning Saturday morning, January 38, these leaders will run a twoday "State of the Negro Feeple" conference.

Dr. King will be there to report his experiences in Selma, Ala. He'll be but one of scores of delegates from most of the national civil rights organizations.

These men have long rejected suggestions for narrow independent political action. They see it as self-dereating, predoomed isolation.

Instead, the conference next weekend will make plans for broadening the political base. Dr. King has not only spoken of a drive to register several million Negroes on the voting lists of the Southern states, but has also been seeking to broaden the drive.

He wants to join with the American labor movement on two fronts. The first is a campaign to convince a large part of the 48,900,900 Americans who did not vote in the 1864 elections to register and cast votes in '86 and '65. The second is to coordinate the economic power of the Negroes and the trade unloss.


Dr. King is expected to urge the conference to dispatch a delegation to President Johnson. It would be instructed to urge him to ask Congress to pass laws at this session which would wipe out the restrictive literacy tests.

## ORGANIZATION OF AFRO-AMERICAN UNITY INTERNAL SECURITY - ORGANIZATION OF AFRO-AMERICAN UNITY

On December 29, 1964, a source who has furnished reliable information in the past advised that Malcolm Little had visited Boston on December 16, 1964 to participate in the Harvard University Ford Hall Forum at Cambridge, Massachusetts. He later appeared on the Jerry Williams Radio Program, station WMEX, Boston, Massachusetts.

This source stated that both the Ford Hall Forum and the radio show fell into the usual format established by Little in his public appearances and nothing new took place.

The source learned that while in Boston, Malcolm Little stated that he had spoken with Wallace Muhammad in New York earlier in that week and that Wallace and himself were joining together. The source advised that Wallace Muhammad is one of the sons of Elijah Muhammad, National leader of the Nation of Islam, and that Wallace has broken away from the Nation of Islam and has been repudiated by his father as a hypocrite. The source also advised that Malcolm Little was formerly the National representative of Elijah Muhammad who fell into disfavor with Elijah Muhammad and formed his own group known as the Organization of Afro-American Unity. A characterization of the Nation of Islam and the Organization of Afro-American Unity are found in the appendix attached hereto.

The source advised that Little has a foreign born Muslim from one of the African countries living at his home. This person has been sent to New York to help Little set up his mosque in New York. Little has

This same source heard recently that Akbar Muhammad is dissatisfied with his father, Elijah Muhammad, and publicly expressed this in an article in a New York paper on Christmas Day.




