Specimens Q1 and Q2 were searched through the appropriate sections of the Anonymous Letter File with negative results. Copies have been added to that file for future reference.

Indented writing in form of a partial telephone number was observed on specimen Q2. No indented writing was observed on specimen Q1.

The Q1 envelope is a U.S. postal envelope. No watermarks were observed on specimen Q2.

If a future hand printing examination is desired, it is suggested that numerous dictated known exemplars be obtained from [redacted] in the same wording and format as the questioned specimens. It is also suggested that undictated known samples be obtained from [redacted] and submitted to this laboratory.



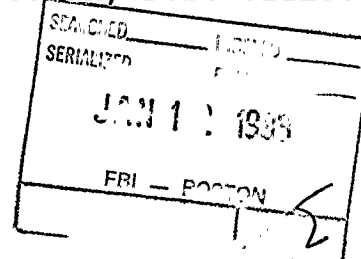
Dear Sir:

This letter confirms a conversation between Assistant
United States Attorney (AUSA) [redacted] and Special Agent
[redacted] regarding referenced matter.

In brief, [redacted], an inmate at the
California State Prison, Corcoran, California, is suspected of
being the progenitor of a letter that contained threats to kill
New York Governor Mario Cuomo, Massachusetts Governor William
Weld, and unnamed members of the New York Supreme Court.

The letter was post marked "Bakersfield, California"
and it was addressed to "New York State Supreme Court, 360 Adams
Street, Brooklyn, New York". The envelope reflected a return
address of [redacted] CSP Corcoran, Post Office Box
3476, Corcoran, California 93212".

The context of the letter contained the following excerpted message: "To Mario Como (SIC) Governor of New York and Governor of Massachusetts Williams (SIC) Weld. I am going to kill you both, I have ties to major crime families in New York and In California, and several other states. I am going to murder the both of you very very soon. I declare under the penalty of perjury (SIC) that the foregoing is true and correct. /s/ [redacted]

[redacted] is presently incarcerated in the California State Prison System, and he has a scheduled release date of February 14, 1998.

AUSA [redacted] was of the opinion that prosecutive jurisdiction fell within the Eastern District of New York, where the letter was received, or the district of California, where the letter originated. Based on this fact, he declined to prosecute this matter, however, he strongly recommended that the Districts of New York and California should be contacted, as proper venue lies within their respective jurisdictions.

In view of AUSA [redacted] declination, and his subsequent prosecutive recommendation, no further investigation will be conducted by this office.
