THE PELICAN BAY CALIFORNIA STATE PRISON IS A FACILITY DESIGNED TO HOUSE PROBLEM INMATES. IT IS LIKELY THAT THE SUBJECT BELIEVES THAT BY THREATENING FEDERAL JUDGES. HE MAY BE ABLE TO LEAVE THE RIGID CONFINES OF PELICAN BAY FOR A MORE LEMIENT FEDERAL PRISON.

THE U.S. ATTORNEY'S OFFICE HAS ADVISED THAT IN THE ABOVE DESCRIBED SCENARIO WAS TRUE AND IF SUBJECT S STATE SENTENCE IS SUFFICIENTLY LONG. THEY WOULD PROBABLY DECLINE PROSECUTION.

CONTACT HAS BEEN MADE WITH THE U.S. MARSHAL'S SERVICE AND THE INVESTIGATIONS UNIT AT PELICAN BAY. SAN FRANCISCO WILL ADVISE FBIHO OF ANY FURTHER DEVELOPMENTS.


