The Jewish Defense League (JDL), founded in 1968, is composed primarily of young Jewish militants who consider themselves as defenders of "Jewish rights." Demonstrations attempting to dramatize the Jewish problem in Russia, and similar demonstrations against Arab establishments have often resulted in violence. Rabbi Meir Kahane, founder and International Director, has stated publicly on many occasions that violence is sometimes necessary to accomplish the aims of the JDL.

On March 27, 1974, Philip Bigger, Federal Probation Office, Brooklyn, New York (NY), advised that a motion for dismissal of Meir Kahane's probation had been withdrawn and the probation terms will not be discharged. It is noted that Mr. Bigger advised on December 20, 1973, that attorneys representing Kahane had filed a motion to dismiss the probation terms regarding Kahane's conviction in United States District Court, Brooklyn.

On March 15, 1974, [REDACTED] who has furnished reliable information in the past, advised that he had been in contact with several of the officers of the JDL in New York City, and formulated the opinion that officers of the organization feel that the only possibility of the JDL prospering in the future, depends on Kahane's return to the United States. Source advised that these officers indicated that a recent article in the "Jerusalem Post," an English-language paper published in Israel, set out the circumstances regarding Kahane's difficulty with Israeli officials. In effect, that article pointed out that Kahane will not be permitted to leave Israel until three outstanding criminal charges pending against him are satisfied. The charges in essence involve his alleged attempt to smuggle arms from Israel in 1972, his efforts to disrupt the Arab-Israeli population by circularizing offers to buy Arab-owned property and his attempt to disrupt friendly relations between Israel and the United States in connection with the visit of Soviet Communist Party Secretary Brezhnev to the United States.

Source also advised that Kahane had engaged in a hunger strike in early February, 1974, in an effort to draw attention to his present status in Israel, which was unsuccessful. According to [REDACTED], Kahane is presently pressing appropriate authorities in the Israeli Government for the return of his passport.

Source also advised that none of the leaders in the New York area feel that Kahane will be able to return to the United States in the near future.

INFORMATIVE NOTE

Date 4/17/74

Legat, Tel Aviv, reported in attached, information which appeared in all Israeli newspapers on 4/17/74, regarding the resignation of Meir D. Kahane as International Director of the Jewish Defense League (JDL).

Kahane stated he was not leaving because of disenchantment with JDL's objectives, describing JDL as the last hope of the Jewish people. He criticized the lack of support of JDL by individuals who while professing belief in JDL, were unwilling to work for the organization.

It is noted Kahane has dual U.S.-Israeli citizenship and has been detained by Government of Israel authorities because of his participation in several criminal actions in Israel. He has been on U.S. Federal probation since 7/71 for violation of the Gun Control Act of 1968.

Details in attached are being relayed by teletype to our New York Office which is origin, as well as to State, CIA, U. S. Secret Service and to the Assistant Attorney General, Criminal Division, Internal Security and General Crimes Sections.

Kahane forms new movement

Jerusalem Post Reporter

TEL AVIV. — Rabbi Meir Kahane, founder of the militant Jewish Defence League, announced yesterday he is forming a new movement called Kach (Hebrew for "thus").

The aims of the group are to set up armed Jewish self-defence units, to disrupt anti-Jewish meetings abroad, and to make candidates for political office aware of the influence of the "Jewish vote," the rabbi said in a lengthy manifesto.

Rabbi Kahane, under a two-year suspended prison sentence for inciting his American followers to sabotage Soviet offices in the U.S., demanded an end to military work for girls and missionary work in Israel. He also proposed a compulsory tax on Jews throughout the world and a campaign of counter-terrorism to curb Arab terrorist attacks.

Kahane, once head of the JDL, quit active service in the movement when it failed to win sufficient votes in national elections last December to give him a seat in the Knesset.

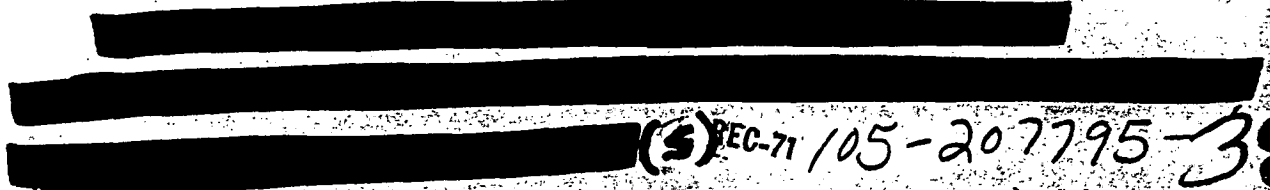
