"IT'S JUST A LOT OF NONSENSE. IF I STOPPED TO WORRY ABOUT EACH GROUP THAT WANTED TO HARM ME, I'D BE OUT OF BUSINESS. FRANKLY, I COULDN'T CARE LESS (IF THE STORY WERE TRUE)," HE SAID AT HIS JERUSALEM HOME.

KAHANE SAID HE WAS A CLOSE FRIEND OF ANOTHER ALLEGED MAFIA LEADER, JOSEPH COLUMBO, WHO WAS SHOT IN THE HEAD IN JUNE, 1971, DURING AN ITALIAN-AMERICAN RALLY.

KAHANE AND COLUMBO APPEARED FREQUENTLY TOGETHER IN PUBLIC, AT FUND RAISING DINNERS, PRESS CONFERENCES AND OTHER PUBLIC MEETINGS. THE AMERICAN RABBI WAS ONE OF THE FIRST PERSONS TO VISIT COLUMBO IN THE HOSPITAL AFTER THE SHOOTING AND LATER AT COLUMBO'S BROOKLYN HOME.

KAHANE'S LIFE WAS SAVED, YEDIOTH SAID, WHEN ISRAELI POLICE ARRESTED HIM ON OCT. 1 IN CONNECTION WITH ATTEMPTS TO SMUGGLE WEAPONS ABROAD FOR USE AGAINST ARABS.

A COURT ORDERED THE JDL LEADER RELEASED FROM POLICE CUSTODY ON \$34,000 BAIL AND RETURNED HIS CONFISCATED PASSPORT ON THE CONDITION THAT HE NOT TRAVEL TO THE UNITED STATES.

THE NEWSPAPER SAID THE DECISION TO "HIT" KAHANE CAME AFTER A MEETING LAST SEPTEMBER IN CHICAGO. "IT WAS HELD, IRONICALLY, JUST A DAY AFTER YOM KIPPUR, ON SEPT. 19, AND THE FATE OF RABBI KAHANE WAS DECIDED BY THE MIDDLE OF THE WEEK."

FOLLOWING THAT DECISION, YEDIOTH SAID, "PLANS WERE WORKED OUT. THE WORD WAS OUT AMONG GAMBINO OPERATIVES THAT KAHANE HAD BEEN 'MARKED FOR A HIT,' AS THEY SAY IN THE UNDERWORLD."

THE NEWSPAPER SAID THE MAFIA PLANNED TO KILL KAHANE AND MAKE IT LOOK AS IF ARAB GUERRILLAS HAD DONE THE JOB.

NOTE:

Subject is the International Director of the Jewish Defense League (JDL). He has been residing in Israel since June 1972 and was scheduled to return to the United States on 10/1/73. He was arrested on the latter date by Israeli authorities in connection with JDL plot to smuggle weapons from Israel into the United States and Europe for use against Arab terrorists. We have been closely following subject's activities and travels and pertinent information developed has been promptly disseminated to all interested agencies. In connection with our intensive investigation of JDL and the subject we should be aware of the authenticity of allegations relating to an assassination attempt on subject by organized crime figures in the United States. Our New York Office has established through its investigation of JDL, and it has been publicly reported in the press, that Kahane and Joseph Colombo, New York crime figure, have been aligned in the past on issues of mutual interest.

Police Sources in New York:

THE "MAFIA PLANNED TO LIQUIDATE RABBI MEIR CAHANE".

(By Gershon Jacobson).

YEDIOT

Friday

October 20, 1972

The life of Rabbi Meir Cahane, leader of the JDL, was in fact saved by the Israeli Police which arrested him and prevented his journey to the U.S. If Cahane had arrived in the U.S. it is possible that he would now be dead. Because no other than this Big Chief of the "Bosses", Carlo Gambino, had given the order "to silence Cahane" when he gets to the U.S.

This surprising revelation, made by a high-ranking officer of the New York Police, has been confirmed by a number of sources, which were involved directly and indirectly in the "Mafia" decision to rub out Cahane.

The arrest of Cahane solved a big problem of the New York crime king, and at the same time saved the lives of a number of people, including the leader of the JDL. It seems that, although these things might astonish a great many people, would be no news for the Federal Authorities in Washington and the Israel Police Thirteen "Godfathers".

From pieces of information which could be collected from Police and other circles, it seems that the Governments of Israel and the U.S. knew quite well about Cahane's intention to go to the U.S., in order to meet with the "Mafia" leaders and to mobilize the aid of "organized crime" to fight the Arab terrorists.

According to the sources, even before Rabbi Cahane revealed this in his appearance on 'Israel Broadcasting', "mysterious informers" revealed these full details about Rabbi Cahane's plan to the Department of Justice in Washington. These "informers" were "Mafia" agents who acted on instructions from Carlo Gambino.

Why did Gambino do that? Why did he decide to liquidate Cahane, and why did he then try to prevent that by passing prior information to the U.S. Department of Justice?

Police sources reported that Gambino responded to an instruction by

the "Committee" or the "Confederation" which is the highest body of power of

the "Mafia".

The "Confederation" is composed of thirteen heads of "Mafia" families, the most powerful of the "Syndicate". When the "Confederation" decides, all must obey them, and all their decisions are adopted unanimously. Last September the "Confederation" held a meeting in Chicago, at which important decisions were taken concerning the world of crime. A previous meeting was held in August. Both meetings were called by the "Mafia Boss" in Chicago, Don Tony Acrardo. The meeting in August was called in order to obtain the votes of twelve of the members of the "Confederation" to reprimand the 13th member, Gambino, who did not come to the meeting. The order of the "Godfathers" was that Gambino must immediately stop the war in the underworld, which then raged in New York. The "Confederation" warned Gambino that if the acts of murder and shooting did not stop, the "Confederation" would send its own army to New York in order to put an end to the gang war "in its own way".

Gambino, who was in fact the planner of the power struggle between the gangs of Colombo and Galo, while reaping the benefits from the conflict between the two understood the hint of the "Confederation", and the series of murders stopped suddenly, after 17 "Mafia" people had been killed.

Immediate Liquidation.

This is where the Cahane affair enters the picture. According to police sources Gambino knew all along that Cahane was 'very close' to Joe Colombo and his men. When Cahane informed one of Colombo's forces of his plan to fight against Arab terror, Gambino tried to prevent that kind of publicity at such a crucial time of his career. When Gambino learned of the connection between Cahane and Colombo Gambino notified the "Confederation" that he washes his hands of all responsibility and was drawing the attention of the Mafia people to the problem fraught with disaster, if Colombo exposes himself to a political struggle which would attract

the attention of the Authorities. The Mafia heads were enraged. They sent out warnings intended to prevent publicity about the operations of the underworld. They accused Gambino of the situation which prevailed and demanded that he get matters in hand. However, Gambino was not in a position to confront Colombo, because Gambino had been the man who had permitted Joe Galo to murder Joe Colombo. Carlo Gambino had another possibility, viz. to carry out slaughter among the key men of Mafia of Colombo, but it was impossible to do that "quietly", in accordance with the instructions of the "Confederation". Therefore he requested a solution from the other 12 "Godfathers" of the Mafia. And then the meeting in September was called. One day after Yom Kippur, on September 19, the thirteen "Godfathers" met and decided the fate of Rabbi Cahane. It was a decision to the effect that, as a last resort to prevent undesirable publicity and a storm around Mafia activities permission was given to Gambino to rub out Rabbi Cahane. Plans were made, and the information was passed round among Gambino's men, that Cahane was a "marked target". Cahane was scheduled to arrive in New York at the beginning of October and, according to the police circles, the gangsters were all set to murder him on arrival. The murder of Cahane was supposed to look as if he had been killed by Arab terrorists, the Mafia remaining "above suspicion". It was the time after the slaughter in Munich and the discovery of the explosive envelopes, therefore the Mafia thought it would look "a natural murder" if Cahane got himself killed as soon as he arrived in the U.S. to fight against the terrorists.

Cahane's liquidation was, as mentioned before, a 'last resort'. The Mafia leaders were looking also for other ways to prevent Cahane from going to the U.S. and to mobilise Colombo's gangs to fight the Arabs. Therefore they gave permission for someone to act as "informer" thus violating one of the iron laws of the underworld. Gambino's men decided to pass the details of Rabbi Cahane's plan for war against Arab terrorists on to the office of the Attorney General in Washington.

According to police circles, it was Gambino's men who revealed Rabbi Cahane's intention to come to the U.S., that sub-machineguns and handgranades were being smuggled out of Israel, and other details on the plot between Cahane and Colombo. The Attorney-General informed the U.S. State Department accordingly, which in turn notified the Israeli Authorities. On September 23 the Israeli Police started their investigations and arrested Rabbi Cahane and some of his supporters. Thus the Mafia was released from the necessity to use the 'last resort' of silencing Rabbi Cahane for good.

Contacts with the Mafia.

As a matter of fact, the F.B.I. already suspected last summer that Rabbi Cahane was planning to return to the U.S. with weapons and to start his war together with Colombo's men, against the Arabs and possibly also against Soviet diplomats.

It is learnt that Bernard Deutsch, a rich businessman of Wall Street, New York, who was one of the supporters of Rabbi Cahane, was interrogated by two FBI Agents for six hours. They wanted to know whether official Israeli circles were secretly supporting Cahane. Deutsch told your reporter that he had said to the FBI Agents that he had no knowledge about these things and that his support for Cahane was limited to the financial side, providing bail for the release of JDL members who had been arrested, as well as paying for flight tickets to Washington where the JDL members demonstrated.

Rabbi Cahane began his contacts with the Mafia two years ago, when Joe Colombo made an agreement with Cahane to fight against the bothersome FBI. They were seen in public, side by side, and Cahane arranged press conferences together with Colombo and even went out to Colombo's summer house to play golf. They participated at dinner parties for charity and were speaking in praise of one another.

In June 1971, when Colombo was hit by three bullets in his head, Rabbi Cahane was among the first to visit him in hospital, while the doctors were still making efforts to save his life. At the time Cahane arranged a prayer for the life of Colombo. Since then Cahane was one of the friends of the Colombo family and he was even allowed to visit Colombo who was convalescing. It was that bond of friendship which worried the other Mafia leaders, particularly Gambino.

When Cahane's plan to come to the U.S. was about to be realised, with the prospects of the publicity that would accompany his activities in the war against terror, it was ^{what} Gambino who wanted to prevent at any price, even at the price of killing Cahane. However, he succeeded in having Cahane arrested without firing a single shot.

Now, after the Attorney-General of Brooklyn has started a campaign against 677 Mafia members, it is possible that some more aspects of the plot against Cahane will be revealed, when the Law Courts begin the hearings of the affair.

A United Press International (UPI) news release datelined Tel Aviv, October 20, 1972, referred to an Israeli newspaper story which alleged that Jewish Defense League (JDL) leader Rabbi Meir Kahane was to be rubbed out by the American Mafia. The UPI release also quoted an unnamed high-ranking member of the New York City Police Department (NYCPD) who commented on the alleged attempt to assassinate Kahane.

The JDL is self-described as a militant activist group dedicated to the struggle for democracy, freedom and Jewish rights.

b7c On October 25, 1972, [redacted] UPI, 42nd Street and Second Avenue, New York City, advised that the article in question was not a UPI release. The story was picked up by UPI in Tel Aviv from a release originating with the Israeli newspaper Yedioth Aharonoth. [redacted] who had no information concerning the source of the Yedioth Aharonoth article, furnished a copy of the UPI story.

Extracts of the UPI article, datelined Tel Aviv, October 20, follow:

"An Israeli newspaper said today that Jewish Defense League leader Rabbi Meir Kahane was to be rubbed out by the American Mafia.

"The report, written by Yedioth Aharonoth's New York correspondent, said a contract to 'silence' Kahane was put out by alleged 'Godfather' Carlo Gambino.

This document contains neither recommendations nor conclusions of the FBI. It is the property of the FBI and is loaned to your agency; it and its contents are not to be distributed outside your agency; nor duplicated within your agency.

"Quoting a 'high-ranking member of the New York Police Department', Yedioth said the killing was connected with Kahane's attempt to have the crime organization counter Arab guerrilla attacks.

"If Kahane would have come to the United States, he might have been dead by now. No other than the 'boss of bosses', Carlo Gambino, had issued the orders to silence Kahane when he arrives in America', Yedioth said.

"Kahane's life was saved, Yedioth said, when Israeli police arrested the Rabbi Oct. 1 in connection with attempts to smuggle weapons abroad for use against Arabs.

"An Israeli court ordered the JDL leader released from police custody on \$34,000 bail and returned his confiscated passport on the condition that he not travel to the United States.

"The newspaper said the decision to 'hit' Kahane came after a meeting last month in Chicago. 'It was held, ironically, just a day after Yom Kippur, on Sept. 19, and the fate of Rabbi Kahane was decided by the middle of the week'.

"Following that decision, Yedioth said, 'plans were worked out. The word was out among Gambino operatives that Kahane had been "marked for a hit", as they say in the underworld.'

"The newspaper said the Mafia planned to kill Kahane and make it look as if Arab guerrillas had done the job.

"The murder of Kahane was to have looked as if it was just another crime perpetrated by Arab terrorists, thus freeing the Mafia of any responsibility", it said.

On October 26, 1972, [redacted] and [redacted] Intelligence Division, Security and Investigation Section, NYCPD, advised that no police official, to their knowledge, made such statements to the press as reported by the New York correspondent of the Israeli newspaper Yedioth Aharonoth. Both men are of the opinion statements such as this frequently are attributed to "unnamed high-ranking police officials" without have any foundation.
