
#### Citizenship and Denaturalization Proceedings

The "New York Journal American", a daily New York City newspaper, in its issue of February 21, 1958, carried an article captioned "Gambler Faces Ouster to Poland". This article reflected that INS was preparing deportation proceedings against LANSKY.

On July 25, 1958, MORTON ROBSON, Assistant United States Attorney, Southern District of New York, advised that the denaturalization proceedings against the subject were dismissed on May 28, 1958, for lack of prosecution. Mr. ROBSON stated it cannot now be reinstituted in New York since subject is now a resident of Florida.







Application number 6697-29 was issued to MEYER LANSKY, white, male, age 26, and ANNIE CITRON, white, female, age 18. LANSKY's perents were MAX, born in Russia, and YETTA, born in Russia. His rasidence was 6 Columbia Street, New York City.

CITRON's perents were MOSES, born in Russia, and SELMA, born in Russia, and they resided at 156 South 9th Street. The certificate reflected it was the first marriage of both, and they were married on May 9, 1929, before Rabbi ISAAC EPSTRIN.

On June 9, 1958, files of the Dade County Circuit Court were reviewed by SA under number under number 106443, and reflected that on January 29, 1947, ANNIE CITRON LANSKY, Plaintiff, filed Bill of Complaint in Action for Divorce against MEYER LANSKY, Defendant. They were married May 9, 1929, at New York City. They had three children: BERNARD, born January 15, 1930; PAUL, born September 22, 1932, and SANDRA, born December 6, 1937. She charged extreme cruelty. A final decree of divorce was granted by Judge M. C. WISENART on February 14, 1947.

The subject in his application for passport on June 10, 1967, stated that he was married to THEIMA SHERR SCHWARTZ on December 16, 1948, and that she was born in New York City on November 18, 1907.






MEYER LANSKY advised SA on May 11, 1961, that he knew for many years. He said he last saw about a year ago in Miani. He said he knew him socially, and it was not a business contact. He said he believed living in Italy, with her two children. He said he believes she moved there from Switzerland, to take advantage of the Italian schools. He said he did not know why she lived abroad. He said he does not have any business interests with time. He refused to discuss any business dealings he may on the advice of his lawyer. have had with stated he knew he was being investigated by the Internal Revenue, and said he was not going to be pinned down to specifics in any way, as he was not going to incriminate himself in any way. His attitude was friendly,





but he evaded all questions on business, or contacts. He advised he was legally merried to his present wife, THELMA, but refused to say where or when. He said he felt he was being persecuted because of his name, and said he took a "fall" in the Arrowhead Inn fiasco because there had been a falling out among politicians, and he was offered up as a sop as a consequence.






The "Las Vegas Sun", daily newspaper, for October 28, 1954, contained an article reflecting that Nevada State Tax Commission was conducting an extensive hearing into the alleged "undisclosed interests" held by JAKE and MEYER LANSKY and others in the Thunderbird Hotel of Las Vegas. This article reflects MARION HICKS, President, Thunderbird Hotel, admitted in testimony that he had used money advanced by GEORGE SADLOW in the operation of the Thunderbird Hotel.
