LANSKY has been the subject of continuous and intense investigation since 1957 but investigation has not developed concrete information concerning any illegal activities over which this Bureau has jurisdiction. The Internal Revenue Service has conducted active investigation of his business activities since 1944, but has developed no information to support a successful prosecution.

It is believed that valuable information sufficiently concrete to support prosecution on any violation may be developed only through the utilization of unusual investigative techniques.

12. Risks of detection involved:

None known.
