New York has ascertained that Lansky's wife engaged Suite #21 and #23 in the Volney Hotel, 23 East 74th Street, New York City, for a period of one month. This suite is to be occupied by Lansky and his wife during further recuperation.

New York Office telephonically requested authority for a survey and installation of a misur in the above suite for coverage of Lansky's activities and conversations held with visitors. [REDACTED]

ACTION:

In view of the stature of Lansky and the excellent potential offered by this microphone coverage, Bureau authority was granted for the survey and installation of a misur at the Volney Hotel provided full security was assured. [REDACTED] in discussing wiretapping bill presently pending, remarked that wiretapping is okay against the Communists, but otherwise is most sickening. She stated she believed the "KENNEDYS" were acting sincerely and in their best beliefs. When LANSKY disagreed, she reminded him that he came up "on the wrong side of the fence", to which subject replied that he was brought up on the "unhypocritical" side.

Two individuals addressed as [REDACTED] discussed the ramifications of the Judge KEOGH-TONY CORALLO trial currently being held in NYC. They generally agreed, in an off-handed manner, that the trial was a "fraud". They stated that NYC is the greatest "fraud" town in the US and said the NY Police were the "greatest frauds of them all." 
