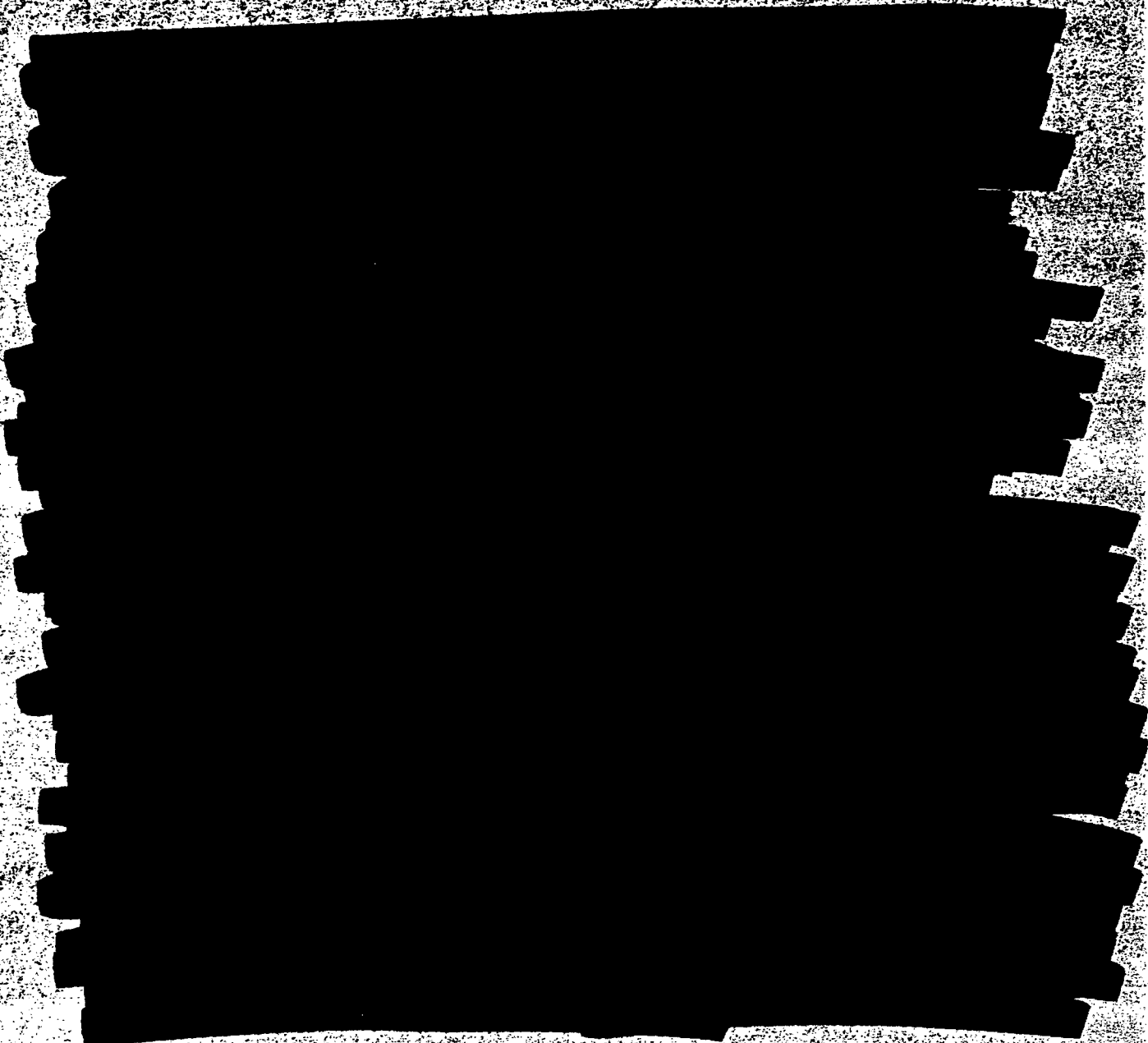

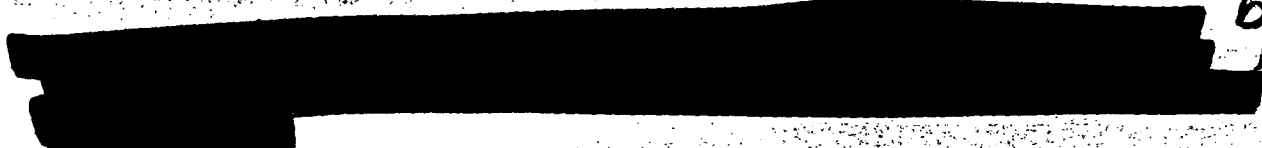

Customs Inspector [REDACTED] Miami Division, advised Special Agent [REDACTED] October 19, 1962, that a thorough search of the LANSKYS' baggage failed to reveal any pertinent information and it was evident that they

expected a thorough search and took pains not to have anything of an informative or incriminating nature in their possession.

- NEWSPAPER ARTICLE -

By dateline October 3, 1962, the Miami News, Miami, Florida, carried the following news article concerning this subject:

"'JUKE KING' AVOIDING THE MAFIA?"

"Meyer Lansky, onetime Miami jukebox king and a former gambling baron in Cuba, is in Israel, fleeing the Mafia, the Associated Press reported today.

"The wire service quoted the Tel Aviv newspaper Yedioth Ahronot as saying Lansky was seeking immigrants' visas for himself and his wife because the Mafia was after him.

"The Lanskys have a home in Hallandale.

"A Miami source said the couple planned to return to Hallandale Sunday, and that there was nothing to the report that Lansky feared the Mafia.

"A police spokesman in Tel Aviv said the Lanskys had tourist visas valid for three months and were free to travel in Israel just as any other tourists are. They arrived there last week.

"Lansky fled Cuba after Fidel Castro overthrew the Fulgencio Batista government. At the time, 1959, Lansky reportedly had extensive juke box interests around New York and Miami.

"In Sen. Estes Kefauver's Senate Crime Committee hearings in 1950-51, Lansky was described as a big-time gambler and an associate of New York and Brooklyn gangsters, including big shots in the old Murder Inc. mob."

From information in the files of the New York Office, a summary memorandum dated 3/5/54, was prepared concerning the activities of Frank A. Erickson (62-). The following information concerns Meyer Lansky and his association with Erickson in gambling activities. b2

In 1939 it was reported that Meyer Lansky, one time a member of the so-called "Big Six," which dominated the rackets in New York City during the latter stages of the prohibition era, was associated with Frank Erickson and Albert Levey in operating the Oriental Race Track and the National Gambling Casino at Havana, Cuba. (p. 10)

Subsequently Lansky advised Bureau Agents that he, Erickson and Levey started the above operation in 1938 and held a six year contract. Lansky also stated that he had been connected with race tracks principally around New York for the past thirty years. (p. 11)

A "New York Times" news item of 5/18/50 stated that on 5/2/50, the offices of Frank Erickson were raided by the District Attorney, New York County. Among the documents seized was a financial statement relative to the Colonial Inn, a gambling casino at Hallandale, Fla., which gave a detailed set up of the inn's operation from 11/1/45 to 10/1/46. The "Las Vegas Sun" of 1/5/59, showed that Alan Jarlson, a staff writer, had interviewed Meyer Lansky. Lansky had stated he "hoped that the new government will emerge from Fidel Castro's liberation of Cuba and will continue to permit American gamblers to operate."
