Although this source has not furnished pertinent information to date, the background information could be highly pertinent when the casinos begin to operate. Harris International is presently expanding its operation and is still not completely set up to operate in the Bahamas at this time. The coverage will pertain to subsequent skimming operations in the Bahamas and as the Bureau is aware the source will not come to its full fruition until the casinos are open and operating in the Bahamas and have reached that stage of development where a skimming operation would be feasible. It is believed that this type of coverage should be maintained in order that this office will be in a po sition to cover the early stages of the skimming, planning and subsequent substantive skimming. In view of the above, this valuable source will be continued for 90 days, UACB.

However, it is felt that the installation has an excellent potential to furnish information regarding the Bahamas operation and will most likely be able to furnish information regarding the skimming of funds once the gambling activities are in full operation.

The Miami Office by telephone call to Assistant Director Evans, was authorized to move the installation into a different room of the office building where it is located after the Miami Office ascertained that*it was getting new quarters. In view of the insight such a misur can provide, it is recommended the Miami Office be authorized to continue this installation for a ninety-day period.

The files of the Passport Office, Department of State, reviewed by a Special Agent of the FBI on July 23, 1965, disclose that Meyer Lansky, born on July 4, 1902, in Russia, was issued passport C 304440 at Miami, Florida, on June 27, 1962. This passport was renewed at Miami, Florida, about March 8, 1965, to expire June 27, 1967. In his renewal application dated March 8, 1965, the subject stated that he intended to take a pleasure trip for two months in 1965 but did not furnish any travel plans or list the countries which he intended to visit.

This passport is valid for all countries except Albania, Cuba, and those portions of China, Korea, and Vietnam under communist control.

The subject gave his mailing address as Post Office Box 356, Hallandale, Florida. In the event of death or accident he requested that Jack Lansky, his brother, be notified at Post Office Box 1596, Hollywood, Florida.

It is noted that under current passport regulations the subject may use this passport for lawful travel within the period of its validity and as often as desired without further notification to the Department of State or other Government agency.
