Based on a news article which appeared in the "Los Angeles Times" dated June 17, 1971, datelined Tel Aviv, Louis H. Boyar was linked romantically to Golda Meir of Israel. This same article reported that Boyar, who was from Los Angeles, California, and a multi-millionaire, had gained recent widespread attention in Tel Aviv as the man who interceded on behalf of Meyer Lansky, reputed to be the financial czar of organized crime in the United States, in Lansky's effort to have a visitor's visa to Israel extended. This article continued that Boyar denied doing this for Lansky on a personal basis, claiming he did not know him but indicated he did it because of a belief in the principle that every Jew wishing to enter and live in Israel should be allowed to do so.

An article relating to Boyar appeared in the "California Jewish Voice", a local newspaper, under the date of January 15, 1954. This article states that Louis H. Boyar had been elected Chairman of the Los Angeles Committee for Bonds of Israel Government. This article identified Boyar as having been active 25 years in the Los Angeles area for various Jewish causes and listed the organization headed by him to be National Vice-Chairman of the National Jewish

On July 28, 1961, an article appeared in the "Pasadena Star News" reporting that Norman Lyon will join the Board of Directors of the Metropolitan Development Corporation, which is headed by Developers Mark and Louis Boyar and Ben Weingart.

On October 4, 1970, an article entitled "Take
Me to Your Power Structure" appeared in the "West Magazine"
which is distributed with the Sunday editions of the
"Los Angeles Times". This article concerned itself with
various individuals in the Los Angeles area who are influential
in fund raising for political purposes. This article included
the name of Mark and Louis Boyar and described them as the
directors of the Metropolitan Development Corporation, a land
development firm responsible for the building of many
suburbs in the San Fernando Valley and other residential
areas in or around the Los Angeles, California, area. The
article described the Boyars as being among the most
accomplished fund raisers for the Democratic Party and of
helping in the campaign of former President Harry Truman and
the Democratic presidential campaign of Hubert Humphrey.







The August 27, 1971, edition of "Ha'aretz," a Hebrew-language newspaper published in Israel, contained an article on its front page headlined "Lansky Offered High Payment in Dollars to 'Ha'aretz' Reporter for the Documents."

The article was written by "Ha'aretz" reporter Yigat Laviv, who claimed that an attempt was made by subject and his associate, Joe Stacher, to buy certain documents in Laviv's possession. Laviv claimed that a considerable sum of money in dollars (not specified) was offered Laviv for copies of material submitted through Laviv to the Israeli Ministry of Justice regarding subject's activities. The offer was made, initially, through a telephone conversation by an intermediary. It is noted that the August 27, 1971, edition of "Maariv," a Hebrew-language newspaper published in Israel, contained the same information as that set forth in the "Ha'aretz" article, identifying the intermediary as Shaul Schiff, a reporter of an additional newspaper, "Hazofe," a religious daily newspaper published in Israel. According to the article in "Hazofe," Schiff admitted that he was the intermediary.

Following the contact by Schiff, Laviv alleged he was contacted directly by an attorney, Haim Basuk, who is the Deputy Mayor of Tel Aviv, and a member of the National Religious Party (NRP). Subsequent meetings with Basuk revealed to Laviv that the former was representing known criminal figures Meyer Lansky and Joseph Stacher. Stacher and Lansky were furnishing the funds for the purchase of the documents in Laviv's possession.

Laviv stated that the matter was brought to the attention of the Israel National Police (INP), and he was advised by Mr. Shmuel Roth, Head of the Investigations Division, INP, that since there were no classified documents involved, there was no violation of law unless the payment to Laviv for the documents would be made in currency other than Israeli pounds. It was suggested to Laviv that he attempt to obtain payment in United States dollars. Basuk agreed to this arrangement, but later indicated he was warned by Aaron Cheloucher, Commander, Special Branch, INP, that this would be a clear violation

and Basuk would be liable for prosecution. Basuk then made the payment to Laviv in Israeli pounds.

An additional article in "Ha'aretz" for August 27, 1971, indicated that Chelouche advised a reporter (unidentified) of "Ha'aretz" that he met with Basuk after it became known to him that Basuk was trying to obtain documents that Lansky expressed an interest in. Basuk assured Chelouche that the intended purchase of the documents was not in violation of any law to which Chelouche agreed and added that the action planned by Basuk would be legal if he obtained the documents without exerting any pressure on Laviv and paid in Israeli currency and obtained a proper receipt. Chelouche also advised that he was not aware that Basuk represented Stacher.

An editorial appearing in the same edition of 'Ha'aretz' was highly critical of the action taken by Chelouche, comparing it to organized crime in the United States. The editorial accused Chelouche of protecting Lansky and Stacher from becoming involved in "illegal and criminal acts." The editorial concluded with a strong appeal for an investigation of the above on the highest level in the Knesset (Israeli Barliament), the Ministry of Justice and the Ministry of Interior.

Israeli newspapers for August 29, 1971, revealed Minister of Police Shlomo Hillel organized a committee to investigate the above matter.

The purpose of this memorandum is to recommend that the case file for Meyer Lansky under the Anti-Racketeering category be maintained in the space of the Criminal Intelligence East Unit of Division 9, room 1537, Justice Building, for a period of 120 days.

Since March, 1971, when it was established, Task Force 18 of the Department has been coordinating intensified investigations of all aspects of Lansky's affiliations, associations and activities with the objective of attempting to determine the amount of his power in organized crime, sources of his income, and the rackets from which he may derive a substantial amount of his wealth. This has resulted in numerous requests for investigations of an intelligence-type with reference to previous history of his activities. These requests are being coordinated by the Criminal Intelligence - East Unit and require frequent use of the 18-volume file.

ACTION:

It is recommended that file 92-2831 be maintained for a period of 120 days in room 1537, Justice Building. Due to the large number of demands requiring access to the file on an almost daily basis as circumstances dictate, consideration will be given to returning the file to the regular file room as soon as practicable and in any event further recommendation will be made after 120 days on the retention of the return of the file.

On September 20, 1971, U. S. District Court Judge JOE EATON, Miami, Florida, granted a motion for a change of venue to Las Vegas, Nevada in the trial of MEYER LANSKY, MORRIS LANSBURGH, SAMUEL COHEN and others in connection with an indictment handed down by a Federal Grand Jury on March 25 1971, charging the aforementioned individuals with violation of income tax statutes resulting from alleged skimm from the Flamingo Hotel in Las Vegas Nevada.

On October 22, 1971, a Federal Grand Jury at Las Vegas, Nevada, returned a superseding indictment on LANSKY, MORRIS LANSBURGH, SAMUEL COHEN and others in connection with an Internal Revenue Service (IRS) violation involving "skimming" of 36 million dollars from the Flamingo Hotel Casino.

Three others were charged with a conspiracy to aid in the preparation of false tax returns during the 1960s and included SAMUEL ZIEGMAN, age 75, Omaha, Nebraska, a stock-holder in the Flamingo during the 1960s and now retired; STEVE DELMONT, age 37, a former Flamingo purchasing agent and HARRY GOLDBERG, age 65, one time Flamingo Casino executive, now employed in the casino of the Frontier Hotel.

According to an article appearing in the Miami Herald on November 15, 1971, furnished by United Press International (UPI), Jerusalem on November 14, 1971, the Israeli Supreme Court forbade the explusion of MEYER LANSKY from Israel as long as his visa status remained unresolved.

The court issued a temporary injunction against explusion of LANSKY and ordered Interior Minister JOSEPH BURG to show cause why he should not reverse his September 23, 1971, decision against extending LANSKY's tourist visa or grant immigrant's status under the 'Law of Return.
