Enclosed for the Bureau for transmittal to Albany is one copy of a Visa Action Request from the American Embassy, Paris, to the Immigration and Naturalization Service, Frankfurt, Germany, which is unclassified and recommends a waiver for subject who is ineligible for a visa in view of former membership in the French Communist Party. FOUCAULT reportedly is to lecture at Cornell University, Ithaca, New York, for a period of four weeks. Paris indices contain no information identifiable with subject.

All logical investigation has been completed and captioned matter is being RUC'd.
