I'm an agent with the Brevard RA out of the Tampa Division. I'm contacting you since you're listed as the violent crime supervisor in Philadelphia. I just finished a conversation with [redacted] According to [redacted] a group recently formed by the name Stop Moms for Liberty. That group has recently compiled a database of Moms for Liberty members in a few counties [redacted] & [redacted] surrounding Philadelphia including the names, work location and other member data. At this point it's unclear on how the information within the database was compiled. According to [redacted] this information being broadly shared within the group Stop Moms for Liberty and may have been disseminated further.
