

It was noted that when HUMPHREYS left, he was not carrying the package.

It is noted that FBI Agents observed that when HUMPHREYS left the residence of Congressman ROLAND LIBONATI, he took a taxicab to the Woodner Hotel, 3636 16th Street N.W., in Washington. He was observed proceeding to apartment number 803.

[REDACTED] It is a matter of public knowledge that he served time with JACK GUZIK, associate of HUMPHREYS, in the Federal Penitentiary at Lewisburg, Pennsylvania. When HUMPHREYS left the Woodner Hotel, he was observed in the company of an individual who was subsequently identified by FBI agents as [REDACTED] accompanied HUMPHREYS to the Purple Tree Bar in the Hamilton Hotel where they remained for almost 2 hours and then accompanied HUMPHREYS to the Town and Country Bar in the Mayflower Hotel, which they entered at 11:08 p.m. and did not leave until 12:38 a.m. on May 25, 1960.

On May 14, 1942, the confidential informant advised the CCC that control of labor unions as well as vice and gambling was in the hands of FRANK NITTI, MURRAY HUMPHREYS, WILLY HEENEY, LOUIS CAMPAGNA and [REDACTED].

On October 24, 1943, the "Chicago Sun Times" listed the following as "Syndicate gambling bosses":

According to the records of the CCC as of May 14, 1942, control of labor unions as well as vice and gambling was at that time "in the hands" of the following individuals:

It is noted that NITTI, HEENEY and CAMPAGNA are deceased and that [REDACTED] has been exiled, leaving only HUMPHREYS of this group.

The "Chicago Sun" newspaper published in Chicago on October 1, 1943, disclosed that JAMES RAGAN had told police that MARTIN "SONNY BOY" QUIRK, former Chicago hoodlum, now deceased, planned the murder of DANNY STANTON (deceased), a reported gambler on the South Side and thereafter took over 34 of STANTON's handbooks, and this was done with the approval of MURRAY HUMPHREYS, whom he described as "the South Side gambling Syndicate head".

On October 24, 1943, the "Chicago Sun", a daily newspaper, listed MURRAY HUMPHREYS as one of "the Syndicate gambling bosses".

An unknown confidential informant of the Chicago Crime Commission advised on March 21, 1944, that MURRAY HUMPHREYS was a powerful member of the "CAPONE Syndicate", and that he had been in control of a large number of rackets in various lines of endeavor in Chicago.

On November 10, 1943, an unknown confidential informant of the CCC advised that "the gambling Syndicate in Chicago" was composed of [REDACTED] and [REDACTED] both reported members of the 'Chicago Crime Syndicate,' along with ROCCO and CHARLIE FISCHETTI, SAM HUNT and MURRAY HUMPHREYS.

On November 10, 1943, the same source advised that "the gambling syndicate and labor rackets" were controlled by the same individuals.

On November 10, 1943, a confidential source of information, whose identity is at this time unknown, advised the Chicago Office of the FBI that "the gambling Syndicate and labor rackets in Chicago" were controlled by the following individuals, at that time:

Of the above listed individuals, it is noted that NITTI, CAMPAGNA, GUZIK, EVANS, STANTON, FONTO, GREENBERG and BIOFF are deceased. RICCA is serving a sentence for income tax evasion in Terre Haute Federal Penitentiary; [REDACTED] whereabouts are unknown; and [REDACTED] has been exiled from the country.

The only remaining member of the above group is MURRAY HUMPHREYS.

The "Chicago Tribune" on February 3, 1942; and the "Chicago Sun" on October 1, 1943, and October 24, 1943, published articles describing MURRAY HUMPHREYS as a "Crime Syndicate gambling figure".

On May 14, 1942, the CCC received information that HUMPHREYS controlled not only labor unions, "but all vice and gambling in the Crime Syndicate" along with a few other individuals.

An article in the "Chicago American", a daily newspaper, dated January 2, 1947, stated that after LOUIS CAMPAGNA and PAUL RICCA, "reported members of the Chicago Crime Syndicate", went to jail in the moving picture industry extortion case, JACK GUZIK, MURRAY HUMPHREYS and EDDIE VOGEL took over the operation of the Syndicate on behalf of AL CAPONE.

An article appearing in the "Chicago Sun" of January 26, 1949, captioned: "Capone's Pals Still in Rackets", stated, "Murray 'The Camel' Humphreys once labeled Public Enemy No. 1 since Prohibition days, has organized gambling and tried his hand at newer rackets, including muscling in on labor unions and industries".

It was also alleged that MURRAY "The Camel" HUMPHREYS was active in the operation of the Trans-American horse racing news service, and was one of the most level-headed businessmen in the "Chicago Crime Syndicate".

An article appearing in the "Chicago Herald-American", dated March 12, 1950, which article was written by JOHN MADIGAN, based on information related to him by ROGER TOUHY, a Chicago hoodlum and beer baron during Prohibition days and at that time in the Illinois State Penitentiary, Joliet, Illinois, for the kidnaping of JAKE "The Barber" FACTOR, stated "Racketeering was at its height in Chicago and the nation in 1932 and early 1933 Both the International Brotherhood of Teamsters (IBT) and some unions not affiliated with the IBT, were controlled by such CAPONE successors as GEORGE "Red" BARKER (deceased), MURRAY HUMPHREYS, WILLIAM "Three-fingered" JACK WHITE, (deceased), and WILLIAM "Klondike" O'DONNELL (deceased).

**Connection of MURRAY HUMPHREYS
 With Crimes in Chicago**

Jewelry Store Burglary in 1920

The files of the Chicago Crime Commission reflect that on April 28, 1920, MURRAY HUMPHREYS was indicted with one HARRY OLSON and JAMES WHEATLEY on a robbery charge. He was also indicted with HARRY OLSON and one JOSEPH HADAD on a charge of robbery of Mandel Brothers Barn, 4812 Cottage Grove Avenue, on December 19, 1919. The defendants, HARRY OLSON, JAMES WHEATLEY and JOSEPH HADAD, were tried and found guilty and sentenced to prison terms. MURRAY L. HUMPHREYS was not apprehended, and the indictments were stricken off with leave to reinstate. Subsequently the indictments were reinstated, and a hearing set for April 18, 1927. Eventually the order reinstating the indictments was vacated.

Murder of TED NEWBURY

The "Chicago Tribune" on January 13, 1933, reported that HUMPHREYS was picked up for questioning in connection with the murder of TED NEWBURY, a Chicago hoodlum.

Murder of DENNIS H. ZEIGLAR

On March 7, 1933, the "Chicago Tribune" reported that HUMPHREYS, together with CHARLES FISCHETTI, was questioned in connection with the murder of DENNIS H. ZEIGLAR, a labor official.

Murder of JENS LARRISON

In an article on May 11, 1944, in the "Chicago Herald American" it was reported that HUMPHREYS was arrested and questioned in connection with the murder of JENS LARRISON.

The Kidnapping of JACK HUGHES

In an article on May 11, 1944, in the "Chicago Herald American" it was reported that HUMPHREYS was arrested and questioned in connection with the kidnapping of JACK HUGHES.

Bombing of Home of MORRIS I. KAPLAN

The "Chicago Sun Times" of May 1, 1955, reported that acting Chief of Detectives HARRY BENZIN had stated he was looking for MURRAY "The Camel" HUMPHREYS and SAM "Golfbag" HUNT for questioning in the bombing of the Rogers Park home of an attorney, MORRIS I. KAPLAN, 1040 Albion, which caused \$500.00 damage to the home and about \$1,000 to surrounding windows.

Arrest of HUMPHREYS for
Carrying Concealed Weapons

On June 4, 1933, an article appeared in the "Chicago Tribune" which reflected that MURRAY HUMPHREYS, "Three-Fingered" JACK WHITE and CHARLES FISCHETTI, a cousin and one-time bodyguard for AL CAPONE and currently reported member of the "Chicago syndicate", appeared in the Felony Court on a charge of carrying concealed weapons. The disposition of this case is not known.

Murder of JAMES "Red" FAWCETT

The "Chicago Daily News" on May 26, 1945, reported that JAMES "Red" FAWCETT, a Chicago hoodlum, was shot and killed in a Chicago tavern on that date. The article reflected that the police were seeking in connection with this murder SAM HUNT, RALPH PIERCE, MURRAY HUMPHREYS and others.

Murder of LLOYD ROURKE

The "Chicago Sun" on August 13, 1946, in an article written by reporter EDDIE DOUGHERTY, stated that HUMPHREYS was questioned in the murder of LLOYD ROURKE, a laundry wagon driver.

Murder of PETE ROSENBERG

The "Chicago Sun" on August 13, 1946, in an article written by reporter EDDIE DOUGHERTY, stated that HUMPHREYS was questioned in the murder of PETE ROSENBERG, a cleaner and dyer whose business was absorbed by HUMPHREYS.

Murder of MARINUS HVID

The "Chicago Sun" on August 13, 1946, in an article written by reporter EDDIE DOUGHERTY, stated that HUMPHREYS was questioned in the murder of MARINUS HVID, a garage owner.

Murder of ANTON GORCZAK

The "Chicago Sun" on August 13, 1946, in an article written by reporter EDDIE DOUGHERTY, stated that HUMPHREYS was questioned in the murder of ANTON GORCZAK, a laundry driver who had been taking customers away from HUMPHREYS.

Murder of ROGER TOUHY

The "Chicago Sunday Tribune" in its edition of December 20, 1959, carried an article on Part 1, Page 1, Column 8, entitled "Police Seek HUMPHREYS For Grilling". This article is quoted below in part.

Illegal Union Activities

Teamsters Union

In the "Chicago Tribune" on August 10, 1932, appeared an article reporting that HUMPHREYS, MARCUS "Studdy" LOONEY, GEORGE "Red" BARKER, R. J. O'MALLEY, and WILLIAM "Klondike" O'DONNELL were attempting to dominate the Teamsters Union. LOONEY, BARKER and O'DONNELL were described as Chicago hoodlums. They are now all deceased.

On May 11, 1933, the "Chicago Tribune" carried an article reflecting that in July, 1932, HUMPHREYS, JACK WHITE, "Studdy" LOONEY, "Klondike" O'DONNELL, and FRANK DIAMOND visited the office of the Milk Wagon Drivers Union, 220 South Ashland, and stated to union officials, "We are going to take over this joint".

In 1939, the Internal Revenue Bureau brought HUMPHREYS into court for failure to declare an item of \$50,000.00 ransom paid to him and GEORGE "Red" BARKER for the purported kidnapping of ROBERT C. FITCHIE, President of the Milk Drivers Union. The Treasury and Business Manager of the Union, STEVE SUMMER, identified HUMPHREYS and BARKER as the individuals who collected the ransom paid by the Union for FITCHIE's release. The kidnapping occurred in December, 1931. HUMPHREYS was fined \$74,000.00. No action was taken against him for the kidnapping for the reason the statute of limitations barred any prosecution.

An article in the "Chicago Herald American" on March 12, 1950, quoted ROGER TOUHY, who was then confined in the Illinois State Penitentiary for kidnapping and aiding another prisoner to escape, as saying that in the early thirties MURRAY HUMPHREYS was one of several hoodlums who controlled the International Brotherhood of Teamsters.

The records of [REDACTED] another government agency, reflect that HUMPHREYS, as well as other known hoodlums, frequented Martin's Restaurant, 33 North La Salle Street, during 1946. These records indicated that Martin's Restaurant at that time was "a front for the so-called Syndicate."

Mike Fish's Restaurant

It is noted that Mike Fish's Restaurant was located for many years at the corner of Ontario Street and St. Clair Street on the Near North Side of Chicago. In 1959 MIKE FISH left the operation of this restaurant to his brother, PETE FISH, and Mike Fish's became known as Pete Fish's at that time. MIKE FISH then opened up a restaurant bearing that name in the Sovereign Hotel, 6200 North Kenmore, in Chicago, which continues to operate as of the date of this report.

In August, 1960, MIKE FISH also opened another restaurant bearing that name in the restaurant formerly known as the Black Orchid and later as Angelo's on the corner of Ontario Street and Rush Street in Chicago.

On November 25, 1958, SAs [REDACTED] and [REDACTED] observed MURRAY HUMPHREYS and [REDACTED] in Mike Fish's Restaurant, located on the corner of Ontario and St. Clair Streets. SAs [REDACTED] and [REDACTED] also observed that approximately an hour and a half after HUMPHREYS and [REDACTED] entered the restaurant, SAM GIANCANA also entered the restaurant. SA [REDACTED] observed that approximately 45 minutes after GIANCANA entered the restaurant he saw an individual resembling HY GODFREY driving a car which carried a license number registered to GODFREY enter the rear door of the restaurant with another unknown individual.

The "Chicago Sun-Times" on October 31, 1950, referred to HUMPHREYS as "an old timer known as the best dressed and best educated of Chicago hoodlums."

On May 23, 1960, at 12:08 p.m. MURRAY HUMPHREYS was observed by FBI Agents disembarking from American Airlines Flight 352 in Washington, D. C. Thereafter, HUMPHREYS was observed proceeding by taxicab directly to the Woodner Hotel, 3636 16th Street, N. W., Washington, D. C. He immediately took an elevator up into the hotel without registering or checking at the desk.

At 5:15 p.m. on May 23, 1960, HUMPHREYS was observed leaving the Woodner Hotel, at which time he was carrying a small package approximately 5" x 3" x 2" wrapped in blue and white gift wrapping and tied with a blue ribbon. He proceeded by taxicab directly to 224 C Street, N. E., Washington, D. C., rang the bell at this address, and entered at 5:43 p.m.

The Congressional Directory reflects that 224 C Street, N. E., is the local address for Congressman ROLAND LIBONATI of Chicago (Democrat, 7th District).

HUMPHREYS left this address at 6:48 p.m., at which time he was no longer carrying the aforementioned package. He hailed a taxicab and returned directly to the Woodner Hotel. It was ascertained that he proceeded to Apartment Number 803, where he was admitted by a male who could not be observed.

At 7:50 p.m. HUMPHREYS, accompanied by an unknown male, departed the Woodner and proceeded by taxicab directly to the Hamilton Hotel, 14th and K Streets, N. W. On leaving the taxi, HUMPHREYS and the unknown man separated on the street. HUMPHREYS entered the lobby of the hotel and unknown male no. 1 entered the "Purple Tree" bar in the hotel. HUMPHREYS took a seat in a small room which was a part of the lobby. At 8:30 p.m. he made a telephone call on one of the house phones in the lobby, and at 8:35 p.m. he was joined by a man subsequently identified as Congressman THOMAS J. O'BRIEN of Chicago (Democrat, 6th District). At 8:57 p.m. HUMPHREYS left this small room, crossed the lobby, entered the "Purple Tree" bar and joined unknown male no. 1 in the bar. They talked briefly, left the bar, obtained a taxicab, and proceeded directly to Fan and Bill's Restaurant, Connecticut Avenue, N. W., where they proceeded to have dinner.

At 10:23 p.m. it was observed that HUMPHREYS and unknown male no. 1 were in the company of another unidentified male, unknown male no. 2. At 11:08 p.m. HUMPHREYS, unknown male no. 1 and unknown male no. 2 left the restaurant and walked directly to the Town and Country Bar in the Mayflower Hotel, where they were observed having drinks. At 12:38 a.m., May 24, 1960, this trio left the bar and walked to an Oldsmobile car parked on De Sales Street bearing current Maryland license tag [REDACTED] (b)(7)(c) They entered this car and proceeded directly to the Woodner Hotel, where HUMPHREYS and unknown male no. 1 left the car, while unknown male no. 2 proceeded north on 16th Street. At 12:54 a.m. HUMPHREYS and unknown male no. 1 entered the lobby of the hotel, where unknown male no. 1 was overheard telling HUMPHREYS that he had to accompany HUMPHREYS upstairs in order to let him into the apartment. They entered an elevator and pressed buttons for the 10th and 12th floors; however, both left the elevator at the 10th floor and entered Apartment No. A-1010. As they entered HUMPHREYS was overheard to remark that "last week" he had stayed in Apartment A-1010, but unknown male no. 1 corrected him, saying it was another apartment. At 1:02 a.m. unknown male no. 1 left Apartment A-1010, saying good night, and proceeded to Apartment B-801, which he entered at 1:03 a.m.

Unknown male no. 1, who was in HUMPHREYS' company from 7:50 p.m., May 23, 1960, until 1:02 a.m., May 24, 1960, is described as 40 years old, 5' 7" tall, 175 pounds, deep tan complexion, brown curly hair, prominent ears and nose and wearing gray suit. On May 24, 1960, agents participating in this surveillance observed a photograph of [REDACTED], and identified it as being a photograph of unknown male no. 1.

At 6:21 a.m. on May 24, 1960, HUMPHREYS left the Woodner Hotel and proceeded via taxicab to the National Airport. No pertinent activities were observed at the airport terminal building until HUMPHREYS boarded Capital Airlines Flight No. 1 at 8:04 a.m. This flight departed for Chicago, Illinois, non-stop, at 8:15 a.m.

Upon the departure of Capital Airlines Flight No. 1 for Chicago on the morning of May 24, 1960, it was ascertained that there was no passenger aboard this plane by the name of MURRAY HUMPHREYS. Investigation developed that [REDACTED] (b)(7)(C):(D)

He used the name J. PORTER, no address or any other identifying data, and had reservations to fly from Meigs Field via Chicago Helicopter Service at 8:26 a.m. to arrive at Midway at 8:33 a.m. However, he was observed by SA [REDACTED] in the lobby of American Airlines at 8:10 a.m. and therefore obviously did not fly to Midway by helicopter at 8:26 a.m. (b)(7)(c)

MURRAY HUMPHREYS was observed by FBI Agents in Washington, D. C., arriving National Airport 11:59 a.m., June 6, 1960, via American Airlines Flight Number 352 from Chicago. He proceeded directly, by taxi, to the Woodner Hotel where he went directly, without stopping at desk, to Room 803 B, which is occupied by [REDACTED] (b)(7)(c)

At 5:53 p.m., June 6, 1960, HUMPHREYS, [REDACTED] and an as yet unidentified white male in his late thirties, referred to as unknown male no. 1, departed the Woodner Hotel by taxi and proceeded to Fan and Bill's Restaurant. At 6:18 p.m. the above three were joined by a fourth individual who answers the description of [REDACTED] local attorney, and who was referred to by [REDACTED] as [REDACTED] and [REDACTED]. The above four ate a meal and at 7:27 p.m. departed the restaurant and proceeded by taxi to the Casino Royal, a restaurant and night club type establishment, which at the time was populated by several hundred visiting high school students watching the floor show.

From the above conversation it appears that HUMPHREYS has a friend who recently conducted an inspection of the prison at Terre Haute, Indiana, who, according to HUMPHREYS, had a conversation with PAUL DE LUCIA. HUMPHREYS then comments on the possibility of getting a parole for DE LUCIA which he doubts because of DE LUCIA's reputation.

In connection with the above conversation between HUMPHREYS and [REDACTED] and since there could be little doubt (b)(7)(C) that the subject of their conversation was PAUL DE LUCIA, SA [REDACTED] discreetly contacted [REDACTED] Records (b)(7)(C)(D) Clerk, United States Penitentiary, Terre Haute, Indiana, who advised that to his knowledge there has not been an employee of the United States Bureau of Prisons conduct any type of inspection of that institution during the past year. [REDACTED] also advised that a review of the file of PAUL DE LUCIA, #16855, failed to reflect that MURRAY HUMPHREYS was on DE LUCIA's approved correspondence or visitors list.

Review of the file of PAUL DE LUCIA reflected that he had FBI Number 832514. He has aliases PAUL VIELA, PAUL RECCIA, PAUL SALVI. He was convicted in Northern District of Illinois at Chicago on June 12, 1958, for income tax violation, and received a three year sentence. The sentence actually began on July 1, 1959, inasmuch as DE LUCIA's case was on appeal. His parole date was June 30, 1960, but his parole was denied on May 23, 1960. He had appeared before the April Board of the United States Board of Parole at the United States Penitentiary, Terre Haute, Indiana. (H)(L)

██████████ advised that file reflects that DE LUCIA will be released from that institution under law under mandatory release, also known as conditional release, on October 21, 1961. He stated that in the event he had to serve the full term his release date would be June 30, 1962. Mr. (H)(7)(C)(D)

██████████ advised that DE LUCIA has a deportation detainer from Immigration and Naturalization Service lodged at that institution against him on January 28, 1960. A letter to Immigration and Naturalization Service from that institution reflects that DE LUCIA was scheduled for release October 21, 1961. DE LUCIA's file reflected that on May 5, 1960, he had a visit from ██████████

On March 22, 1960, DE LUCIA had an approved visit from ██████████

A letter in the file reflected that ██████████

██████████ agreed to hire DE LUCIA if he was paroled. ██████████ claims to be a general contractor.

On September 20, 1960, SA ██████████ contacted Warden T. WADE MARKLEY inasmuch as a discreet inquiry with Records Clerk ██████████ failed to reflect that a Bureau of Prisons employee had inspected that institution during the past year. MARKLEY advised that on or about August 24 or August 31, 1960, ██████████

██████████ visited United States Federal Penitentiaries at Chillicothe, Ohio, Ashland, Kentucky, and Terre Haute, Indiana. With Congressman ██████████

He stated that the Federal Jail Inspector at Terre Haute, Indiana, drove to Chicago, Illinois, and picked up Congressman [REDACTED] and [REDACTED] and drove them to Terre Haute, Indiana, where the two of them visited the institution. Warden MARKLEY advised that the visit to the Terre Haute Penitentiary was in regard to an article that LIBONATI wrote for the Congressional record which appeared in the Friday issue, September 2, 1960, on Page A, 6737. This article was entitled "Inspection of Federal Prisons". After [REDACTED] inspected the United States Penitentiary at Terre Haute, Indiana, he requested to visit with PAUL DE LUCIA and [REDACTED] both serving sentences at that institution from Chicago, Illinois, for income tax violations. Warden MARKLEY advised that inasmuch as the Congressman's visit had been approved by the Bureau of Prisons in Washington, D. C., he authorized the visit between DE LUCIA and KEERNAN with [REDACTED]. He stated that at all times during the visit a Bureau of Prisons employee was present. He advised that when DE LUCIA and [REDACTED] met there was a disgusting display of affection inasmuch as [REDACTED] hugged and kissed DE LUCIA. MARKLEY advised that it was his personal opinion that the congressional courtesy was being carried a bit too far. MARKLEY advised that at no time during and after the visit of [REDACTED] with DE LUCIA, did [REDACTED] make a request of any kind for any types of favors for DE LUCIA. MARKLEY advised that since the visit of [REDACTED] with DE LUCIA and [REDACTED] he has received no inquiry from anyone regarding these two inmates. He advised that [REDACTED] is due for release in the very near future. Warden MARKLEY advised that inasmuch as the information he furnished is in connection with the visit of a Congressman, he desired that the information be handled confidentially.

The following conversation is a continuation of (b)(7)(C) the meeting held on September 12, 1960, and involves MURRAY HUMPHREYS, [REDACTED] and an unknown individual:

This particular conversation touched on several topics, the first of which is not too clear. HUMPHREYS had first attempted to get in touch with ROLAND V. LIBONATI, United States House of Representatives, however, LIBONATI was not in his office. The immigration case referred to by [REDACTED] may possibly be the case involving PAUL DE LUCIA, mentioned in Chicago airtel to the Bureau dated September 13, 1960, DE LUCIA is up for deportation proceedings upon his release from the United States Penitentiary. The person referred to as "having died" could possibly be the main witness against DE LUCIA, an Italian immigrant whose name DE LUCIA took upon entry into the United States.

JOE referred to is of course ANTHONY ACCARDO and the unknown individual who apparently is a lawyer was speaking of giving instructions to ACCARDO as to his demeanor in and near the federal court room where his trial was then in progress. [REDACTED] the attorney representing ACCARDO on his tax case.

[redacted] referred to by the unknown is the individual who with MURRAY HUMPHREYS, FRED EVANS and others were indicted for extortion involving the Hotel Employees, Bartenders and Waiters Union in 1940. All defendants were dismissed. [redacted] is probably one of ACCARDO's closest associates and as was noted in Chicago airtel to the Bureau dated September 13, 1960, is [redacted]

[redacted] FRANK FERRARO discussed here his trip to Las Vegas, Nevada, where he stayed at the Desert Inn under his true name.

The golf match referred to herein is one which was mentioned in an article appearing in the "Chicago Daily Tribune" of September 12, 1960, which revealed that CERONE, DICK HAUFF, notorious owner of the Mt. Prospect Country Club, and hoodlum associate; WILLIAM DADDANO, lieutenant of SAM GIANCANA; and MARSHALL CAIFANO, North Side Chicago syndicate member, held a golf game for high stakes at the White Pines Country Club in the Chicago area on September 11, 1960. An interesting feature in the conversation pertaining to [redacted]

HY GODFREY then enters the room and relates the fact that the jury in the ACCARDO case was in the process of being selected and that the Judge (JULIUS J. HOFFMAN) had turned down a request by the defense for a continuance, the request being based upon the fact that one of the defense witnesses, [redacted] was undergoing treatment for cancer of the throat and was unable to appear. The person believed to be [redacted]

[redacted] who is on the jury panel list, however, it should be noted that it is also possible that this individual will not be put on the jury panel list but will be placed in a position in the

federal court room whereby he will be able to act as a sort of "runner" and pass messages back and forth between the individuals and officials of the court and possibly the jury. (b)(7)(c)

FERRARO then goes into a long and involved conversation, the complete text of which is not included herein, pertaining to [REDACTED], who was recently acquitted of attempted murder in a case wherein he shot his, [REDACTED] two sons. According to FERRARO, [REDACTED] is again on the rampage and has apparently made threats to his wife and to his wife's children. FERRARO appeared to be greatly upset over this situation and was discussing the fact that if the situation arose similar to the past incident, FERRARO would kill him. HUMPHREYS then intercedes that he should not kill him that he should have someone else do it.

HUMPHREYS and [REDACTED] et al, then had a brief conversation pertaining to income tax settlements, etc. with HUMPHREYS advising that one of his items which he puts down for a source of income is the sale of antiques which he claimed last year as a \$1,500 profit.

[REDACTED] then advised HUMPHREYS how [REDACTED], according to HUMPHREYS, is very good "for that big lazy (obscene)".

The [REDACTED] mentioned by [REDACTED] was [REDACTED]

[REDACTED] and who was subsequently elected.

On September 13, 1960, a conversation was held between MURRAY HUMPHREYS and [REDACTED] which was as follows:

Here's what we've done. We've raised money for this thing through the labor people, you know, and ahh, we've raised \$12,000 up to now. We've gotta raise about \$20,000 so what I want to do is write 'em a letter.

HUMPHREYS dictated a letter to [REDACTED] in which he attempted to be most vociferous in his insistence that [REDACTED] and the Teamsters Union throw their wholehearted support behind LIBONATI and more or less adopt this camp as their own in order to afford the Teamsters Union more favorable publicity. An interesting feature in this conversation is the fact that LIBONATI, according to HUMPHREYS, has "stood by labor" and has been influential in having the Teamsters monitors investigated and also in attempting to stop any legislation which would be unfavorable to labor and particularly the Teamsters. In this connection it is noted that [REDACTED] has reported in the past of HUMPHREYS making trips to Washington, wherein subsequent investigation has revealed that HUMPHREYS has been in contact in Washington with, among others, Representative LIBONATI. (b)(7)(c) (b)(7)(d)

Following that conversation, a long involved conference held with the known participants being HUMPHREYS, [REDACTED], FERRARO, possibly ROSS PRIO, and other unidentified individuals. This conversation for the most part is held in low tones and much of which was whispered. The conversation which could be ascertained was as follows:

For the information of the Bureau, on September 14, 1960, SA [REDACTED] contacted Federal Judge JULIUS HOFFMAN, United States District Court, Chicago, concerning the possibility of Judge HOFFMAN writing an article for the FBI Law Enforcement Bulletin. It is noted that Judge HOFFMAN

has made available his facilities for moot court procedures for the International Railway Police School. Judge HOFFMAN advised SA [REDACTED] that there has been considerable pressure placed on him through unscrupulous attorneys to the effect that he, Judge HOFFMAN, is prejudiced on the side of law enforcement, and should disqualify himself from various criminal cases, including the present ACCARDO case. Judge HOFFMAN stated that he is of the opinion that his role with law enforcement agencies should not preclude his presiding over criminal cases, including ACCARDO's, and has no intention of disqualifying himself. Judge HOFFMAN is of the opinion that ANTHONY ACCARDO is guilty, but the burden of proof rests on the Government; however, this case will be judged on the facts presented. He also indicated ACCARDO apparently does not like being tried by him and is attempting to delay this case as much as possible. He said that recently ACCARDO's defense requested a delay on the basis of an affidavit from a doctor claiming that [REDACTED] is not physically well enough to be present at this trial. HOFFMAN declined to furnish a delay since he felt that each defendant is entitled to counsel, however, ACCARDO does not need three attorneys in this instance. He said that he has known for a long time that [REDACTED] has had a serious throat ailment and believed that he is taking advantage of this situation to delay ACCARDO's trial. Judge HOFFMAN claims that [REDACTED] is a tax attorney and not a trial attorney, therefore, is not essential to the hearing of this case.

Cook County. FRANKIE referred to is probably Chicago top hoodlum FRANK FERRARO. [REDACTED] is an associate of MURRAY HUMPHREYS who has been connected with the race wire service. VOLPE is apparently DOMINIC VOLPE, president of Premium Beer Sales, Inc., Chicago.

It is apparent from the above conversation that

HUMPHREYS reluctantly indicated that he would, through his contacts, get this person in the union; however, would rather keep this membership exclusively for close friends and members of their family. According to the informant,

Following this conversation, the above individuals started playing gin rummy. An individual later appeared at Celano's who is referred to only as [REDACTED] who is probably [REDACTED], a West Side gambler and [REDACTED] Chicago top hoodlum SAM GIANCANA.

MURRAY HUMPHREYS then called in HY GODFREY and started the following:

HUMPHREYS: I was supposed to call RALPH last night, I forgot. Listen, I want you to go out and see [REDACTED].....Here, [REDACTED] see that, 7338. (Probably [REDACTED], who is one of jurors).

GODFREY: Yeah, I got that.

HUMPHREYS:you understand?.....find out all about.....what's that, Sinclair, or uh, Shell. Have him come outside. Call him.... find out all about him, what kind of a guy he is, if he can really make him, but not to make him. And come back, go out there now and come back. Go straight there, and don't let anybody stop you. You know the name?

I got it.

MURRAY HUMPHREYS then made a phone call to the office of [REDACTED] a Chicago attorney, and was told that [REDACTED] was not in. HUMPHREYS indicated that he would call back and identified himself as JIM MURRAY. (b)(3)

[REDACTED] advised that following the above conversation HUMPHREYS departed for a brief period and then returned and had the following conversation with RALPH PIERCE, HY GODFREY, and [REDACTED] an employee of Celano's: (b)(7)(c)

HUMPHREYS: These guys are really running me around. You talk about a guy working his can off. I seen your boy friend over there. [REDACTED] My wife and I.

I wanted to see him. Where's he at?

It appears that the prospects of approaching this juror look bleak according to PIERCE. PIERCE again mentioned [REDACTED] and [REDACTED] who are possibly friendly with Judge JULIUS J. HOFFMAN and claimed that they would wait [REDACTED] return to Chicago Monday. The conversation continued as follows:

CURLEY, I talked to [REDACTED] on that thing you told me about. Now, he also said...

HUMPHREYS:

Who?

The cab driver.

The above conversation is self-explanatory. HUMPHREYS continued to make arrangements to have a juror approached apparently through [REDACTED] HUMPHREYS indicated to GODFREY that he did not want this juror approached then and

desired that they find out all about him. Staley's referred to is a Chicago restaurant, 335 South Clark Street. [REDACTED] is [REDACTED] ACCARDO's tax attorney, who was not present at ACCARDO's trial due to a serious throat condition.

HUMPHREYS' comments to PIERCE that they contact several judges was probably in connection with the ACCARDO trial. It appeared HUMPHREYS was trying to show that Judge HOFFMAN was prejudiced in the case and should have been disqualified. Informant was unable to learn the identities of the judges that HUMPHREYS had in mind.

Following this conversation, HUMPHREYS and PIERCE discussed more on the ACCARDO trial with the usual complaints about not receiving justice in this matter. HUMPHREYS made arrangements for [REDACTED] attorney, to obtain a statement from [REDACTED]

PIERCE then said, "They tell me MOONEY's dying," to which HUMPHREYS replied: "They said they don't give him 6 months to live."

MOONEY is SAMUEL M. GIANCANA. It was alleged that about two years ago GIANCANA had cancer and it was ascertained that he had been operated on in 1959 for a ulcerated colon. It would seem from this conversation that GIANCANA does have cancer.

On September 16, 1960, [REDACTED] advised that (b)(2) MURRAY HUMPHREYS and [REDACTED], top hoodlums of the Chicago (b)(7)(C)(D) Division, met with HY GODFREY, a lieutenant of HUMPHREYS and [REDACTED] and [REDACTED], an associate of ANTHONY ACCARDO and Chicago West Side gambling figure. Their conversation, to the best of the informant's knowledge, was as follows:

[redacted] was obviously concerned about an investigation being conducted by the Internal Revenue Service on him. An interesting observation by HUMPHREYS herein is that in his estimation the FBI apparently is a fact gathering agency whereas the Internal Revenue Service is apparently more interested in the obtaining of prosecution. The significance of his comment about "They are (FBI) doing that because of what those guys did that time...they don't catch us...", is not known by this office, however, it apparently refers to some situation which occurred in the past.

Part of this conversation was HUMPHREYS relating to [redacted] situations which occurred in the late 1920's and early 1930's with the CAPONE gang, wherein HUMPHREYS stated that he was the contact man with the politicians for CAPONE. Much of this conversation was garbled and unintelligible.

Following this ROSS PRIO, [redacted], HY GODFREY, HUMPHREYS, and [redacted] were all present; however, nothing of pertinence was noted. Most of the time was spent apparently standing by for some situation. [redacted] attorney for ACCARDO, made a brief appearance but again nothing of significance was noted.

[redacted] advised on September 21, 1960, that (H)(7)(C): (D) MURRAY HUMPHREYS and [redacted] held a conversation which was as follows: (H)(7)(C) ↓

It is possible that [REDACTED] was to be considered for a witness of ANTHONY ACCARDO inasmuch as his work for VOGEL gave him access to many taverns that sold Fox Head 400 Beer.

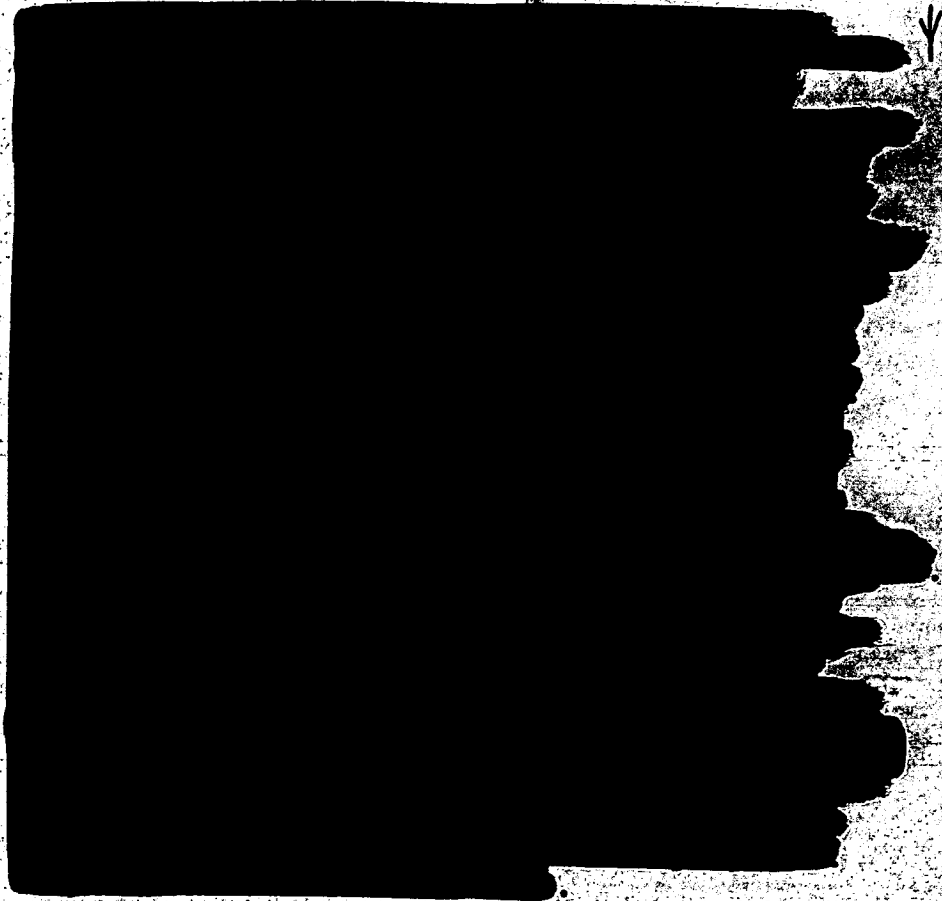

Attempts will be made to ascertain his identity and background. The [REDACTED] mentioned is [REDACTED] previously mentioned, former partner of [REDACTED] and also prominent realtor in the Chicago area.

[REDACTED] It would appear here that HUMPHREYS has some kind of an interest or at least is backing this operation.

HUMPHREYS then made a telephone call to Mr. [REDACTED] who was the former [REDACTED]. The telephone conversation went as follows:

HUMPHREYS:

(On phone) Is Mr. [REDACTED] in? Don't wake him, it's not that important. [REDACTED] How are you? What's wrong. This is MURRAY. Yeah. I'm all right. I called your office, and they said you went to a convention. All right. About three o'clock. Are you staying in bed all the time? Around the clock, huh? I just heard about it. [REDACTED] told me. I lost the sight of that eye, but I get along all right. Just taking it easy. I sold that place. I went away when I was sick. I'm doing pretty good. I got a doctor named [REDACTED]. That Doctor was a phoney. Yeah. [REDACTED], you're not much older than I am. 61. Did it do any damage to your heart? It did huh? I had two of them myself. It's kind of a warning to slow up. That's it, that's the way I was. If you feel anything come on, you just stop. I had a leakage too, but I take it easy, and it doesn't bother me. No, they been on me all my life. That doesn't bother me. When you were with Pabst Blue Ribbon, how much salary did they pay you? Well, this fella got a salary of 65,000. You read that,

didn't you? No kidding. That was when he was a kid. Yeah. I remember when you took me by the hand. I was wondering, because they say this isn't so, when it is so. They do that though, and they knock you out. That's right. What started a lot of this stuff, the stockholders started fighting. They had a proxy fight, and they moved this [REDACTED] from head of it. Did you? Yeah. Huh? He was in that restaurant, you're right. You got the right dope on him. He tried to get control and we wouldn't get in it. We told them we were selling, and we wouldn't get in the brewery, that was their business. Then he grabbed that Löwenbrau, and did a good job with that. When you get a little better, I'd like to have lunch with you. Bye bye.

I was talking to [REDACTED], he only got 25 thousand a year.

[REDACTED] is [REDACTED]. Apparently HUMPHREYS was contemplating using [REDACTED] as a rebuttal witness in the ACCARDO tax trial to show that [REDACTED] at one time held a position similar to that of ACCARDO in a local sales manager capacity; however, [REDACTED] only received \$25,000 per year in this capacity which more or less negated his value as a rebuttal witness to show that he received similar salary as ACCARDO, who received \$65,000 per year in his position as "salesman" for Premium Beer Sales.

HUMPHREYS then engaged in a brief conversation with FRANK FERRARO which was as follows:

FERRARO: 25 thousand?

HUMPHREYS: Yeah. He had a heart attack. I went this morning. This guy sent [REDACTED] over to my house at 7:30 this morning. The only thing I saw, I went out of the house and went north instead of south, and the only I saw was a

woman, then went back the other way, and got a car, and I saw a couple of guys from Scotland Yard, and they yelled, hiya HUMP, then I grabbed a cab and came over.

FERRARO: I just saw FRANKIE LA PORTE, and says that they got that guy in Joliet, that... [REDACTED] They know a guy that sleeps, drinks, and bunks with the guy every morning.

HUMPHREYS: I'm going down to see JOE tonight. 9:00. RALPH and them, they're away, you know that.

FERRARO: Yeah. All we have to do is send word to the guy to give him a fair trial, anyway.

FRANK LA PORTE is a prominent Chicago Heights and South Suburban Syndicate member and former partner of ACCARDO in the Owl Club, which was at one time a notorious gambling spot located in South Cook County. It would seem from this conversation that LA PORTE had been in touch with an individual who is close to [REDACTED] in Joliet, Illinois. It is noted that [REDACTED], Joliet, was a member of the jury which tried ACCARDO. Apparently this contact of LA PORTE was to try and influence [REDACTED] in his adjudication in the ACCARDO case.

Most of the foregoing conversation is self-explanatory. The reference to [REDACTED] is in all probability an indication that HUMPHREYS and/or his associates have attempted to have someone familiar with telephone workings enter the chambers of Judge JULIUS HOFFMAN, the Federal Judge who heard the ANTHONY ACCARDO income tax trial, for the purpose of monitoring phone calls leaving his office. The Chicago Office is attempting to determine if there is an individual by the name of [REDACTED] employed by the phone company who would have access to the Judge's chambers. Other individuals referred to in the conversation are believed to be as follows:

The MOONEY referred to in the conversation would be SAM GIANCANA.

In reference to the above conversation concerning the Lake Tower Motel, attention is drawn to the body of this report under the caption "Background" and the subcaption "Residences" wherein information is reported that HUMPHREYS resided during October, 1960, under an assumed identity, at the Lake Tower Motel. It is obvious that when GODFREY gave instructions to [REDACTED] as to where to go in the Tower Motel, he was referring to HUMPHREYS' suite.
