1st Moon Man, 6

President Nixon announced yesterday he has appointed Neil A Armstrong, first man on the moon, to be chalrman of the Peace Corps. Advisory Council.

Armstrong, the 39 year-old astronaut who was commander of the Apollo 11 mission, will remain in the space program. A civilian, he will receive no more than \$1,000 a year expense money for his duties with the advisory council.

President Nixon last week named Apollo 11 command module pilot, Col. Michael Collins, as assistant secretary of state for public affairs.
