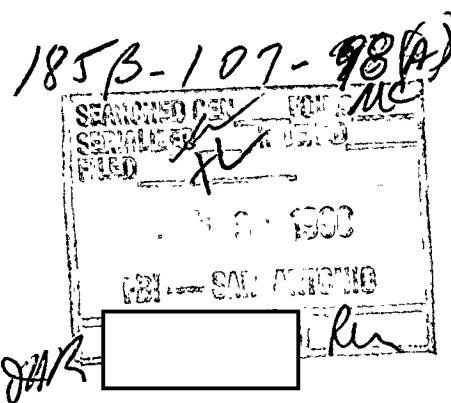

[REDACTED] MIAMI POLICE DEPARTMENT, INTELLIGENCE DIVISION, TELEPHONE (305) 579-6587, ADVISED THAT THE KU KLUX KLAN (KKK), JEWISH DEFENSE LEAGUE (JDL), SKINHEADS, AND A LARGE CONTINGENT OF CUBAN CITIZENS, ARE PLANNING A DEMONSTRATION IN MIAMI ON 6/28/90 IN CONJUNCTION WITH THE VISIT OF NELSON MANDELLA AND MAYOR DAVID DINKINS OF NEW YORK CITY.

ACCORDING TO [REDACTED] THE INDIVIDUALS PARTICIPATING IN THE DEMONSTRATION WILL ENGAGE IN CIVIL DISOBEDIENCE.

ON 6/24/90, METROPOLITAN POLICE OFFICERS ARRESTED TWO SKINHEADS IN WASHINGTON, D.C. WHO WERE HANDING OUT SKINHEAD PROPAGANDA. APPARENTLY, ONE OF THE SUBJECTS WALKED UP BEHIND A PLAIN CLOTHED POLICE OFFICER AND STUCK A CAMERA LID IN THE SMALL OF HIS BACK AND SAID "DIE". SHORTLY THEREAFTER THE FOLLOWING INDIVIDUALS WERE ARRESTED AND CHARGED WITH TWO COUNTS OF ASSAULT ON A POLICE OFFICER: [REDACTED] WHITE MALE, DOB: [REDACTED]

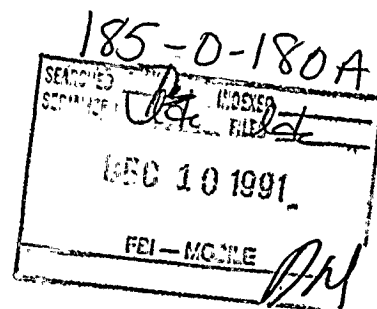

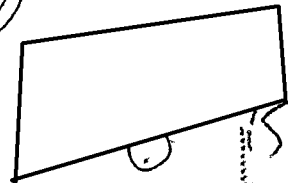
