## Funding woes delay employee paychecks at beef plant

Northern Beef Packers will delay paying its employees their wages this week because of financial difficulties.

Employees were told Wednesday that their Friday paychecks would not be distributed, but it was hoped wages could be paid early next week.

Northern Beef issued the following statement by email.

"Due to ongoing delays with securing additional funding, Northern Beef Packers has notified its employees that payroll will be delayed this week. The company is making every effort to rectify the situation as quickly as possible."

Northern Beef Packers laid off 108 workers on April 25 because of a lack of working capital to buy and process cattle, plant officials said at the time.

David Palmer, CEO, said that the plant, south of Aberdeen, needed to raise about \$20 million. Northern Beef hoped to call back laid-off workers by mid- or late July, he said.

The beef plant will not release the number of employees currently working at the plant or how many cattle the plant has slaughtered since the layoff occurred.

"For competitive reasons, the company does not release employment numbers or actual production and sales data to the public," said A.J. Minger, Northern Beef Packers director of new business development.

# Branded-beef program fails to meet expectations

## Aberdeen's Northern Beef Packers cited as part of problem

PIERRE — Launched with great hopes and fanfare eight years ago, the South Dakota Certified Beef program has so far fallen short of its goal of helping farmers and ranchers sell state-branded beef as a premium product commanding higher prices.

When then-Gov. Mike Rounds persuaded the 2005 Legislature to create the program, he envisioned a time when people across the nation and around the world would choose to pay more for steaks that carry a South Dakota seal of approval. He said codes on package labels could let buyers visit an Internet site to track the meat's origin, following it from a calf's birth to a feedlot and then a processor.

But that hasn't happened, largely because South Dakota hasn't had a meatpacking plant operating at a large scale that

would make processing economical, officials say. They hope the long-delayed Northern Beef Packers plant in Aberdeen will soon fill that void.

In the first eight years of the program, only 16,386 cattle — a tiny slice of a state herd that approaches 4 million head — have been enrolled by farmers and ranchers. Only 500 have made it all the way through the program to be sold as meat from the program, mostly just within South Dakota from cattle processed by small custom meat lockers.

Rounds, now running for the U.S. Senate, still thinks the program will succeed once the Aberdeen packing plant is running at full speed and more buyers demand verification of when and where cattle are born.

"I think its time will come," Rounds said earlier this month.

Todd Mortenson, a Hayes rancher who is still

registered with the program, recalled sky-high expectations when the program was launched.

"I keep hoping that something will come of it, that they'll get it revived," Mortenson said.

Mortenson and others, including state Agriculture Secretary Lucas Lentsch, said that will require developing a large-scale packing plant in South Dakota that can process cattle economically. Mortenson said selling a few cattle at a time through the program isn't worth the effort because he needs to sell a truckload of 50 cattle at a time to make the Certified Beef program work financially.

Northern Beef Packers, first proposed six years ago, is now operating in Aberdeen but well short of capacity. The plant laid off 108 of its approximately 420 workers in April, citing lack of money to buy and process high volumes of cattle. The plant at the time was slaughtering

about 200 cattle a day; its goal is up to 1,500 daily.

A.J. Mungér, director of new business development at the plant, said Northern Beef Packers wants to work with the South Dakota Certified Beef program. He said plant managers hope to reach capacity soon. He declined to talk about efforts to get additional financing to buy more cattle.

Sarah Caslin, with the state Agriculture Department's livestock marketing and development program, said about 60 farmers and ranchers are registered with the program, with about 6,000 head of cattle currently enrolled. The program requires that cattle be born, fed and processed in South Dakota, and most cattle now are shipped to packers in Omaha or Sioux City, Iowa, she said.

The Agriculture Department spends about \$52,000 a year to run the program, with much of the cost attributed to a federal

audit of the program and the state's checking of farmers and ranchers to make sure they follow the rules, Caslin said. Part of that cost is recovered from the \$100 annual fee paid by producers and the 50-cents-a-head fee to enroll each calf, she said.

To qualify as South Dakota Certified Beef, the cattle have to be born in the state, carry electronic ear tags and be tracked every time they are sold. Before being slaughtered, cattle have to be fed a high-starch diet or corn or other grain for at least 100 days.

Caslin said other certification programs have taken a long time to develop.

"We're still in our baby steps. The producers still feel this is a good program, and we're just going to grow," she said.

And even though little meat has actually been marketed in the program, its tracking components help some farmers and ranchers sell to buyers who demand to know when and where cattle were born, Caslin said.

June: Northern Beef Packers plan to build near intersection of 135th Street and 387th Avenue on Aberdeen's south side. Businessmen Dennis Hellwig and Norg Sanderson are involved with the project.

August: Plans call for construction to start in fall with possibility of opening in spring.

November: Plant ready to begin dirtwork, but opponents circulate petitions to refer the county's TIF vote to a public vote. Petitions containing more than 1,800 signatures turned in.

December: Hellwig says there are 66 Korean investors through the EB-5 program. TIF bonds remain unsold. Hellwig says they are one of the last pieces of financing needed.

April: Number of liens is 12, totaling about \$8 million. Plans call for October or November opening.

August: Northern Beef Packers has yet to pay first half of property taxes due April 30. It owes \$62,003 plus a penalty of \$2,067.

September: Records filed with the Secretary of State's Office show Dennis Hellwig is no longer an owner of plant. Oshik Song is listed as the general partner. Hellwig, the former owner of Hub City Livestock Auction, had been the largest investor and plant's prime spokesman.

## 2010

February: Brown County Commissioners say Northern Beef Packers will not get benefit of TIF bonds unless it first pays past-due property taxes and penalties totaling more than \$131,000.

## 2011

May: Northern Beef Packers hires 57 employees; plant expected to open between Oct. 15-Nov. 15, Steve Kaiser, acting public relations director, said.

June: Officials: Construction on schedule to open sometime in mid-to-late fall.

July: The plant will cause Brown County's gross domestic product to quadruple and Aberdeen's population to double in 15 to 20 years, a consultant said in Aberdeen. The plant will generate \$10.1 billion economic boom to the region in the next five years and have an annual \$2.5 billion effect by its fifth year. Rod Bowling of AgriFood Solutions International said at a conference.

December: Brown County Commission announced it would release to the plant about \$917,000 in increased property taxes resulting from construction as part of an agreement that also requires the beef plant to pay for roadwork. Northern Beef Packers will be obligated to pay the cost of improving about 1.3 miles of County Road 14W in front of the plant, less \$450,000 in state grants.

## 2012

February: Officials: Plant is 90 to 95 percent completed and should be done in the first half of the year. Promotional materials for the plant state the plant will open sometime in spring 2012.

May: The Brown County Commission gave Northern Beef Packers more time to sell TIF bonds by issuing bonds for \$2.97 million directly to the company, which it can then resell. While the plant had sold \$3.98 million in TIF bonds as of the April 27 deadline, the company was short of the \$8.51 million it could have sold. The commission capped the total amount of TIF bonds the company could sell at \$6.95 million.

June: Northern Beef officials say construction is not complete at the plant because of lack of financing. The plant still had \$2 million left in TIF bonds to sell. Nine more liens are filed against the plant by contractors. Palmer said the company has not paid the contractors and that the best chance of them getting paid is for the plant to open. About 200 construction workers are on site working toward opening the plant by July 15, he said.

July 15: Beef plant opening delayed.

Sept. 28: Northern Beef Packers slaughters five cattle as part of a test. It was the first slaughtering at the plant. The plant was later approved to slaughter up to 500.

## 2013

February: Despite repeated warnings by city officials, Northern Beef Packers failed to install necessary wastewater monitoring equipment, resulting in a fine and administrative compliance order.

April 25: One hundred and eight workers were laid off to cut expenses. The plant is pursuing other financing, officials said at a news conference.

June: Northern Beef Packers fined \$7,315 after wastewater escaped from a breached wall at one of its treatment lagoons and flowed into Moccasin Creek.

July 19: Northern Beef Packers files for Chapter 11 bankruptcy.

## Debts mount as production slows at Northern Beef Packers

Northern Beef Packers has struggled with construction delays, lack of financing, environmental fines and now faces its latest setback: Chapter 11 bankruptcy.

The plant, which began to slaughter cattle in October, has never been able to increase its production to anywhere near its projected capacity of 1,500 cattle a day.

While beef plant officials will not comment on the number of cattle slaughtered, several workers in the plant have said that there has not been any cattle slaughtered for about three weeks.

"It's been quite awhile since they have slaughtered cattle," said Herman Schumacher, a producer who has furnished the plant with cattle.

**What happened?** Northern Beef Packers filed for Chapter 11 bankruptcy, protecting it from its creditors until it can reorganize.

**What's next?** An Aug. 8 deadline has been set for the plant to file documents with the U.S. Bankruptcy Court for the District of South Dakota. A plan for reorganization must address the resolution of unpaid bills.

Without adequate cash coming in, Northern Beef has been racking up debt. The company owes money to 277 creditors locally, nationally and in South Korea. Northern Beef filed for bankruptcy protection Friday afternoon.

## Documents: Plant owes millions

Northern Beef Packers owes money to 277 unsecured creditors, including more than \$1 million to a prime investor, according to documents filed in federal bankruptcy court.

Two new mechanics liens, both modest, have also been filed against the beef processing plant south of Aberdeen.

According to bankruptcy court documents, Northern Beef Packers has estimated assets of more than \$50 million, but less than \$100 million, and estimated liabilities of between \$10 million and \$50 million.

The largest unsecured creditor is Oshik Song, general partner, to whom \$1.04 million is owed, according to bankruptcy paperwork.

The plant also owes \$1.03 million to Hanul Law of Santa

Ana, Calif.; \$903,028 to the U.S. Treasury for payroll taxes and \$182,263 to the City of Aberdeen for utility bills, according to the court documents.

Unsecured creditors don't have any security or collateral — anything to foreclose on or repossess. So they have to, in essence, line up and hope they will eventually be paid.

According to a voluntary petition of bankruptcy filed by the plant, it "estimated" that after any exempt property is excluded and administrative expenses are paid, there will be no funds available for distribution to unsecured creditors.

The nature of the debts is "primarily business related," according to the petition.

Under federal law, when a person or business files for

■ Creditors cannot try to collect debts until a bankruptcy judge grants them permission.

■ Pending legal action is halted until the bankruptcy court allows it to proceed.

Northern Beef Packers is involved in an unresolved civil lawsuit with a Huron contractor, Scott Olson Digging, which filed a \$2.1 million mechanics lien against Northern Beef Packers. The plant has sued the contractor, claiming it overpaid and was overcharged for dirtwork at the plant site. Scott Olson Digging then countersued the beef plant.

Previously, the plant had resolved dozens of other mechanics liens that had been filed against it.

The two new mechanics liens against the beef plant are from recent months. One, for \$4,300, was filed earlier this month by Climate Makers of Hastings, Minn. It is for labor and materials related to repairing a boiler,

Chapter 11 gives a company protection from its creditors while it reorganizes, said Rory King, the attorney representing Northern Beef. A business can continue to operate, unlike under Chapter 7 bankruptcy, which involves liquidation of a company.

An Aug. 8 deadline has been set for the plant to file a statistical summary, a statement of financial affairs and other documents with the U.S. Bankruptcy Court for the District of South Dakota, according to court paperwork.

Ultimately, a plan for reorganization must address the resolution of unpaid bills. The creditors, Northern Beef and the court will all have some say in the restructuring of debt.

The plant's most recent financial difficulties came

to light April 25 when the company laid off 108 workers. Northern Beef CEO David Palmer said that the plant, south of Aberdeen, needed to raise about \$20 million in working capital to buy and process cattle.

Northern Beef was not successful in raising all the additional funding it needed. Last week, employees were told that their paychecks would be delayed because of financial difficulties.

"For the last several months, we have been working to secure a strategic equity investment to move our business into the next phase of production," Palmer said through a news release Monday.

"Due to the size and importance of this investment, the process is taking longer than what was originally expected. At the same time, the beef packing industry has been experiencing some of its worst processing margins in recent decades, causing expected start-up costs to

be much higher than anticipated. This has significantly reduced our cash position and is preventing us from meeting our current obligations."

The beef plant is working with secured lenders and interested parties to formulate a restructuring plan, Palmer said. Once approved by the court, the financing, along with cash generated from any ongoing business operations, will be used to pay operating expenses, he said.

Northern Beef officials declined to answer questions about the timeline for employee payment and production numbers when contacted by the American News. Contacted by phone Monday, Oshik Song, general partner of Northern Beef, said he preferred to let the written news release explain the situation because of his English speaking abilities. Song, a South Korean businessman who lives in Eden Prairie, Minn., is the beef plant's biggest investor.

The debts racked up by

the company affect many companies as well as the city of Aberdeen.

Northern Beef owes municipal utility bills of \$182,263, according to a list of the 20 largest unsecured creditors included in the U.S. Bankruptcy Court documents. The bills are for unpaid water and wastewater treatment, said Lynn Lander, city manager. The city will require Northern Beef to provide a surety in order for the city to continue to provide service, he said. That surety must be set up within approximately 20 days, he said.

"We need to wait and see how this works itself out," Mayor Mike Levsen said. "The word 'bankruptcy' scares people, but for businesses having difficulties, it is one option for them. Sometimes it is a step toward a good resolution. It could work out for the better or worse. We will have to see what happens."

Northern Beef Packers laid off 260 workers Wednesday, leaving only six employees to watch over the vacant plant while it goes through Chapter 11 bankruptcy.

“We were all called into a

# Laid-off beef workers angry about paychecks

Chapter 11 filing halts delayed wages; former employees rally at courthouse, beef plant

Several dozen laid-off Northern Beef Packers workers Friday demanded answers about their delinquent paychecks, but state officials said bankruptcy proceedings have halted a process that would have gotten them at least partial compensation.

Workers took their frustration around the city Friday, first at a morning labor department Rapid Response meeting, then to the Brown County Courthouse and finally back to the

beef plant in the late afternoon, where Brown County sheriff's deputies dispersed the crowd.

The news about the paycheck delays was not well received at the South Dakota Department of Labor meeting at the Ramkota Inn, where about 60 former plant employees yelled questions in both Spanish and English while state officials attempted to relay information about services that were available.

Interpreters were available to translate in Spanish and Karen, but as the meeting progressed, officials had less


