Confidential Informant T-1 advised that the Chemurgy Design Corporation was known to be at 420 Lexington Avenue on January 8, 1945. The officers of this corporation were named by informant as: Henry A. Galwynna, President; Abraham Brothman, Vice President; Arthur P. Weber, Secretary. The corporation was incorporated July 7, 1942, in Connecticut and operates as a chemical engineering and manufacturing concern producing processed chemicals and equipment, the principal products being food and synthetic rubber materials. The corporation in June, 1944, was erecting a chemical plant designed by its engineers in Connecticut.

Brothman resigned, according to informant, on August 15, 1944, at which time he organized the consulting engineering firm of A. Brothman and Associates, a partnership with offices in Room 1606, 114 East 32nd Street, New York City. The partnership consisted of the following: Abraham Brothman, age 31; Emil Z. Barish, age 29; Gerhart Kollan, age 34; Oscar J. Vago, age 47; Jules Korchien, age 40. The partnership began operations, according to this informant, on August 15, 1944, and the style of business name was taken by the partnership on August 29, 1944.

Confidential Informant T-1 stated that Brothman was a native born citizen of Russian extraction, graduated from Columbia University in 1933 with a Chemical Engineering Degree, and was employed by the Hendrick Manufacturing Company of Pennsylvania, but in July, 1942, he became Vice President of the Chemurgy Design Corporation.

The files of the Federal Bureau of Investigation reflect that Brothman was a signer of a Communist Party Nominating Petition at New York City in 1943.

SYNOPSIS:

Arthur Phineas Weber employed Kellax Corporation at Oak Ridge, Tennessee, prior to 6/21/49. During course of Atomic Energy Act-Employee investigation, Weber was found to have been an associate of Abraham Brothman, whom admitted Soviet Agents said they contacted for purpose of obtaining information for ultimate transmittal to Soviet Union. Kellax Corporation unable to locate four classified documents charged Weber's section following his termination. Harry Gold, convicted Soviet agent, said that in Fall of 1942 Brothman indicated to him that Weber had agreed to join the Communist Party. In 1943, Gold discussed with his Soviet superior the advisability of recruiting Weber into Soviet espionage. On interview, Weber denied he ever agreed to join or did join the Communist Party or that he was ever approached to or did engage in espionage activities. By advice of the Criminal Division of the Department, reports in this case were furnished to the United States Attorney, Southern District of New York, who now advises he contemplates presentation of this case to a Grand Jury on November 14, 1952.

Arthur Phineas Weber was investigated as an Atomic Energy Act-Employee based on a PSQ submitted by Weber dated 5/26/47. This investigation disclosed Weber was born March 10, 1920, at Brooklyn, New York. His parents were born in Russia. He received a BS in chemistry from the City College of New York in 1941 and has been employed since that date as a chemical engineer. He was employed at Oak Ridge, Tennessee, under a Manhattan District clearance until 1948 when he was granted clearance by the Atomic Energy Commission and employed by the Kellax Corporation at Oak Ridge, Tennessee, on classified work until June 21, 1949. Weber made frequent airplane trips to New York City during his employment at Oak Ridge with the Manhattan District and following his termination, he is alleged to have visited numerous Atomic Energy Commission installations.

Investigation in the Atomic Energy Act-Employee case disclosed Weber listed Professor Charles A. Marliss, who has been identified with Communist front organizations, as a reference. Weber was determined to be an associate of Abraham Brothman, having known Brothman as a fellow employee since 1941 or 1942 and later Weber and Brothman became officers of an engineering corporation. Abraham Brothman was convicted on November 22, 1950, in the Southern District of New York on the charge of obstruction of justice. During the course of this trial, Elizabeth Bentley and Harry Gold, admitted Soviet espionage agents, testified that they contacted Abraham Brothman for the purpose of obtaining information for ultimate transmittal to their Soviet superiors. Weber was a subject in the case captioned "Tedlee Chemical Corporation; Regal Chemical Corporation; 115 Dobbin Street Corporation; Fraud Against the Government." Investigation in this case disclosed subject corporations charged expenses to the Government consisting of consultant fees which were never actually paid. Weber admitted in a signed statement that he made false statements to the Government by billing fees of approximately \$50,000 of which he actually received less than \$19,000. This case was presented to the Grand Jury in March, 1948, and a true bill returned against the corporations and one of their officers. Weber testified concerning his participation in the fraud; however, he was not considered a defendant by the Grand Jury.

Following the termination of subject's employment by the Keller Corporation, four classified documents, which were charged out to the subject during the period of his employment on classified work of the Atomic Energy Commission, could not be located. On May 26, 1949, Weber submitted a memorandum which reflected in general that the most important of these documents dealt with a meeting of a group of technicians and had been lost en route to an office in the Keller Corporation for reproduction. Investigation disclosed that the Security Office, Keller Corporation, questioned Weber concerning the other three documents, all of which were drawings, and the subject apparently explained their loss satisfactorily.

Harry Gold, when interviewed regarding Weber, recalled that during the latter part of 1941 and throughout 1942 he had numerous telephone conversations with the subject. He stated he first met the subject in person in January of 1943 at which time the subject was accompanied by Abraham Brothman. According to Gold, subject made the statement, "Shake the hand that shook the hand," which Gold believed referred to a meeting between Gold, Brothman and Semen Semenov, Gold's Soviet espionage superior. Gold said that in the Fall of 1942,

Brothman indicated Weber had agreed to join the Communist Party. In 1943, Gold discussed with Semenov the advisability of recruiting Weber into Soviet espionage explaining it was his opinion that this could be successfully done wholly on a monetary basis. Gold believes he wrote a report for Semenov concerning Weber recommending he be recruited and used in the place of Brothman.

Weber has been interviewed by Bureau Agents on several occasions in 1950 and 1951. On August 9, 1951, subject was interviewed and denied he ever joined or agreed to join the Communist Party. He admitted that Abraham Brothman asked him to join; however, he was successful in putting off Brothman without giving refusal or agreement to join the Party. Weber denied he was ever approached to engage in espionage on behalf of the Soviets or that he ever did engage in any espionage activities. Weber denied that Brothman had ever made mention to him that Brothman had been introduced by Harry Gold or anyone else to Semen Semenov or to anyone engaged in espionage on behalf of the Soviets. Further, Weber said that Brothman had never mentioned to him that he had met anyone who was employed by or an official of the Soviet Government. Weber said Brothman never in any way mentioned that he was engaged in espionage activities. Accordingly, Weber said if he had made the statement, "Shake the hand that shook the hand," the statement in no way indicated that Brothman had mentioned to him that Brothman had been introduced to Semen Semenov. With respect to the documents charged out to the subject at the Keller Corporation, Weber was unable to recall any details concerning them other than that one of these documents was sent from his section to another for reproduction and never returned.

PROSECUTIVE ACTION:

By letter dated November 30, 1951, Mr. James M. McInerney of the Criminal Division was requested to review reports reflecting investigation of Weber. Attention was called to Weber's denial that he was ever approached to engage or did engage in espionage activities or that he ever agreed to, or did, join the Communist Party, USA. An opinion was requested as to the desirability of presenting the subject before a Federal Grand Jury convening at a future date in order that Weber's denials might be made under oath. By letter dated December 17, 1951, the Criminal Division requested that all available information developed during our investigation of the activities of Weber be made available to the United States Attorney, Southern District of New York.

This report contains a section referring to ABRAHAM BROTHMAN, one of the subjects of the SILVERMASTER case, and who has been identified as an active Soviet Agent in the United States and who is presently undergoing an active investigation in the FOCCAL. INTERNAL SECURITY - R. (u)

The above mentioned report reflects that [redacted] who is in a position to observe BROTHMAN's activities, advised SA FRANCIS D. O'BRIEN that BROTHMAN has been in close touch with BERNARD O. KOOPMAN, and that BROTHMAN held a conference on February 7, 1946 with KOOPMAN at which time they agreed to meet in KOOPMAN's room at Kings Crown Hotel, 420 West 116th Street, New York City. On February 13, 1946 at 3:30 PM, SA's LAWRENCE W. SPILLANE and EDWARD W. DOOLLEY observed BROTHMAN enter this hotel and inquire for KOOPMAN's room and take the elevator to KOOPMAN's room No. 512. [redacted] advised that KOOPMAN conferred with BROTHMAN and told him that he had broken down the differential equation problem and would meet BROTHMAN for dinner at the Faculty Club, Columbia University and show the problem to him.

It is noted that ABRAHAM BROTHMAN was convicted on November 22, 1950, in the Southern District of New York on the charge of conspiracy to obstruct justice and the obstruction of justice.

During the course of the trial of ABRAHAM BROTHMAN in the Southern District of New York, ELIZABETH BENTLEY, an admitted Soviet espionage agent, testified that she acted as a courier in receiving information from BROTHMAN and transmitting same to her Soviet espionage superior, JACOB GOLOS during 1941. Further, that during that same year she was known to BROTHMAN as "HELEN" and that during 1941 she made arrangements with BROTHMAN whereby BROTHMAN would be contacted by a new Soviet courier, whose identity was not known to Miss BENTLEY.

Further, during BROTHMAN's trial HARRY GOLD, convicted Espionage Agent, testified that in about September, 1941, he received instructions from his Soviet espionage superior, SEMEN SEMENOV, to contact an individual in New York City for purposes of obtaining information. GOLD testified that he did contact this individual, who turned out to be ABRAHAM BROTHMAN, and on the original contact he told BROTHMAN that he was sent by "HELEN". GOLD testified further that subsequently he received various information, much of which related to chemical processes, from BROTHMAN.

HARRY GOLD, presently serving a sentence at the United States Penitentiary for espionage, informed that he first met MILTON YUSEM at ABE BROTHMAN's laboratory in New York in the summer of 1945. He said he became acquainted with YUSEM as the result of two days' association in the laboratory. He said that he can recall nothing that was said during those two days which would indicate YUSEM had Communist sympathies. GOLD said he could not prove that YUSEM is a Communist, but he is convinced that he is one.

GOLD said that YUSEM apparently did not please ABE BROTHMAN. He gathered this from BROTHMAN's conversations. One GUS WALLEY, whom GOLD described as a "Browderite", was in charge of the laboratory and he apparently liked YUSEM. It was through his influence that YUSEM was permitted to remain, but his influence apparently waned and BROTHMAN fired him.

After YUSEM was fired, BROTHMAN was called before the Federation of Architects, Engineers, Chemists and Technicians for a hearing. For some reason or other, the matter was taken up by a Communist Party Disciplinary Committee. GOLD said that he does not know who the members of this committee were and he does not know what transpired, although his understanding is that BROTHMAN was required to pay some back salary. GOLD said, however, that it

is his impression that the Committee considers matters only when the parties involved are all Communists.

GOLD informed that on one occasion, the circumstances of which he cannot recall, either ABE BROTHMAN or MIRIAM MOSKOWITZ, both Communists according to GOLD, told him that YUSEM was a Communist. He could not elaborate on this.

GOLD emphasized the fact that the information he had given was all hearsay; that he knew the truth of none of it from his own knowledge. He repeated that his personal association with YUSEM was for only two days and he noted nothing that occurred during that period which would indicate Communist sympathies or any other un-American feelings or activities.

GOLD said that he would be willing to appear before a hearing board and he has no objection to having his name furnished to another Government agency. He declined to furnish a signed statement.

The above information relating to the personal and employment history of BIRGFELD was found contained in personnel files relating to the employee at the Department of Commerce and the Department of State.

II. BASIS FOR INVESTIGATION

With regard to WASSERMAN, it is noted that she is a native of Hamburg, Germany who entered the United States in 1939. Significant activities on her part first came to the attention of the Federal Bureau of Investigation through her association with one JULES KORCHIEN. KORCHIEN is a business partner of one ABRAHAM BROTHMAN, who, in 1945, was reported by Washington T-2 as having furnished copies of blueprints to a Soviet espionage agent in New York City, who was known to Washington T-2. At that time, according to the informant, BROTHMAN was employed as an engineer by the Republic Steel Company. Investigation of KORCHIEN, BROTHMAN and WASSERMAN subsequently revealed that all three were in contact with various other individuals, many of whom have been identified by Washington T-2 as principals in a Soviet espionage conspiracy centering in New York City and Washington, D. C. during the late 1930's and early 1940's. Washington T-2 is a former member of the Communist Party, of established reliability, who has furnished considerable information to the FBI. The informant refused to execute a signed statement and will not testify before a loyalty board.

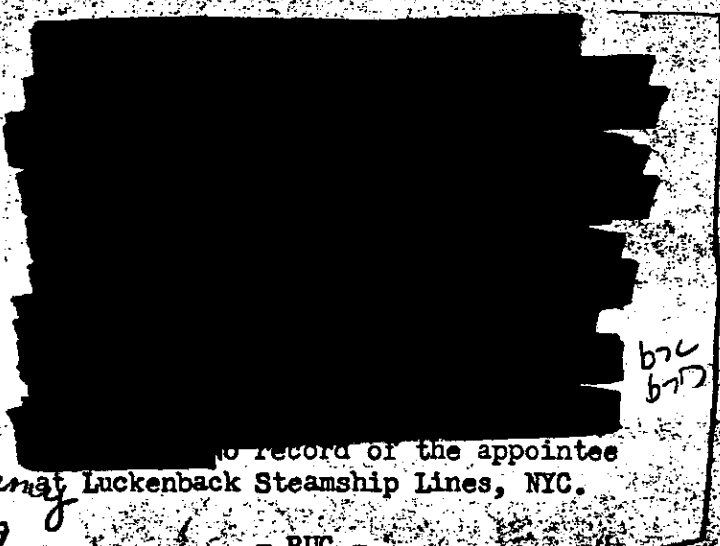

The report of SA EDWARD W. DOOLEY dated March 1, 1946, at New York, in the case entitled "NATHAN GREGORY SILVERMASTER, was., et al; ESPIONAGE - R", [REDACTED] advised on February 7, 1946 that ABRAHAM BROTHMAN held a conference with BERNARD O. KOOPMAN, Associate Professor of Mathematics, Columbia University, at which time they agreed to meet in KOOPMAN'S room in the King's Crown Hotel, 420 West 116th Street, New York City, at 3:30 P.M. on February 13, 1946. (NY file 65-14603 - 1058) b2

On February 18, 1946, in the above mentioned report, [REDACTED] advised that Professor KOOPMAN held a conference with ABE BROTHMAN, and during the conference told BROTHMAN that he had broken down the differential equation problem and that he would meet BROTHMAN for dinner at the Faculty Club, Columbia University, and show the problem to him. b2

In a teletype dated February 27, 1950, in the FOOCASE - ESPIONAGE - R, New York advised the Bureau, Boston, Cincinnati and Atlanta of the results of an interview with ARTHUR P. WEBER, a former business associate of BROTHMAN. WEBER stated to Agents that among acquaintances of BROTHMAN was one BERNARD KOOPMAN, a mathematician at Columbia University. WEBER stated that BROTHMAN'S association with KOOPMAN was for assistance on a mathematical formula.

By teletype dated June 13, 1950 from Philadelphia to the Bureau and New York, in the case entitled, "ABRAHAM BROTHMAN, ESPIONAGE - R",

Philadelphia advised that in the interview with HARRY GOLD concerning ABRAHAM BROTHMAN and his associates, GOLD described Professor BERNARD KOOPMAN, a friend of BROTHMAN, as definitely not a Communist and stated that if KOOPMAN was a liberal, he was only liberal to a very slight extent. GOLD said that the relationship between BROTHMAN and KOOPMAN was one wherein BROTHMAN basked in the reflected glory of KOOPMAN. GOLD said that KOOPMAN was one of the few individuals whom BROTHMAN definitely idolized for his mathematical ability.

The files of the New York Office also reflect that Professor KOOPMAN was investigated by this office under the Atomic Energy program. In this connection the report of SA FRANKLIN L. JOHNSON dated May 31, 1950, at New York, in the case entitled, "BERNARD OSGOOD KOOPMAN -WA-15907, AEAA" contains no information of a subversive or disloyal nature concerning KOOPMAN. o/s

On the basis of the information furnished by HARRY GOLD and that which is contained in above mentioned AEAA file, the New York Office felt that it was not unadvisable to interview Professor KOOPMAN.

Washington T-1, of known reliability, advised that IRVING ROTH, while overseas with the United States Army, corresponded with WILLIAM LUDWIG ULLMAN.

KLEPPER, WASSERMAN, KEENEY, and ULLMAN have been the subjects of investigation by the FBI, and information concerning them is being hereinafter set forth.

RESULTS OF INVESTIGATION

Upon re-contact, Washington T-1 could furnish no additional pertinent information. This informant declined to furnish a signed statement and will not testify before a loyalty hearing board.

SIDNEY LESTER KLEPPER, who shared an apartment with ROTH at 1726 North Quinn Street, Arlington, Virginia in 1946-1948, was investigated in 1948 by the FBI under the provisions of Executive Order 9835. By letter dated 3/4/50, The Loyalty Review Board advised that KLEPPER had "resigned or otherwise separated from Federal Service".

Washington T-2, of known reliability, advised that URSULA WASSERMAN has been a close associate of MARY JANE KEENEY and ABRAHAM BROTHMAN. Washington T-2 declined to furnish a signed statement and will not testify before a loyalty hearing board.

Washington T-3, of known reliability, [REDACTED]

Washington T-4, a former member of the Communist Party, of established reliability, who has furnished considerable information to the FBI, advised that WILLIAM LUDWIG ULLMAN was engaged in Soviet espionage conspiracy in Washington, D. C. and New York City in early 1940, that he was a dues-paying member of the Communist Party, and he was a contact of an admitted espionage agent.

Washington T-4 also advised that ABRAHAM BROTHMAN was involved in a Soviet espionage conspiracy in New York City, and was a contact of the admitted espionage agents.

Washington T-4 declined to furnish a signed statement and will not testify before a loyalty hearing board.

An investigation of RITA CLAIRE HELLER, former wife of the employee, was conducted by the FBI in 1948 under the provisions of Executive Order 9835.

The personnel files of the employee at the Civil Aeronautics Board and Securities and Exchange Commission, Washington, D. C., reflected no pertinent information regarding his loyalty.

Washington T-3, T-5, and T-6, of known reliability.

Accounting and Rates Division, Civil Aeronautics Board, Washington, D. C., advised [redacted] IRVING ROTH from 1946 to date. He did not know the employee prior to 1946. He has no knowledge of any associates of ROTH which would cast any reflection on the matter of his loyalty and during the time that he has known the employee, he has never had any occasion to question his loyalty to this country. It is his opinion that ROTH is entirely loyal to the United States.

[redacted], Accounting and Reports Section, Accounting and Rates Division, Civil Aeronautics Board, Washington, D. C., advised that the employee [redacted] period in 1946 and 1947, and that he has known the employee [redacted], when he came to work for the Civil Aeronautics Board. He pointed out that the employee is now Chief of the Domestic Rates Section, Accounting and Rates Division, and that he sees the employee practically every day. Based on his long acquaintance with the employee, it is his opinion that the employee is loyal to this country. He said that in conversations he has had with the employee, he has never given any indication of having any Communist or un-American sympathy of any kind. He knew of no organizations of which the employee was a member.

It may be noted that in his Loyalty Form dated June 4, 1952, the applicant indicated employment at 17 John Street, New York, New York, from July, 1945 to October, 1946 with the firm of SUTNAR, FLINT and HALL.

Upon recontact during the course of this investigation, Confidential Informant New York City T-6 advised that he is not acquainted with the applicant and does not possess any additional information concerning him. T-6 further advised that he does not know the significance of the aforementioned notation which appeared in the address book of ABRAHAM BROTHMAN.

Concerning ABRAHAM BROTHMAN, it may be noted that the records of the United States District Court, Southern District of New York, reflect that he was tried before IRVING R. KAUFMAN, United States District Judge, in November, 1950, charged with two counts; namely, obstructing justice, in that he, with one MIRIAM MOSKOWITZ and HARRY GOLD, agreed on fictitious explanations of their associations with each other and divers other persons, and count two, that he, BROTHMAN, wilfully caused HARRY GOLD to give false testimony before a Federal Grand Jury on July 31, 1947.

On November 28, 1950 ABRAHAM BROTHMAN was sentenced to two years imprisonment and \$10,000 on count one, and five years imprisonment and \$5,000 on count two, which sentences were to run consecutively.

During the course of this trial, ELIZABETH BENTLEY, an admitted former Soviet espionage agent, testified that she acted as a courier in receiving information from BROTHMAN and transmitting same to her Soviet espionage superior, JACOB GOLES during 1941. Further, that during the same year she was known to BROTHMAN as "HELEN" and that during 1941 she made arrangements with BROTHMAN whereby he would be contacted by a new Soviet courier whose identity was not known to Miss BENTLEY. Miss BENTLEY also testified that during the period from 1940 to 1941 she collected ABRAHAM BROTHMAN's Communist Party dues.

Further, she stated that during BROTHMAN'S trial, HARRY GOLD, a convicted Soviet espionage agent, testified that in or about September, 1941 he received

instructions from his Soviet espionage superior, SEMEN SEMENOV, to contact an individual in New York City for the purpose of obtaining information. GOLD testified that he contacted this individual who turned out to be ABRAHAM BROTHMAN and that on the original contact he informed BROTHMAN that he was sent by HELEN. GOLD also testified that he subsequently received various information, much of which related to chemical processes, from BROTHMAN.

Immigration and Naturalization Service

The records of the Immigration and Naturalization Service reflect under petition #569236 that LADISLAV SUTNAR entered the United States for permanent residence at Rouse's Point, New York, from Montreal, Canada, on December 22, 1941 and that he filed Declaration of Intention on May 5, 1942 in the Southern District of New York, and was granted naturalization certificate #6870687 on December 13, 1948. In his petition for naturalization the applicant indicated that he was employed as an artist designer; that he was born on November 9, 1897 at Pilsen, Czechoslovakia and that he was married on July 3, 1923 to FRANTISKA SUTNAR. According to these files, the applicant's wife, FRANTISKA, born on March 19, 1897, entered the United States by plane on June 14, 1946.

These files further reflect that the applicant in a General Information Form listed BRACKETT LEWIS, American Friends of Czechoslovakia, 8 West 40 Street, New York, New York, as a "close friend in the United States".

The Guide to Subversive Organizations and Publications, prepared and released by the Committee on Un-American Activities, United States House of Representatives, Washington, D. C., dated May 14, 1951, reflects the following concerning the American Friends of Czechoslovakia:

1. 'This front organization became active in June of 1944. Its headquarters is located at 8 West Fortieth Street in New York City, and the organization is under the leadership of William J. Schieffelin.'
(California Committee on Un-American Activities, Report, 1948, p. 145.)"

The informant recalled that NAOMI METT "never was friendly with anyone who wasn't Communistically inclined or brought anyone to this bank who wasn't Communistically inclined."

In conclusion the informant advised that the employee, during her period of employment with this concern, had been a competent worker who was always pleasant and cordial. The informant stated she knew of nothing of a derogatory nature concerning the employee's character, reputation or associates and that she would not be willing to execute a signed statement or appear before a Security Hearing Board in this matter.

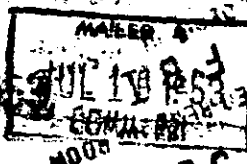

Concerning ABRAHAM BROTHMAN, he was convicted on November 22, 1950 in the Southern District of New York on a charge of conspiracy to obstruct and the obstruction of justice. During the course of the trial of ABRAHAM BROTHMAN in the Southern District of New York, ELIZABETH BENTLEY, an admitted Soviet Espionage agent, testified that she acted as a courier in receiving information from BROTHMAN and transferring same to her Soviet Espionage superior, JACOB GOLOS during 1941. She further stated that during that same year she was known to BROTHMAN as "HELEN", and during 1941 she made arrangements with BROTHMAN whereby BROTHMAN would be contacted by a new Soviet courier, whose identity was not known to Miss BENTLEY.

During BROTHMAN'S trial HARRY GOLD, a convicted Espionage agent, testified that in about September 1941 he received instructions from his Soviet Espionage superior, SEMEN SEMENOV, to contact an individual in New York City for the purpose of obtaining information. GOLD testified that

he did contact this individual who turned out to be ABRAHAM BROTHMAN, and on the original contact he told BROTHMAN that he was sent by "HELEN." GOLD testified further that subsequently he received various information much of which related to chemical processes from BROTHMAN.

[REDACTED] advised that in conversations with Mr. EGLOFF during official hours there has been nothing expressed by EGLOFF which could be considered as disloyal to the United States. On the other hand [REDACTED] advised he is quite sure that Mr. EGLOFF is loyal to the United States. [REDACTED] advised that the only remark that he has heard Mr. EGLOFF make which is more or less pertinent to his loyalty to the United States is the remark to the effect made by Mr. EGLOFF that he was quite pleased with the opportunity presented everyone in this country to vote for the man of his choice.

Investigation in the case entitled, "MARY LOSEY, WAS., INTERNAL SECURITY - R" has reflected that JOHN FERNO, JORIS IVENS and MARY LOSEY, were associated in the enterprise known as DOCUMENTARY FILM PRODUCERS INCORPORATED. Mrs. POLLY KORCHIEN FERNO is the subject's sister and the subject is a friend of JORIS IVENS and occupied his apartment when IVENS went to the West Coast. (u)

It is also worthy of note that Confidential Informant [REDACTED]

Reference is made to the letter from New York to the Bureau dated July 31, 1946, in which mention was made of the subject's contact with RICHARD M. BARR, an employee of the State Department. [REDACTED] the subject's contact with BARR apparently referred to some architectural work that KORCHIEN is doing for BARR. b1 (c)

On July 28, 1946, a highly confidential informant, having access to the premises of A. BROTHMAN ASSOCIATES, 114 East 32nd Street, New York City, advised that the subject's address book contained the name of VAN DYCKE, 224 West 57th Street, New York City, telephone number Circle 6-4400, Extension 185-153. As noted in the referenced letter, this telephone number is listed to the Office of International Information and Cultural Affairs, State Department, 224 West 57th Street, New York City.

Telephonic inquiry at this office under suitable pretext reflected that OMAN VAN DYCK was at one time employed at that office but is not presently employed. OMAN LAWRENCE VAN DYCK was the subject of a Bureau investigation in 1942 entitled, "OMAN LAWRENCE VAN DYCK, Office of Coordinator of Information, Employee Investigation." It is possible that VAN DYCKE mentioned in the subject's address book may be identical with WILLARD VAN DYCK. b2 b7D

VAN DYCKE was employed until September 21, 1944 as a script writer and labor representative by the Office of War Information, which it is noted formerly had offices at 224 West 57th Street, New York City. It is further noted that TOM VAN DYCKE on June 6, 1944 furnished New York telephone number Circle 6-4400, Extension 184, as the number where he could be reached.

URSULA WASSERMAN contacted MARIA at Governor PINERO's suite at the Hotel New Yorker and made a date to see her on that date. The Informant advised that URSULA and MARIA seem to be quite friendly and addressed each other by their given names. URSULA also inquired if JESUS would be in. It is noted that she was unquestionably referring to JESUS PINERO, who was recently appointed Governor of Puerto Rico.

[REDACTED] JULES KORCHIEN conferred (a) b1 with URSULA WASSERMAN and read part of a letter from an unknown individual who may be identical with the subject's sister, POLLY KORCHIEN, who is in Puerto Rico. The letter stated in part, "You can imagine how happy we are with the confirmation of the appointment of JESUS PINERO for the Governorship." The letter went on to say that now their program can move along. It was further stated that a Mr. MOSCOSO (phonetic), who was apparently unknown to either KORCHIEN or WASSERMAN, was sending something to ABE BROTHMAN (KORCHIEN's business associate and a subject in the Gregory case). KORCHIEN then mentioned that he was going to Washington the next afternoon, at which time he would see "him."

o/s [REDACTED] KORCHIEN told URSULA (a) b1 WASSERMAN that his trip to Washington had been a disappointment because he had not seen JESUS. It is believed that JESUS is probably identical with JESUS PINERO and with the person KORCHIEN was going to see in Washington and who he referred to as "him."

Brothman and Associates, Consulting Engineers consisting of five partners, three of whom are known Communists.

Jules Korchein is the son of Russian-born parents who came to the United States from Russia in 1899. The father subsequently became a citizen and resides in Rochester, New York. He was married on March 8, 1932 to Lillian Levitch and two children were born of this marriage. However, he has since separated from his wife. Jules Korchein is a graduate of Cornell University.

You may perhaps recall that, according to Informant Gregory, in approximately May of 1940, Jacob Golos, the Russian Agent, introduced Gregory to Abe Brothman, who was employed in the Republic Steel Company, New York City as an engineer. After Gregory met Brothman he indicated that he had some blue prints to be copied and the copies delivered to Golos. Gregory met Brothman approximately ten times until sometime in the Fall of 1940. Sometimes Golos would meet Brothman to obtain these blue prints direct but whenever these appointments could not be handled personally, Gregory would execute them.

CURRENT ACTIVITIES IN GREGORY CASE

9/5 Jules Korchheim is the paramour of Ursula Wasserman, a suspected Communist and Soviet espionage agent who is presently in South America and since her departure from the United States, Korchheim has been living in her apartment at 110 Christopher Street, New York City.

On May 23, 1947, KORCHIEN contacted FRANCES McCLERNAN, mentioned in previous reports as a close associate of URSULA WASSERMAN, the alleged paramour of MAURICE HINDUS, well known writer and former correspondent of "New York Herald Tribune". McCLERNAN told KORCHIEN that she saw "FRANK E. FRANK" (ph.) last night and stated that FRANK was a correspondent for "Business Week" magazine and that he was leaving for Prague. McCLERNAN suggested that KORCHIEN endeavor to reach FRANK before he leaves, and she thought he would make a good contact man in selling the plastic process developed by ABE (probably ABE BROTHMAN) in Central Europe. On the same day, KORCHIEN contacted the McGraw-Hill Publishing Company. The Company stated that FRANK is no longer working for them and would not be doing anything for them in Prague and that he usually stayed at the Holland Hotel, New York City. The informant advised that KORCHIEN contacted the Holland Hotel with negative results.

On the same day, BROTHMAN contacted KORCHIEN, and they discussed the possibility of using FRANK E. FRANK as a contact in Prague, Czechoslovakia.

On May 26th, KORCHIEN was in contact with a Mr. HOLMES, advising him that JOHN FERNO, KORCHIEN's brother-in-law, was showing a preview of some of his films at the Preview Theatre, 600 Broadway, New York City. KORCHIEN then indicated that he may go to Columbus, Ohio, for a week or so in June, providing the General Homes Corporation starts production of his aluminum house.

On May 27th, KORCHIEN was in contact with BELLA DODD and advised her that he had looked over the building for necessary repairs and that it would cost approximately \$10,000. From the conversation, it appeared that the building in question would be used for a school.

On May 27, 1947, an unknown man contacted KORCHIEN's office. The informant ascertained that the person in charge of KORCHIEN's office is a negro draftsman and that he gave his name and address to this unknown man as JACK HILL, 108 East 97th Street, New York City.

On May 28th, KORCHIEN was in contact with one LEON STRAUSS (ph.) and advised STRAUSS that he had spoken to LEON JOSEPHSON regarding the housing matter.

On May 29th, KORCHIEN was in contact with BROTHMAN's office and was advised by MIRIAM MOSKOWITZ, BROTHMAN's secretary, that ABE was still busy with two government men. KORCHIEN stated to MOSKOWITZ that he had lunch with ED SMITH, who was now in the export-import business. It is to be noted that perhaps this ED SMITH is identical with the former Director of the National Council of Soviet American Friendship.
