five copies of the report of SA THOMAS H. ZOELLER, dated
10/9/50, at New York.

"In connection with pages 11 - 21 of this report
in which the letters, notes and shorthand notes left by
MIRIAM MOSKOWITZ at the Women's House of Detention are
set forth, the following observations are made:

"In item 1, the initials 'R' and 'B' may refer
to HERSH RABINOWITZ and ABRAHAM BROTHMAN.

"In item 9 '...meeting of 6/1/7' probably should
be meeting of 6/1/8 and refers to meeting of BROTHMAN'S
employees that took place on June 1, 1948 while BROTHMAN
and MOSKOWITZ were in Europe. It was at this meeting
that GOLD, VAGO, LEVINE, etc. decided BROTHMAN was mis-
representing himself and his contracts to them.

"In connection with the material written by
MOSKOWITZ that is set forth on pages 13 and 14, it is
believed that these are phrases, thoughts, and expressions
she has heard fellow inmates express at the House of
Detention. It is felt that she was making a record of
this material for use in the future writing of a book.

"This is born out by MOSKOWITZ in her letters to her sister, CLARE, and to ABE BROTHMAN, which are also set out. In these letters she mentions that 'I walk around with pencil and paper as constant companions' and '...what material for writing later is now within my grasp!' Also in connection with the material on pages 13 and 14, it is noted that the following sentence appears 'When you write that book you be sure and write about the food.'"

"Among the effects found in the residence of THOMAS L. BLACK, 1929 N. 6th Street, Philadelphia, Pa. by Special Agent ELWOOD A. PETT on June 15, 1950, was a letter on the stationery of Abraham Brothman Associates dated July 7, 1948. This letter was addressed to J. A. MULLEN, President, Spruce Chemical Company, 3357 Miller Street, Philadelphia 34, Pennsylvania. This letter stated among other things 'HARRY GOLD was in our employ for two years during which time we found him to be a diligent and hard worker.' The letter was signed 'A. Brothman And Associates'.

"This letter was exhibited to BLACK on July 12, 1950, and he advised that HARRY GOLD was interested in knowing whether he would get a favorable recommendation from ABRAHAM BROTHMAN if he used BROTHMAN'S name as a reference. This question was in GOLD'S mind because GOLD and BROTHMAN had quarreled over finances and GOLD took this opportunity to find out what BROTHMAN would say about him. GOLD requested BLACK to write the letter to BROTHMAN, and BLACK did so using the name of JOSEPH MULLEN, President of the Spruce Chemical Company. GOLD was satisfied with BROTHMAN'S reply.

"C. ABRAHAM BROTHMAN

"On June 26, 1950, BLACK said he had first heard of ABRAHAM BROTHMAN, although not by name, from HARRY GOLD, probably around 1942. From time to time HARRY GOLD had mentioned to BLACK having a very important contact who was furnishing information for transmission to the Soviets and had asked to use BLACK'S apartment

was a place to take down this information. BLACK had refused to allow this. When HARRY GOLD expected that his induction into the Armed Forces was imminent, he told BLACK that he was making contact with a person of technical background and asked BLACK if he would take over the contact in the event GOLD were drafted. GOLD said the man had given him valuable information on mixing equipment and on continuous processes, both fields in which BLACK learned later ABRAHAM BROTHMAN specialized.

"Sometime in the Fall of 1944, GOLD appeared at BLACK'S Newark apartment and invited him to go over to Brooklyn and meet a Chemical Engineer with whom GOLD at that time was working on a process for manufacturing Plexiglass. At this time GOLD, in his contacts with BROTHMAN, was using the name FRANK KESSLER, and BLACK was introduced to BROTHMAN as TOM WRIGHT. The first visit was described by BLACK as being social in nature. After HARRY GOLD went to work for BROTHMAN and was known to BROTHMAN by his true name, BLACK made a trip to BROTHMAN'S laboratory with a sample of Plexiglass which he picked up for HARRY GOLD at Rohm and Haas in Bristol, Pa.

"At one time BROTHMAN offered BLACK a job supervising the operation of a penicillin production plant in Russia which BROTHMAN was designing. It was BROTHMAN'S proposition that an American technician familiar with the processes would need to spend six months to a year in Russia getting the production under way. BLACK did not accept the offer as he was at that time unwilling to go to RUSSIA. It was BLACK'S recollection during the period of these contacts, that HARRY GOLD told him that BROTHMAN was the valuable contact about whom he had spoken some time before, and whom he had asked BLACK to take over in the event of his induction. BLACK said there was no doubt in his mind of ABRAHAM BROTHMAN'S Communist sympathies because the first time he met BROTHMAN he had a copy of 'The Daily Worker' in his car and his conversation on political matters faithfully followed the Communist Party line.

"According to BLACK, all his contacts with BROTHMAN were made through HARRY GOLD and whatever information he has re-

"garding BROTHMAN'S possible Soviet connections he got from HARRY GOLD."

"The records of the Chicago Office contained no information pertaining to the officers of the Leonard Construction Company or to CLIFFORD M. LEONARD or the Biltmore Country Club.

"The Leonard Construction Company was one of the subjects in a Fraud Against the Government investigation in 1943 of which the Los Angeles Office was office of origin, Bureau file 46-2879. The allegations against the Leonard Construction Company were to the effect that in connection with certain contracts in the Panama Canal Zone this construction company, which had its headquarters in Chicago, Illinois, had been paid twice in certain instances by the United States Government or its representatives. The disposition of this case is not included in the information available to the Chicago Office.

"The records of the Chicago Office contained no

NY Rpt., 12/9/50 reads in part, as follows:

"The title of this case is being marked changed to reflect the true name of the subject as FILIPP TIKHONOVICH SARYTCHEV, inasmuch as HARRY GOLD identified him as the individual who contacted him on several occasions in 1949, as will be hereinafter set forth..

"On November 1, 1950, HARRY GOLD, admitted Soviet espionage agent, furnished the following signed statement:

"New York, New York
November 1, 1950

"I, HARRY GOLD, made the following voluntary statement to Special Agents Joseph C. Walsh and John J. O'Brien, each of whom has identified himself to me as a Special Agent of the Federal Bureau of Investigation. I know that I do not have to make any statement and that anything I say may be used against me in a court of law. I also know that I am entitled to benefit of counsel.

"On October 27, 1950, I was shown a picture of an individual whose name is FILIPP TIKHONOVICH SARYTCHEV. I had seen this picture on several occasions in July and August, 1950.

"After carefully considering this photograph, I am now completely certain that this is a photograph of the individual that first contacted me at my residence 6823 Kindred Street, Philadelphia, Pennsylvania, on a Saturday evening approximately September 24, 1949.

"....

"Sometime during this first conversation I had with SARYTCHEV I brought up the fact that A. BROTHMAN (who is a member of the firm of A. Brothman and Associates, Engineers, New York City) had related to me in early August, 1946, about having seen an article in a New York Sunday 'Herald Tribune' dated about that time concerning Dr. FUCHS. This article purportedly stated that FUCHS was being detained in Great Britain on suspicion of espionage. SARYTCHEV did not seem perturbed over this information and made no explanatory comments regarding it.

"SARYTCHEV then told me at this first meeting that he would next see me at a time that as near as I can recall was October 5, or 6, 1949."....

"On about October 5 or 6, 1949, when I finished my work at the Philadelphia General Hospital I took the train from Philadelphia to New York and then took the Queens - IND subway to get to my meeting place with SARYTCHEV outside the theater at the 74th Street stop of the Queens - IND subway. After I reached the appointed place at about 9 p.m. I stood in front of the theater for a short period of time. Suddenly I saw him standing in a doorway and I approached him. He quickly told me to go back down the street one block, then turn to the left and go in that direction an additional two blocks at which point I was to turn to the left again and walk one block where he would join me. It was obvious to me from this that SARYTCHEV was very cautious in making this meeting. Due to the inclement weather there were few people about and it did not appear that he had anything to worry about in the way of curious bystanders.

"I did as directed in this matter and found SARYTCHEV waiting for me on the street corner. He immediately launched into a discussion of my testimony before the Federal Grand Jury in New York City in 1947. He said that he wanted full details

"about this at which time I explained how I had testified . In this connection I received the impression that SARYTCHEV was already acquainted with the general facts of my testimony. I do recall him asking how I could explain my use of the name FRANK KESSLER in dealing with BROTHMAN, who I previously mentioned. I told SARYTCHEV that in discussing the possibility of any such question by the investigating authorities that I would say to them that I had used the name of KESSLER merely to avoid my employers at the Pennsylvania Sugar Company finding out that I was holding two jobs. At this time I also gave to SARYTCHEV the names of FRANK O'BRIEN and Agent SHANNON as being the FBI Agents who questioned me and in addition I furnished him the names of THOMAS DONEGAN and T. VINCENT QUINN as the Prosecutors who questioned me in front of the Grand Jury in New York City. During this second meeting SARYTCHEV asked me whether or not I had ever been questioned since 1947, whether or not any of my friends in Philadelphia had been questioned about me since then, and whether or not I thought that I was being followed at any time. I explained to SARYTCHEV that I believed that I was in the clear because I had not been questioned in over two years. During the conversation SARYTCHEV asked me whether I had obtained any hint from the Grand Jury that they knew I was involved beyond that with BROTHMAN.

"I replied to the effect that I thought the matter to be over and done with; and that it seemed to me that I had succeeded in creating the picture of a small, timid, frightened man, who by some set of circumstances had gotten involved in the fringe of industrial espionage -- all this some years back. I recall that after I had given this answer SARYTCHEV shook his head and smiled giving me the impression that I was wrong in my opinion of the Grand Jury's naiveness. He then stated that in any case I should just 'sit tight' until our next meeting by which time he would have thought this matter over."

NY Rpt., 2/21/49, re JAY DAVID WHITTAKER CHAMBERS, was.; ALGER HISS; ET AL, reads in part, as follows:

"Re: ELIZABETH ROSSMAN
aka Mrs. Edward Everett

"As set out in a letter dated February 2, 1949 from the Washington Field Office to the Bureau, it was reported that [REDACTED]

[REDACTED] that ROSSMAN had joined the Communist Party sometime prior to 1935 in New York and that subsequently ROSSMAN was sent to a Communist Party training school in Long Island, New York in about 1935 or 1936. b7d

"The Informant continued that the Communist Party thereafter obtained a position for ROSSMAN in the Resettlement Administration in Washington, D. C., and also in the Federal Housing Administration, Washington, D. C.

"According to the Informant, ROSSMAN remained active in the Communist Party in the District of Columbia until 1941 when she married EDWARD EVERETT who was an anti-Communist. After this marriage, ROSSMAN turned bitterly against the Communist Party and discontinued her activities.

"The Informant further stated that ROSSMAN had been in the underground group of the Communist Party and that her Party activity was maintained through a contact. It was also recalled that ROSSMAN, [REDACTED]

[REDACTED] was bored with her inactivity and had gone to MARTIN CHANCEY, who at that time was the Communist Party Secretary in Washington, D. C. and asked him for additional Party work. b7d

"Mrs. EDWARD EVERETT, nee ELIZABETH ROSSMAN, Garth Apartments, Garth Road, Scarsdale, New York, advised SA'S DONALD E. SHANNON and ROBERT F. X. O'KEEFE on February 2, 1949

....

"....

"The nature and purpose of the interview was explained to Mrs. EVERETT in general terms and at one point her attention was directed to published reports which noted the existence of a Communist apparatus and underground activity in Washington, D. C. during the years of her residence in that city. Mrs. EVERETT denied that she had ever been a member of the Communist Party in New York City or Washington, D. C. She further stated that she did not know any members of the Communist Party as such. She has surmised, however, from the activities of a number of her friends and co-workers that they might have been members of the Communist Party. She stated that she was a close friend of JULES KORCHIEN. She believed that he might have been a Communist Party member although she had no evidence of this fact....

"....

"Mrs. EVERETT stated that at no time was she engaged in the open activities of the Communist Party nor was she ever engaged in the underground activity of the Communist Party. She was particularly questioned, in view of her apparently cooperative attitude, as to whether she had ever operated either knowingly or possibly unknowingly through a contact on behalf of the Communist Party in Washington, D. C. She stated, however, that she had never done so. She further denied knowing or having had contact with an individual named MARTIN CHANCEY or of ever having approached him for the purpose of engaging in Communist Party activity.

"....

"Mrs. EVERETT further denied that she had ever attended any Communist Party Training School in New York as previously alleged by Washington Confidential Informant [REDACTED]. Concerning JULES KORCHIEN, it is to be noted that he was the paramour in 1946 of URSULA IRENE WASSERMAN, and resided at 110 Christopher Street, New York City. KORCHIEN has been active in Communist matters and was a partner of ABRAHAM BROTHMAN, who reportedly furnished industrial blue prints to JACOB GOLOS, a

Soviet Agent. Mrs. EVERETT denied that she ever knew of
URSULA IRENE WASSERMAN or of the nature of the relationship
which existed between WASSERMAN and JULES KORCHIEN. She fur-
ther stated that she knew of no activities carried on by
KORCHIEN of a nature detrimental to the United States.

She said the money to set up this laboratory was borrowed in the firm's name from BERNARD PIDTO who was a salesman for the Malone Bronze Powder Works, Inc. of New York City, and who had a business in Brooklyn called the Processed Chemicals Company. PIDTO, according to MOSKOWITZ, first put up \$16,000.00 but later put up additional amounts until he had furnished a total of \$25,000.00.

"Confidential Informant T-6, of known reliability, advised that on January 23, 1950 Ulster Chemicals, Inc., a corporation controlled by ABRAHAM BROTHMAN, entered into an agreement with the Processed Chemical and Coatings

"Corporation, Inc., 33 North First Street, Brooklyn, New York, of which MORRIS KUSHEN was secretary, and under which Processed Chemical and Coatings Corporation, Inc. became exclusive sales agent for a certain chemical product known as thioglycolic acid manufactured by Ulster.

"ABRAHAM BROTHMAN has been identified as being a Soviet espionage agent in the early nineteen forties by HARRY GOLD and ELIZABETH T. BENTLEY, both admitted former Soviet espionage agents.

"BROTHMAN and MIRIAM MOSKOWITZ were convicted of Obstruction of Justice in the United States District Court, Southern District of New York, in 1950."



"This is a joint report of SA LESTER G. DAVIS and the
writer.

"GERHARD NORVAL WOLLAN was interviewed at Dahlonega,
Georgia, where he is presently employed as an Associate Professor
in the Mathematics Department, North Georgia College, at which time
he furnished the following information:

"WOLLAN advised that he was a partner in A. BROTHMAN
& ASSOCIATES, a partnership of consulting chemical engineers, New
York City, from August 1944 to August 1946. When questioned as to
whether he knew an individual by the name of FRANK KEPPLER, WOLLAN
stated that an individual by this name was connected with A. BROTHMAN
& ASSOCIATES, and came to the firm after relations between BROTHMAN
and WOLLAN were strained. WOLLAN believed this was about the spring
of 1946. He recalled that KEPPLER was BROTHMAN'S right hand man
and replaced WOLLAN to a large extent in the A. BROTHMAN & ASSOCIATES
Laboratory. KEPPLER became the General Over-all Supervisor in the
Laboratory. WOLLAN had not known KEPPLER who came from Philadelphia,
Pennsylvania, and commuted from that city while employed by A. BROTHMAN
& ASSOCIATES. WOLLAN knew very little concerning KEPPLER'S back-
ground, but believes KEPPLER'S family was in Philadelphia. He was
a chemist or chemical engineer and was employed in this connection.

"Upon being shown a photograph of HARRY GOLD, which was
exhibited to him in such a manner that the name appearing on the
photograph could not be seen, WOLLAN readily identified GOLD as the
person he knew as FRANK KEPPLER.

"Later during the interview, WOLLAN was asked if he knew
an individual by the name of HARRY GOLD, to which he quickly
replied that he did and that it was GOLD'S photograph he had
previously identified during the course of the interview, referring,
of course, to the photograph he had identified as being FRANK KEPPLER.
Then WOLLAN became slightly frustrated when he apparently realized
that the name of GOLD had not previously been mentioned during the

"course of the interview. He then stated that FRANK KEPPLER and HARRY GOLD were the same, recalling that GOLD used both names while employed by A. BROTHMAN & ASSOCIATES. At this point of the interview, WOLLAN did not explain why GOLD used two names. WOLLAN believed that GOLD was married to a second wife by whom he had two small children.

"GOLD, according to WOLLAN, was a chemist with some apparent chemical engineering experience but was not a physicist.

"When first employed, GOLD worked only a day or two at a time commuting from Philadelphia, inasmuch as he apparently had other employment. GOLD first worked in the offices of A. BROTHMAN & ASSOCIATES on 32nd Street, but would come to the Laboratory and make sketches of his own and conduct various tests, allegedly at the specific request of BROTHMAN. WOLLAN did not know the nature of these tests and stated that although at that time he, WOLLAN, was the Laboratory Superintendent, GOLD did not disclose to him the nature of the tests or drawings. WOLLAN volunteered the statement 'I was not involved with the work which GOLD was doing' but would not elaborate on this further. When questioned more specifically concerning this statement, WOLLAN remarked that GOLD never conferred with him on any work which he was doing even though it was done in the Laboratory where WOLLAN was Superintendent.

"According to WOLLAN, GOLD was employed by BROTHMAN in the late winter of 1945-46 or early spring of 1946, and after being there a few months was employed fulltime, returning to his home in Philadelphia on weekends. GOLD and BROTHMAN became very closely associated together, and WOLLAN gathered the impression from general conversation that BROTHMAN and GOLD had known each other for a considerable length of time prior to GOLD'S being employed by BROTHMAN.

"WOLLAN recalled that GOLD assisted BROTHMAN in obtaining a contract with the Palestine Potash Company. This contract was for specifications for manufacturing plants to produce DDT. The firm actually drew up specifications for two plants for the Palestine Potash Company and in addition to that ran tests in the A. BROTHMAN & ASSOCIATES Laboratory in connection with 'gun cotton' and 'TNT'. These tests were conducted in the hopes of obtaining a contract from the Palestine Potash Company to design plants to produce these items. WOLLAN did not know whether a contract was ever obtained from the Palestine Potash Company for plants to produce gun cotton and TNT.

"WOLLAN left the firm of A. BROTHMAN & ASSOCIATES in August 1946 and at the time he left, GOLD had come to the Laboratory and more or less replaced WOLLAN as Laboratory Superintendent. It was WOLLAN'S belief that GOLD was given the position of Laboratory Superintendent when he, WOLLAN, left.

(Pages 1,2,3)

"WOLLAN was questioned in detail concerning any knowledge of GOLD'S background and of any business trips made by GOLD while employed by A. BROTHMAN & ASSOCIATES. WOLLAN advised that he knew very little of GOLD'S background other than that he was a chemist, came from Philadelphia, and was apparently married to his second wife by whom he had two small children. WOLLAN stated he did not become closely acquainted with GOLD inasmuch as he felt that GOLD was apparently replacing him, WOLLAN, in the confidence of ABRAHAM BROTHMAN and was apparently, on BROTHMAN'S instructions, assuming duties which normally would have been WOLLAN'S responsibility.

"WOLLAN volunteered that GOLD had a friendly feeling toward the Soviet Union. WOLLAN stated, however, he could recall no specific incident which occurred to indicate GOLD'S friendly feeling toward the Soviet Union."

*MORRELL EDWARD DOUGHERTY, 5517 Litchfield Street, Philadelphia, who was born in Philadelphia December 2, 1906, furnished the following information to Special Agents Albert L. Pierce and William H. Naylor.

*Shortly after February 1946, GOLD obtained a position with ABRAHAM BROTEMAN ASSOCIATES in New York City and DOUGHERTY started employment with ACHESON COLLOIDS CORPORATION, Port Huron, Michigan, being a Service Engineer for that company, at the Land Title Building, Philadelphia, Pa. DOUGHERTY is still with that corporation, while GOLD returned to Philadelphia in 1948, having been connected with the Philadelphia General Hospital since his return.

*....

*In February 1946, following their release from the Pennsylvania Sugar Company, both Gold and Dougherty went on a three day trip to Atlantic City to attend an American Chemical Society meeting or convention for the purpose of obtaining new positions through the American Chemical Society Placement Bureau.... In their attempt to obtain positions, GOLD and DOUGHERTY filled out applications listing their qualifications. As a result of this, DOUGHERTY was interviewed by a man from the Philadelphia Navy Yard regarding a position there. DOUGHERTY, upon learning the qualifications required for the job, felt that GOLD would qualify better than he and suggested GOLD'S name as a prospective applicant.

"Soon after this, DOUGHERTY, GOLD and REGINA LOOKABAUGH made a trip to go to New York City. DOUGHERTY went as far as Rahway, New Jersey, where he attempted to obtain a job with MERICK and COMPANY....He was unable to obtain the job for which he had applied. After the interviews, he continued on to New York City, where he met REGINA LOOKABAUGH and GOLD at the Pennsylvania Railroad Station. DOUGHERTY explained that during that day, GOLD had taken REGINA LOOKABAUGH to ABRAHAM BROTHMAN ASSOCIATES in New York for the purpose of obtaining a position for her. However, she was unsuccessful and DOUGHERTY did not know the exact reason for her not obtaining the position....

"DOUGHERTY was unable to furnish any information of value relating to GOLD'S actual connections with ABRAHAM BROTHMAN ASSOCIATES in New York City, other than that GOLD'S employment there continued approximately two years and that during this period GOLD on occasional weekend visits to Philadelphia, discussed the fact that he was not being paid and explained the absence of pay by indicating that there was always some big enterprise going on that would result in the Associates obtaining a considerable sum of money. On occasions DOUGHERTY mentioned to GOLD about quitting, but GOLD continued in this employment at BROTHMAN'S, leading DOUGHERTY to believe that GOLD may possibly have had some investment in the enterprise.

"DOUGHERTY indicated that it was his opinion GOLD first became associated with ABRAHAM BROTHMAN through another Philadelphia chemist, one TOM BLACK. According to DOUGHERTY, BLACK had done work for BROTHMAN for a number of years and about 1944 or 1945, he believes that BLACK referred some of BROTHMAN'S work to GOLD to handle, the particular work pertaining to the recovery of a silver product." p37

"B. ABRAHAM BROTHMAN

"HARRY GOLD, on June 16, 1950, advised that his initial contact with ABRAHAM BROTHMAN was made on September 29, 1941, according to the best of his recollection. HARRY GOLD said that he received instructions from his espionage superior 'SAM' for making his initial contacts with ABRAHAM BROTHMAN. GOLD said that he had made three unsuccessful attempts to meet BROTHMAN, until the contact was finally effected on the fourth try. GOLD said that on one or two of these first occasions, 'SAM' showed up rather than BROTHMAN. On the first occasion when 'SAM' showed up, he told GOLD not to contact BROTHMAN. Later, however, 'SAM' reinstated the arrangements for GOLD to contact BROTHMAN.

"GOLD advised that when he eventually did meet BROTHMAN in the latter's car on 27th Street in New York City, the two of them drove after a short while, to what GOLD believed to be a Bickford's Restaurant, somewhere on Sixth or Seventh Avenue, between 34th and 42nd Streets. GOLD said that at this initial meeting most of the

"conversation between BROTHMAN and himself was concerned with the advance of the German army through Russia and BROTHMAN's statements that there was no point in trying to minimize the Russian losses or deaths.

"On June 20, 1950, HARRY GOLD said that in the last few months of 1942, or the first two months of 1943, a meeting in the Hotel Lincoln in New York City was arranged between HARRY GOLD, ABRAHAM BROTHMAN and GOLD's contact 'SAM'.

"HARRY GOLD advised that from the period of his first contact with ABRAHAM BROTHMAN in 1941 up until the early part of 1944, he received material from BROTHMAN for transmission to the Soviets.

"The principal items received by GOLD from BROTHMAN for transmission to the Soviets were material on Buna-S, mixing equipment and on Aerosol." p7

the last time I believe that I saw YAKOVLEV until in either
December of 1945 or January of 1946, and this was the last
time that I saw YAKOVLEV until December 26, 1946.

"Q. Where was that?

"A. Again at the bar on Third Avenue near 42nd Street.

"Q. How often did you go there?

"A. We met there possibly 2 or 3 times altogether.

"Q. How did you happen to go there - how did he know about that
meeting?

"A. He called me at the place where I was employed - at the
laboratories - Elmhurst Laboratories.

"Q. What did he say?

"A. He said this was JOHN and I would remember him and I recognized
his voice.

"Q. Where did you say you were employed?

The following excerpts were taken from the Administrative Page of New York report of SA JAMES E. FREANEY:

"It will be recalled that HARRY GOLD related that in 1942 or early 1943 he had considerable difficulty with ABRAHAM BROTHMAN, a contact furnished to him by SEMENOV, because BROTHMAN failed to keep their pre-arranged meetings. It was decided by SEMENOV and GOLD that the former would meet BROTHMAN and give him a 'pep talk.' Pursuant to this, GOLD engaged a suite consisting of a bedroom and parlor at the Lincoln Hotel in New York City, and subsequently introduced SEMENOV to BROTHMAN.

"ABRAHAM BROTHMAN was interviewed by Special Agent JOHN R. MURPHY and Special Agent ROBERT M. KANE. When asked had he ever met GOLD at the Lincoln Hotel, BROTHMAN immediately countered with the question, 'Where is the Lincoln Hotel?' Mr. FOWLER HAMILTON, Mr. BROTHMAN'S attorney who was present at the interview remarked, 'Well Mr. BROTHMAN, if you don't know by now where the Lincoln Hotel is, you better find out.' BROTHMAN then stated again that he did not know where the Lincoln Hotel was.

"He did state at this point, however, that he now recalled that he had seen GOLD on one occasion in a

"room at the Hotel New Yorker at 34 Street and Eighth Avenue, New York City. He stated that he had some business problem to discuss with GOLD and that GOLD had rented this room at the Hotel New Yorker. BROTHMAN, when asked, said that probably this was an unusual practice for GOLD never rented a hotel room, since when he came to New York City GOLD usually stayed with him, BROTHMAN, or went back to Philadelphia on the same day as his trip up here. BROTHMAN could not explain GOLD'S purpose for having rented this room. Also, BROTHMAN advised that he recalled one occasion when he had seen GOLD in a room at the Hotel Commodore, New York City.

"Photographs of SEMENOV were exhibited to BROTHMAN. He denied knowing SEMENOV, and repeated his assertion that he had never met SEMENOV in company with GOLD at the Hotel Lincoln."

On October 25, 1950, ELIZABETH BENTLEY was interviewed by SA Thomas G. Spencer in the New York Office. "During this interview, Miss BENTLEY volunteered that on October 15, she had had a conversation with Miss DORIS STEVENS, who is also known as Mrs. JONATHAN MITCHELL. By way of background, Miss STEVENS is a prominent feminist, American club woman and a writer of some note. Miss BENTLEY declared that during the conversation on this date, Miss STEVENS related that she had been requested by REBECCA WEST, a well-known novelist in England, to obtain some information relative to the recent espionage expose revolving about the FUCHS, GOLD, GREENGLASS and relative espionage cases. It appears that Miss WEST has published a book on well-known English traitors and is desirous of adding a final chapter concerning the above mentioned FUCHS, GOLD, etc. cases, for an expected reprinting. Miss BENTLEY stated that during this conversation, she told Miss STEVENS about her connection with ABRAHAM BROTHMAN. Miss BENTLEY related that she told the story generally, but did state how she met BROTHMAN, the type of work BROTHMAN was engaged in on an espionage level, and also the manner in which BROTHMAN was turned over to another espionage agent who happens to be HARRY GOLD.

"Miss BENTLEY stated that her reason for advising the agents was that she felt that she had made a rather grave mistake in making this information available, particularly in view of the fact that it might be printed or become somewhat well known prior to the date of the BROTHMAN trial. It is to be noted that Miss BENTLEY was well aware of the fact that BROTHMAN was arrested, and that he was indicted and had been

released on bond. The matter of BROTHMAN'S arrest was discussed with Miss BENTLEY by the writer and Agents handling the BROTHMAN case. It is the writer's opinion that Miss BENTLEY made these remarks in an unguarded moment and with no thought of injuring the Government's case."

"PASS recalled that BLACK once asked PASS to

"obtain information concerning Vitamin B-1. BLACK explained that BROTHMAN desired this information for the State of Israel and had asked HARRY GOLD to procure the same. GOLD in turn asked BLACK, and BLACK subsequently contacted PASS. PASS recalled that BLACK made his request in the presence of PASS' family. Upon learning that the Vitamin B-1 information was desired by BROTHMAN, PASS questioned BROTHMAN's motives, whereupon BLACK dropped the subject and never pursued it subsequently. PASS reiterated he has never met BROTHMAN.

"PASS said he was told by BLACK that HARRY GOLD could not get a job because he had testified in the 1947 Grand Jury investigation of BROTHMAN. PASS indicated that BLACK was therefore aware in about 1948 that BROTHMAN was under investigation by the FBI. According to PASS, BLACK conceded that BROTHMAN was a Communist and that Communists are capable of anything including espionage.

"BLACK told PASS he had introduced GOLD to BROTHMAN in 1944 or 1945 when BROTHMAN was seeking a chemist. BLACK recommended GOLD who was then out of work, but BLACK himself declined. BLACK said he did not want to get mixed up with BROTHMAN, as the latter was a Communist. BLACK assumed BROTHMAN did not know BLACK had left the Communist Party but rather that he was still loyal to that organization.

"PASS stated he learned that GOLD and BROTHMAN became closely associated and worked particularly long hours. According to information received by PASS, MIRIAM MOSKOWITZ was a mistress to BROTHMAN prior to being a business associate. On another occasion, PASS learned that BROTHMAN had accused GOLD of breaking up BROTHMAN's home.

"On November 20, 1950 PASS telephonically contacted the writer to advise he had talked to THOMAS BLACK on November 19, 1950 as a result of which he was desirous of being interviewed. Accordingly, SA JOHN R.

"LYONS and the writer interviewed the subject on November 20, 1950 at the Spruce Chemical Company in Paterson, New Jersey. p8

"The following is extracted from the notes of JACOB PASS and reflects portions of conversations between PASS and BLACK on November 19, 1950: p9

"On November 4, 1950, Mr. HERMAN FELLTON, Technical Director, Orkin Termite Company, 591 Peachtree, N. E., in Atlanta, was interviewed by the writer and Special Agent Paul F. Tierney. FELLTON advised that in 1944 he was employed as a Sanitarian for District No. 1, at the Regional Office of the U.S. Public Health Service in New York City. FELLTON stated that the main work of his section involved mosquito control in the immediate areas surrounding government reservations. He stated that his entire section was composed of fieldmen, who studied conditions relating to the control of mosquitos around these installations.

"FELLTON stated that any records which his section may have kept are, to the best of his knowledge, still in the United States Public Health Service Offices in New York City. He stated that he doubted seriously whether any member of his section made any contact with ABRAHAM BROTHMAN either at the home or laboratory of BROTHMAN in New York. He stated that if BROTHMAN was conducting research relative to D.D.T. and if any calls made on BROTHMAN were in connection with any person having become ill or poisoned by D.D.T., undoubtedly the Industrial Hygiene Division of the United States Public Health Service would have conducted such an inquiry.

"FELLTON stated that, to the best of his knowledge, in 1944 D.D.T. was still on the restricted list and could not be discussed openly. He stated that if BROTHMAN was in fact or had been in fact working on D.D.T. research and his section had had anything to do with BROTHMAN, he probably would have handled it personally.

New York report dated 10/26/53, entitled SONIA ZELTZER RESIKA, was,, reads in part as follows:

"In 1950 in the Southern District of New York ABRAHAM BROTHMAN was convicted on a charge of obstruction of justice in connection with the investigation of HARRY GOLD, self-admitted Soviet espionage agent. In December, 1950 during Supplementary Proceedings relative to his arguments for release of bail pending an appeal BROTHMAN furnished the government with a list of names of persons who had contributed to his bail fund. This list reflected that SONIA RESIKA'S husband had contributed \$500 to BROTHMAN'S bail fund and he was interviewed by Bureau agents during an investigation of the sources of this bail fund. RESIKA advised that he had loaned \$500 to CLARA LEET, 161 East 96th Street, New York City, which he understood was to be turned over to NAOMI BROTHMAN, wife of ABRAHAM BROTHMAN. He exhibited a note dated August 30, 1950 signed by CLARA LEET in the amount of \$500. CLARA LEET upon interview in this matter stated that NAOMI BROTHMAN, who is a close relative, had asked for a loan of \$500 for ABRAHAM BROTHMAN'S bail fund. Mrs. LEET stated that she then borrowed this money from ABRAHAM RESIKA and turned it over to NAOMI BROTHMAN."

He was paid the \$40,000 for working on and developing an explosive for the Palestine Government to be used in the fighting over there. The \$40,000 was paid to BROTHMAN by Haganah. BROTHMAN stated that he gave officials of Haganah a receipt for the \$40,000

but the receipt had a fictitious name on it. He stated that Haganah would deny ever having given him the \$40,000 since his work was in direct violation of the President's Embargo Act.

"BROTHMAN is not concerned about being questioned in reference to the \$40,000 since he states that he has completely destroyed all the evidence reflecting his experiments with the explosives. BROTHMAN stated that the boxes and cartons which he had kept the materials for his explosives were thrown by him in NEWTOWN (Ph.) Creek."

The following excerpts were taken from New York report 8/22/51 entitled "RETORT":

"Confidential Informant T-1, of unknown reliability, who will not testify under any circumstances, confidentially advised on April 5, 1951 that JULIUS ROSENBERG and ABRAHAM BROTHMAN were working on the draft of a news-letter type of publication similar to 'In Fact' which is to be called 'Retort.' This publication was to be organized as a counter-propaganda unit and will be drawn up, printed, published and distributed in a completely secret fashion.

"Plans are for distribution in the cities of New York, Chicago, Detroit and Los Angeles. Seven persons have been designated as distributors in each of the above cities and their duties include preparing a list of persons to obtain the letter. Seven people will form the National Board of the organization.

"It is planned to print and distribute 125,000 copies of this news letter on a bi-monthly basis. Copies are to be varityped and mimeographed. ROSENBERG and BROTHMAN discussed this plan with T-1, and he agreed to work with them.

"They estimate that \$10,000 cash will be required and ROSENBERG is to put up the bulk of this. Informant is to make a contact in the Bronx and, thereafter, this person will be the contact between informant and EMANUEL BLOCH, attorney for JULIUS ROSENBERG, who is to supply the funds. ROSENBERG estimated that about \$4200 would be required immediately and informant is to receive \$5000 to set up operations. Informant's part in this plan has been approved by EMANUEL BLOCH. Informant is to locate a house suitable for setting up mimeographing equipment and is to travel to Philadelphia or Chicago to buy equipment, and is also to take part in the distribution. Informant stated that ROSENBERG advised that all the details of this plan have been minutely worked out and will be so set up that no one will know or have complete control of the entire operation. The house used will be set up and operated on a basis similar to the 'Morton Street deal.' (It is pointed out that

The following excerpts were taken from report (New York) of SA JAMES P. MARTIN, entitled: "ARTHUR PHINEAS WEBER, wa.":

"On October 17, 1951, PERCY MADEL, residing 79 Schenck Avenue, Brooklyn, New York, was interviewed at the offices of Delton Products Corporation, 154 Nassau Street, New York City, by SA ROBERT C. BLOUNT and the writer. PERCY MADEL advised that he is employed as President of Delton Products Corporation, which he described as a chemical house, dealing mainly in exports of chemicals to certain large firms who have business interests outside of the United States.

"MADEL identified a photograph of the subject as a person he had known as ARTHUR WEBER, who was an associate in business with ABRAHAM BROTHMAN. MADEL said he had first met ABRAHAM BROTHMAN in 1941, when he was doing sales work for various American tin companies and recalls that at that time BROTHMAN was employed by Hendrick Engineering Company at 30 Church Street, New York City.

"PERCY MADEL also advised that he had never discussed his Communist Party membership with ABRAHAM BROTHMAN or NAOMI BROTHMAN, saying that in his conversations with BROTHMAN, no question concerning Communist Party membership had ever come up and, accordingly, he had never mentioned same to either ABRAHAM or NAOMI BROTHMAN at any time.

"NADEL further related that he never had any knowledge concerning any espionage activities on the part of ABRAHAM BROTHMAN. He said that his acquaintanceship with BROTHMAN was brought about through business and that he had contacted BROTHMAN at the Hendrick Engineering Company when he, NADEL, was attempting to sell certain tin material to that company. He advised that he had thereafter contacted BROTHMAN on many occasions in connection with BROTHMAN'S engineering business, and related that he had some social contacts with BROTHMAN, but advised that none of these had anything to do with Communist or espionage activities.

"....

"NADEL advised that he has not seen subject in many years, advising that the last time he saw subject, subject was associated in a business with ABRAHAM BROTHMAN. He related he had subsequently inquired of BROTHMAN as to the subject and had been advised by BROTHMAN that subject was working for some private concern and that subject's work required him to do some research work at Columbia University regarding some secret matter. NADEL could not recall the specific words of BROTHMAN in regard to this, but recalled that the above was the substance of what BROTHMAN had mentioned concerning subject after subject had ceased business associations with BROTHMAN.

"Subject was asked if he had ever apprised ABRAHAM BROTHMAN or PERCY NADEL of the fact that he had reason to go to Columbia University to work on atomic matters there. Subject said that he had no conversations with BROTHMAN or any dealings with BROTHMAN from approximately the late summer of 1944, and said that he had not seen PERCY NADEL since sometime in the early part of 1944.

"Subject advised that it was his recollection that he had furnished no information outside Kellogg Corporation regarding his trips to S.A.M. Laboratories at Columbia University for research work on atomic matters there.

"Sen. Joseph R. McCarthy said yesterday that Abraham Brothman, linked to the Julius Rosenberg spy ring, is out of Federal prison and working in 'a radar plant' at Port Jervis, N. Y.

"The Wisconsin Republican said he had summoned Brothman for questioning this morning at closed hearings of the Senate Permanent Investigations subcommittee in the United States Court House at Foley Square. The Senator has been investigating an alleged spy ring at the radar laboratories at Fort Monmouth, N. J.

"Brothman, now thirty-nine, was linked to the spy ring by Harry Gold, courier for Dr. Klaus Fuchs and other Red espionage agents, now serving a term in Federal prison. Brothman was convicted of obstructing justice and jailed for two years in 1951.

"The moment we heard that Brothman was free and working in a radar plant, we called the plant,' Sen. McCarthy said yesterday. 'It is the Techni-Flex Co., and one of his superiors said that the Brothman employed in the plant was the same Brothman who had served a sentence on a conspiracy charge. . . . We immediately issued a subpoena ordering Brothman to appear in closed session before us tomorrow.'

"A Techniflex Corp., listed in Poor's Register of Directors at 55 Jersey Ave., Port Jervis, has as its

"principal products vibration eliminators, door gaskets, sight glasses, driers, check valves, sponge rubber tubing and machine parts for aircraft and air conditioners. Officials of the corporation could not be reached last night.

"Sen. McCarthy also announced that he had changed his plans on the New York questioning of David Greenglass, confessed atomic spy, now serving a fifteen-year term. Instead of bringing Greenglass to the Federal Building, Mr. McCarthy said, he would go to the Federal penitentiary in Lewisburg, Pa., and question him in private.

"The Senator gave several reasons for his change. One was that he had received two letters 'tipping us off that Greenglass' life might be in danger and he would be open to possible pot shots while en route here.'

"The Senator said the other reason was that Attorney General Herbert Brownell jr. had told him it would require a court order to get Greenglass up to New York and 'advised' him to go to the prison instead. Sen. McCarthy said that Greenglass could give vital information about the Rosenberg spy ring at Fort Monmouth, N. J. Greenglass had testified against his sister, Ethel Rosenberg, and his brother-in-law, Julius, and both were executed on June 19.

"The Senator's claim was challenged by O. John Rogge, Greenglass' attorney. Mr. Rogge accompanied subcommittee investigators to the prison last week and was present when they questioned Greenglass. He said his client had given no important 'new' information on espionage.

"Gold had testified against Brothman at the latter's trial, and last week, during the visit to Greenglass, Senate investigators got a new statement from him in which he swore that Brothman was his 'contact.' Brothman, who lived at 41-08 42d St., Sunnyside, Queens, and Miss Moskowitz, of 151 Eighth Ave., were charged with conspiring to concoct a story to throw the F. B. I. 'off the track' and defeat justice in the spy investigation.

"Sen. McCarthy's sessions, closed to the press, have always been open to his friends and relatives as observers. Yesterday's guest 'observer' during the questioning of eight witnesses, including several Signal Corps employees who invoked the Fifth Amendment, was Tom Driberg, a Labor member of the British Parliament from Malden, Essex. Mr. Driberg said he was 'much interested in the Fifth Amendment, because we have no such thing, not having a written constitution.'"

"Abraham Brothman, who served two years in prison for conspiracy to obstruct justice during an espionage investigation, has free-run of a Port Jervis, N.Y., plant that manufactures defense material, Senator Joseph R. McCarthy said yesterday.

"The plant has served the Department of Defense and the Army Signal Corps, the Wisconsin Republican declared.

"Brothman, 39-year-old chemical engineer, was a witness at a closed session of the Senate Permanent Subcommittee on Investigations, of which Senator McCarthy is chairman. The witness was linked to an espionage plot and convicted in 1950 of conspiracy on the testimony of Harry Gold, confessed atom spy now serving thirty years.

"Before his appearance before the subcommittee Brothman told reporters that he had worked as a technician at the Techniflex Corporation's Port Jervis plant since his release from prison a year ago today. He said he had not worked on anything that had to do with Government contracts—only private contracts dealing with refrigerator parts.

"Senator McCarthy and Brothman's statement was in direct contradiction to the testimony before the subcommittee. The senator added that Brothman refused to say whether he was a Communist today or was 'still engaged in espionage.'

TELLS OF BIDDING ON GUNSIGHT

"A high official of the company, whom the Senator refused to identify by name or position, also testified. The official told

"the sub-committee, the Senator added, that his company did not deal in classified materials and was now bidding on a new-type gunsight.

"I can't understand how that could be regarded as unclassified," the Senator said, referring to the gunsight.

"Asked under what conditions he had hired Brothman, the official gave two versions, according to Senator McCarthy. The official was said to have told the sub-committee that he gave Brothman a job on the recommendation of a friend 'who was in grave difficulty with the Department of Justice.' The friend, the Senator explained, had income tax trouble. The second version, the Senator added, was that the official met Brothman at the trial of the the United States Court House, Foley Square, where the subcommittee is holding its hearings. Mrs. Brothman, the official told the subcommittee, interceded to get the job for her husband.

"Senator McCarthy said the official went so far as to send his car to the Federal Prison at Atlanta, Ga., to pick up Brothman the day he was released.

"The official later identified himself to reporters as Norman Gaboriault, president of Techniflex, which he said was a manufacturing engineering concern. Mr. Gaboriault said his company which has seventy-five employees, was not engaged in radar work. He emphasized: 'We are doing no classified work.'

"Mr. Brothman, asked when he would return for questioning, replied: 'When he (Senator McCarthy) needs a new headline, he'll call me again.'"

Submitted herewith is a documentation of the subject to be maintained in the library on a permanent basis. This documentation was obtained from serial 842 of the subject's case file.

Regarding ABRAHAM BROTHMAN, on July 11, 1950, HARRY GOLD, self-admitted Soviet Espionage Agent, furnished a signed statement to SA'S T. SCOTT MILLER and RICHARD E. BRENNAN in which he related he met BROTHMAN IN 1941 at the direction of SEMEN SEMENOV, his Soviet Espionage superior. GOLD said that early in 1942 BROTHMAN furnished to him, complete and detailed materials for transmission to the Soviets.

In another signed statement Feb. 11, 1950 GOLD stated that at the bidding of BROTHMAN, he (GOLD) told an untrue story to the Federal Bureau of Investigation and the Federal Grand Jury in New York City in the summer of 1947 concerning his initial meeting and association with BROTHMAN.

On November 22, 1950, BROTHMAN was sentenced to 5 years imprisonment and a \$5,000 fine in the U.S. District Court.

On November 22, 1950, ~~Southern District~~ Southern District of New York, found ABRAHAM BROTHMAN guilty of conspiracy to obstruct justice and intimidation of a government witness. On November 28, 1950, he was sentenced to 5 years imprisonment and a \$5,000 fine on the count charging intimidation of a government witness and two years imprisonment and a \$10,000 fine on the charge of conspiracy to obstruct justice.

On July 26, 1951, the United States Court of Appeals, Second District, affirmed the conspiracy count, but reversed the count charging intimidation of a government witness. He was confined to the United States Penitentiary, Atlanta, Georgia, on August 21, 1951, and released on November 5, 1952.
