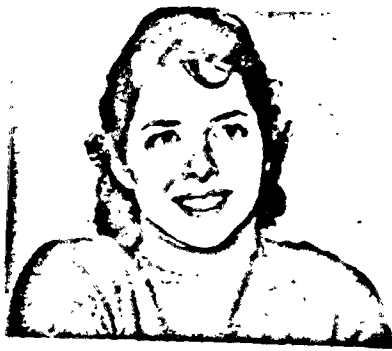

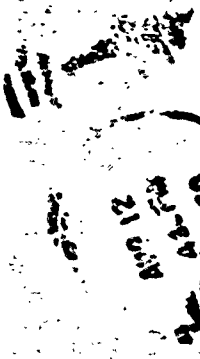
And you would be a most wonderful help if you could manage to turn up a house

I can't locate it. Oh woe.

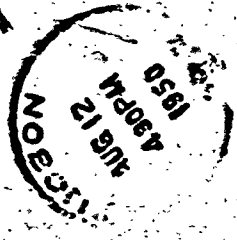
— Bruce's parents are visiting

do I miss them!

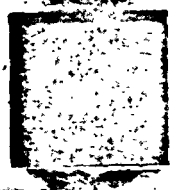
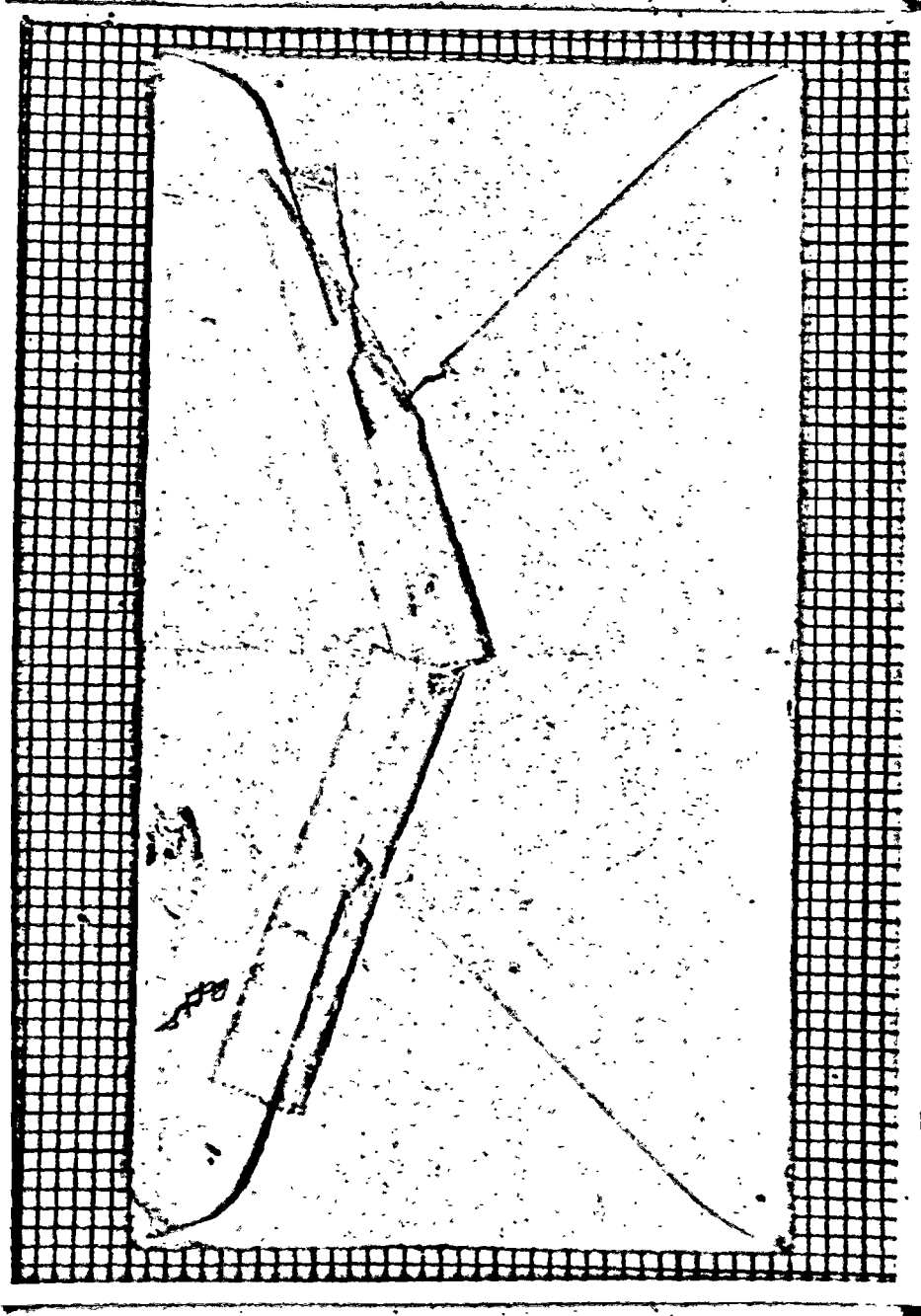

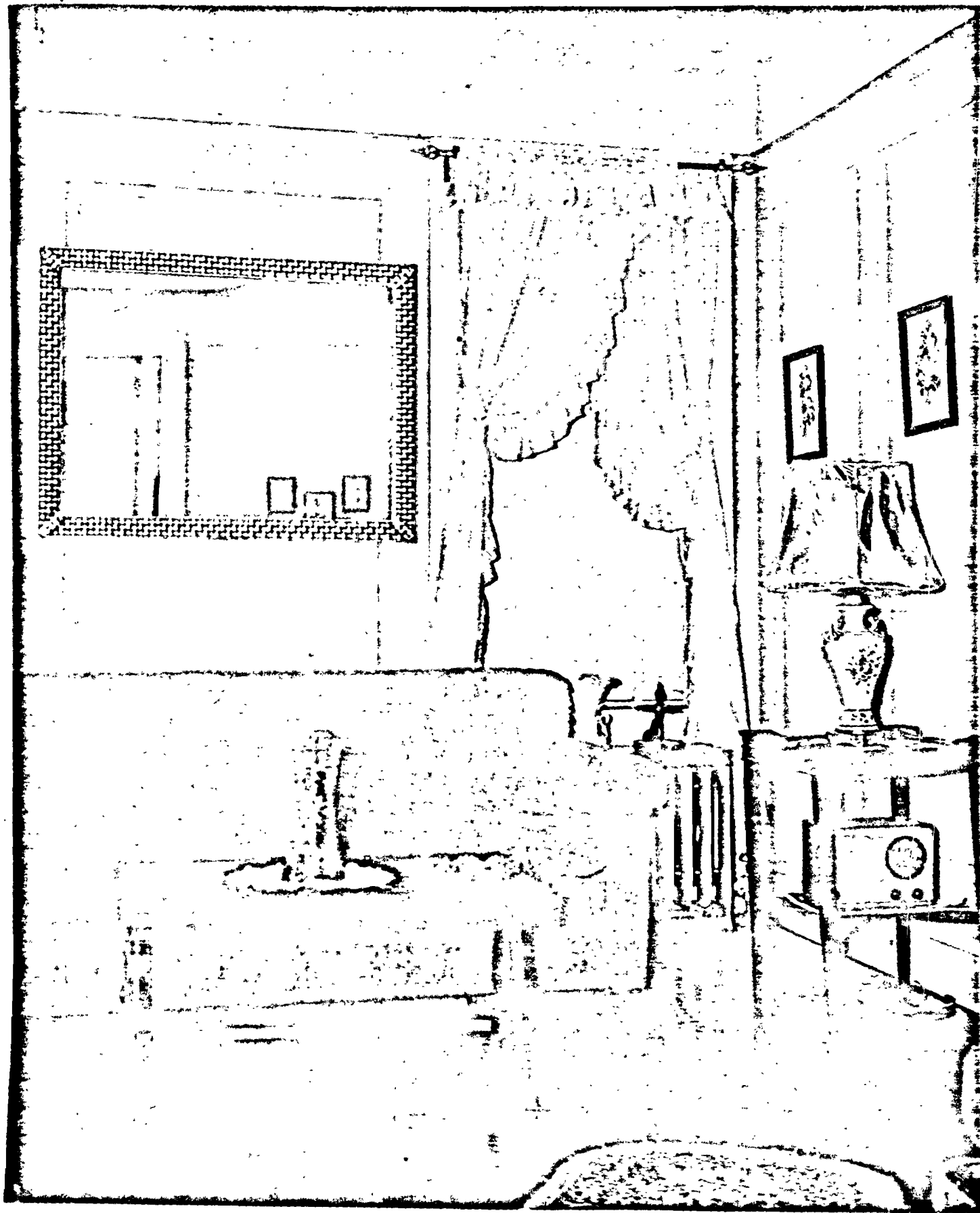


(2) Photo of entrance hall leading to the bedroom of Apt. 6I, 65 Morton Street, New York City



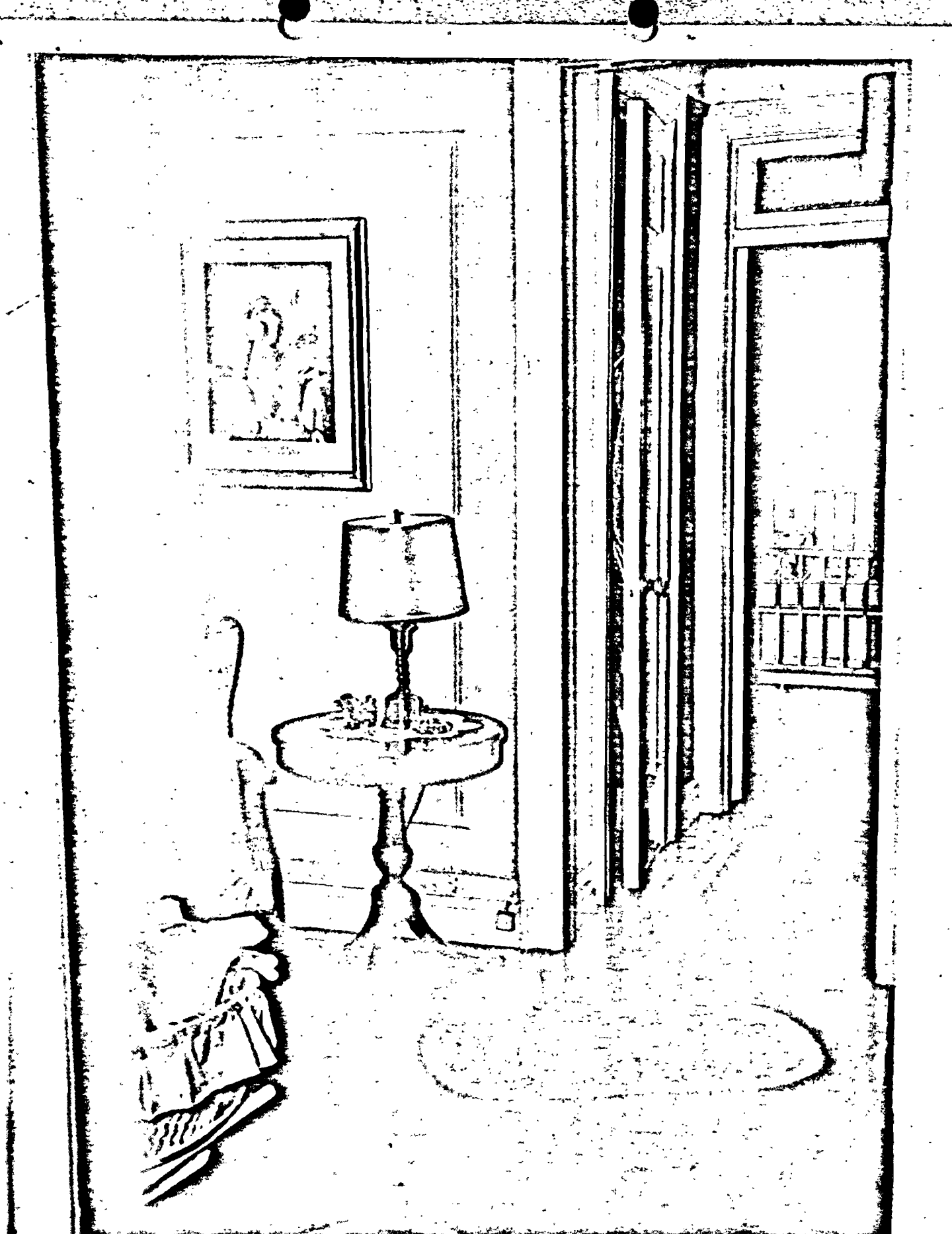
(5) Photo of same entrance hall leading to bedroom at 65 Morton Street,

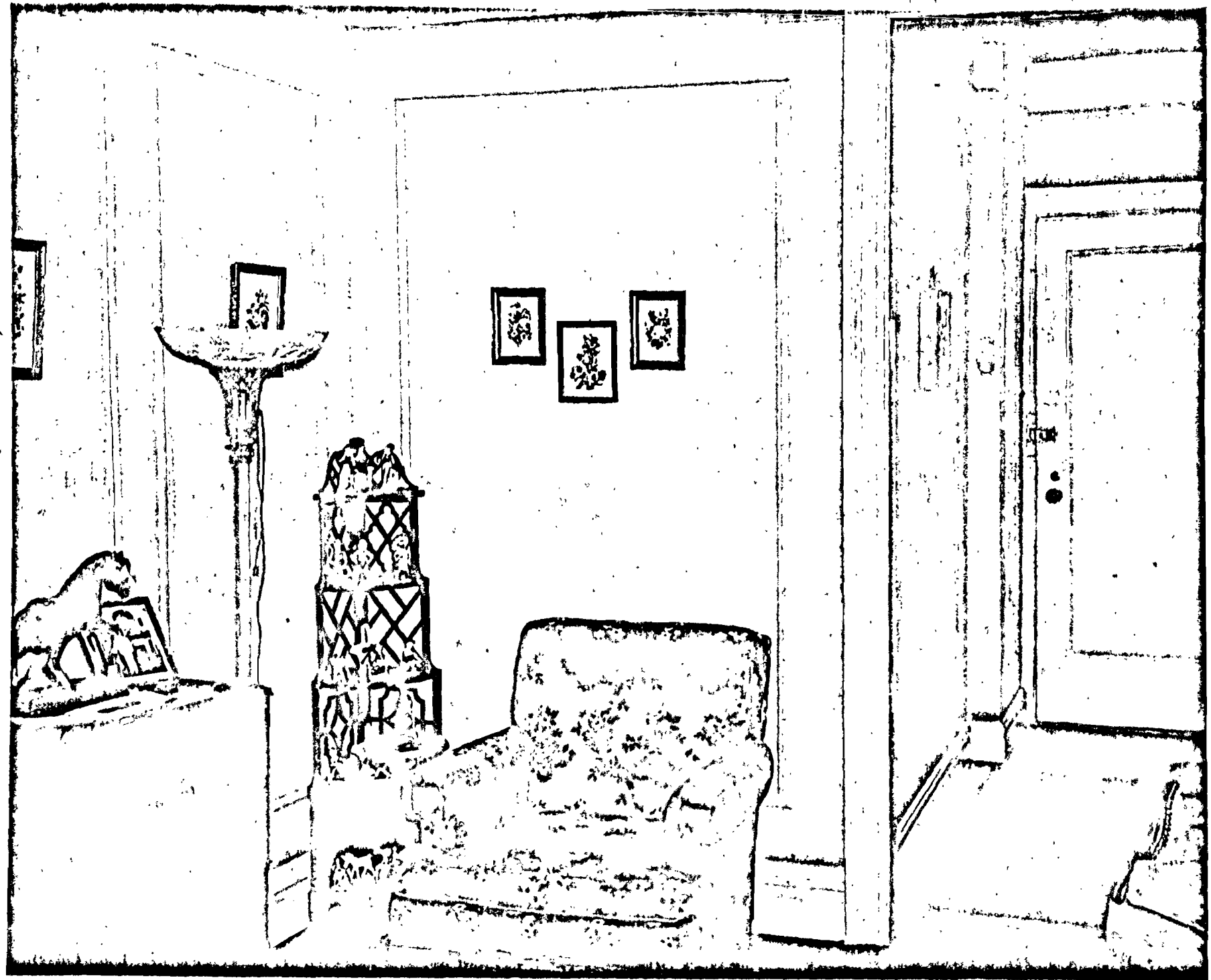
(6) Photo of the right corner of the living room of Apt. 6I, 65 Morton Street,
