It is believed that this letter is from CARL GOLDEN, and that the "Max" referred to in this letter is MAX FINESTONE, presently under investigation by your office by reason of his connection with the 65 Morton Street Apartment in the ALFRED EPOINONDAS SARANT, ESPIONAGE-R, investigation.
