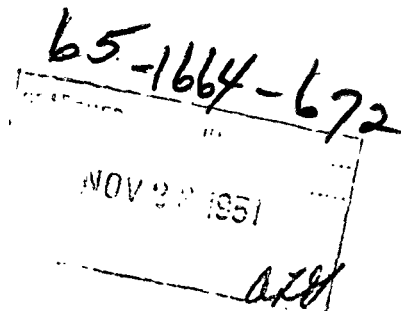

It is further requested that a mail cover be placed on her mail and further, that all toll calls emanating from Coral Gables telephone 487643 be periodically checked, to determine her contacts.

For the information of the Miami Office, information has recently been received from a confidential informant, of unknown reliability, that female subject was also actively engaged in Soviet espionage. At the request of the Bureau, this office is presently preparing a summary report on LOUISE ROSS SARANT. It is the intention of this office, upon preparation of this summary, to recommend to the Bureau the preparation of a security index card on her. The Bureau is not being requested to change the office of origin in this matter, since subject has apparently not changed her-permanent residence but is merely vacationing for the winter in your field division.
