b7D [REDACTED] was interviewed by SA'S WILLIAM E. DEICHLER and SA PETER F. MAXSON on June 7, 1955. It will be noted that [REDACTED] VICTOR W. D. ROSS from [REDACTED] ROSS is the stepfather of LOUISE SARRANT.

[REDACTED] stated that he was acquainted with ALFRED SARRANT, [REDACTED]

b7D

[REDACTED] stated that he never had any reason to believe that ALFRED SARRANT or his wife LOUISE were engaged in espionage activity and that he feels sure that neither ROSS nor LOUISE SARRANT have any idea of the present whereabouts of ALFRED. Subject stated that he, himself, was not surprised when ALFRED SARRANT ran off with CAROL DAYTON because he knew that the marriage of ALFRED and LOUISE SARRANT had been in difficulty and that he had suspected an affair existing between ALFRED and DAYTON.

b7D [REDACTED] stated that he would immediately notify the Bureau if through his friendship with VICTOR ROSS he ever learned anything indicating subject's present whereabouts.

b7D [REDACTED] requested that his name be kept confidential.
