Rerep Special Agent Robert F. Royal, dated August 3, 1951, at New York City, in the above-captioned matter.

You are authorized to furnish a copy of that report to the United States Attorney, Southern District of New York.

A review of the above report reflects that on page 33 there is set forth information obtained as a result of an interview which was had with Gary Pickard. It is noted that according to Pickard, during the Christmas vacation period of 1949 either Max Finestone or himself invited John David Lyle, Harold Lindsay Gatty, Ronald Gatty, and Mr. and Mrs. Norman Poirier to spend the Christmas holiday period with them in their apartment at 65 Morton Street, New York City. It was pointed out that all of these individuals were students at Cornell University. Pickard further advised that it was necessary for them to improvise sleeping facilities by making beds on the floor to handle the overflow group.

In this respect, as is pointed out in this report, Mr. Elwyn, Jr., the Superintendent at 65 Morton Street, advised during this Christmas period he had occasion to visit Apartment 6-I which was occupied by Finestone and Pickard in order to repair the plumbing in the bathroom. He stated he noted upon entering the apartment that there were seven men in the apartment and sleeping bags laid out on the living room floor.

Inasmuch as Pickard, who is apparently cooperating in furnishing information concerning this matter, advised he did not recall any such visit by Mr. Elwyn during this holiday period it would appear that this occurred during the two days when he had left New York City in order to visit his parents. Although Mr. Elwyn indicated that he saw seven men in the apartment on that occasion the identities of only four of these men can be accounted for on the basis of Pickard's statement concerning the visitors in that apartment. It is therefore desired that during the interviews requested of the Los Angeles and

Kansas City Offices an effort be made to specifically determine whether there were any other persons present in this apartment during any portion of the period during which they stayed at the apartment.

It should be specifically ascertained during the course of the interviews with John David Lyle and Harold Lindsay Gatty whether William Perl and possibly Weldon Bruce Dayton may have joined them and stayed in the apartment during this period. It is noted here for your information that Dayton was an instructor at Cornell University and his wife, Carol Dayton, fled from the United States with subject Sarant. The photographs of Perl and Dayton should be exhibited during these interviews.

For the further information of Kansas City and Los Angeles, any information indicating the presence of Perl and Dayton in this apartment would be of material value in connection with the possible future prosecution of Dayton for perjury. It is noted that Dayton has denied ever being in the apartment at 65 Morton Street or having had any acquaintance or association with William Perl. He has further denied having had any contact with Finestone in New York City.

It is further suggested for the consideration of the New York Division that interviews with Ronald Gatty and Mr. and Mrs. Norman Poirier, the latter being allegedly from Worcester, Massachusetts, along the same lines might be of importance in connection with this matter as well as the perjury investigation concerning Dayton.

On page 43 of refrep it is noted that Max Finestone resided in an apartment at 173 West End Avenue with one Harry Shaich. Inasmuch as a check of Bufiles has failed to indicate any identifiable subversive record concerning Shaich you are authorized to interview him concerning any information he may possess regarding Finestone, as well as the other members of the Rosenberg espionage network.

This investigation should be given prompt attention, and any information developed which would be of interest and evidentiary value in connection with the Dayton perjury case should be reported under the caption "William Bruce Dayton; Espionage - R" (Bufile 65-59336), in which case the Boston Division is the office of origin.

Rerep of SA ROBERT F. ROYAL dated April 14, 1951 at New York, New York, Albany letter to SAC Chicago dated May 29, 1951, report of SA FRANCIS X. JAHN dated July 5, 1951 at Baltimore, Maryland, Albany letter to SAC Boston dated July 23, 1951.

The Albany office in referenced letters has requested that Chicago interview MURRAY PESHKIN and LAURIE BROWN, both instructors at Northwestern University, Evanston, Illinois, concerning their knowledge of WELDON BRUCE DAYTON and his association with ALFRED SARANT.

It was ascertained on August 20, 1951 that both PESHKIN and BROWN are currently employed as instructors at Northwestern University.

Chicago indices contain no information relative to PESHKIN or BROWN.

Bureau permission is requested to interview PESHKIN and BROWN.

Reurlet August 22, 1951, requesting Bureau permission to interview Murray Peshkin and Laurie Brown, both of whom are presently instructors at Northwestern University.

A check has been made of Bufiles concerning Peshkin and Brown and there is being set forth hereinafter for your information the substance of the available subversive information appearing therein, which information has not previously been furnished to your office:

In the case entitled "Federation of American Scientists; Internal Security - C," the report of SA E. Hyatt Mossburg dated 8-12-47 at Washington, D. C. sets forth a list of the members of the Executive Committee of FAS. This list was made available by Confidential Informant [redacted] and reflects that Murray Peshkin, Magazine Committee, was connected with the Los Alamos Association, Santa Fe, New Mexico. (100-344452-33) **b7D**

The report of SA T. A. Bronstad dated 7-19-42 at Albany, New York, in the case entitled "Young Communist League, Ithaca Area, New York; Internal Security - C" contains information concerning one Laurie Mark Brown. This report reflects that a Mrs. Lela Tisdal of Ithaca indicated Laurie Brown was known to be an active leader of the American Student Union on the Cornell campus. Further, that a Robert Lewis is reported to have given Brown a mimeograph machine previously used by the YCL.

In the case entitled "American Student Union; Internal Security - R," the report of SA [redacted] B. Beachum, Jr., dated 1-23-42 at Albany reflects that one Foster N. Coffin, Director of the Willard Street Hall, Cornell University, disclosed that the ASU through Laurie Mark Brown made application for a meeting room in that hall on November 28 and December 4, 1941.

Peshkin and Brown were former associates of Sarant and Weldon Bruce Dayton at Cornell U., Ithaca, NY. It is anticipated that additional info concerning the associations & activities of Sarant & Dayton may be obtained as result of these interviews.

In this same file, the report of SA T. A. Bronstad dated 7-17-42 at Albany indicates that Donald H. Moyer, Counselor of Students, Cornell University, exhibited a letter dated April 26, 1942, directed to Dr. E. K. Graham, Secretary of that university. This letter was from Laurie Brown, who was described as a leader of the ASU, and advised that as of that date the ASU no longer existed on the Cornell campus. Further that, according to Edward Whiting, Assistant Director of the Willard Strait Hall, the front organization known as the War Council made its appearance on the Cornell campus in April, 1942. According to Professor A. W. Gibson, the leaders of the War Council were also connected with the ASU and among these leaders was Laurie Brown, who was the Financial Chairman and Treasurer of the group.

The report of SA Donald E. Roney dated 11-25-49 at Albany in the case entitled "Federation of American Scientists; Internal Security - C," sets forth the results of an interview with Dean Carleton C. Murdock, Professor of Physics and Dean of the University Faculty. According to Dean Murdock, Laurie Brown was Treasurer of the Association of Scientists of Cornell University, which was the local chapter of the FAS. This Cornell group went on record as favoring the free international exchange of scientific information about the atomic bomb. (100-344452-278)

In the case entitled "John A. Scott, Registration Act; Internal Security - C," the report of SA John G. Fleming dated 7-21-42 at Albany reflects that according to Professor A. W. Gibson of Cornell University, Laurie Mark Brown was an associate of Scott and considered to be a member of the YCL. Scott was reported as being an associate of a number of Communists and other individuals who attempted to organize the Student War Council at Cornell University.

Inasmuch as reflet indicated that a check of your files reflected no information concerning Peshkin and Brown, you are authorized to conduct interviews with these individuals

concerning their knowledge of the activities and associates of Dayton and Sarant as previously requested by the Albany division.

This matter should receive your immediate attention.

SYNOPSIS OF FACTS:

JOHN DAVID LYLE states he met MAXWELL FINESTONE, JAMES WEINSTEIN and GARY PICKARD in 1947-1948 while attending Cornell University. Later visited and lived with them in New York City. Recalls Christmas, 1949, holiday visit to Morton St. apartment. States those present were FINESTONE, PICKARD, LINDSEY GATTY, NORMAN POIRIER, SHIRLEY POIRIER, himself, and ARTHUR BANKS, former roommate of LYLE; also stayed one night at apartment during this period. Furnished names several associates of FINESTONE. WILLIAM PERL and subject unknown to LYLE. Believes photograph and name VIVIAN GLASSMAN familiar; unable to identify other photographs. Recalls going to Morton Street apartment with PICKARD after FINESTONE had moved to obtain pieces of furniture from basement at which time saw superintendent of building. Photographs of LYLE transmitted herewith to New York.

JOHN DAVID LYLE was interviewed on August 20, 1951 at the Los Angeles Office. LYLE stated he is presently residing with his mother and father at 108 1/2 South Sultana Avenue, Temple City, California, Telephone Atlantic 68970. He stated within the next

10 days he expects to return to New York where he can be reached care of SCOTT, MERIDETH Literary Agents, where he expects to be employed as editor of a new writer's magazine. He stated he is presently subletting an apartment at 27 Elliot Road, Lexington, Massachusetts. However, if he obtains employment as expected in New York City he will release this apartment and live in New York City.

LYLE stated that he met MAXWELL FINESTONE at Cornell University in the fall of 1947 through 2 students who had asked him to live with them, namely, LEONARD MARSAK and MARVIN MILLS. He stated that FINESTONE was a friend of theirs and during the time he resided with them FINESTONE visited their apartment on several occasions. At that time, according to LYLE, FINESTONE was attending the International Labor Relations School at Cornell University. He stated that he saw FINESTONE regularly until about the fall of 1949 at which time FINESTONE went to New York having left school in June 1949. Subsequent to FINESTONE's departure from the University in the fall of 1949, LYLE stated he occasionally visited New York City at which time he would stay with FINESTONE at his apartment on Morton Street. LYLE recalled that the street number was 55 Morton Street. However, he stated he was not certain of this number. He definitely recalled that the apartment was on the 5th or 6th floor and located in the rear of the building. He stated on these occasions when he visited FINESTONE at the Morton Street apartment, GARY PICKARD, whom he had met at Cornell University in the fall of 1949, was living with FINESTONE.

LYLE stated that in the latter part of January 1950 he and LINDSEY GATTY, a fellow student at Cornell University, went to New York City where they moved into the apartment located at 418 East 9th Street, which was then occupied by FINESTONE, PICKARD and JAMES WEINSTEIN, whom LYLE had previously met at Cornell University and who was a close friend of FINESTONE. LYLE stated that all resided at this apartment for about 2 weeks after which GATTY, PICKARD and LYLE obtained their own apartment at 780 Greenwich Street and FINESTONE and WEINSTEIN remained at 418 East 9th Street.

LYLE stated that during the times he visited FINESTONE on weekends at the Morton Street apartment house he did not recall meeting anyone, although he stated it was possible that friends of FINESTONE's may have dropped in during these trips. He stated, however, that during the time he resided with FINESTONE, et al, at the 9th Street apartment and subsequently when he visited FINESTONE after having obtained his own apartment, he met many of

their friends and recalls specifically JACK MINKOFF and his wife. He stated MINKOFF was a former student at Cornell University and he did not know whether the latter was a particular friend of FINESTONE or WEINSTEIN. LYLE also recalled at one gathering at the 9th Street apartment, subsequent to the time he had moved, among the guests of FINESTONE and WEINSTEIN was PAUL ROBESON, JR., son of the negro singer, and his wife. LYLE advised that PAUL ROBESON, JR. and JACK MINKOFF had been roommates at Cornell University. Also at this gathering LYLE recalled one DANNY MARION, whom he identified as a former student at Cornell University and whom he believed was attending Columbia University at the present time. In addition, a young couple named BOBEY and MARY FEIDEN (phonetic), also former students at Cornell University, were present at this time. Among the guests, the majority of whom were former Cornell students, was a close friend of FINESTONE's one MARTY MORAN, whom LYLE described as a union organizer in Pennsylvania, possibly representing the International Ladies Garment Workers Union, although LYLE was not certain of this. LYLE stated MORAN was a frequent visitor at FINESTONE's as was another guest on this occasion, one JOHN MARQUESSE who is believed by LYLE to be presently attending Cornell University. In this connection LYLE pointed out FINESTONE and his friends regularly frequented an Italian restaurant named JOHN CARDINELLI'S located on Houston Street near the intersection of Sullivan, and that MORAN, MARQUESSE, and FINESTONE went to this restaurant on many occasions. At that time LYLE stated this restaurant was identified by a large red awning.

In addition to the above individuals, also present was RUEY RANORR (phonetic) and wife MARILYN who were former students at Cornell University and lived in the neighborhood a few blocks north of 9th Street. Both of these individuals were friendly with FINESTONE and WEINSTEIN, according to LYLE. LYLE could not recall any other individuals present at this time.

LYLE advised that while at Cornell University FINESTONE and WEINSTEIN were members of a campus political organization known as The Young Progressives of America, which LYLE described as the "most left wing organization on the campus". LYLE stated he could not recall the specific occasion but believes that at one time or another FINESTONE asked him to join this organization which he declined. However, FINESTONE was active in the organization and he recalls that on one occasion the Young Progressives of America invited HOWARD FAST, the novelist, to speak before the group and FINESTONE invited LYLE to go with him to Syracuse, New York to drive FAST from there to Ithaca. LYLE stated he accompanied FINESTONE and was introduced by him to FAST.

With regard to his visit to New York City during the Christmas vacation of 1949, LYLE stated he recalled being in New England at this time and around December 26 or 27th he drove from Boston in his jeep and brought with him NORMAN POIRIER and his wife, SHIRLEY POIRIER. LYLE stated he had been in the Navy with POIRIER and following his return from the Navy POIRIER attended Cornell University at which time LYLE introduced POIRIER to FINESTONE and WEINSTEIN. LYLE stated that they went to the Morton Street apartment and when they arrived FINESTONE, PICKARD and GATTY were there. He stated he believes that a girlfriend of PICKARD's was also present although she may have dropped in at some time during the next few days. LYLE could not recall the name of this girl other than the nickname "NONNIE". LYLE stated that all of the above were present at this apartment from around December 26 or 27 to about January 2nd and in addition, on at least one night, ARTHUR B'NKs, a former roommate of LYLE's at Cornell who presently resides at 5153 Sherrier Place, N. W., Washington, D. C., also spent the night at this apartment. On this occasion LYLE stated the following individuals would have been present at one time or another in the apartment: FINESTONE, PICKARD, GATTY, BANKS, NORMAN POIRIER, SHIRLEY POIRIER, and LYLE. LYLE stated that 2 or 3 people shared the bed and couch and 1 or 2 slept on the floor. He stated he believes that on one or two occasions to relieve the congestion he stayed at the Hotel Lexington. LYLE stated that during this period he, GATTY and BANKS attended social affairs sponsored by the New York debutante set and that to the best of his knowledge PICKARD and FINESTONE were working and he saw very little of them.

LYLE explained that the use of the apartment at Morton Street was for economic reasons and was not used as a place for social gatherings but rather as simply a place to sleep. LYLE stated that during this period he does not recall any individuals other than the above visiting the apartment for any purpose. At this time LYLE was shown a photograph of WILLIAM PERL and stated he had never seen PERL to the best of his knowledge and that the latter was unknown to him by name.

With regard to the apartment at Morton Street, he stated that FINESTONE on one occasion explained to him that it belonged to friends of FINESTONE named SARANT, who were then living in New Jersey but had formerly lived in the apartment and were retaining it since they might return to New York. Later, at the time FINESTONE gave up the apartment, he explained to LYLE that the SARANTS had decided to release the apartment. To the best of his knowledge LYLE stated he believed the mail box at this apartment bore the name SARANT. Photographs of ALFRED SARANT were displayed

to LYLE who was unable to identify them and stated he never recalls hearing the name other than in the course of the above explanation by FINESTONE.

LYLE stated that after PICKARD, GATTY, and he obtained their apartment, FINESTONE offered them a couch and 2 chairs which had formerly been in the Morton Street apartment and which were then stored in the basement of the MORTON Street apartment building. He stated that he recalls to the best of his knowledge in the latter part of January 1950 going to the Morton Street apartment house with PICKARD, contacting the superintendent of this building, and obtaining the above mentioned furniture from the basement. He states he recalls seeing one or two of the tenants of the building in the hallway during the time they were moving this furniture but was unable to identify these individuals by name. He described the superintendent as being of average size, possibly in his forties.

Concerning FINESTONE, LYLE stated that he was practically without funds on most occasions. However, WEINSTEIN appeared to have sufficient funds as his family was wealthy.

LYLE recalled that at one time FINESTONE had a girl-friend whom he was fond of named BETTY BEUHLER (phonetic). LYLE recalls being introduced to BEUHLER by FINESTONE at her apartment in Greenwich Village, the address of which he could not recall. LYLE stated that BEUHLER was a folk singer by occupation although he was not familiar with her employment, if any.

LYLE stated that he believes WEINSTEIN left Cornell in June 1949 and thereafter attended Columbia Law School. He stated he understood WEINSTEIN also worked for the Progressive Party in New York during his residence with FINESTONE.

During his association with FINESTONE and WEINSTEIN, LYLE stated neither mentioned or indicated membership in the Communist Party although from FINESTONE's conversation in particular LYLE regarded him as "definitely very left wing." When asked to explain this description LYLE stated he recalled that on several occasions during the time legislation was pending to outlaw the Communist Party that FINESTONE was bitterly opposed to this and so expressed himself.

LYLE stated that during his association with FINESTONE and WEINSTEIN no indication was given by either that they were engaged in any suspicious activities and that at no time was he ever requested by them to perform any service.

VIVIAN GLASSMAN - LYLE stated the photograph of GLASSMAN looked familiar and the name also sounded familiar but he could not recall meeting GLASSMAN. However, he stated it was possible she could have attended one of the gatherings at FINESTONE's apartment.

MAXWELL FINESTONE - LYLE immediately identified FINESTONE from the photograph.

CRAIG, the wife of ROBERT T. CRAIG. She stated she is twenty-four years of age and has resided at 44 West Ninth Street, Jamestown, New York since May 16, 1951. She advised that previous to coming to Jamestown, New York, she resided at 809 Ardmore Avenue, Erie, Pennsylvania from October 18, 1950 to May 16, 1951. Previous to that period, she resided at 100 Sunnyside Avenue, Pleasantville, New York and at 72 East Eighty-sixth Street, New York City from February, 1948 to July, 1949. From October, 1949 to June, 1950, she advised she resided at 5 Riverside Drive, New York City. She stated that while she resided at 5 Riverside Drive, the following three young women resided with her: BETTY RITTER, MARILYN MITCHELL and BARRIE REID.

Mrs. CRAIG was shown a photograph of FINESTONE. She advised she knew him as MAX FINESTONE and first met him in the fall of 1949 in New York City. She stated that her brother, GARY, and FINESTONE had requested permission to use her telephone to receive phone calls from their employer, the American Research Bureau. She recalled that probably five or six telephone calls were in fact received from the American Research Bureau requesting that either GARY or FINESTONE contact that Bureau either by phone or a personal appearance in the office the following morning. She stated she could not recall any calls from any other source whatever as having been for either her brother or FINESTONE.

She stated that the first time she met FINESTONE was actually at her place of employment, the Lever Bros. Company of 505 Park Avenue, New York City. She stated that her brother had telephoned her concerning a possible position with Lever Bros. for FINESTONE. Mrs. CRAIG stated that in her capacity as Psychological Test Administrator, it was her duty to interview prospective applicants for her company. She stated she recalls that she had told her brother to have FINESTONE come to the Shelton Hotel, Lexington and Forty-ninth Street, New York City, where all prospective employees were being interviewed. She recalled that FINESTONE appeared at her office one day in either October or November of 1949 and that she furnished him an application to fill out there and then. She stated that within one-half hour, FINESTONE told her that the application would do him no good inasmuch as he could not sign the application. She advised that there is a paragraph in the application inquiring of prospective applicants whether or not they have ever held membership in the Communist Party or other such groups. She stated that FINESTONE had told her that he could not sign the application as it would be against his principles. She advised that inasmuch as he did not sign the application he was not further considered for a position with her company. She stated that inasmuch as the application had not been completed, she had torn it up. She stated further that on this date was the only occasion she had had personal contact with FINESTONE.

Concerning the apartment at 65 Morton Place, New York City, she advised that she had never visited that apartment or that address at any time.

She recalled that her brother had informed her that he was living with FINESTONE at that address at no cost to himself. GARY had further informed her that a friend of FINESTONE's was letting FINESTONE use his apartment while this friend was away from the city. She stated she did not recall if her brother had ever told her of this friend's identity. She stated that as far as she could recall, only GARY and MAX stayed at that apartment.

She stated that the names of JAMES WEINSTEIN and WELDON BRUCE DAYTON were unknown to her.

Concerning JOHN MOORE who resided in an apartment located at the corner of Lexington and Forty-fourth Street, New York City, she recalled that her brother had informed her that he had stayed two or three days at MOORE's apartment sometime early in 1950. She stated that JOHN MOORE is a friend of her brother's divorced wife's family. She stated she had no information concerning JOHN MOORE

Concerning CLAIRE D'ARCY HAUSDORFF, she stated that CIAIRE was married and divorced on the West Coast sometime in 1945. She stated that at about Christmas, 1950, she married one DON HAUSDORFF and that they presently reside at Apartment 5-B, 352 West Eighteenth Street, New York, New York.

Concerning FRANA KLEIN of 7 East Eighty-fifth Street, New York City, she stated FRANA is a former girlfriend of her brother, GARY.

She stated she had no information concerning BETTY BOEHLER of 178 East Seventy-first Street, New York City, New York.

Concerning any possible friends or associates of FINESTONE, she stated that one SUNNY PORTER may be a friend of FINESTONE. She stated that SUNNY PORTER had attended Cornell University and that her brother GARY had met her there in 1949. She stated that her brother, GARY, had informed her that SUNNY PORTER had visited Italy during the summer of 1950 but that the purpose of this visit was unknown to her. HAROLD LINDSEY GATTY, Company B, Class 36, A.O.C. Division, gave his association with GARY PICKARD, MAXWELL FINESTONE, as follows:

He stated that he met GARY PICKARD at Cornell University at Ithaca, New York around July or August of 1949 through a mutual acquaintance named MARILYN PORTER, now MRS. JAMES SHERWOOD, who presently resides in Philadelphia, Pennsylvania. He stated that he saw PICKARD quite often until PICKARD left Ithaca, New York in September, 1949 when he went to Pleasantville, New York to his home and then on to New York where he resided at 65 Morton Street. He stated that he saw PICKARD again during the Christmas Holidays of 1949 when DAVID, NORMAND POIRIER, and his wife, SHIRLEY, and himself, who were all stu-

dents at Cornell, were invited by MAX ~~FINESTONE~~ and GARY PICKARD to stay at their apartment at 65 Morton Street. He stated they stayed there for approximately four to ten days. He stated that they only stayed there at night and did not associate with FINESTONE or PICKARD or FINESTONE's crowd. He stated that LYLE, POIRIER, POIRIER's wife, and himself returned to Cornell on January 2, 1950. He said a few weeks later during final examinations at Cornell, PICKARD came back to Ithaca for a few days. GATTY advised that he and LYLE, and their roommate, ARTHUR BANKS, put PICKARD up in their apartment at 140 College Avenue, Ithaca, New York while he was there.

After graduation the first of February, 1950, GATTY stated, he went to New York City and, being out of a job and short on money, he stayed at 418 Ninth Street, at WEINSTEIN's and FINESTONE's apartment. He stated that he stayed there with PICKARD, WEINSTEIN, FINESTONE and LYLE until LYLE, PICKARD, and himself rented an apartment at 780 Greenwich Street approximately two weeks after moving in with FINESTONE and WEINSTEIN. He stated that about August, 1950 PICKARD left New York to go to Las Vegas, Nevada to obtain a divorce and he and LYLE moved to 353 West 57th Street, Apartment 4-D. He advised that he stayed there a couple of weeks and enlisted in the Army on September 12, 1950.

He stated that he met MAXWELL FINESTONE during the Christmas of 1948 in New York City. He said that he was closely associated with FINESTONE at Cornell until FINESTONE graduated about June, 1949. He stated that FINESTONE's home is in Ithaca, New York and he saw him frequently until he moved to New York City. He advised that after LYLE, PICKARD, and himself moved to 780 Greenwich Street, he did not see much of FINESTONE or WEINSTEIN.

GATTY stated that he met JAMES ~~WEINSTEIN~~ through MAX FINESTONE at Cornell during early, 1949. He stated that he may have known him earlier but he could not recall ever having met him before. He stated WEINSTEIN and FINESTONE were always together while they were at school and he drank beer and partied with them some. He stated that they were living at 418 East 9th Street when he enlisted in the Army in September, 1950. He stated that several times at drinking parties that PICKARD, LYLE, and himself would get in "bull sessions" and argue political issues with WEINSTEIN and FINESTONE. He stated upon several occasions FINESTONE and WEINSTEIN tried to persuade them to join various organizations such as the N.Y.C.P., the AYD, and about six other clubs at Cornell University that Communist sympathizers belonged to. He stated that LYLE and himself never had anything to do with them and he believed that PICKARD did not either.

The photographs of FINESTONE, PERL, DAYTON, ROSENBERG, GLASSMAN (ELEANOR), and SARANT were shown to GATTY and he stated that he never saw WILLIAM PERL before but he did recognize FINESTONE and thought he had met SARANT at Ithaca, New York during the summer of 1949. He stated that he went for a ride with FINESTONE out to the house that SARANT was building in Ithaca. He stated that he was nosing around the house and did not know what FINESTONE and SARANT talked about. He said he never saw SARANT again.

GATTY stated that FINESTONE told him that SARANT gave him the apartment at 65 Morton Street for a place to stay while SARANT and his wife were away. He stated that he never saw SARANT or PERL while he was staying there during the Christmas Holiday of 1949 and had no reason to question FINESTONE any further about the apartment. He said that he did not notice anything unusual happening in the apartment at 65 Morton Street during the Christmas Holiday of 1949 but that he wouldn't because he was only there at night time. The file on SARA NAIMA LANDMAN ROSSANT in the Miami Division has been reviewed and it has not been possible to establish any connection between the ROSSANTS and Mrs. VICTOR K. D. ROSS of Ithaca, New York, mother-in-law of the Subject, ALFRED E. SARANT.

From information in the Immigration & Naturalization Service file on SARA NAIMA LANDMAN ROSSANT it was reflected that she was born in London, England, July 19, 1919 and apparently had resided in London most of her life until coming to the United States in February of 1950. Mrs. ROSSANT, under relatives, listed only her husband, MURRAY JUSTUS ROSSANT, her father, SAMUEL LANDMAN, and her mother, AUGUSTA LANDMAN, nee TOMANSKA. She did not indicate any other relatives in the United States.

Re: SALE OF THE SARANT RESIDENCE, CAYUGA HEIGHTS ROAD,

On July 30, 1951, Albany Confidential Informant T-1, of known reliability, advised that he had learned that VICTOR K. D. ROSS, LOUISE SARANT's step-father, had been attempting to sell the SARANT residence, and that he believed that a sale had recently been consummated through the Ithaca Savings and Loan Association.

Albany Confidential Informant T-2, of known reliability, advised that on July 25, 1951, LOUISE SARANT, as seller, conveyed the SARANT residence on Cayuga Heights Road to WILLIAM MOONEY WOODWARD for the purchase price of \$12,000.00, it being estimated that \$3,400.00 would be necessary to complete construction. At the time of sale, the Ithaca Savings Bank held a mortgage with an unpaid balance of \$5,700.76. This mortgage was assumed and increased to \$9,100.00 by the Ithaca Savings and Loan Association. Albany Confidential Informant T-6, of known reliability, advised that VICTOR K. D. ROSS, in addition to his own residence, owns a cottage located between his house and the lake front on the West Shore, and that he has seen the SARANT children at this cottage. Mr. LAWRENCE RUMSEY, who owns a summer home adjoining the ROSS property, advised that Mrs. SARANT and her children recently moved into the lake cottage and apparently have taken up temporary residence there.

Re: ALLEGED APPEARANCE OF ALFRED SARANT IN ITHACA

On June 16, 1951, Albany Confidential Informant T-7, of known reliability, advised that he had heard [REDACTED] that subject had returned to Ithaca for a very short period. HANSEN was interviewed at the National Army Store, where he is employed as manager. He advised that sometime early in June, while he was in an inebriated condition, some person told him that SARANT had returned to Ithaca, remained for a few hours, and immediately left. HANSEN stated that he could not be sure of the identity of the person who furnished this information, but that it might possibly have been SEYMOUR HOROWITZ, a Cornell University student, who also had worked for the subject for a short time. b7D



He was questioned concerning any contacts of SARANT and was displayed photographs of JULIUS ROSENBERG, WILLIAM PERL, JOEL BARR and VIVIAN GLASSMAN. BENNETT stated that none of these persons are familiar to him and that he does not associate these photographs with any of SARANT's contacts. BENNETT did state that he was acquainted with MAX FINESTONE, having met him while he was also employed by SARANT. It is BENNETT's understanding that FINESTONE and LOUISE SARANT met in high school and that they at one time went together. He added that they have always seemed to be very good friends. BENNETT advised that he never heard any mention of an apartment at 65 Morton Street, New York City, or any connection between FINESTONE and the SARANTIS with regard to any apartment in New York City.

BENNETT was questioned concerning the relationship between ALFRED SARANT and HANS BETHE and PHILIP MORRISON. He advised that he has seen these individuals in and about Ithaca, but he never saw them with SARANT. He stated that he recalls something that ALFRED SARANT once told him about trying to get BETHE to help him enter Cornell University Graduate School, but that this is the only time SARANT ever mentioned BETHE, and that he does not believe that they were ever close friends. He does not remember SARANT ever mentioning MORRISON.

It is noted that this report indicates John David Lyle expects to return to New York around the middle of September, 1951, and can be reached there in care of Scott, Merideth Literary Agents.

From a review of this report it appears that a reinterview of Lyle might be desirable in order to obtain certain additional specific information in connection with this matter.

It is therefore desired that your office reinterview Lyle at the earliest possible date for the purpose of determining whether he may ever have seen James Weinstein at the apartment at 65 Morton Street, Greenwich Village, New York City. He should be questioned further as to the descriptive information relative to Weinstein's automobile. He should also be questioned as to whether he recalls having seen the superintendent of the building at 65 Morton Street in the Sarant apartment during the period when he and several of his associates from Cornell University were visiting in that apartment during the Christmas holidays of 1949. You will recall that according to Mr. Elwyn, the superintendent at 65 Morton Street, he entered the apartment for the purpose of fixing the plumbing in the bathroom and noticed a number of individuals in sleeping bags on the floor of that apartment.

Your office should likewise exhibit the photograph of Lyle to the Elwyns to determine whether they recall ever having seen him in the vicinity of the Sarant apartment in their building.



As of possible interest to the Bureau, it is noted that there is a similarity between THEODORE BETHNAHUM, mentioned in the latter Bureau letter and one ASHER BEN-NATHAN mentioned in the former Bureau communication. It would appear more than a coincidence that THEODORE BETHNAHUM and ASHER BEN NATHAN, whose names bear some similarity, would both be connected with the KATZ affair. *U*

It is noted that, on page 2 of this report, your Confidential Informant T-2 advised that Louise Sarant, at the time she closed the deal with respect to the sale of the Sarant residence in Ithaca, New York, displayed a power of attorney executed by her husband.

It is believed that it might be of considerable importance to determine if possible the exact time when Sarant executed this power of attorney, bearing in mind the subsequent information appearing in this report to the effect that Sarant left Ithaca rather hurriedly and apparently without premeditation. It is suggested that your office determine whether it is possible that a copy of such power of attorney may have been filed with either the Ithaca Savings and Loan Association or with William Mooney Woodward, the purchaser of this property.

On pages 5 and 6 of this report, there was set forth a compilation of the various deposits made to the account of Alfred and Louise Sarant at the First National Bank of Ithaca, New York, during the year 1951. It is desired that your office immediately determine whether that bank maintains either photostatic or recordar copies of checks which are deposited to the account of its customers. In the event same is true, such checks as were deposited to the Sarant account should be carefully examined to determine whether same may have any pertinence to this investigation.



It will be noted that subject is being investigated under an espionage classification, rather than under a Security Matter or Internal Security classification. It is not clear, since instructions appearing in referenced SAC Letter seem to apply only to the latter type classifications, whether the Bureau desires an investigative or a prosecutive type summary. The outline set forth in this SAC Letter does not seem applicable to an espionage subject.

It is further noted that practically all information involving LOUISE SARANT is based upon hearsay and other inadmissible evidence.

It is noted that an undeveloped lead set forth in this report requests that with Bureau approval the Albany division should interview Ronald Gatty. Further, there is a lead set forth for the Los Angeles division to interview Mr. and Mrs. Norman Poirier.

A check has been made of Bufiles concerning Ronald Gatty and Mr. and Mrs. Norman Poirier, but no identifiable subversive information was located. The Albany and Los Angeles divisions are therefore authorized to conduct the desired interviews with these individuals unless information appears in the files of those offices which would make such action undesirable at the present time.

It should be borne in mind during these interviews that any testimony showing an association between William Perl and Weldon Bruce Dayton and placing Dayton at the 65 Morton Street address would be of considerable evidentiary value in connection with the contemplated perjury prosecution against Dayton. Emphasis should therefore be placed upon developing such information at the time of these interviews.

It is desired that any information of value to the Dayton perjury prosecution should be properly reported in the Dayton case, as well as in instant matter.

Miss MARY MC LEOD, 2307 Lyons Avenue, New York 61, New York, was interviewed by SAS Richard T. Hradsky and Robert F. Royal on October 15, 1951.

Miss MC LEOD advised that she is currently employed as a Secretary, Industrial Engineering Department, Columbia University, New York City. She indicated that she was previously employed by the American Institute of Physics, 57 East 55th Street, New York City.

Miss MC LEOD stated that from April 1, 1946 until May 14, 1947 she was employed as a Departmental Secretary for the Physics Department at Cornell University. During this period she served as a secretary to both Doctor HANS A. BETHE and Doctor ROBERT F. BACHER, who were Directors of the Nuclear Studies School at Cornell University. She indicated that Doctor BACHER left Cornell University in February, 1947 to continue his work with the Atomic Energy Commission on a full time basis and that he is now at the California Institute of Technology.

Miss MC LEOD further advised that there were two safes, one in the office of Doctor BACHER and the other in the office of Doctor BETHE, at Cornell University, which were used to keep classified AEC documents. For clarity these safes will be referred to as the Number One safe, which was maintained in the office of Doctor BACHER, and the Number Two safe, which was later maintained in the office of Doctor BETHE.

She stated that this was the safe in which the very important AEC documents were maintained, and that there was a stenography notebook maintained in the safe which was used for charge-out purposes. She stated that when she came to Cornell University Doctor BACHER furnished her with the combination of the safe on a piece of paper and thereafter she committed it to memory and destroyed the piece of paper by burning it. She stated that Doctor BACHER was the only person who knew the combination of the Number One safe at that time and he must have forgotten part of the combination because he relied upon her for the memory of the combination.

Miss MC LEOD stated that she passed this combination on to JEAN TOWER (Mrs. STEPHEN NELSON TOWER) in February, 1947. Miss MC LEOD indicated that JEAN TOWER had become her assistant and she later succeeded her as Departmental Secretary. She explained that she passed this combination in writing to JEAN TOWER and advised her that she should commit the combination to memory and thereafter burn the piece of paper on which the combination had been recorded. She further advised that JEAN TOWER had joined the Departmental Secretarial staff in either September or October, 1946.

Miss MC LEOD stated that upon Doctor BACHER'S departure he furnished the combination to the Number One safe to Doctor ROBERT WILSON, who was Doctor BACHER'S successor as one of the Directors of the Nucleur Studies Laboratory at Cornell University.

Miss MC LEOD further advised that Doctor RICHARD FEYMAN would keep some of his confidential materials in the Number One safe; however, on any occasion which he might desire these materials she would remove them for him and after he had completed the use of the materials she would return them to the safe. She advised that the only

other person who would keep anything in the Number One safe was EMILY MORRISON, who is the wife of Doctor PHILLIP MORRISON. She stated that EMILY MORRISON, who is a bacteriologist and a writer by profession, had had the job of historian or some similar titled position at Los Alamos and Miss MC LEOD recalled that during the period she was employed as Departmental Secretary a special courier came from Los Alamos and delivered to EMILY MORRISON a quantity of classified material which was allegedly to be used as a continuation of the position which EMILY MORRISON had formerly held at Los Alamos. She stated that EMILY MORRISON gave her this package of documents for safekeeping in the Number One safe. She indicated that EMILY MORRISON would from time to time come to her and request these documents and thereafter she would remove them from the Number One safe and EMILY MORRISON would usually take them to the office of her husband, which was approximately 150 feet or so down the hall from Doctor BACHER'S office, where the Number One safe was kept.

Miss MC LEOD stated that EMILY MORRISON would subsequently return the documents to her to be replaced in the safe; however, she stated that there was no accounting of these documents and she never knew the exact number of documents which were maintained in this package.

Concerning the Number Two safe, Miss MC LEOD furnished the following information:

She stated that this safe was obtained during the winter of 1946 to hold classified materials which were sent from Los Alamos to Doctor BETHE. She explained that Doctor BETHE was on a committee which reviewed materials in order to decide whether they should be declassified. She stated that there were considerable classified documents sent to Doctor BETHE by Registered Mail from Los Alamos.

She believed that one ROBERT DAVIS was employed at Los Alamos and that he would receive the documents upon declassification, from this committee. She indicated that there was no charge-out record kept in this safe while she was employed as Departmental Secretary.

Concerning the combination for this safe, she stated that upon obtaining the safe, which was Government property as was the Number One safe, Doctor BACHER set the combination and recorded it on a piece of paper for her to commit to memory and thereafter this piece of paper was burned. She stated that she passed this combination on to JEAN TOWER in February, 1947 and she does not recall that anyone else other than Doctor BACHER, JEAN TOWER and herself knew this combination.

Miss MC LEOD furnished the following information pertaining to NEPA:

She stated that Doctor BETHE, Doctor BACHER and CHARLES BAKER, a research assistant at Cornell University, were all consultants to the NEPA Project. She stated that BAKER had formerly been connected with the Los Alamos Atomic Energy Project, as were Doctors BETHE and BACHER. She recalled that all three of these men had on various occasions made separate trips to New York City to see a Mr. LAMBERT(?), who was President of the Fairchild Airplane and Engine Corporation, with offices at Rockefeller Plaza, New York City. She indicated that this individual would on occasions come to Ithaca, New York via his private plane, to consult with Doctors BETHE, BACHER and BAKER. She recalled taking dictation on the early stages of the NEPA Project for Doctors BETHE and BACHER, copies of which were maintained in the Number One safe. She stated that these letters were sent Registered Mail.

Miss MC LEOD stated she could not recall any progress

reports during the period she was employed as Departmental Secretary, and stated that "The NEPA Project from the outset was considered to be something fantastic and was just a matter which you might joke about." She stated she had later learned that the idea of NEPA had considerable merit and it is her understanding that today it is or will be a successful venture.

Miss MC LEOD identified various photographs of Doctor WELDON BRUCE DAYTON as an individual who was either a graduate student or a graduate assistant in the Physics Department during the period she was at Cornell University. She stated she possibly had met CAROL DAYTON, the wife of Doctor DAYTON, and she would call for DAYTON at Rockefeller Hall. She indicated that Rockefeller Hall housed the Physics Department and the Laboratory at Cornell University.

Miss MC LEOD stated that DAYTON did not work directly under Doctor BETHE; however, she stated the Graduate School was a well knit, close organization and almost everyone in the Department was known to everybody else. She stated they often attended socials and receptions at various Faculty members' homes and they had ample opportunity to become known to one another. She stated that DAYTON, to her knowledge, did not have access to either the Number One or Number Two safes aforementioned and she has no knowledge that DAYTON may have had any access to materials which Doctor BETHE maintained.

Concerning WILLIAM PERL, Miss MC LEOD failed to identify various photographs of him which were exhibited to her; however, she stated that she recalled reading about his arrest in the New York newspapers. She stated it was very hazy in her mind; however, she cannot definitely place where, but there was something about PERL or PERLE in Doctor BETHE'S papers. She stated it was possible that Doctor BETHE had corresponded with someone by the name of PERL.

Photographs of ALFRED SARANT, LOUISE SARANT, MAXWELL FINESTONE and various other individuals connected with the ROSENBERG Espionage group were exhibited to Miss MC LEOD without effecting identifications.

Miss MC LEOD telephonically contacted the New York Office on October 16, 1951 and advised SA Robert F. Royal that Doctor BETHE may have obtained the combination for the Number Two safe at the time she furnished the combination to JEAN TOWER. She stated that Doctor BETHE had access to this safe inasmuch as it was in his office and he would help himself in obtaining documents from this safe. She also advised that at the time Doctor BACHER furnished her with the combination of the Number One safe he reset the combination, and there is a question in her mind as to whether at the time he physically passed the safe on to Doctor WILSON that he passed on the combination of this safe to Doctor WILSON. She stated Doctor WILSON was reluctant to accept the responsibility of the Number One safe and this accounts for question in her mind as to whether he actually received the combination from Doctor BACHER.

Miss MC LEOD also advised that Doctor BACHER filed the necessary forms for her to obtain clearance to handle the classified documents in the Number One safe at the time of her employment in April, 1946. She stated she does not know whether she ever received any clearance inasmuch as there was no apparent investigation conducted pertaining to her clearance. In this connection she also advised that she had no knowledge of whether JEAN TOWER had clearance to handle classified documents.

The Indices of the New York Office fail to reflect any references believed to be identical with Miss MC LEOD.

Copies of this letter are being furnished to the Buffalo and Pittsburgh Offices for information inasmuch as they are currently conducting investigation pertaining to requests made in relet dated 9/28/51.
