It was Ers. LESLIE's first opinion that perhaps this was the occasion of her meeting SARANT. However, when the words "Greenwich Village" were mentioned, Ers. LESLIE recalled SARANT and furnished the following information concerning him:





Informant advised that telephone service at the ROSS cottage (where LOUISE SARANT resided during the summer) was temporarily suspended on October 6, 1955. According to this informant, on September 15, 1955, Mrs. EDNA DOROTHY, 3017 5th Avenue, Sacramento, California, telephone HIL 5-7653, was contacted from the cottage phone. (It is noted that Mrs. DOROTHY is the mother of CAROL DAYTON who fled the country with ALFRED SARANT in 1950.) On the same date, a telephone sall was also made from this telephone to Corning, New York, telephone 69696.

Informant further advised that GEORGE SARANT, Telephone Freeport 9-2801 (Freeport, Long Island) was contacted from the ROSS residence phone on September 19, 26, and 28, 1955. (GEORGE SARANT is the brother of ALFRED SARANT.)

On September 30, 1955, a call was made to the ROSS office phone by Mrs. ROSS from Freeport Telephone FRE 9-2801. On October 1, 1955, Mrs. ROSS called from New York City, telephone

### Interview with VICTOR K.D. ROSS

In above-referred to interview with VICTOR K.D. ROSS, he advised that no information has been received by him or any other member of the family concerning the present whereabouts of ALFRED SARANT or CAROL DAYTON. He stated that no one has any idea of where he might be, and that he has never contacted or attempted to contact LOUISE SARANT since his disappearance.

ROSS further advised BRUCE DAYTON has obtained a divorce from CAROL DAYTON and that Mrs. EDNA DOROTHY came east this summer for the purpose of assisting ETUCE DAYTON in the disposal of the DAYTON residence on the Cayuga Hieghts Road in Ithaca. According to ROSS, at the time that BRUCE and CAROL DAYTON were constructing this house, Mrs. DOROTHY advanced them \$8,000. Her purpose in coming east was to change ownership of the residence to her and BRUCE DAYTON, so that the property could be disposed of.

ROSS advised that he conversed with Mrs. DOROTHY concerning ALFRED SARANT, and CAROL DAYTON and that she told him that she has had absolutely no contact from CAROL DAYTON since her disappearance, and she strongly indicated that she has no idea of her present whereabouts.

T-2 said that aside from the trip in 1952 and the trip in 1954, he knew nothing concerning the activities of SCHULER away from his employment.

DONALD WARING, Personnel Supervisor, caused the payroll records to be checked, which indicated the company has no record of any time SCHULER may have been away from his employment during 1953 and 1954. The records indicate he received full pay for the year. The Payroll Department has no knowledge of vacation periods for this period. The payroll records do reflect only a vacation period from September 11 to September 17, 1955, however, Nr. WARING advises employees earn two weeks' vacation per year.

Records of the Corning Credit Rating Bureau reflect FREDERICK SCHULER has satisfactory credit relations in Corning, N. Y.



Mr. HARRY BROWN, 16851 Fenmore, Detroit, formerly substitute Instructor in English at Wayne University, Detroit, made available to the Detroit Office on January 27, 1950, a theme dated January 14, 1935, which had been written by ELSIE BEDERIN captioned "My First Semester In College." There are numerous passages in the theme which Mr. BROWN felt followed the Communist Party line. The Communist Party, USA is an organization which has been cited by the Attorney General as "falling within the purview of Executive Order 10450. The theme written by ELSIE BEDERIN is being retained in the files of the Detroit Office.

Mrs. ABRAHAM BLUM. 2476 Waverly, Detroit, advised that no one in the neighborhood is closely acquainted with the BEDERIN family. She stated that when the father, LOUIS BEDERIN, died in the summer of 1955, the daughters did come to Detroit from New York City. Mrs. BLUM said there are two sons, MORRIS and OSCAR, residing with Mrs. BEDERIN at 2468 Waverly at the present time.

Mr. DAVID WEXLER, 2482 Waverly, stated he had formerly been employed with LOUIS BEDERIN, years ago, but stated he knew nothing of the BEDERIN family except that there were two daughters of the family residing in New York City.

Mrs. HERMAN SHAPIRO, 2464 Waverly, Detroit; stated she has lived at this address for nineteen years. She stated that she has known the family slightly for a number of years. She stated that there are two pons who reside at 2468 Waverly, and two daughters who reside in New York City. Mrs. SHAPIRO stated both daughters were in Detroit last summer at the time of their father's funeral. Mrs. SHAPIRO stated she did not know the address of the daughters in New York City.

Mrs. CHARLES ABLECOP, 2477 Waverly, stated the BEDERINs had two daughters residing in New York City who came to Detroit last summer to attend their father's funeral.

Mrs. LOUIS BEDERIN was contacted under appropriate pretext to obtain ELSIE BEDERIN's address in New York with negative results.

The record further reflects that as of June 5, 1941, LOUIS BEDERIN's wife, ANNA, 1609 Gladstone Avenue, Detroit, was 54 years of age and had four children and formerly resided at 2014 Blaine, and 17544 Brush Street, Detroit.

Mr. FLOYD B. SHANNON, Superintendent of Industrial Relations, Western Electric Company, Kearny, New Jersey, was contacted during August, 1950, by SA JAMES H. HIGDON, JR., in an effort to establish the identity of LITTITZ. After a review of the indices of past and present employees in the New York metropolitan area, which includes New Jersey, Mr. SHANNON stated that he could locate no record of any person by the name of LITTITZ.


HARVEY LEE SACHS telephonically contacted SA ROBERT W. LAKE, JR., on March 21, 1955, and advised that he had come upon certain letters he had written to BENJAMIN LEWIS, a personal friend, in 1946. SACHS advised that in his opinion these letters explained the circumstances surrounding his association with ALFRED SARANT in 1946.

SACHS voluntarily appeared at the New York Office on March 22, 1955, and was interviewed by SAs ROBERT W. LAKE, JR., and ROBERT EDWIN TAYLOR. SACHS advised that he was residing at his new home, 1158 Achley Drive, Valley Stream, Long Island, New York. SACHS advised that he was unemployed and had been so unemployed since December, 1954, when his employment with Shaw Television Company, 195 Front Street, Brooklyn, New York, was terminated with the close of business there. SACHS advised that he was visited a couple of weeks previous by BENJAMIN LEWIS, an old friend of his with whom he had once resided and with whom he has since corresponded.

SACHS stated that he and LEWIS were talking over various matters and the subject of SACHS' association with ALFRED SARANT in 1946 was brought up. SACHS stated that LEWIS produced personal letters he had received from SACHS in 1946. These letters referred to SACHS! association with SARANT in 1946. According to these letters written by SACHS to LEWIS, SACHS had told LEWIS that he had been visited by SARANT at SACHS' father-in-law's residence, 200 West 54th Street, New York City, approximately March, SACHS stated that this visit was about March, 1946, because these letters to LEWIS were dated March 29, 1946, April 14, 1956, and April 19, 1946. SACHS stated that the visit had been preceded by a telephone call from SARANT. Si.CHS stated that he previously had been unable to explain how SARANT knew to call him at SACHS' father-in-law's residence, where he was at the time of the call. stated that he has since found out that prior to the telephone call, SARANT had run into his brother, SYLVAN SACHS, somewhere on Broadway in New York City, and had inquired as to his whereabouts. SARANT gave SYLVAN SACHS his address and telephone number, which in turn was given to HARVEY SACHS by his brother. It was then that SARANT and HARVEY SACHS were able to get together. SacHS stated that this explained how SARANT knew to call him at his father-in-law's. SACHS stated that since he had not been in touch with SARANT in a long while it had puzzled him SARANT knew where to call him.

SARANT advised that approximately two weeks after the aforementioned visit by SARANT, SACHS and his wife visited SARANT at SARANT'S apartment. SACHS stated that this was the only visit be made.

Benjamin Green Could Could Take The September, 1941, to September, 1942, he rented a furnished house with BENJAMINADEWIS and HARVEY SACHS at 590 Russell ivenue, Long Branch, New Jersey. LEWIS and SACHS were at that time employed at Fort Monmouth, New Jersey, and formerly were classmate of SARANT at Cooper Union Institute of Technology.



When interviewed by Bureau Agents in 1952, FRED JOSEPHAKITTY, former co-worker of SACHS at United States Signal Corps, Fort Monmouth, New Jersey, advised that he gained the impression when talking to SACHS that SACHS had been a member of the Young Communist League. KITTY could not provide specific dates of SACHS' attendance at any Young Communist League meetings.

The Young Communist League has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

In an interview with Bureau Agents during 1952, KITTY admitted membership in the International Workers Order during the period 1936 to 1938, and the Young Communist League during the period 1939 to 1941.

The International Workers Order has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

During an interview with MRON COLEMAN by Bureau agents, prior to 1953, COLEMAN stated that HARVEY LEE SACHS started to work for him at Camp Evans Signal Corps Laboratory soon after World War II began. COLEMAN stated that soon after meeting SACHS he had a discussion with him concerning world affairs, in which SACHS defended the Hitler-Stalin Pact, saying that Finland had attacked Russia.

About August, 1950, Mrs. BARSKY advised SA CHARLES D. VANCE that she was formerly employed by the United States Army Signal Corps at Fort Monmouth, New Jersey. Mrs. BARSKY stated that she was acquainted with ALFRED SARANT but was unable to furnish any information concerning SARANT'S activities.

Unless advised to the contrary by the Bureau or the Albany Office, no further investigation concerning ALICE KATZ will be conducted.

ALFRED and LOUISE SARANT have advised that they do not know this individual.

GAVIN made a surprise visit to the residence of RUTH PRAGO, Apartment 2 E, 105-37 64th Avenue, Forest Hills 75, New York, for the purpose of interviewing her to determine the extent of her relationship and the nature of her contacts with ALFRED and LOUISE SARANT.


ALBERT RRAGO, husband of RUTH PRAGO, answered the doorbell ring and agents asked if they could speak with Mrs. PRAGO. Mr. PRAGO asked who wished to speak with her and when the agents identified themselves, Mr. PRAGO, without saying another word, immediately slammed the door.

In view of the above, unless advised to the contrary by the Bureau, no further attempt to interview RUTH PRAGO concerning the SARANTS will be made.

#### HARVEY LEE SACHS

HARVEY LEE SACHS, during the interview with SAs LAKE and TAYLOR on March 22, 1955, exhibited the three letters he had written to BENJAMIN LEWIS in 1946, and advised Agents that he did not want them to make copies. SARANT stated that the letters contained some obscene passages which might cause him embarrassment. These-letters were reviewed by SAS LAKE and TAYLOR and were found to contain information regarding the visit to SACHSIBY SARANT and the visit to SARANT by SACHS.

HARVEY LEE SACHS, Plant Manager, Shaw Television Company, 195 Front Street, Brooklyn, New York, was interviewed by SA ROBERT F. ROYAL on August 25, 1952, for information concerning SARANT. The results of this interview are contained in the report of SA ROBERT F. ROYAL, New York, November 17, 1952, entitled "ALFRED EPAMINONDAS SARANT was, ET AL, ESPIONAGE - R."

HARVEY LEE SACHS was interviewed on January 4 and January 5, 1954, by SAS ROYAL and LAKE, at which time he furnished additional information concerning SARANT (report of SA ROYAL, New York, February 10, 1954, entitled "ALFRED EPAMINONDAS SARANT, was, ET AL, ESPIONAGE - R."

Re: Bulet to New York, dated 1/3/56, under second caption above, which sets forth a program with respect to individuals currently included in the Missing Section of the Security Index in an effort to attain penetration of the CP underground.

It is noted that instant subject is the subject of an Espionage investigation, and not a Security investigation. Subject fled the United States in 1950, into Mexico. Extensive investigation has been conducted since that time in an effort to locate him with negative results, although JULIUS ROSENBERG indicated that he had gone to Europe. No information has been developed indicating that he has ever been in the United States since his departure, and appropriate border stops are outstanding against him.

Subject was added to the Security Index of this Office, based upon his espionage activity, and his Security Index card was placed in the Missing Section of the Index because his exact foreign whereabouts was not known.

The Bureau is requested to advise if SARANT should be considered as a Missing Subject under this program or whether his Security Index Card should be transferred from the Missing Section to the Out of the Country Section of the Security Index.

There is attached one copy of the report of SA Loren E. Bidwell made at Burralo 2-29-56 in instant case. Investigation has developed that on August 3, 1955, a telephone call was placed from the home of Louise Sarent; subject's ex-wife, at Ithaca, New York, to one Frederick Schuler, Madison, Wisconsin. It was determined Frederick Schuler is a high school teacher at Madison and has a son, Frederic Schuler, born April 2, 1923. Frederic has been employed at Corning Glass Works, Buffalo, New York, since 1953 and prior to that time was employed at National Research Corporation, Cambridge, Massachusetts, where held a secret clearance although he was not engaged in secret or classified research.

Investigation conducted at Buffalo indicates Schuler is quite friendly with Weldon Bruce Dayton whose ex-wife fled from the U.S. in August, 1950, with Sarant. In the englosed report it is reflected that Schuler's wife was born in Milan, Italy, and had lived the major portion of her life in Switzerland until she came to the U.S. in 1953. This report also indicates schuler made a trip to Europe in 1955 and furnished as her address abroad the following: 23 Dufourstrasse, Lucerne, Ewitzerland.
