Dear Sir:

Reference is made to your letter dated August 7, 1946 in which you advised that the State Department had informed you that ANATOLI ANTONOVICH YAKOVLEV had been appointed to the position of Vice-Consul at the New York Consulate. As you pointed out this undoubtedly refers to ANATOLI ANTONOVICH YAKOVLEV. You requested to be advised if this office had any information indicating that YAKOVLEV had been elevated to the position of Vice-Consul.

This office has learned through [REDACTED] ⁶² to the Bureau, that following his return to the United States by plane from Moscow on July 26, 1946, YAKOVLEV reportedly was to be given a higher position in the New York Consulate. It is also noted that upon his re-entry, he informed the United States Immigration Authorities that he was the Assistant Consul General at the U.S.S.R. Consulate in New York City.

You will recall that during February, 1945, Ranson was in contact with Anatoli Yakovlev, an employee of the Soviet Consulate General in New York City who has been tentatively identified as a Soviet agent operating as a representative of NEVD. In this connection your attention is directed to the report of Special Agent Robert E. Dowd dated February 25, 1946, at Des Moines, Iowa, entitled "Sodac - New York City." Specific attention is directed to paragraph 3, page 3 of this report, where it is stated that Ranson is the subject of an Internal Security - R case in your office.

The Bureau files fail to reflect any main file on Ranson. Consequently, it is desired that all information presently available to you concerning Ranson be incorporated in a report which should be submitted to the Bureau within the near future.

Reference is made to the teletype from the New York Field Division, dated September 30, 1946, in the above captioned case.

It has been ascertained that the telephone number Market 0406 is listed to Mr. MARIAN SCHULTZ, 202 Poplar Street, Philadelphia, Pa.

The files of the Philadelphia Field Division reflect that SCHULTZ was born, either on November 30, 1910, or October 30, 1910, in Russia. He claims to be a citizen by virtue of the naturalization of his mother, ROSY KOBIERSKI, who was naturalized on March 5, 1929, Certificate No. 3031975.

SYNOPSIS OF FACTS: RANSOM, an editorial writer, Des Moines Register & Tribune, was born 11-29-09, at Somerville, Mass. Graduated from Tufts College and Fletcher School of Law. He is registered with LDB 3, Des Moines and is classified 4-A. He is a liberal thinker and active in Civil Liberties Union in Iowa. He was in company of ANATOLI YAKOVLEV, Clerk of Soviet Consulate, NYC, when latter made a speech before National Farm Institute on Febr. 15 and 16, 1946. No evidence RANSOM member of C.P.

DETAILS: This investigation is predicated upon receipt of a request from the Bureau that information in possession of the Des Moines Office be supplied, as no previous information is in the possession of the Bureau concerning CHARLES FOSTER RANSOM.

A review of the Des Moines file reflects that subject first came to the attention of the Des Moines Office through a memorandum dated December 12, 1940, submitted by Chief Clerk I. S. OLSEN, which reflected that Mr. PAUL A. BROWN, Assistant Postmaster, Des Moines, Iowa, telephonically advised that RANSOM was unusually interested in Communist matters; that he resided at 4115 Walker Street, Des Moines, Iowa, and that he, BROWN, believed it would be advisable for an agent to call upon him.

A memorandum submitted by reporting agent on January 9, 1941, reflects that [redacted] Avenue, had called Mr. BROWN'S attention to a large number of cards which had been sent out by CHARLES RANSOM, and that mucrous replies

had been coming in for a period of several weeks. It was ascertained that RANSOM is an officer of the Iowa Civil Liberties Union, and that the nature of the cards was to the effect that the persons to whom they had been addressed had been asked if they wished to be placed on the mailing list of this particular organization. At that time RANSOM was employed as an editorial writer for the Des Moines Register & Tribune Newspaper. RANSOM had formerly resided at 920 27th Street, but had now moved to 4115 Welker Avenue.

Again, a memorandum by the writer dated April 13, 1941, reflected that in a report of former Special Agent T. W. LAWSEY, Washington, D. C., dated March 10, 1941, in the case entitled "National Federation for Constitutional Liberties - Internal Security R," that on Page 74 of that report appears the name of CHARLES F. RANSOM.

In another memorandum by the writer, dated June 27, 1941, it was noted in the report of Special Agent J. A. CARLSON, Kansas City, Missouri, dated June 11, 1946, in the case entitled, "American Peace Mobilization - Internal Security R," from a notebook which was taken by the Kansas City Police Department from a ROBERT WOOD, an avowed Communist from Oklahoma City, it was noted that those mentioned in the notebook included the name of CHARLES F. RANSOM, 4115 Welker Avenue, Des Moines, Iowa.

In a memorandum of Special Agent ROBERT E. DOWD, dated March 5, 1946, based upon an investigation conducted in the case entitled "Sodac, New York City - Internal Security R," it is noted that it developed that one ANATOLI YAKOVLEV, Clerk of the Soviet Consulate, New York City, was scheduled to arrive in Des Moines, Iowa, on February 14, 1946; further, that YAKOVLEV had recently been contacted by a known NKVD agent in Philadelphia, Pennsylvania. It was noted that CHARLES RANSOM met YAKOVLEV at the train and was seen in his company at the National Farm Institute at the Hotel Fort Des Moines, Des Moines, Iowa, which was in session on February 15 and 16, 1946, and that RANSOM escorted YAKOVLEV to the train when he departed at 11:30 p.m. on February 16, 1946. The other person who met YAKOVLEV with RANSOM was JAMES WALLACE, who is the son of Secretary of Commerce HENRY WALLACE, and who is Secretary and Treasurer of the Pioneer Hybrid Seed Corn Company, Des Moines, Iowa. WALLACE resides at 5310 Grand Avenue, Des Moines, and is a member of the American Legion Post No. 60.

Agent DOWD, in his memorandum, indicates he contacted Mr. ARTHUR BRAYTON, Secretary of the Convention Bureau of the Chamber of Commerce, Des Moines, Iowa. He also contacted Miss ELECTA FLICK, also of the Convention Bureau of the Chamber of Commerce, who indicated she had attended one of the sessions of the National Farm Institute, and that an individual who was an editorial writer for the Des Moines Register & Tribune, during a conversation with YAKOVLEV, told him he was greatly interested in Russia and at the present time was studying the Russian language.

An editorial appearing in the Des Moines Tribune on February 29, 1946, entitled, "You can Hear Anything About Those Russians," is an editorial highly favorable to the Soviet. It is not known, but presumably it was written by RANSOM.

In commenting on a legend that Soviet officials in this country had a rule against any of them ever opening their mouths in public, the editorial writer commented, after YAKOVLEV had made his speech at the convention, that he had asked Mr. YAKOVLEV about the rule, at which time YAKOVLEV said there was not such a rule. The comment of the editorial writer is, "So, lots of things people 'know' about Soviet Russia, aren't so." The whole tenor of the editorial is highly favorable toward the Soviet.

A memorandum in the file dated June 13, 1946, by the writer, discloses the following information:

RANSOM is registered with Local Draft Board No. 3, Des Moines, Iowa, and a check of his file discloses that he was born on November 29, 1909, at Somerville, Massachusetts. His wife is CATHRYN OWEN RANSOM, who was born in Marshalltown, Iowa. RANSOM is employed by the Register & Tribune as an Editorial Writer, and has been so employed since September 6, 1937. He took his B.A. Degree at Tufts College in 1931, and his MA. from the John Fletcher School of Law. He has taught History and Political Science at Tufts and at Drake University in Des Moines. His Social Security Number is 475-05-3038. He also indicated that he operated puppet shows for about ten years. His family physicians are MAURICE RUTHKOW and W. W. HANSEL, both of Des Moines, Iowa. He was married on June 25, 1938. He is not eligible for Army service because he shows a history of Tuberculosis. He was classified 4-A on October 31, 1945. His file reflects that his wife at one time had been Society Editor for the Register & Tribune and that her Social Security Number is 482-07-7246.

A review of the file, as well as interview with [redacted] whose identity is known to the Bureau, fails to disclose any information which would indicate that RANSOM is a member of the Communist Party or has any such connections. It would appear that the subject is a liberal thinker belonging to the category of those individuals interested in the Civil Liberties Union. It is known that he has been on the staff of the Register & Tribune under W. W. WAYMACK who is considered a liberal, if not radical, editorial writer for the Register and Tribune. b7d

In a book review section of the Des Moines Sunday Register dated August 4, 1946, appears a review of the book entitled "The Great Globe Itself," by WILLIAM C. BULLITT. This review is by CHARLES RANSOM and as showing the attitude of subject in dealing on the subject of Russia, this review is being set forth as follows:

"The great globe is Shakspeare's (The Tempest, Act IV, scene 1) which 'shall dissolve, and ... leave not a rack behind' — just what is likely to happen if Bullitt has his way.

"Bullitt is one of that numerous host to change his mind violently about the Soviet Union, only instead of acquiring balance in the process, he moved from a moderately favorable to a violently anti position.

"He is not content with Byrnes' Get-Tough policy, he wants to organize a network of defense leagues against Russia, and use atomic bombs against any further extensions of Russian control.

"He thinks Stalin and the whole ruling Communist clique of Russia form an unscrupulous, unappeasable gang with limitless ambitions for world domination, and that the only 'mystery' about their policy is their tactical delays and retreats, and the lies they use to cover up.

"Bullitt knows a great deal more about Russia than most dopes who write hysterical books about it, and he goes way back to the 13th century Mongol invasions and Lenin's London conference of 1903 to explain Stalin. But his mission to Russia for Franklin Roosevelt is mentioned only on the title page, and his mission there for Woodrow Wilson isn't mentioned at all, nor how he came to change his mind about the possibility of doing business with the Bolsheviks.

"By selecting his facts carefully and dinging away at them, he can make a terrifyingly good case for his theory — yet his second mission to Russia covered exactly the years when Professor Nicholas Tinasheff thinks Russian Communists finally abandoned the policy of world revolution by force, and documents his Great Retreat theory even more fully than Bullitt documents his Great Conspiracy theory.

"Don't look now, but both theories are much too simple and one-way to fit the complex facts about our greatest and prickliest ally."

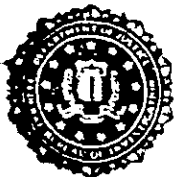

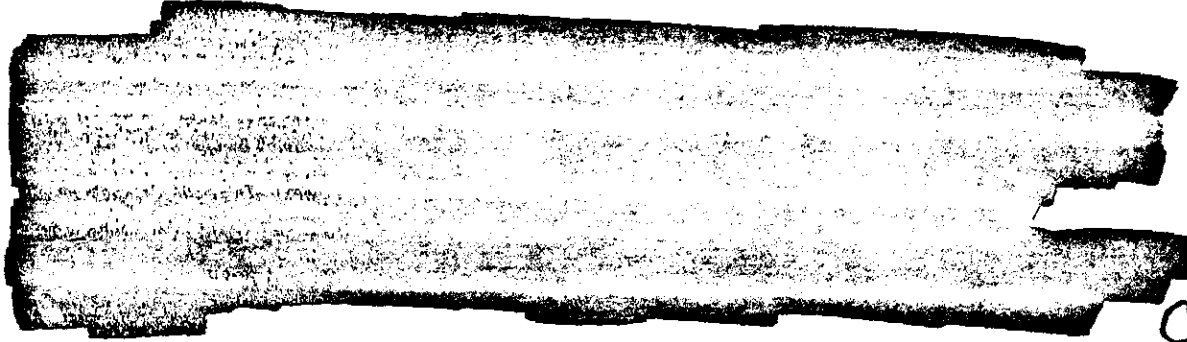

In 1944 and 1945, he worked with HARRY GOLD and accepted espionage material from him for the Soviets. GOLD has identified him as "JOHN", his Russian superior in espionage.

Why Columnists Go Nuts

The following letter, verbatim, signed by a man and with a Manhattan address given, is herewith presented to our readership:

"As we all know, we are living in an Electronic Age. So it is only natural that someone would come up with an Electronic Racket. And here it is.

"For years I have been tortured and controlled by some smart scientific people with some sort of a death ray—a powerful invisible remote-controlled ray of electricity. It paralyzes, cripples, burns and causes terrific pain when it hits you and will destroy or ruin anything it hits, like flying saucers.

"I don't know where it comes from nor can I find anyone who can help me in any way. This ray has made my life a living hell. They not only torture me day and night but control every move I make.

"If I want to go out they paralyze my legs so I can't walk. I can't work. They ruin everything I try to do. To sleep I have to take pills. Three times they wrecked my radio, two clocks, my watch. This past week they have kept the back of my neck paralyzed all day long.

"This will give you some idea of what I go through every 24 hours of the day. And if it does not stop soon they will either drive me insane or in my grave. This is what happens when the wrong kind of people get a hold of these so-called Secret Weapons and start to use them in a racket.

"Another thing—these rats could bump me off anytime and nobody would know what happened or how it was done. Can you advise me?

"P. S. Here is your perfect crime."

There is a hunt on for Anatoli H. Yakovlev, Soviet agent, indicted here recently. Pointed "information" has been circulated stating he fled back to Russia. But the U. S. authorities have reliable reports that he has slipped back into this country.

Irving Sussman's summary of interesting incidentals about the States (which I ran but for which I stated I refused to be held to account, as I had no time for checking) was dated as to South Carolina. A flood of correspondence from that State advises me that, since April, 1949, the following are grounds for divorce in S. C.—Adultery, Desertion for more than one year, Physical cruelty, Habitual Drunkenness. To institute a divorce action, a year's residence is requisite. So the law there is far more "liberal" than New York's, which recognizes only one charge, infidelity. (There will be no more round-ups of Fascinating Facts from Sussman here.)

Many ex-convicts are being thumbed down for voluntary service in the Armed Forces. Those who have run out their paroles and can prove good citizenship six months thereafter rate consideration.

The files of this Office reflect that there is a closed investigation on EUGENE IVANOV VLADIKOV, was; Internal Security - R, New York file 100-59768, in which it is reflected that VLADIKOV is an electrical engineer who first came to the attention of the F.B.I. in New York City as a Selective Service violator in 1942. VLADIKOV was later located in San Francisco, California, where it was ascertained that he had claimed false citizenship to obtain employment at the Naval Dry Dock, Hunters Point, San Francisco, in 1943.

During this investigation it was alleged that VLADIKOV had shown a great deal of interest in blueprints of radar equipment and fire control equipment on new vessels while employed by the firm of Walsh-Kaiser Company in San Francisco.

No information either substantiating or disproving the possible espionage activities of VLADIKOV was noted in the file.

This investigation resulted in VLADIKOV being sentenced to a term of one year at McNeil Island on a charge of claiming false citizenship. The file further reflected that in August of 1946, VLADIKOV was reported to be leaving the United States for Bulgaria under voluntary deportation proceedings as a result of his previous conviction.

'Guilty as Charged'

When the United States exploded the first atomic bombs in the summer of 1945, American scientists said that the basic theories involved were known to scientists everywhere in the world, including Soviet Russia. But most predicted that it would probably be the mid-Fifties before Russia, with the limitations of her technology and war-damaged industry, could make the bomb. Four years later, in September, 1949, President Truman announced: "An atomic explosion [has] taken place in the U.S.S.R." Harold C. Urey, the physicist, says it would be a good guess now that Russia has fifty atomic bombs—at a time when many scientists thought she would still be trying to make her first.

A major reason for Russia's rapid advances in atomic energy, it is now clear, was a vast and enormously effective espionage setup in the West. This spy apparatus kept the U.S.S.R. informed about the Western atomic weapons project almost from the time it was started. There is evidence

that just a month after the bomb was dropped on Nagasaki, a sketch and detailed description of it was in the hands of the Soviets.

Last week in New York three persons were convicted of participating in the spy ring that sent the information to Russia. Many details on how the ring operated were brought out in the trial, but much is still to be learned.

The chief prosecution witnesses in the case were two men who have confessed to a part in the spy apparatus—David Greenglass and Harry Gold. Greenglass was an important source of information for the ring during the war, when, as an Army sergeant, he was assigned to the Los Alamos, N. M., atomic laboratory. Gold was a courier, receiving material from Greenglass and others and passing it on to a Russian Vice Consul in New York, Anatoli Yakovlev.

ReNYlet to Bureau, 1/15/54, advising that Dr. LAWRENCE SLOBODY would be interviewed in an attempt to further identify subject's wife.

Dr. LAWRENCE B. SLOBODY, currently residing at 875 West End Avenue, with office at One East 105th Street, NYC, where he is attached to the staff of the Flower and Fifth Avenue Hospitals as a pediatrician, was interviewed 1/19, 20 and 25/54 by the writer.

By way of background, the 1950 "American Medical Directory" reflects that Dr. LAWRENCE B. SLOBODY was born in 1910. He graduated in 1936 from the New York Medical College, Flower and Fifth Avenue Hospitals, NYC. He was licensed in 1938. His speciality is pediatrics. He resided (as of the 1950 Directory) at 875 West End Avenue, with office at 239 Central Park West, NYC. He also had the position as an Associate Professor of Pediatrics at New York Medical College, Flower and Fifth Avenue Hospitals, NYC.

Dr. SLOBODY advised that he was the pediatrician for children of Russians connected with the New York Russian Consulate from approximately 1941-1945. He stated that he has no records of any of his treatments during that period and, therefore, cannot particularize further concerning the dates.

ANATOLI A. YAKOVLEV

ANASTASIA YAKOVLEV

SLOBODY identified photographs of both of the above after furnishing the information below, although he stated that the photo of ANATOLI (NY 100-81002-1B1) was not a good one as it was obviously much younger than the YAKOVLEV of 1944-1945, and the hair was not parted in the same way. He recalled the last name as being YAKOVLEV and the wife's first name as ANASTASIA. However, he did not recall the first name as being ANATOLI. Throughout the furnishing of the following information, Dr. SLOBODY gave no indication that he was aware of the importance of YAKOVLEV in the Russian espionage apparatus as has been disclosed in the newspapers.

He advised that the YAKOVLEVS impressed him more than any other Russians he met, possibly due to their actions and the authority they appeared to represent and possibly also because of the great number of times he treated their children. He advised that altogether he may have treated their children on as many as thirty different occasions. He could not recall the years covered by the period of treatments, but believed they ran from about 1943 to 1945, or early 1946.

He first treated the children when the YAKOVLEVS resided in the West 80's between Central Park West and Columbus Avenue on the south side of the street. Later they moved to the building on 109th Street west on the sixth floor, which building housed many other Russians. Their children consisted of two little twins, born about 1941 or 1942, and a third child who was older and who was a girl. He

could not recall whether the two little twins were boys or girls.

In addition to his visits to the two YAKOVLEV residences above, on occasion, the YAKOVLEVS brought their children to the SLOBODY office, which, at that time, was at 239 Central Park West. Also, on occasion, Dr. SLOBODY would see Mr. YAKOVLEV at the Russian Consulate, although he had never seen Mrs. YAKOVLEV there. He got the impression that YAKOVLEV was important and was possibly a member of the Russian "Secret Police" for the following reasons:

On the few occasions when he saw YAKOVLEV at the Consulate or possibly at the Soviet private school, the other Russians treated YAKOVLEV with respect and he acted with an air of authority. Unlike the others, when his children were even slightly sick, Dr. SLOBODY was called. Regardless of the time of day that SLOBODY visited the YAKOVLEV residence, on many occasions YAKOVLEV was there, as though he had no regular job. On one occasion when he was not there, Dr. SLOBODY commented on that fact to Mrs. YAKOVLEV and she replied that he was out of town and did a lot of traveling. YAKOVLEV gave the impression of being his own boss.

ANASTASIA YAKOVLEV spoke fairly good English, but had a definite Russian appearance. She told Dr. SLOBODY that she did translating of documents. SLOBODY did not recall any maid, housekeeper or nursemaid at either of the YAKOVLEV residences, but he stated that this did not mean that it was not possible that there was one. SLOBODY did not know the YAKOVLEVS socially and never conversed with them on anything unusual. They never requested anything unusual of SLOBODY and SLOBODY did not know of any Americans who had contact with YAKOVLEV.

In about 1945, the other Russians stopped coming to Dr. SLOBODY with their children. However, oddly enough, the YAKOVLEVS continued to have him for their children and one time he or she made the comment that they preferred him to the other doctor being used. They did not state who this individual was, however. Also, about this same time, Dr. SLOBODY raised his prices. However, the YAKOVLEVS did not seem to mind this, indicating that they were fairly prosperous.

The informant advised that he remembers both she and her husband fairly well, although his only contact with them was of a professional nature. The husband of ANASTASIA YAKOVLEV especially impressed him as a person of ability, inasmuch as he spoke excellent English, also spoke French, and possibly some German. Also his manner indicated that he was a person of some importance. Nothing unusual was ever noted by the informant concerning either of them.

Information was recently received that MRS. YAKOVLEVA was observed in New York City in February 1956, at which time she allegedly made the remark that her husband was employed by the Amtorg Trading Corporation.

You are undoubtedly aware of the fact that the subject was HARRY GOLD'S espionage superior and that a warrant is presently outstanding for his arrest. He was employed at the Soviet Consulate in New York from 1941 - 1946. His wife was employed by the Amtorg Trading Corporation in New York during approximately the same period of time and had Social Security No. 064-20-9185.

Since there is a good chance that if the YAKOVLEVS returned to the U.S. they did so under assumed names, particular attention should be given to MRS. YAKOVLEV'S account number to determine whether it has been used recently. It is noted that the arrival of the YAKOVLEVS in the U.S. may be very recent and, therefore, [redacted] may not have a record of their employment as yet. Therefore, if possible, it is suggested that a stop be placed with the informant against the names and aliases of the subject and his wife and against MRS. YAKOVLEV'S account number. If this cannot be done it is suggested that arrangements be made to check this matter with [redacted] on a weekly basis. b 2

The Bureau has instructed that the investigation to determine whether the YAKOVLEVS are in the U.S. must receive prompt attention and handling.

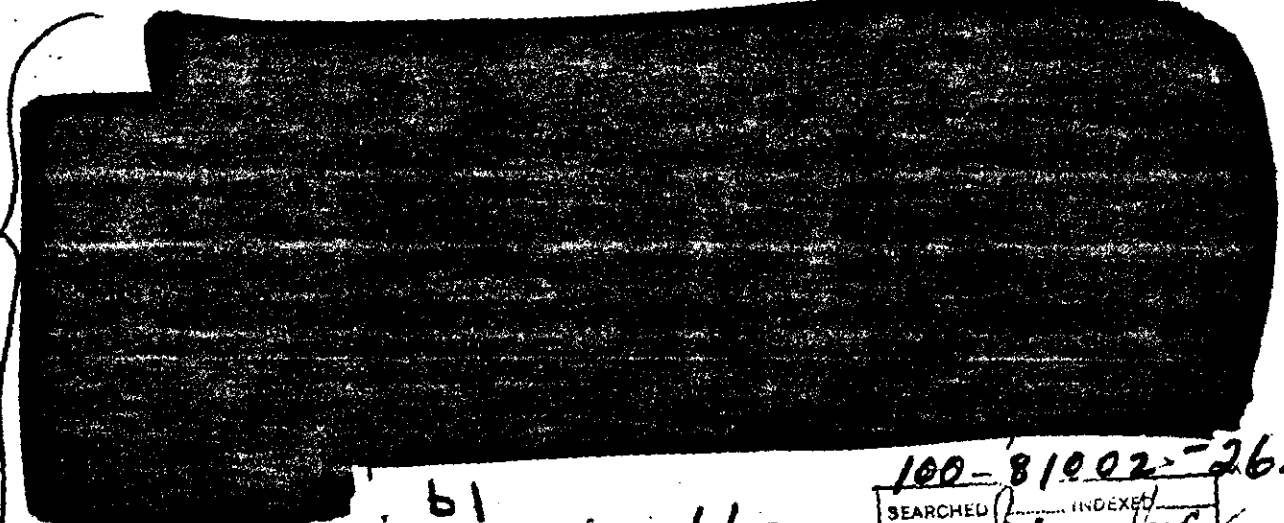

On May 2, 1956, Miss HELEN WILCOX, former teacher at Amtorg Trading Corp., telephonically advised the writer that in her present capacity as a teacher at the Latin-American Institute, 17 West 45th St., she learned from another professor, Mr. FORRESTER, that YURI D. KVASHNIN, after enrolling as a student in the class "English for Foreigners" in February, 1956, had attended only 2 classes and since then has not returned to the Latin-American Institute.

Miss WILCOX also mentioned that in February she had seen ANNASTACIA IVANOVNA YAKOVLEV at Hunter College. At this time YAKOVLEV was discussing the possibility of enrolling in a class "English for Foreigners" with Professor L. LEO TAUB. Miss WILCOX advised that she formerly knew YAKOVLEV from her association with Amtorg and spoke with her in February, 1956, regarding mutual acquaintances. WILCOX advised that this was the same YAKOVLEV whose husband was with the Consular Division in New York City.

A search of the NYO files failed to reflect any information to the effect that either ANNASTACIA IVANOVNA YAKOVLEV or her husband, ANATOLI YAKOVLEV, was presently in the United States. This search further reflected that a case file on ANATOLI YAKOVLEV was presently in a pending status and assigned to SA WALTER C. ROETTING.

SA ROETTING was immediately apprised of the above information regarding YAKOVLEV and immediate attempts to recontact Miss WILCOX and have her definitely identify a photograph of YAKOVLEV were made unsuccessfully. However, on May 7, 1956, she was recontacted and an interview was arranged for SA WALTER C. ROETTING and the writer.

Re: *Anatoli Yakovlev*

MARTIN advised that JACK SOBLE never asked her anything about her husband, JAMES MARTIN'S United States Army duties at any time, and that SOBLE never asked her to obtain any information from her husband concerning military equipment, information, nor any other thing connected with the United States Army, either during JAMES MARTIN'S tenure of duty or after his discharge. She stated that the information she furnished SOBLE was absolutely limited to Jewish affairs and concerning RICHARD LAUTERBACH. She added that to her knowledge JAMES MARTIN never furnished JACK SOBLE any information concerning the United States Army.

ALICE MARTIN further stated that she recalls only one contact with Dr. ROBERT SOBLE which took place at his office in 1946 regarding medical treatment. She stated that she did not see Dr. SOBLE after this visit to his office, nor was she ever furnished any information concerning Dr. SOBLE by JACK or MYRA SOBLE or ESTHER RAND, or by any other person. She added that at no time was she aware that Dr. ROBERT SOBLE had any relationship with the Soviet Union.

MARTIN stated that she has no personal recollection of having any contact with JACK SOBLE after early 1949. She stated that she furnished no information to JACK SOBLE after 1944 or 1945.

She stated that at no time did she ever furnish ESTHER RAND with any information which RAND was to furnish to SOBLE or any Soviet representative, and that ESTHER RAND never furnished her, MARTIN, with any information to be furnished to SOBLE for any representative of the Soviet Union. She added that ESTHER RAND never discussed with her the type information that RAND furnished JACK SOBLE, nor did RAND ever mention furnishing information to SOBLE. She stated that her last meeting with ESTHER RAND took place in the Fall of 1948 when RAND mentioned that she had returned from Europe.

MARTIN stated that to her knowledge she was never in contact with any representative of the Soviet Union other than JACK SOBLE, and that the names MIKHAIL CHALIAPIN, ANATOLI YAKOVLEV, KONSTANTIN CHABANOV, and STEPAN CHOUNDENKO, were unknown to her. MARTIN was shown photographs of the above named persons and stated she did not recognize them.

MARTIN stated that she recalled being in the law office of a person named BRODSKY whose first name she believed was JOSEPH. She stated that she thinks she was in BRODSKY's office in connection with her work for BILL LAWRENCE concerning the Abraham Lincoln Brigade. MARTIN could recall no other details concerning this visit to BRODSKY's office. She stated that this visit may have dealt with legal matters in connection with BILL LAWRENCE's work.

MARTIN stated that it was her opinion that ESTHER RAND and JESSE ZEL LURIE were acquainted. She stated ESTHER RAND may have mentioned to her that she knew LURIE due to their common interest in Jewish affairs.
