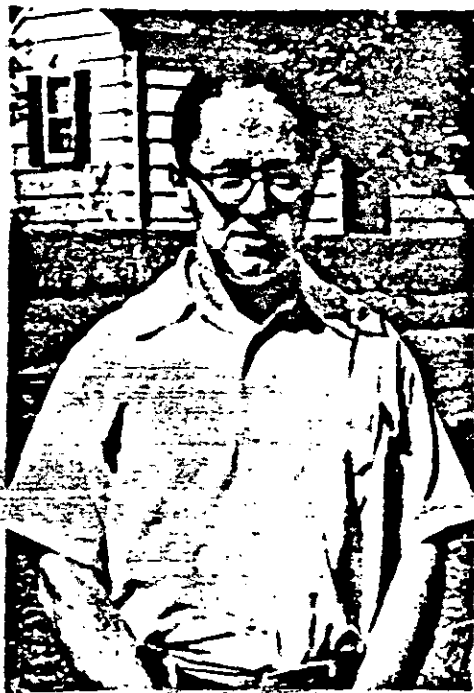

GLASSMAN, Vivian

1. Ernest J. Pataki interviewed August 1, 1950 at Federal Telecommunications Laboratories Inc., Hatley, N. J. advised he met Vivian Glassman in 1945. Pataki has dated Vivian Glassman on numerous occasions since that time and has become a close friend. Pataki could not recall telephone call from Glassman. Pataki said that he considered Vivian Glassman loyal to the United States and that she had no foreign sympathies. Pataki re-interviewed August 7, 1950 after thinking it over he recalled telephone call. He said he got a telephone call from Glassman approximately two weeks ago between July 17th and July 21, 1950 at about 7:30 P.M. The conversation was interrupted when Glassman told him a man was knocking on her door and was frightened. Pataki did not recall whether he or Glassman said to leave the phone off the hook so he could hear if there was any trouble. Pataki said Glassman opened the door, and returned to the telephone such relieved. Pataki advised visitor was a friend. Pataki spent night of August 4, 1950 with Glassman and on August 5, 1950 Pataki accompanied Glassman to Fire Island, Long Island, N. Y. there she saw Leonard Rowlin, attorney-at-law, relative to the FBI checking bar. Pataki spent the day of August 6, 1950 with Glassman. He said Glassman would not discuss with him the reason for the FBI's interest in her. It should be noted that Glassman has since married Pataki.

2. Stephen L. Javna furnished a signed statement relative to Vivian Glassman bringing Julius Rosenberg to his (Javna's) apartment at 131 East 7th Street, New York City in the Spring of 1946. Glassman introduced Rosenberg to Javna as a "friend of the family". Javna said he knew of no association between Vivian Glassman and David Greenglass.

On 4/27/54, Mr. EDWARD H. MEIER, Cashier of the National Bank of Palisades, advised that the bank was in receipt of an acknowledgment notice from New Republic, 824-26 Jefferson Place, N.W., Washington, D.C., expressing appreciation for a notification made to that publication. The notice was addressed to "HARLAN L. FARNA, care of the National Bank of Palisades". Mr. MEIER said that STEPHEN L. JAVNA maintained an account at that bank and was in all probability the individual to whom the notice was to be forwarded. He surmised that JAVNA had sent a contribution check drawn on the National Bank of Palisades and that being the only address to which an acknowledgment could be sent the New Republic undertook to send it to the bank. JAVNA, according to Mr. MEIER, had attended CCNY during the same period as JULIUS ROSENBERG, convicted espionage agent. He resides at Tenafly, N.J., and has a plant called Magnetic Devices Corp., Englewood, N.J.

Mr. MEIER expressed a desire to cooperate and he was thanked for the information made available. It is to be noted that the investigation concerning JAVNA is in a closed status and that he was interviewed by Bureau agents on 8/13/53 at which time he admitted applying for Communist Party membership, but claimed that he is not a Communist.

Re memo to SAC of SA ROBERT F.A. O'KEEFE dated April 27, 1954.

Mr. EDWARD H. MEIER, Cashier, National Bank of Palisades Park, N.J. was contacted at which time he furnished an envelope addressed to "Mr. HARLAN L. FARNA, Palisades Park Bank, Palisades Park, N.J." containing a letter reflecting information as set out in rememo.

Mr. MEIER stated that due to his familiarity with the signature of JAVNA, a customer of his bank, he had guessed that "FARNA" was identical with JAVNA.

Mr. MEIER furnished a check, for inspection, signed by subject and this agent noted that the signature is written in such a style that it could be read as "HARLAN L. FARNA".

According to Mr. MEIER, JAVNA is a very good customer of his bank, with whom he has lunched on several occasions. MEIER stated that in 1953, evidently at approximately the time the ROSENBERGS were executed, JAVNA had, during lunch, advised that he had had an apartment on the East Side, New York City, which he had rented to the ROSENBERGS, during World War II. Further, that JAVNA had stated that he had known ROSENBERG by sight, while both attended City College, New York.

Mr. MEIER also advised that JAVNA according to his records, presently owns the Magnetic Devices Corp., doing 100% government contract on sub-contract work, from Curtiss-Wright Corp. Further that he owns the Magnetix, Inc., which is engaged in consumer goods manufacturing solely.

MEIER also advised that JAVNA presently has the following assets:

MEIER further stated that JAVNA has been associated with SIDNEY COHN, a Palisades Park attorney for several years, in real estate ventures.

Reurlet 7/21/54, stating that the Subject issued a check to ROBERT DUBIN, Detroit, Michigan, in the amount of \$600.00.

The Detroit Office has no record of a ROBERT DUBIN in the city of Detroit, Michigan. However, the Detroit Office has an applicant file on ROBERT JORDAN DUBIN whose address in July 1954 was 2638 Haslett Road, East Lansing, Michigan. He has resided in East Lansing since July 1953. He formerly resided in Boston, Massachusetts or in the immediate Boston area. He is described as follows:

In November 1949 he was a member of the Tom Paine Club in Boston which was a club devoted to Marxism and Marxist theory. In 1949 and 1950 he was Secretary-Treasurer of the Massachusetts Branch of the Young Progressives of America, which the Boston Office advised was Communist dominated. In February 1950 he became Executive Director of the Young Progressives of America in the Massachusetts Division.

The Detroit Office has no information indicating that ROBERT DUBIN has an address in Detroit, either residence or mailing.

It is suggested that the Newark Division attempt to determine from either the cancelled checks or the recordax system if the bank in Newark, where the Subject does his banking, maintains such a system, at which bank in Detroit the \$600 check was cashed in order that the Detroit Office might attempt to identify the ROBERT DUBIN who was the recipient of the check.

In the absence of any other identifying information, the Detroit Office is considering this case RUC'd.

The March 30, 1954, Washington address telephone directory lists "New Republic" as occupying space at 1824 Jefferson Place, N.W.

The 1954 Washington city directory lists MICHAEL STRAIGHT as editor of "New Republic". The August 31, 1954, Washington address telephone directory does not list "New Republic" as occupying space at 1824 Jefferson Place, N.W., nor was the publication listed in the September, 1954, Washington telephone directory. MICHAEL STRAIGHT, according to the latter, resides at 6300 Greenspring Road, Alexandria, Virginia. His wife, Dr. BELINDA STRAIGHT is also listed at this address.

The files of this office, in connection with a previous investigation of STRAIGHT, reflect that in an article appearing in the "Saturday Evening Post" of 2/15/41 entitled, "Muddled Millions, Capitalistic Angels of Left-Wing Propaganda," by BENJAMIN STOLBERG, he states that the two magazines which have given the most aid and prestige to the Communists in this country are the two leading professional journals, "The Nation" and "The New Republic". He then states that the "New Republic" from 1935 until the Russo-German Pact was merely a "liberal" echo of the "New Masses." It was founded in 1914 by HERBERT CROLY with money provided by Mr. and Mrs. WILLARD D. STRAIGHT. WILLARD STRAIGHT had been in diplomatic service in the Far East. Later he represented the Morgan, Harriman and Standard Oil interests in China. On his return from the Orient he married DOROTHY WHITNEY, whose father, WILLIAM C. WHITNEY, amassed one of America's largest fortunes and

whose mother was FLORA PAYNE of the Standard Oil Payne family. After WILLARD STRAIGHT's death in 1918, his widow, now Mrs. LEONARD K. ELMHIRST, continued for a good many years to subsidize the "New Republic" to the tune of \$100,000.00 a year until she went to live in England. Thenshe established a trust fund of which the "New Republic" is a beneficiary. All together this journal has had almost \$2,500,000. of the WHITNEY fortune.

Concerning MICHAEL STRAIGHT, an anonymous source of this office in 1941 reported that the name of MICHAEL STRAIGHT appeared on the active indices of the American Peace Mobilization and The Spanish Refugee Relief Committee. The Bureau in a letter dated 3/9/42 in the STRAIGHT case, furnished information reportedly received from a highly reliable and confidential outside source. It was stated that according to the source, MICHAEL WHITNEY STRAIGHT at one time was an ardent supporter of the CP in England and was in close touch with HARRY POLLIT, engaging in active work for the CP under cover from the Cambridge University Internationalism Party. It was also stated by the source that STRAIGHT made several visits to the USSR.

Another anonymous source of this office advised MICHAEL STRAIGHT was on the official mailing list of subscribers to the "Daily Worker" in New York City, current as of 9/1/43. By memorandum dated 2/17/54, the RCMP forwarded to the Bureau Liaison representative in Ottawa, Canada, MICHAEL STRAIGHT's name which appeared on a list of U.S. subscribers to the publication, "Peace Review" a monthly organ of the Communist controlled Canadian Peace Congress.

The files of this office contained no further pertinent identifiable information concerning the "New Republic" or MICHAEL STRAIGHT.

On 11/1/57 the writer telephoned Mrs. Roy Anthony, 44 Edgewood, Tenafly, N.J. in accordance with relet. Mrs. Anthony advised that it would be alright if the agent called at her home.

Mrs. Anthony was interviewed regarding the Javna's but she could add little to that furnished in relet. She stated that Sidney Cohen and wife Estelle Cohen were moving next door to the Javnas on Edgewood Road. Cohen is a lawyer in Palisade Park and a friend of Javnas. Cohen and Steve were once in business together as Steve said that they made \$100,000 in last ten years in real estate.

Blanche Small, Carla's mother is now in Mexico City and is evidently interested in art.

Mrs. Anthony is very cooperative and appears to be a very high type person. She said she was not interested in becoming any more closely associated with the Javnas than just being neighbors. She appeared to be a somewhat suspicious person and tends to imagine Communist Fronts and etc. based on suspicion. The actions of the Javna's are possibly not what would be considered by most people to be normal and that fact and since they are evidently anti-American, would tend to make many people suspicious. Mrs. Anthony has not furnished any information which would give sufficient reason to open this investigation again. She advised she would furnish the Newark any future information she might secure.

This case should be closed administratively.

On 9/12/58 Mrs. ROY ANTHONY, 44 Edgewood Road, Tenafly, N.J. who has in the past furnished some background information regarding CARLA and STEPHEN JAVNA, who are the subjects of a closed ISR case in this office and who live across the street from the ANTHONYS, furnished the following information:

Mrs. ANTHONY's husband ROY LESLIE ANTHONY was formerly employed by the Weston Electrical Instrument Co., Newark. A short time ago, he left Weston and founded a business of his own called Mid-Eastern Electronics, 32 Commerce St., Springfield N.J. Three other individuals are in the company with him and they are WILLIAM W. HARTZ, 74 Spring Brook Rd., Springfield, N.J.; LAWRENCE OAKLEY, P.O. Box 415, Dunellen, N.J. and THOMAS A. CHABRAK, 184 Greenbrook Rd., Dunellen, N.J.

CHABRAK formerly worked in the Sales Department of Weston and Mr. ANTHONY hired him to be the sales manager of their company. Since he hired him he has endeavored to play the "Big Shot" and to try and run the company himself. In order to maintain peace in the company, Mr. ANTHONY had CHABRAK elected president as he had a small amount of money in the company.

This appointment only made CHABRAK worse and he then worked shorter hours and wanted larger expense accounts.

Mr. ANTHONY took as much as he could from CHABRAK but finally at a board of directors meeting had him removed as president. CHABRAK became very mad and sent a letter to the Board of directors of Mid-Eastern Electronics, which letter was dated 9/8/58. In this letter CHABRAK said that he was going to turn the accountant for the firm into Trenton, N.J. because of mispractice and that he wanted Mr. ANTHONY discharged because of his own admission of association with alleged Communists and he also said he would write to the FBI which

would be detrimental to the company in getting any military contracts. He accused the company of mismanagement and stated he would bring action to dissolve the corporation.

The writer also observed a ^{NOTARIZED} notorious statement signed by Mr. WILLIAM HARTZ and RAYMOND FREDENBURG as well as Mr. ANTHONY, which stated that at 9:55 a.m., 6/27/58 on the premises of the corporation that Mr. CHABRAK among other things said to Mr. ANTHONY [REDACTED] b7c

Mrs. ANTHONY stated that she would bring this to the attention of the FBI as obviously the threats by CHABRAK are unwarranted in that they never associated with any Communists to their knowledge. She stated that JAVNAS once visited the plant when CHABRAK was there and perhaps someone told CHABRAK that Mr. and Mrs. ANTHONY suspected JAVNA of having subversive tendencies. Mrs. ANTHONY stated that they have never associated with the JAVNAS and maintain only a speaking acquaintance with them and did not invite him to visit the plant.

She stated that JAVNA once offered to sign as an architect their home plans when they were first building their new home and he offered to do it at no fee which was an assistance to them at that time. She stated the JAVNAS would often come over and look at their house while it was in the process of being built and would offer suggestions, but they were never friendly with them. She said that their attitude toward the JAVNAS was reflected in the information which they previously furnished the FBI.

She stated that she wanted to go on record regarding the above information so if anything came up regarding military contracts, the facts would speak for themselves.

Mrs. MARVIN SMALL, who sounded as though she was in a highly excited and emotional state, telephonically contacted this office during the evening of September 7, 1960. Mrs. SMALL related that as an artist she also uses the professional name of SYLVIA CAREWE. She related she has been staying at 491 Commercial Street, Provincetown, Mass., but on the following morning, September 8, 1960, she was returning to New York City where she resides at 544 East 86th Street.

Mrs. SMALL stated that she is having domestic trouble with her husband, who now resides at 2175 Hudson Terrace, Fort Lee, New Jersey. Mrs. SMALL stated that on September 8, 1960 it was imperative that she be in New York City to participate in litigation against her husband. She said, however, that she was fearful of her husband and was desirous of securing protection from the FBI in order to insure that she arrived safely in New York City. She said that on that day, September 7, 1960, a salesman had been at her house asking her questions and in her opinion this individual was sent there by her husband to spy on her. She said she also believed that her car had been tampered with and for this reason she was afraid to drive in it to New York City. It was pointed out to Mrs. SMALL that this service could not assist her in this regard. When it was suggested that she contact the Provincetown Police, she contended that they gave her no satisfaction after having been over to see her.

Mrs. SMALL went on to say that in the past while in New York City, she felt her telephone was tapped, also that she had received telephone calls threatening her and her young son, JOHN. Mrs. SMALL said she believed her husband was also responsible for these incidents, and

Due to the file destruction moratorium then in effect, that Court Order was not brought to your attention in 1975. Due to the continuing litigation and current discussion regarding reinstitution of a file destruction program in the near future, you are hereby being advised of the Order of the Court in this matter. Accordingly, no files maintained in your office (origin or auxiliary office) relating to any of the main subjects or individuals appearing on the Government's Witness List should be destroyed. These files must be maintained until further notice.

To insure that no files are destroyed concerning this Court Order, you should immediately prepare a search slip on all of the names mentioned in all of the referenced communications (including all serial references) and place a copy of this communication as the top serial in each of the applicable files. A stamp should be placed on this serial to read "THIS FILE IS NOT TO BE DESTROYED UNLESS ADVISED BY THE BUREAU KEEP AS TOP SERIAL."
