

Security Office did not contain forms showing travel made by him. However, a file in the Security Office captioned, "Completed Vacations - Tech Area" reflected that L. W. ALVAREZ had traveled to Chicago, Illinois, and Rochester, Minnesota, between December 18, 1944, and January 4, 1945. This accounts for the fifteen days annual leave in December, 1944, reflected in the University of California leave records.

the University of California further reflect that ALVAREZ made an official trip to Washington, New York, and Boston in February, 1945. He left Los Alamos at 2:00 P.M. on February 13, 1945, and flew from Albuquerque, New Mexico, to Washington, D. C. On February 14, 1945, he traveled from Washington to New York City by rail and on the same date from New York City to Boston by rail. He claimed taxi fare to Harvard on February 15, 1945. On February 17, 1945, he traveled by rail to Chicago, Illinois, and on to Lamy, New Mexico. He arrived at Los Alamos, New Mexico, at 4:00 p.M., February 19, 1945.

Referenced letter from San Francisco reflects
that the middle name of ALVAREZ on his birth certificate is
BCHMELL. A PSO completed by LUIS WALTER ALVAREZ, which is undated
reflects that he was born at San Francisco, California, on June
13, 1911. His mother's name is shown as HARRIET SXALVAREZ. Since
ALVAREZ is a Spanish name and as he was born in San Francisco,
California, it would not be unusual for his mother's maiden name
to be listed as his middle name. If SCHMELL is his mother's
maiden name, it would not be unusual for him to be called by that
name, in view of his apparent Spanish ancestry, especially if it
were not desired that his true identity be known to others.

The Security Office file concerning ALVAREZ contained the following teletypes which might be pertinent to this investigation. On November 15, no year shown, but believed to be 1944 as this was the only November that ALVAREZ was at Los Alamos, a teletype was sent from Los Alamos to USEO, Berkeley, California, which read as follows:

Alamos which would indicate the nature of this alleged censorship violation. Apparently the original information came from the installation at Berkeley, California. It might be extremely important in the event this was a telephone call. Referenced letter from the Bureau reflects that on November 14, 1944.

DN 65-671 Professor NORMAN F. WITT, Professor of Chemistry at the University of Colorado, furnished SA WILLIAM E. ROBINSON with a pamphlet on November 3, 1949. This pamphlet was distributed on the University of Colorado Campus and it announced a meeting of the Marxist Study Group for October 20, 1949, in the Arts Building. The pamphlet reflected that DAVID HAWKINS, of the Philosophy Department of the University of Colorado, was to speak on "Marxism and the Origin of Life". 143417 whose identity is known to the Bureau, obtained an official press release of the Bill of Rights Conference issued July 9, 1949, which purportedly invited the Attorney General, TOM CLARK, and J. EDGAR HOOVER to attend the conference. They would discuss the FBI as a threat to our Constitutional rights, and unlike the FBI are willing to give the accused a hearing. The "Times Union", local newspaper of Rochester, New York, (no date given) reported that before a closed Congressional Committee Dr. J. ROBERT OPPENHEIMER stated that previously he had termed BERNARD PETERS as "a dangerous man and quite Red". The article states that PETERS told the committee (House Un-American Activities Committee) that he was not and never had been a member of the Communist Party.

The Boulder Daily Camera in its edition of January 22, 1949, reported that DAVID HAWKINS was the president of the Unitarian Fellowship at Boulder, Colorado.

The Boulder Daily Camera in its edition of October 1, 1949, reported in an article concerning the Unitarians in Boulder, Colorado, that Dr. DAVID HAWKINS of the Philosophy Department of the University would give a brief talk on "The Meaning of Liberal Religion". It indicated that Dr. HAWKINS had recently returned from the University of California where he held a visiting appointment at the summer school. He is now engaged in developing a new course on "Man and the Physical World".

In the University of Colorado student publication Silver and Gold in its April 12, 1949, edition, reported concerning the United Nations week series VII, "Science and World Affairs". This article reflected that Dr. DAVID HAWKINS would discuss "The Impact of Technology on Social Change" at the round table conference on April 12, 1949. This discussion would be concerning the general problem of which atomic energy is one part, according to HAWKINS.

The Silver and Gold in its February 17, 1950, edition reported that according to DAVID HAWKINS "It is now within the range of technical possibility to destroy all life with the Hydrogen-bomb, so it is not a weapon significant to the conduct of war." According to HAWKINS the bomb is significant only as a weapon in the cold war. The necessary size of the H-bomb prohibits its use by airplanes. The cost of the bomb would be greater than the cost of the comparable power of plutonium bombs.


According to the same article, HAWKINS stated: "Present U. S. proposals for international controls could be good, but because they have not worked they must be considered no good," said HAWKINS "Widespread opinion should force the country to re-examine policy and attempt a settlement in the light of this new development, the H-bomb."

This same article reported that HAWKINS had spoken on the subject "The U. S. and World Peace" as a speaker for the Young Progressives meeting, on February 16, 1950.








It will be noted that information has been set out to the effect that ROBERT GUGENE MARSHAK was reported to have been at a party in New York in November 1944, at which time relatives of MARSHAK discussed RUSSIA, the Communist Party, and political and world affairs. It is suggested that it may have been as a result of some conversation by ROBERT E. MARSHAK at that time that might have caused. It is further pointed out that member 2. Marshak that his wife were in Albuquerque, New Mexico on December 8 and 9, 1945, and that Mrs. RUTH GUP MARSHAK made a trip to Rochester, New York and New York during the latter part of January 1945.

it is pointed out that the leave records of the university of California only reflect the number of days taken during a particular month and do not show the exact date that the employee was on leave. Therefore, where other records could not be located showing travel by the individual, there was no way to tell the exact time that an individual was on leave. Impleyees at Los Alames during the war were required to advise the Security Office when they planned to travel cutside of a 200 mile radius of Los Alames. In some instances, records have been found of travel to Santa Fe and Albuquerque, however, that any individuals who traveled to Santa Fe and Albuquerque, especially when they did not plan to contact anyone in particular in these cities, did not advise the Security Office of such travel.

Employees at Les Alames during the war worked a six day week and were allowed one shopping day each month, for which they would not charge leave. It appears from an examination of the University records that employees U.


were allowed to save up the shopping days and take several at one time. It is therefore believed that an individual may have been away from work for a week, but that he was charged only two or three days leave, the other days being due him as shopping days.

METAGER and BILCHER have advised that all consorship records maintained by the Army concerning telephone calls and mail were destroyed at the time the Atomic Energy Commission was astablished. It has been observed, however, that some individual reports of consorship violations or possible violations, have been filed in the Security Office file of the individual concerned. Much information maintained by the Security Office at Los Alamos under the LED was forwarded to Oak Ridge, Tennesses.

The Bureau has indicated in previous correspondence that these LED files may presently be in the possession of the Bureau. If this is true, it is requested that the Bureau cause a search to be made of the LED files concerning the individuals listed in referenced report to determine whether any of these files centain a record of a telephone call in Movember 1944, which might be pertinent to this investigation.

For the infermation of diffices receiving region of this report, the Bureau has instructed that infermation from the model of the set forth in reports under a temperary symbol number and designated in the report as coming from a confidential and reliable infermant. The infermation from this source is not, under any circumstances, to be disseminated outside of the Bureau. The infermation from this source should not be placed in communications in other cases. The number of agents having access to information from this source should be restricted to those agents who will have to have the information available for the appropriate handling of the investigation.

Scientific Laboratory, made available to the writer and SA FRED W.
AMISTRONG a payroll of the Laboratory for the month of December,
1944. He also made available leave records for all individuals on
this payroll. SEAY explained that prior to 1946, no record was
kept by the University of the exact days that an employee was on
leave. The records prior to 1946 only slow the number of days'
leave taken during each month. SEAY also stated that the number of
days' leave taken during each month was submitted by each employee
to the Business Office at the end of the month. SEAY pointed out
that prior to the end of the war, all employees worked a six-day
treek. Due to the lack of shopping facilities at los Alamos, omployees were allowed one shopping-day each month for which they were
not charged leave. He advised that these shopping days might be
saved up and several used at one time.

Mr. SEAY stated that several months prior to this investigation, he had instructed employees of his office to go through the files kept by the Business Office on each employee and destroy certain material that was no longer needed. Through a misunderstanding, one of the employees working on this Project had destroyed some leave records for the years 1943, 1944, and 1945. Most of the leave records destroyed were for present employees of the Laboratory.

All leave records for individuals appearing on the payroll of the University for December, 1944, were examined by SA AIMSTRONG and the writer. A list was kept of the individuals whose leave records had been destroyed and the records of Confidential Informant T-2 were checked for travel by these individuals.

Confidential Informant T-2, of moun reliability, advised that prior to the end of the Mar, all individuals traveling out of a 200-mile radius of the Los Alamos Project were required to fill out a travel form prior to their departure, showing when and where they were going and any official contacts to be made by them, he stated many of these forms had been maintained in the individual's file in his office but that some of them had been destroyed. T-2 made evailable his filesfor examination by SA ARISTRONG and the riter.

Files of all individuals the took leave during the portinent period tiere examined for evidence of travel.

Confidential Informent T-3, of known reliability, made evailable records of the Atomic Energy Commission, Discontinued

Records Branch, Los Alamos, which contained a file captioned "VACATIONS - TECH APEA." This file contained a list by months showing travel by Tech Area personnel. These lists showed dates an individual was away from Los Alamos, the cities visited, and in some cases, persons contacted.

Mr. EDGAR S. BILLS, Business Office, Nos Alarios Scientific Laboratory, University of California, Ios Alamos, New Mexico, made available to SA ARISTRONG and the writer Travel Vouchers which showed official travel by Laboratory employees.





Lecords of the Business Office, University of California, Los Alamos, reflected that ALVAREZ took twenty days sick leave in November, 1944, and fifteen days annual leave in December, 1944.

It will be noted that ALVAREZ reported twenty days' sick leave in November, 1944, and no sick leave in December, 1944. From experience in checking leave records against other records at Los Alamos, it has been found that it is not uncommon for an individual to report continuous leave, either annual or sick, all in one month, although it extended over parts of two months. It appears that ALVAREZ was probably on sick leave from November 20, 1944, through December 13, 1944.

Travel Vouchers in the Business Office of the University of California, at Los Alamos, reflect that ALVAREZ left Los Alamos at 4:00 P.F. on December 14, 1944, and that he flew from Albuquerque, New Hexico, to Los Angeles, California. He left Los Angeles by rail December 17, 1944, and showed he arrived at the Los Alamos Project 2:00 P.M., December 18, 1944.

Travel Vouchers in the Business Office of the University of California reflect that ALVALEZ made an official trip to Washington, New York, and Boston in February, 1945. He left Los Alamos at 2:00 P.M. February 13, 1945, and flew from Albuquerque, New Mexico, to Mashington, D. C. On February 14, 1945, He traveled from Washington to New York City by rail and on the same date from New York City to Boston by rail. He claimed taxi fare to Harvard University on February 15, 1945; on February 17, 1945, he traveled by rail to Chicago, Illinois, and to Lamey, New Hexico. He arrived Los Alamos, New Mexico, at 4:00 P.M., February 19. 1945.

The files of Confidential Informant T-2 contained teletypes concerning a possible censorship violation on the part of LUIS ALVATEZ. On Fovember 15, no year shown, but believed to be 1944 as this was the only November that ALVARIZ was at los Alamos, a teletype was sent from Los Alamos to USEO, Berkeley, California, thich read as follows:

No record could be located at Los Alamos which would indicate the nature of this alleged censorship violation.

By teletype dated March 6, 1950, the Bureau advised that the H.E.D. files reflected that on November 13, 1944, T-4 of the Radiation Laboratory, University of California, had learned from EMANUEL CALANDERFELD of the Laboratory that MANDEFFELD's relatives in New Vlm, Minnesota, had chided him in letters about not having advised them of his work and the connection between the Radiation Laboratory and Site "Y." NANDERFELD's relatives stated they had learned of this activity through ALVAREZ who was allegedly highly informative concerning his work in letters to his relatives in New Ulm. No investigative action was taken by M.E.D. due to fear of compromising their informant.







During at least part of the time, she was employed at Los Alamos, she was the head secretary in the office of Dr. J. FOBERT OPPENPERIER, the Laboratory Director. The files of the Personnel Office of the University of California also reflect that at one time she worked under DAVID MANNINS. The files of Confidential Informant T-2 contained a summary of information concerning SHIFLEY BLANCHARD BARNETT which read as follows: 66 DOE

# GERHALT FRIEDLANDER

GERHART FRIEDLANDER was employed as a Chemist by the Los Alamos Scientific Laboratory from September 2, 1943, to February 15, 1946. The files of the University of California reliect that he had one day annual leave in November, 1944, and one day annual leave in December, 1944.

No record could be found of travel by FRIEDLANDER to New York City during the pertinent period.

### ANTON GRUBLIAN

ANTON GRUBIAN was employed by the University of California at Los Alamos, New Hexico, as a Technician and Assistant Scientist from April 22, 1943, until March 12, 1946. Upon his termination, GRUBMAN gave a forwarding address of 218 104th Street, Rockaway Park, New York.

No record could be located that he had leave during November or December, 1944.

The report of SA PAUL V. SMITH, Nevark, New Jersey, dated June 12, 1944, in the case entitled, "ANTON GRUBMAN; SECURITY MATTER - C", reflected that Confidential Informant T-6 advised that ANTON GRUBMAN and his wife, STELLA GRUBMAN, were members of the Communist Party, New York State, and were transferred to Princeton, New Jersey.

GRUBMAN's father, LEO GRUBMAN, 237 141st Street, Rockavay Park, New York, and his mother, ANNAYGRUBMAN of the same address were both born in Russia, his parents-in-law, MAIRY and BESSIE FRIEDLANDER, 274 East 172nd Street, New York, New York, were also both born in Russia. His wife, STELLA FRIEDLANDER GRUBMAN, was born in the United States.

# FRANCES POCKMAN HAUKINS

DAVID HAWKINS was born February 28, 1912, at El Paso, Texas. He attended Stanford University from 1930 until 1936. He

received his A.B. Degree on June 18, 1934, and his M.A. Degree in 1936. He entered the University of California in 1936 and received his Ph. D. Degree in 1940. He was an assistant teacher in the Philosophy Department at the University of California while a student; an instructor at Stanford University from 1940 to 1941, and an instructor at the University of California until May 7, 1943. He was employed in an administrative canacity at the Los Alamos Project of the Atomic Energy Commission from May 7, 1943, to August 26, 1946, during which time he had access to highly classified information on atomic wearons and atomic research. Following his leaving Los Alamos, HAVAINS was employed as a teacher of Philosophy at George Mashington University in Mashington, D.C., until about June, 1947, when he commenced his present employment at the University of Colorado in Boulder, Colorado. He presently resides at 2133 Fifth Street, Boulder, Colorado.

FRANCES JAMEK (POCHIAM) HAM INS was born Hay 6, 1913, at San Francisco, California. She attended San Hateo Junior College, San Hateo, California, for one semester in 1931 and the University of California at Los Angeles for one semester in the same year. She was enrolled at Stanford University from 1934 until 1935, receiving an A.B. Degree on June 16, 1935. She also attended San Francisco State College from 1932 until May, 1934, and from September, 1935, to January, 1936, at which time she received her State Teaching Certificate. Mrs. HAMMINS was employed as a Kindergarden teacher at the Emerson Grade School, San Francisco, California, from August, 1936, until December, 1940. She was employed as a nursery schooltsecher and an assistant librarian in the technical area library at the AEC Project. Los Alamos, New Mexico, from August 1, 1943, until January 14, 1946. Mrs. HANKINS had access to highly classified documents while employed in the technical free library. She left Los Alamos permanently on September 2, 1946, and is presently residing with her husband at 2133 Fifth Street, Boulder, Colorado.

DAVID and TRANCES HAVAINS were married at San Francisco, California, on June 22, 1937.

The following information concerning DAVID and FRANCES HALLINS was taken from the report of SA DAVID EDWIN TODD, San Francisco, California, dated June 21, 1947, in connection with the case entitled, "DAVID HAWKINS, ARA-E; INTERNAL SECULITY-C":

Professor PAUL CAMENKE, Professor of Philosophy, University of California, Berkeley, California, advised that he had been an associate of DAVID HAVKINS since 1933 and knew him very well. HARHENKE stated that DAVID HAVKINS was a Marxist. When

questioned as to the basis of his belief that HAVKINS was a Harxist, HALHENKE replied that he had had long conversations in his office over a period of years with HAVAINS and that HAVAINS had expressed ideas along these lines which had led him to this conclusion. MALHENKE also said that HAVAINS was a Russian apologist and admirer and that he had made an about-face with respect to the United States war effort at the time Germany invaded Russia.

expressed any desire for revolutation, but, after all, that was only one means to accomplish the end of an economic and governmental change and that HAVAINS certainly believed in Harxist principles. MARHENKE said that HAVAINS was definitely a Communist, but he was not to MARIENCE's knowledge a member of the Communist Party. However, from the ideas DAVID HAVAINS had expressed, he could very well be a member of the Communist Party.

LASI IE FOLLOCK of Benicia, California, who, according to reliable information furnished to T-1, was a member of the Communist Party. T-1 also stated that the "San Francisco Chronicle" had published in its "Letters to the Editor Column", under date of August 11, 1942, a letter written by DAVID HAWMINS in which HAWMINS urged the opening of a second front in the war against Germany.

On October 15, 1942, Confidential Informant T-8, of known reliability, advised that STEVE FELSON and BELNADETTE DOYLE, then officials of the Communist Party, Alameda County, California, were making efforts to contact DAVID HAVAINS, a philosophy teacher at the University of California, to invite him to Communist meeting.

On May 4, 1943, this informant advised that she candelled her subscription to the "Daily People's World," a Communist-dominated newspaper, because her address was indefinite. On Harch 4, 1943, the same informant advised that LOUISE HOSENBURG BRANSTEN was an associate of DAVID and FRANCES HALFINS. It is to be pointed cut that LOUISE LOSENBURG BRANSTEN, now known as LOUISE BRIDAN, was in 1943 an active Communist Party functionary at San Trancisco, California.

Confidential Informant T-9, of known reliability, reported that O. C. TANIER, formerly an instructor of religion at Stanford University, considered DAVID HALLINS to be a disciple of MALL HAIX and he described HAVKINS as being pro-labor in his philosophy and in his remarks to TANIER, HAVKINS definitely favored Compunism. When directly questioned, he would not admit to TANNER that he was a Communist. TANIER said that HAVKINS was op osed to the economic system of the United States. TANIER also advised that HAROLD CHAPMAN BLOWN, head of the Department of Philosophy at Stanford University, we was a close friend of HAVKINS, was also a believer in Communism and that he was more radical than DAVID HAVKINS.

T-9 was advised in 1943 by CARL THOMAS, formerly an English instructor at Stanford University, that DAVID HAMKINS arguments and teachings reflected that he was a follower of HARL HALK and that labor is more deserving of credit than management. HALKINS felt, however, that any change in the economic system should be made by social r form and not by revolution.

T-9 elso advised that DAVID HAVEINS associated with a number of Communists while attending school and that his wife's two brothers, LEONARD TRAINTE POCKMAN and JACK CLAIL POCKMAN, were both Communist Perty members.

Reliable informants of the Sen Francisco Office have advised that both JACK CLATK POCHIAN and HATIRYH KOBS FOCKMAN, brother and sister-in-law of HANCES HALTINS, are active members in the Communist Party at San Francisco, Celifornia, JACK C. POCKMAN is a member of the Seeman's Branch of the Communist Party as recently as May 21, 1947. On December 9, 1943, JACK C. POCKMAN visited DAVID HAWIIIS while DAVID HAWIIIS was employed at the Los Alamos, New Mexico, Laboratory, KATHEYN HOBS POCKMAN joined the Communist Party at San Francisco in June, 1943. She is a member of the Richman Club of the Party and is presently employed by the "People's World", a Communist-dominated newspaper.

Feliable informants of the San Francisco Office have advised that both LEOFALD TLAIMER POCKHAN and his wife, ALI E ALM GOLDSTEIN FOCKHAN, also brother and sister-in-law of FRANCES HALKINS, are members and presently active in the New Era Branch of the Communist Party at San Francisco, California. LECHARD POCKHAN has acted as dues secretary of this group.

Confidential Informent T-II, of known reliability advised that while in San Francisco during the summer of 1946. FRANCES MAININS contacted and apparently was friendly with. FRANCES MAININS contacted and apparently was friendly with. FRANCE and JACLIE OPPENDENCE, L. ROBERT and MATHEMY OPPENDENCE, ROBERT and CHALLOTTE SE BER, MAINING GOLDBURG, and J. C. CASTELLANOS. This informant also reported that DAVID and FRANCES MAINING were friendly with PHILLIP OURISON and ROBERT R. DAVIS, both of whom were formerly employed at the Los Alamos Laboratory.

Reliable informants of the San Francisco Office have reported that FRANK and JACKIE OPPENHEDIER, MARTHA GOLDBERG, and Mis. JANE C. CASTELLANOS, are or were members of the Communist Party. Information from reliable sources indicates that CHARLOTTE STEBLE's parents and relatives have a past record of being active in Communist Matters in Philadelphia.

The report of SA WILLIAM A. STIGLER, El Paso, Texas, dated June 30, 1947, in connection with the case entitled, "DAVID HAWKINS; ANA-E; INTERNAL SECURITY-C", reflects the following:

By letter dated Harch 15, 1950, the Denver Office furnished the following information concerning DAVID HAW INS (FRANCES POCKMAN HAWAINS):

The second edition of the publication dated Harch 1, 1948, "Facts for Action," the official publication of the Colorado University Wallace for President Club, Lists DAVID HALLIES as a co-sponsor of this organization.

"The Boulder Daily Camera" in its edition of May, 29, 1948, reported that various representatives from Boulder, Colorado, would attend the state convention of the Progressives Party in Denver, Colorado. DAVID HAMINS appeared on the list of these representatives.

Confidential Informant T-13 on April 11, 1949, furnished information to SA GELALD E. GOTSCHALL reflecting that DAVID HAMTINS had spoken on the subject "Atlantic Pact" at a meeting of the Young Progressives of America. T-13 stated that HAMMINS' comments toward the Atlantic Pact and the United States foreign policy were unfavorable. HAMMINS stated that the Atlantic Pact was not necessary and that American industrialists in Europe were the ones who wented war.

Feader of the Young Progressives of America at Colorado University. BLOUSTEIN was observed at Communist Party meetings in Denver, Colorado, on July 17 and 18, 1948, at 1247 Ash Street and also 2418 Harion Street by SA's LOUIS D. NELAN and G.FLADER COTSCHALL.

The "Boulder Daily Camera" in its edition of January 22, 1949, reported that DAVID HALKINS was the president of the Unitarian Fellowship at Boulder, Colorado.

The "Boulder Daily Camera" in its edition of October 1, 1949, reported in an article concerning the Unitarians in Boulder, Colorado, that Dr. DAVID MAWKINS of the Philosophy Department of the University would give a brief talk on "The Meaning of Liberal Religion." It indicated that Dr. HAWKINS had recently returned from the University of California where he held a visiting appointment at the summer school. He is now engaged in developing a new course on "Man and the Physical World."

In the University of Colorado student publication "Silver and Gold", in its April 12, 1949, edition, reported concerning the United Nations Week, series VII, "Science and World Affairs." This article reflected that Dr. DAVID HAW INS would discuss "The Impact of Technology on Social Change" at the round table conference on April 12, 1949. This discussion would be concerning the general problem of which atomic energy is one part, according to HAWKINS.

The "Silver and Gold" in its February 17, 1950, edition reported that according to DAVID HAWKINS, "It is now within the range of technical possibility to destroy all life with the Hydrogen-bomb, so it is not a weapon significant to the conduct of war." According to HAWLINS, the bomb is significant only as a weapon in the cold war. The necessary size of the H-bomb prohibits its use by airplanes. The cost of the bomb would be greater than the cost of the comparable power of plutonium bombs.

According to the same article, HANTINS stated, "Present U. S. proposals for international controls could be good, but because they have not worked they must be considered no good," said HANTINS, "Videspread opinion should force the country to



No records have been located of travel by ANNA KAHN during that period and it appears she may have spent this leave in the vicinity of The Alamos, New Mexico.



The report of Special Agent REX ELLIS cated August 17, 1948, at Los Angeles, California, in the case captioned "ELLTON KAHN - NY - 3220, AEAA" reflects that DAVID LOBE, 6161 Pico Boulevard, Los Angeles, California, advised KAHN's father was born in Russia and was always complaining about the position of the laboring man in this country as compared with the laboring man in Russia. KAHN's father was reported to have told him that he was a member of an organization which held meetings in KAHN's home. At these meetings they discussed the condition of the working man in this country. LOHE also reported that he had noticed that books read by KAHN's father were written by MARX and SPINOZA.

The report of Special Agent MILLIAM P: POOLE, San Francisco, California, dated August 25, 1948, in the same case, reflects that Confidential Informant T-17 in 1943, advised that one MAX BERNARD FRIEDMAN; known Communist, in his application for employment at the Radiation Laboratory, University of California, listed MILTON KAHN as a reference. During the investigation of FRIEDMAN by T-17, DAVID KAHN, the father of MILTON KAHN, was interviewed and advised that MILTON KAHN and FRIEDMAN were good friends at Los Angeles and Berkeley, California. In October 1948, MILTON KAHN re-applied for a position with the University of California at Los Alamos, New Mexico. Clearance was withheld by AEC and on August 4, 1949, the University of California advised that MILTON KAHN was no longer being considered for employment.

#### KEATON KENT KELLER

KENTON KENT KELLER was employed by the Les Alamos Scientific Laboratory at Les Alamos, New Mexico, from May 21, 1943 until February 27, 1946. The files of the University of California reflect that in December 1944, he took 16 days annual leave.

The report of Special Agent JOHN J. O'TOOLE, St. Louis, Missouri, dated February 13, 1950, in the case captioned "Dr. RAIPH EUGENE LAPP, LEA, Theft of Government Property" reflects that on December 30, 1949, REX EUMRENCELLER had admitted in a signed statement that he had been given several pounds of normal uranium to destroy while he was at Los Alamos. He destroyed this material with the exception of three uranium hemispheres which he brought to his home in Dexter, Missouri. He stated that he gave one of these hemispheres to his brother, KEATON KENT KELLER, and a neighbor, ANDREWATKINS. The other two hemispheres were placed by him in an abandoned well at the rear of his home in Dexter, Mo.


On December 31, 1949, KEATON KENT KELLER admitted in a signed statement that in May 1946, his brother, REX EDTAND KELLER had given him a small hemisphere of uranium metal. He matated that he used this uranium for about three months conducting experiments with it at Washington University in St. Louis, Missouri. He stated that on his way to the State of Washington, he had disposed of this uranium hemisphere by throwing it in Bear Lake in the State of Utah.

JANET KREINER was employed at the Los Alamos Scientific Laboratory at Los Alamos, New Mexico, in the division headed by KISTI/KOVSKY from January 26, 1944, to February 18, 1946. Files of Confidential Informant T-2 reflect

Files of T-2 further reflect that JANET KREINER made a trip both rebruary 27, 1944, and January 17, 1945, ab which time she stated that she would be available in care of BURT, 61 Lexington Avenue, New York, N. Y. At the time she left the Project she stated that she would visit Santa Fe, New Lexico, and New York, N. Y. When she returned, she advised that she had relso visited Philadelphia, Pa., and Newport News, Va.

#### ROBERT EUGENE MARSHAK and lirs. RUTH GUP MARSHAK

ROBERT EUGENE MASHAK was employed as a scientist in the Theoretical Physics Division at Los Alamos, New Mexico, from May 30, 1944, to April 19, 1946. During this employment, MRSHAK had access to restricted data and areas. Following his termination at Los Alamos, MRSHAK was retained as a Consultant by the University of California at Los Alamos and in this capacity, has visited Los Alamos on infrequent occasions. On January 27, 1949, MRSHAK was granted clearance by the Atomic Energy Commission Security Office at Los Alamos which permits him to have access to restricted data and exclusion areas where such access is essential in the performance of his duties.

The files of the Personnel Office of the University of California at Los Alamos reflect that MASHAK is presently employed in the Physics Department at the University of Rochester, Rochester, New York, and that his home address is listed as 1525 Highland Avenue, Rochester, New York.

ROBERT EUGENE MERSHAK - 15 AEAA." The report of Special Agent
JAMES E. GORDON, Now York City deted August 19, 1948, reflects that lies.

SALLY MERSHAK, 1247 Thindlander Avenue, Bronx, New York, advised that she
had formerly been married to REUPEN MARSHAK, who is a cousin of ROBERT EXMASHAK. She continued that she first met HOBERT EXMASHAK at a party in Mer 1944 which was given by her former husband's parents, DAVID and EDITH
MASHAK, 3018 Holland Jenue, Bronx, New York. ROBERT EXMASHAK and his wife, JACK and HITTE PASHKIN, ELLAMARSHAK and SALLY MASHAK and his
wife, JACK and HITTE PASHKIN, ELLAMARSHAK and SALLY MASHAK stated
that during the course of this party there was constant conversation about
Soviet Russia, the Communist Party, and various organizations which were
dedicated to helping the cause of Russia such as Russian Tar Relief and the
Council of American-Soviet Friendship.

perty was held honoring Mrs. SHLY LASHAK and her husband because of their recent marriage. Dr. NOREAT EUGENE LASHAK was present at this party along with other members of the family. Dr. MARSHAK's wife was not present at this party. Also at this party the usual line of conversation was held concerning Russia, the Party, and world affairs. No remarks unfavorable to Russia were made by anyone present.

Irs. FEICH, mother of Frs. SALLY HERHAK, stated that on one occasion when ROBERT E. HERRAL present, her son was discussing an incident which had occurred at Cornell University where he was a student. The fist of the matter was that the son of PAUL OFFSON had been forced to withdraw drom Cornell University because a white woman had been discovered in his room: The REICH continued that ROBERT E. MALSHAK was supposed to have remarked, "That couldn't happen in Russia."

ITS. SALLY MRSHAK recalled that on one occasion, after ROBERT E. HARSHAK made a trip to Peris, France, in 1947, to represent the Federation of A crican Scientists at a conference of the World Federation of Scientific Workers, her former husband read to her an article which appeared in the "New York Herald Tribune" and which quoted ROBERT E. MARSHAK. This article contained certain views concerning what took place at this conference. After showing her the article, RUEEN s in to her, "Read that article and then read between the lines." She stated that her only interpretation of this remark of her husband's was that MOSERT E. LARSHAK had made a statement that he did not believe but had said it because it was expedient.

Visited his relatives at Canti Beacon, which is near Beacon, New York. She advised that this camp is run by Communists for Communists, and preaches nothing but Communism. She said that the relatives whom ROFERT E. LARSHEK visited stayed at a cottage in a small group near the camp and were constantly going over to the camp for entertainment and for the purpose of meeting friends of theirs who were staying at the camp.

It was pointed out by SALLY MARSHAK that she knows nothing which would indicate that ROBE I E. LINSHAK is a member of the Commist Party. She advised that his wife is very liberal but that she does not know if she is a member of the Commist Party. It was her belief that ROBERT E. MARSHAK could not help being aware of the attitude of his parents, his aunt and uncle and other relatives.

According to SALLY MARSHAK, MOSE and HARN MARSHAK, nevents of ROBERT E. MARSHAK, are active in various front organizations such as Russian War Relief and the Council of American Societ Friendship. Her impression is that these people are vitally interested in Russia and have been very active in any activity which would favor Russia. She stated that in their conversations they seemed very sympathetic to the Communist Party. She advised that she had never heard them criticize any activity of Russia in any way. She further state that she had no information which would indicate whether or not they were member of the Communist Party.

In regard to the aunt and uncle of ROEERT E. RAMSHAK, EDITH and DAVID RASHAK, SALLY RESHAK stated that EDITH was a very active worker for Russian Var Relief and spent a great deal of time in a store which was used to sell articles for this organization. She stated that EDITH was very friendly to the Communist Party and to Russia. She further advised that she was unable to state whether or not EDITH was or is a member of the Communist Party.

SALLY MARSHAK said that on one occasion DAVID MARSHAK showed her two Communist Party membership cards which he stated had been issued to him in previous years. This was about 1946. He did not indicate at the time whether or not he was still a member of the Party. She advised that she did not notice with what club he was affiliated or whether the cards were made out in his name. She continued that DAVID has been active in Russian "Ter Relief and in selling the "Daily Yorker" and a magazine called "Soviet Life Today." She also stated that DAVID is active in fund raising campaigns for activities connected with the Council of American-Soviet Friendship and has gone to dinners sponsored by this organization. He is also an avid admirer of everything done by the Communist Party and Russia.

MASHA EEST SCHUIMIN, or SCHUMIN, according to SALLY MARSHAK, is a cousin of ROBERT E. MASHAK. SCHUMIN was a lieutenant in the WAC and before the war was active in the Young Communist League. She is married to BERNARD SCHUMIN who was a meteorologist in the Air Corps. Both she and her hysband were very active in the PCA and campaigned actively on behalf of HENRY WALLACE, BERNARD SCHUMIN stated in the presence of SALLY MASHAK that he was formerly a member of the Communist Party, but that he was not now a member because he felt that he could do better work outside of the Party, and if asked, could truthfully state that he was not a member of the Party.

ROBERT E. MARSHAK's wife, RUTH, is believed by SALLY MASHAK to be commected with some front organization in Rochester, New York. She was not sure, but she believed that it might be the Council of American—Soyist Friendship.

SALLY MARSHAK did not know of any other indication of any activity on the pert of ROPERT E. MARSHAK's wife, but as a result of conversations with her, she advised that she was definitely liberal to the extent of not being critical of Russia. She advised that by liberal she meant inclined to be favorable to Russia or the Communist Perty.

According to SALLY MARSHAK, her former husband is not a member of the Communist Party because of his professional status as a veterinarian. He is practicing in Springfield, Vermont, and has refrained from expressing his views in that locality, because the general nature of the neighborhood in which he lives is such that he would be held in very poor repute Af he indicated any feeling for Communism. She continued that he is extremely friendly with a couple residing in Toodstock, Vermont, ABNER and EETTY KODESS. AENER KODESS is connected with the Soil Conservation Service, Department of Agriculture. SALLY MARSHAK went on that Mrs. KODESS told her that she had been a member of the Communist Party under the name of MITA MCCAMTHY and had been active in the Young Communist Largue in Ithaca, New York, when her husband was working in that city.

The records of the Board of Elections, Bronx, New York, reflect the following voting registrations for NOTERT E. MAISHAK and his relatives:

ROBELT E. MARSHAK registered as a member of the American Labor Party in 1937, but did not vote.

HURRY TUESHAK, father of ROBERT E. TURSHAK, registered as a member of the Democratic Party in 1933, 1934, and 1939. He registered as a member of the American Labor Party in 1936, 1937, and from 1940 through 1947.

ROSE MARSHAK, mother of MOBERT E. MERSHAK, registered as a member of the Democratic Party from 1933 through 1936, and in 1939. She registered as a member of the American Labor Party in 1937, and from 1940 through 1947.

RUTH MARSHAK, sister of ROBERT E. MARSHAK, registered as a member of the Democratic Party in 1939, and as a member of the American Labor Party from 1940 through 1947.

EEATRICE MARSHAK, sister of ROBERT E. MARSHAK, registered as a member of the American Labor Party in 1943 and 1944.

ELLA MARSHAR, aunt of ROBERT E. MARSHAK, registered as a member of the Communist Party in 1933 and 1934, and as a member of the American Labor Party in 1937, and from 1939 through/1947.

MARSHA SCHUMAN, cousin of MOBERT E. MARSHAK, registered as a member of the American Labor Party in 1946 and 1947.

BERNARD SCHULLAN, husband of MASHA SCHULLIN, registered as a member of the American Labor Party in 1946 and 1947.

DAVID MARSHAK, uncle of ROBERT E. MARSHAK, registered as a member of the Democratic Party in 1934, 1936, and 1944. He registered as a member of the American Labor Party from 1937 through 1943, and from 1945 through 1947.

EDITH MASHIK, aunt of WEERT E. MASHIK, registered as a member of the American Labor Party in 1937, 1938, and from 1940 through 1947.

A souvenir program of the Carnival Bazaar, held at the City Center Casino, New York City, on May 4,5,6; and 7, 1947, for the National Council of American-Soviet Friendship, Inc., had many advertisements donated by people expressing greetings and best wishes. In a one-half page advertisement, which contained many names, the following names were set out:

No addresses or other identifying naterial was contained in this list of names.

In the issue of the "Daily Torker" for April 27, 1947, Section 2, page 30, column 4, under the heading "May Day Greetings from our Friends" the name of ELLA MARSHAK appears.

On April 27, 1944, New York City Confidential Informant T-18, of known reliability, advised that he had learned that ELLA FLRSHAK was a member of the Burnside Club of the Communist Party which is in the Eighth Assembly District South of the Bronx, New York. This informant further advised that ELLA MARSHAK resided at 2007 Davidson Ayonue.

New York City Confidential Informant T-19, of known reliability, advised on January 14, 1947, that the name ELLA MASHAK appeared on an undated list he had seen which indicated that she was a member of the Burnside Club of the Communist Party. He stated that this list was entitle that the communist Party. He stated that this list was entitle that the communist Party. Functionaries Heeting, Burnside, Fordham."

On December 3, 1946, the same informant advised that he knew that the name ELLA MASHAK was on file in the Bronx County Headquarters of the Communist Party.

The report of Special Agent JAES E. GORDON, New York City, dated June 30, 1947, in the above-entitled case, sets out the following:

New York City Confidential Informent T-20, of known reliability, advised that ROBERT E. MASHAK is co-cuthor with ELDED C. HELEON (should be ELDED C. MELEON) and LEONED ISMAN SCHIFF, of a book to be known either as "Layman's Guido to Atomic Energy" or "Atomic Energy Primer." This book was to be sponsored by the Association of Los Alamos Scientists to advance its view for future research and control relating to Atomic Energy.

The report of Special Agent LATION E. TOWENS, Buffelo, New York, dated June 10, 1947, in the NOWLAT E. LANGE case, supra reflects the following:

Rochester, Rochester, New York, advised that ITESHIK is a liberal but not a radical and seems to be a loyal incrican. CHILDS stated that in discussing the Russian situation, Mishik indicates that the United States will have to make concessions and doesn't feel Russia is as bad as pictured. However, he does not agree with Mussia's stand in regard to atomic energy control and favors the Billich plan for dontrol of atomic energy. He further advised that Mishik is a member of the Executive Cormittee of the Rochester chapter of the Federation of incrican Scientists and was recently elected Chairman of the National group.

Rochester, Mochester, New York, stated that he considered MASHAN to be a left wing liberal, but not a Communist, as he did not follow the Communist Party lines. COATES continued that he was a number of the Speaker's Board of the Rochester Association for the United Nations and that MASHAN was recently elected Chairman of that organization. COATES also mentioned that he was a member of the Mochester Group for Liberal Action, now known as the American Association for Democratic Action, a liberal organization, but one which repudiates Communism. He advised that MASHAN attended a few of their meetings, but did not continue to attend because the organization did not advocate enough of a left wing program. COATES further stated that he listened to MASHAN argue with Professor EELMAD PETERS about the control of atomic energy and heard MASHAN oppose PETER's suggestion that our stock of atomic bombs be destroyed in accord with Mussia's plan.

United Nations reflects that the Association backs the United States foreign policy and there have been no reports concerning any Communist influence in the policy making group of this organization.

Irs. COR DONOVIE, 189 Rossiter Road, Rechester, New York, advised that in ISHIK round at her house for approximately two and one-hald years from 1941 to 1943, when she lived at 32 Genesee Park Boulovard. Irs. DONOVIN stated that she had many conversations with Maishid and that he was strongly opposed to what he referred to as the "Capitalists" and "Industrialists" for exploiting the working class. She continued that he had subscribed to a union paper which she believed was published by a teacher's union. She said that this paper seemed to have considerable influence on his beliefs. Irs. DONOVIN advised, however, that in spite of his criticism of the capitalists, he was strongly in favor of our form of Government and rever opposed our foreign policy.

The records of the Rochester; New York Eoerd of Education reflect that the naiden name of MRSHAK's wife, RUTH MRSHAK, was MUTH GUP and that her parents were born in Massia.

Further, that his wife, Dr. H.MN.H P.TEMS, was active in the Professional Group of the Communist Perty.

Reports concerning the Progressive Citizens of America in Rochester, New York, reflect that its membership is made up nainly of persons who have never been reported as being affiliated with the Communist program. However, there are some known Communists among the members and approximately half of the officers of the organization, including committee chairmen, are reported as having been closely associated with Communist activities.

The report of Special Agent THEODO E C. HUKE, El Paso, Texas, dated June 17, 1947, in the above-entitled case, reflects the following:

Dr. MORRIS E. BRADEURY, Director, Los Alamos Laboratories. Los Alamos New Mexico, advised that his association with MARSHAK had been limited. He continued that he believed MARSHAK to be of liberal political views and understood that MARSHAK had previously been associated with a group of men in the Association of Los Alamos Scientists who favored the international dissemination of atomic information. However, BRADBURY stated that he thought MARSHAK was fundamentally loyal and patriotic and that his viewpoints had undoubtedly changed with the recent developments in the world situation.

University of California, Los Alemos, New Mexico, stated that he was quite familiar with LAMSHAK and had numerous opportunities to work with him. He continued that LAMSHAK's work at Los Alemos had consisted of compiling and evaluating all the work done by the various scientists in developing the atom bomb. LAMSHAK also prepared several chapters for a publication called the "Technical Series." De HOFFLAN said that he worked frequently with LAMSHAK in determining what should be declassified and also in evaluating the material to go into the "Technical Series." De HOFFLAN went on that he believed that LAMSHAK was fundamentally loyal and patriotic but thought that LAMSHAK was very liberal minded and a "hot head" in his political views. He stated that LAMSHAK would do anything to put his point across or accomplish a political issue.

According to De HOFFILM, MARSHAM had been a source of some trouble to the declassification section during his stay at Los Alamos. The first difficulty had arisen when the booklet "Our Atoric World" had been published This booklet was published by ROBELT E. MARSHAK, LEONARD ISLAC SCHIFF and ELDED C. NELSON. The written portion of the booklet had been properly declassified, however, the photographs had, by error, been passed as being declassified when they were actually still in a classified status. This, according to deMOFFLAN, was not the fault of the authors but a result of the loose system of declassification that existed at that time. The second problem that had given the Declassification Section some concern was an article that IMRSHAK had attempted to publish. MARSHAK had been connected with experiments on the atomic bomb while in Canada and upon leaving, had the Canadian authorities declassify several papers he had worked on. De HOFFILM stated that these papers, along with some of the work done at Los Alaros, had been written up in an article for publication in a leading physicist magazine. The raterial had been given to the publishers and was ready for publication when MASHAK was advised by some of the scientists at Los Alamos that this material should be declassified at Los Alamos first. The article as such

dres not reveal any of the secrets of the etoric bomb but the Declassification Section was displaced in the manner that Minishik handled the situation. At that time, (June, 1947), de HOFFMIN state that the article was still being hold up by the Declassification Section.

De HOFFILIN further stated that ordinarily NURSHIK is "security conscious" and readily follows any suggestions made by the Declassification Section. However, NURSHIK, in de HOFFILIN's opinion, is most interested in securing publications under his name in order that he might build up his prestige in the profession. De HOFFILIN had heard NURSHIK, on numerous occasions, state his political views for world control of the atomic bomb and international dissemination of atomic information. To the best of his knowledge, de HOFFILIN believes that this was still NURSHIK's idea and that he will do his utmost to further this point.

J. M. B. KELLOGG, P Division Leader, University of California, Los Alanos, New Mexico, advised that he had been acquainted with MARSHAK on a professional basis during the time that MARSHAK was at Los Alanos. KELLOGG continued that he had heard nu crous comments on MARSHAK's political views and had heard him express himself on several occasions in his agitation for international dissemination of atomic information. KELLOGG believed MARSHAK to be "liberal minded" and indicated that he had strong political feelings. KELLOGG continued that MARSHAK was probably loyal and patriotic to this country, but he felt that sametime due to his political zeal, that he might say or do samething "foolish." KELLOGG did not regard MARSHAK as being a Bussian sympathizer but know that he still deinitely fevored world control of atomic energy. It was KELLOGG's conclusion that he personally would "watch out" for him.

KELLOGG also stated that he was quite certain that MARSHAK was well acquainted with MELEA PHILLIPS and further stated that he too had been closely associated with her. KELLOGG continued that MELEA PHILLIPS was, to the best of his knowledge, a quiet, censervative and patriotic individual who had been quite concerned over the passage of the May-Johnson Act. To illustrate his point, KELLOGG stated that she took all her savings and vacation money and quit her job to go to Mashington to fight the passage of the May-Johnson Act and to assure that the Makahon Act was instituted in its place. KELLOGG said that his provious association with MELBA PHILLIPS at the Radiation Laboratory, combined with his knowledge o MARSHAK's activities, placed him in a position where he was able to state that he believed a close friendship existed between MARSHAK and PHILLIPS.

JOHN LANGEE, Scientist with the argon Laboratories at Chicago, Illinois, and a donsultant to the Los Alamos Laboratories, stated that he had previously been an associate of MARSHAK and considered himself fairly well acquainted with him. MAGEE stated that MARSHAK was very strong in his political beliefs and would do anything to favor his line of reasoning.

MAGEE believed MARSHAK to be very liberal minded and during all of his association with MARSHAK, MAGEE stated that MARSHAK had favored the international dissemination of atomic information. According to MAGEE, MACHAK had on several occasions, made statements to the effect that he was a close friend of HARLOTCHAPLEY who had been accused by Representative MAY as being a Communist Party member. MAGEE further stated that during his association with MARSHAK he had never received the impression that MARSHAK was a Mussian sympathizer or that he would be disloyal in any way to the United States.

Confidential Informent T-22, of known reliability, stated that he had frequent contact with MANSHAK and felt himself fully qualified to speak regarding him. T-22 continued that he regarded MANSHAK as being a trouble maker, an extreme liberal, and a Communist sympathizer who favored world control of atomic energy. T-22 added that MANSHAK strongly favors international dissemination of atomic information. According to T-22, MANSHAK, in his position of Chairman of the Federation of American Scientists, is a dangerous influence.

Confidential Informent T-23, of unknown reliability, stated that he was acqueinted with MASHAK and further, that he personally disliked MARSHAK and wanted this understood during the interview. T-23 described MANSHAK as an idealist, extremely liberal minded, and strongly in favor of the international dissemination of atomic information. According to T-23, LYDSHAX was elected to the advisory board of the Kesa Li'rary at Los Alamos and "threw his weight around" to obtain certain magazine subscriptions and books which he favored. T-23 stated that he, along with many others at Los Alamos, was somewhat upset to find that the money they had subscribed for the latest and up-to-date magazines had been spent on "The New Republic". "The Nation" and "PI". It was common knowledge among the members of the library that MASHAK had been largely responsible for obtaining the above. T-23 went on that several books were also obtained such as "Mat To Do With Italy" by SILVE INI and LATEINO. The text of this book was criticism of the imerican occupation of Italy. Various series by UPTON SINCLAIR were also purchased at that time.

The persons interviewed in connection with the investigation of MARSHAK by the El Paso Office, advised that the following persons were among the close friends and associates of MARSHAK:

EDWARD TELLER was born January 15, 1908, at Budapest, Hungary. He was naturalized March 4, 1941, at Washington, D. C Certificate #5081872. He was employed as a physicist by the University of California at Los Alamos, New Mexico, from April 1, 1943, to January 31, 1946, at which time he terminated and went to the University of Chicago. He continued to be a consultant of the University of California at Los Alamos and in this capacity visited Los Alamos at frequent intervals until July, 1949, at which time he returned to Los Alamos as the Associate Director for Weapon Development for the University of California.

Mrs. AUGUSTA HARKANYI TELLER was born April 30, 1909, at Budapest, Hungary, and was naturalized March 4, 1941, at Washington, D. C., Certificate #5081781. She was employed by the University of California at Los Alamos as a computer in the Theoretical Physics Division from August 26, 1943, until August 14, 1945, and from July 22, 1947, until September 23, 1947, and again from August 29, 1949, to the present. During most of this time, she was only employed on a part-time basis and worked three-eighths of the time.

During the AEAA investigations concerning the TELLERS, information was received from a confidential informant of the New York Office that one EDWARD TELLER had been on the roster of teachers at the Communist Workers School, New York City, in 1941, teaching Political Economy, Marxism, Leninism and the History of the Communist Party of the Soviet Union. This school is directly operated by the Communist Party for the education of Party members.

Considerable investigation was conducted to determine whether the EDWARD TELLER employed at Los Alamos was identical with the EDWARD TELLER who taught at the Communist Workers School. EDWARD TELLER's photograph was shown to a number of informants, and one informant of the Albany Office identified the photograph of the EDWARD TELLER employed at Los Alamos as a man he saw on various occasions at the headquarters of the

Communist Party School on Thirteenth Street, New York, New York, during what he recalled was the early part of 1942.

Dr. EDWARD TELLER was interviewed by Agents of the El Paso Office at Los Alamoš, New Mexico, January 4, 1949, at which time he denied any knowledge of of present of former connection with the Communist Workers School in New York. He stated, however that he was employed at Columbia University the latter part of 1941 and early 1942.

A confidential informant of the Washington Field Office made available a list of individuals, which list was in the possession of the United American Spanish Aid Committee. It was not known whether this list of individuals was a list of members or merely a mailing list of this organization. The name of Dr. EDWARD TELLER appeared on this list. No other identifying data was set forth on the list.

The Washington Field Office also obtained a list from a confidential informant

which carried the title "Members List." The exact significance of this list is not known. An investigation has reflected, however, that this list may only have been a mailing list. This list included the name of EDWARD TELLER, 2610 Garfield Street, N. W., Washington, D. C., and identified him as a teacher with telephone number Columbia 6955.

The Washington Committee for Democratic Action is listed as a Communist Front organization by the Attorney General.

The files of the Washington Field Office reflect that a membership list of the "League of Women Shoppers," Washington, D. C., contained the following:

"TELLER, Mrs. EDWARD (AUGUSTA HARKING), 3511 Davenport Street, N.M., Emerson 8172."

The same source of information revealed that the following name appeared on the active indices of the Washington Committee for Democratic Action:

"TELLER, Mrs. EDWARD, 2610 Garfield Street, N.W."

During the AEAA investigation concerning the TELLERS, all of their associates and acquaintances advised that they were both loyal to the United States and anti-Communist.

Agent of the Chicago Office of a letter he had received from his wife's brother, GARBOR SCHUTZ in Hungary. This letter preised the Russian occupation of Hungary and suggested that TELLER come to Hungary to see for himself the conditions there. TELLER informed the Agent that this person was the only member of either his own or his wife's family who had ever shown any tendencies other than anti-Communist or anti-Russian. TELLER furnished the letter in question to the Chicago Office. On another occasion, TELLER told a Bureau Agent during an interview that he believed in the group plan for the control of atomic energy but doubts that it can be successful under such international control because he does not believe the Russians would accept it. He further advised that he considers Russia at the present time to be the only real source of danger to world peace. He said he believed that everything should be done to counter such danger.

viewed by reporting Agent concerning EMIL JULIUS KLAUS FUCHS who has admitted Soviet Espionage activities. She advised at that time that in the latter part of November, 1945, she had made a trip with FUCHS and Mr. and Mrs. RUDOLPHAPETERIS to Mexico City. She also stated that in November, 1947, at which time FUCHS was back in the United States, he had had dinner at her home on two occasions in Chicago, Illinois.

EDWARD TELLER was also interviewed concerning FUCHS on February 14, 1950, at which time he advised he had first met FUCHS at Los Alamos in 1944 and that he had had some business and social contact with him during the time FUCHS was at Los Alamos. TELLER stated he was in England during the summer of 1949 and that he saw a lot of FUCHS at that time. He stated FUCHS had met him at the American Embassy at London shortly after TELLER's arrival in England and that later they had had official contact at Harwell. One evening during TELLER's stay at Harwell, he had spent several hours with FUCHS at FUCHS! flat.

Records at Los Alamos reflect that EDWARD TELLER on official trip between November 6, 1944, and November 1944, to Chicago, Illinois, Washington, D. C., Baltimore, Maryland, New York, New York, Princeton, New Jersey, and Knoxville, Tennessee.

Records at Los Alamos also reflect that Mrs. AUGUSTA MALLER made a trip between November 6, 1884, and November 20, 1944, to Chicago, Illinois, and New York, New York.

Between December 11, 1944, and December 17, 1944, DWARD TELLER made an official trip to Chicago, Illinois, and New York, New York. He made another official trip between January 1, 1945, and January 15, 1945, to Baltimore, Maryland, New York, New York, and Knoxville, Tennessee. He made still another trip on official business between January 30, 1945, and February 6, 1945, to New York, New York, and Chicago, Illinois.

The files of Confidential Informant T-2 reflect that on February 23, 1950, EDWARD TELLER made a person-to-person telephone call to JOHN WHEELER, c/o Pelnicion-Domecqu., 70 Rue D Assas, Paris 6. The call lasted for four minutes and was made from Los Alamos, telephone 5581. Inquiry has revealed that Los Alamos Telephone 5581 is in the office of Dr. NORRIS B. BRADBURY, the Laboratory Director. Therefore, this was meetably an official call.

## STANISLAW MARCIN ULAM

STANISLAW MARCIN ULAM was born April 13, 1909, at Lowo, Poland, and became a naturalized citizen of the United States on April 2, 1943, at Madison, Wisconsin, Certificate #5635865. He was employed in the Theoretical Physics Division, University of California, Los Alamos, New Mexico, from February 5, 1944, to August 20, 1945, and from May 25, 1946, to the present time.

was listed in the address book of ISRAEL HALPERIN, identified as a Soviet Espionage agent who was prosecuted but not found guilty of violating the Canadian Official Secrets Act. MARSHALL W. STONE, presently at the University of Chicago, Chicago, Illinois, who was listed as a reference by ULAM, was also listed in the address book of ISRAEL HALPERIN.

ULAM stated that his association with HALPERIN was only professional.

Information concerning DAVID HAWKINS and his wife is set out elsewhere in this report.

FRANCCISE ULAM was born March 2, 1918, at Paris, France, and became a naturalized citizen of the United States on August 25, 1945, at Santa Fe, New Mexico, Certificate #6113511.

confidential Informant T-22, of known reliability, advised that FRANCOISE ULAM's general conversation and reactions reflect she is extra progressive and even radical in her political views. T-22 was of the opinion that STANISLAW ULAM did not subscribe to the theories and ideas of his wife.

## VICTOR FREDERICK WEISSKOPF

VICTOR FREDERICK WEISSKOPF was employed in the Theoretical Physics Division by the University of California at Los Alamos, New Mexico, from June, 1943 to February, 1946. He has been retained as a consultant at the University since that time.

The files of the Albuquerque Office contain little information concerning WEISSKOPF but it appears that the Boston Office has conducted considerable investigation concerning WEISSKOPF under the caption "INTERNAL SECURITY - R, ATOMIC ENERGY ACT."

Records at Los Alamos reflect that VICTOR WEISSKOPF made an official trip from January 1, 1945, to January 15, 1945, to Chicago, Illinois, Boston, Massachusetts, Washington, D. C., Princeton, New Jersey, New York, New York, and Ithica, New York.

## WILLIAM SPINDEL

WILLIAM SPINDEL was at Los Alamos, New Mexico, as a member of the Special Engineering Detachment of the U.S. Army from March, 1944, until October, 1945. He was as the new socientific work for the University of California

In connection with this investigation, Dr. MEYER, Chairman of the Chemistry Department, Brooklyn College advised that he had first met SPINDEL while he was a student at that college in 1941. He stated that while SPINDEL was a student at Brocklyn College he became a member of the Chemical Society. This society, according to MEYER, affiliated itself with and gave moral support to the Karl Marx Society and the American Students Union which, according to Dr. MEYER, were Communist-dominated. Dr. MEYER stated there was no doubt in his mind that SPINDEL associated with the Communist elements in the school and that concluding from his observation of SPINDEL's conduct could not recommend him for a position involving loyalty. SPINDEL gave the name of JOSEPH GREENSPAN as a reference. GREENSPAN was employed as an Instructor of Chemistry at Brooklyn College from 1939 to 1942. In 1944, GREENSPAN organized his own laboratory in partnership with PHILIP/ACSENBLATT and SYLVESTRO LIOTTO, both reported formerly active in the Communist clique at Brooklyn College and both later associated with the RSM Project. From 1942 to 1943, GREENSPAN was employed at the Rockefeller Institute, E. 66th Street and New York Avenue, New York, at which time he was reported to be very friendly with Dr. HARRY GRUNDFEST, a contact of ARTHUEXADAMS.

Confidential Informant T-25, of known reliability, reported that SARAH LEW SPINDEL, of 1249 Ocean Avenue, Brooklyn, New York, was a member of the Midwood Club, 2nd A.D., Kings, County Branch of the Communist Party of America in 1944.



GEORGE CHARLES ELTENTON, who has admitted attempting to obtain information concerning Atomic Energy experiments at the University of California Radiation Laboratory at request of PETER IVANOV, then a secretary, USSR Consulate General, San Francisco, of opinion that ALVAREZ possibly mentioned as scientist known to IVANOV.

DETAILS:

San Francisco T-2, another governmental agency, provided information indicating that LUIS ALVAREZ was mentioned as possibly violating Censorship regulations imposed by the Manhattan Engineers District in 1944. San Francisco T-2 noted that the U.S. Engineers Office at Berkeley, California, had mentioned a possible censorship violation by LUIS ALVAREZ in a teletype transmitted to Santa Fe on November 15, 1944. The files of the Security Office of the Atomic Energy Commission at Berkeley, California, were searched in an effort to locate such a teletype. No such teletype was located, nor was any other record of possible censorship violations by LUIS ALVAREZ located. It was ascertained that information collected by the Manhattan Engineers District with regard to ALVAREZ was possibly on file with the Bureau in Mashington, D.C. San Francisco T-3, a representative of another governmental agency, advised that he had no personal recollection of any such correspondence pertaining to possible censorship violations by ALVAREZ.

In an Atomic Energy Commission Personnel Security Questionnaire completed in 1947, ALVAREZ used the name LUIS WALTER ALVAREZ. He indicated he had been by another name "LUIS SCHMOLL ALVAREZ". It is parenthetically noted after this other name that this name appeared on his birth certificate.

The records of the Bureau of Vital Statistics, San Francisco, contain a duplicate Certificate of Birth under Local Registry No. 3051. This certificate was filed June 15, 1911 and bears the certification of AUGUST JEROME LARTIGAN, a physician, with offices at 391 Sutter Street. This duplicate Certificate of Birth reflects that LUIS SCHMOLL ALVAREZ was born at 12:45 A.M., June 13, 1911, and was male and white. The father of this child; was listed as ROBERT CLEMENT ALVAREZ, age 27 at the time of this birth, and born in California. The mother was listed as HARRIET SWYTH, born in China, age 23 in 1911, and it was indicated that LUIS ALVAREZ was her third child.

There were located additional certificates of birth bearing Registrary No. 3535 for ROBERT SHYTHYALVAREZ, born June 7, 1912, and No. 4723 and 4724 for BERNICE and GEORGE ANABEZ, born August 12, 1913. On these birth certificates it was noted that the mother's name was HARRIET SKIDLYORE SHYTH, a native of Foochow, China.

In response to a teletype inquiry, the Bureau of Vital Statistics for the State of California at Sacramento, California, replied by teletype dated May 16, 1947 to the effect that LUIS SCHMELL ALVAREZ had been born in San Francisco, California, June 13, 1911. The same agency, in response to a teletype inquiry dated March 7, 1950, replied that LUIS SCHMALL ALVAREZ was born June 13, 1911 at San Francisco. The original Certificate of Birth was examined at the Vital Statistics Bureau for the State of California and it was noted that this certificate, completed in ink, bears the handwritten name LUIS SCHMALL ALVAREZ. Due to the manner in which the middle name is written it could possibly be read as SCHMOLL.

The Selective Service file of LUIS WALTER ALVAREZ was examined at the office of Selective Service records, 1724 24th Street, Sacramento, California. The original registration card is made out in the name of LUIS WALTER ALVAREZ, address 101 Panoramia way, Borkeley, California. This registration was completed October 16, 1940. A Selective Service Questionnaire returned to Local Board 65, Berkeley, California, January 3, 1941, was signed by ALVAREZ as LUIS WALTER ALVAREZ. Page two of this Selective Service Questionnaire indicates that in addition to the name LUIS WALTER ALVAREZ registrant had also been known by the name LUIS S. ALVAREZ.

Mrs. DOROTHY ANDEREGG, Secretary to the Principal, Polytechnic High School, Arguello Boulevard and Frederick Street, San Francisco, made available the attendance record of LUIS ALVAREZ, which record reflected that ALVAREZ attended that institution from 1924 to 1926, at which time he resided at 3837 Clay Street, San Francisco. The high school record is carried under the name LUIS ALVAREZ, with no middle name.

By toletype dated March 21, 1950, the State Department of Motor Vehicles, Sacramento, advised that he possesses Operator's License No. Y985948, issued September 3, 1946, in the name LUIS WALTER ALVAREZ.

San Francisco T-1, Winknown reliability, and unavailable to testify, advised that he had learned from OLGA NIKOLAEVNA ARTEMOFF that during World War II consideration was given by certain Seviet representatives the United States to a the different they would kidnap certain key scientific personnel who pure then escaped in research and ultimately produced the

come to the attention of OLGA ARTEMOFF with regard to the advisability of Ridnsping three scientists, namely J. ROBERT OFFENHEIMER, ERNEST ORLANDO FINNEINCE, and a third individual, name not recalled by San Francisco T-1 but described by San Francisco T-1 as an individual who had invented a "new circle". Subsequently San Francisco T-1 suggested that possibly the name of the scientist who had invented the "new circle" was ALVAREZ, San Francisco T-1 possessed no information to indicate that ALVAREZ was in any way personally acquainted with OLGA ARTEMOFF, whom San Francisco T-1 has described as an individual acquainted with numerous aspects of Soviet espionage in the United States. San Francisco T-1 related that in no conversation with OLGA ARTEMOFF had she indicated that ALVAREZ was being contacted by, or utilized by any Soviet personnel engaged in espionage.

GEORGE CHARLES ELTENTON, formerly a resident of 986 Cragmont, Berkeley, but at present in England, advised in an interview with agents of the san Francisco office in 1946 that he, ELTENTON, had been approached in late 1942 by PETER VANOV, then a secretary at the Consulate General of the USSR in San Francisco, and that IVANOV desired that ELTENTON attempt to obtain information concerning research being conducted at the University of California Radiation Laboratory. ELTENTON in the course of this interview furnished additional details concerning his cooperation with IVANOV in an effort to obtain information concerning this research. Puring the preliminary discussion between MLTENTON and IVANOV, according to ELTENTON's statement to interviewing agents, IVANOV mentioned the names of Professors ERNEST O KLAWRENCE and J. ROBERT OPPENHEIMER, and a third scientist, indicating that those three would be in possession of information concerning the research then in progress. ELTENTON, when interviewed, could not recall the name of the third scientist montioned by IVANOV. ELTENTON mentioned the name of ALVAREZ, stating that possibly IVANOV had used that name, but that this was merely his (ELTENTON's) conjecture at the time of the interview and that ELTENTON did not specifically remember whether or not IVANOV mentioned the name ALVAREZ.

Of possible interest in the consideration of ALVAREZ as a suspect in instant matter, a review of the Selective Service record pertaining to ALVAREZ discloses that he was issued a permit to leave the United States for a two month period for travel to England where he would engage in work of interest to the National Defense Research. This permission was granted ALVAREZ on May 13, 1941. On April 26, 1943, ALVAREZ was issued a permit to leave the United States, no destination was shown. In the history of his employment, ALVAREZ indicated that in 1941 he was associated with the National Defense Research Council at the Massachusetts Institute of Technology.

San Francisco T-4, of known reliability, unavailable to testify, has furnished information indicating that LUIS ALVAREZ was an intimate friend of CHARLOTTE and ROBERT SERBER and also well acquainted with FRANK and JACQUENETT COPPENHETMER.

In the preparation of the foregoing report, the San Francisco Office has made no effort to compile complete data pertaining to ALVAREZ as it appears in the files of this office. Bureau teletype of March 16, 1950 advised that copies of reports concerning ALVAREZ were being submitted to the office of origin by the Bureau. It is believed that all of the information concerning ALVAREZ appearing in the files of the San Francisco office has been reported to the Bureau and would therefore presumably be in the reports being furnished to the office of origin.

INVESTIGATION TO IDENTIFY

On February 7, 1950, a teletype was directed to the Albuquerque Office requesting them to check the records at Los Alamos for individuals employed in 1944 and 1945 by the name of an several teletypes 5 received since that date the Albuquerque Office has advised that they have not been able to locate anyone with a similar name who was employed at los Alamos during the pertinent period. On February 21, 1950, a letter was directed to Albuquerque furnishing them additional information and instructing them to continue their investigation. Copies of this letter also were sent to New York, Washington Field, los Angeles and San Francisco. By teletype dated February 24, 1950, the San Francisco Office advised that they had interviewed Mr. Robert F. Daerr, Atomic Energy Commission Security Officer at Berkeley, California, and he had advised that among the close associates of Fuchs at Los Alamos was Luis Alvarez, who presently is employed as a physicist at the Radiation Laboratory in Berkley. The San Francisco Office pointed out that Inis Walter Alvarez is also known as Inis Schmell Alvares. The San Francisco Office suggested that Alvar might be identical with the Unknown Subject

It is to be noted that in filing a personnel security questionnaire with the Atomic Energy Commission, a copy of which is on file at the Bureau, Alvarez listed his name as Luis Walter Alvarez and set forth, in addition, that his birth certificate was under the name of Luis Schmell Alvarez. The San Francisco Office has checked the Bureau of

Vital Statistics at Sacramento, California, and has determined that on the birth certificate his name is illegibly written, but it appears to be

The Albuquerque Office, on March 3, 1950, with respect to determining if Alvarez had had leave from Los Alamos subsequent to November 22, 1944, advised that Alvarez was in the hospital at Los Alamos from November 24, to December 2, 1944, with an illness diagnosed as catarrhal jaundice. He was examined at the Los Alamos Hospital on December 8, 1944, and apparently had been on sick leave from November 24 to December 13, 1944.

With respect to determining if he made a trip to New York in mid-Jamuary, 1945, the teletype sets forth that he made an official trip to Los Angeles, California, on December 18, 1944, returning to Los Alamos on Jamuary 4, 1945. During this trip he reportedly traveled to Chicago, Illinois, and Rochester, Minnesota, where his father is connected with the Mayo Clinic. He also made an official trip to Washington, New York, and Boston, from February 13 to February 19, 1945.

### AVAILABLE INFORMATION CONCERNING ALVAREZ

On November 20, 1945, a teletype was directed to the KI Paso Office advising them to obtain copies of reports and personal data on certain individuals formerly associated with the Los Alamos DSN Project. One of the individuals listed was Luis Alvares, and the El Paso Office, by letter dated February 15, 1946, furnished a photostatic copy of his file at Los Alamos. By letter dated March 29, 1946, the San Francisco Office advised that they were opening an investigation on Alvares. However, by letter dated April 10, 1946, they were instructed to discontinue this investigation in view of the fact that Alvares was then employed at the Radiation Laboratory at the University of California, Berkeley, and was, therefore, within the primary jurisdiction of the Manhattan Engineering District. On April 27, 1948, information was received from the Air Force regarding certain statements made by Dr. Luis Alvarez to the press concerning

Russian jet fighters which had been plotted on Air Force radar screens by ground crews stationed in Korea. The matter was referred to the Criminal Division by memorandum of May 15, 1948, and in reply on June 2, 1948, the Criminal Division requested that an investigation be conducted to determine if Dr. Alvares, in revealing the data, had violated a federal statute. In the report of Special Agent Charles Frederick Brusch dated September 13, 1948, at San Francisco, in the case entitled, "Inis Walter Alvares, Espionage - Xy the details concerning this technical violation were set forth, and the report also contains the results of an interview Alvares stated he had had a conversation with Colonel with Alvarez. Robert McCormack of the Chicago Tribune, and during the conversation Col. McCormack had mentioned having heard a rumor concerning the speed of Russian airplanes and their having been charted on Air Force radar screens, and Alvarez, at that time, mentioned to McCormack the information he had received along these lines. The investigative report was submitted to the Criminal Division on October 7, 1948, and on October 26, 1948, the Criminal Mivision advised that it was not believed that prosecution was warranted on facts available, and that no further investigation was necessary.

In addition to the foregoing, on May 13, 1947, an Atomic Energy Act - Applicant Case was instituted on the basis of the receipt of a personnel security questionnaire from the Atomic Energy Commission. Investigative reports were submitted regarding Alvarez by various field offices and no derogatory or disloyal information was developed with the exception that Mr. Phillip Belcher, Assistant to the Security Officer at Los Alamos, stated that Alvarez was a little dubious and resentful concerning security at Los Alamos, and that after he had: returned from the Pacific following the dropping of the A-bomb on Japan a personal diary was found in his possession. However, this diary contained no classified information and was returned to Alvares. When Alvarez left the project at Los Alamos he took some photographs relating to the container of some part of the bomb and these pictures were classified. According to Belcher, Alvares was somewhat hardheaded and reluctant to give up the pictures until admonished by a security officer of the Atomic Energy Commission, after which Alvares was very cooperative in the matter.

A review of the Bureau files also has been made concerning Alvares and the following items of particular interest were noted: During an interview of George Eltenton on June 26, 1946, regarding the approach made to him by Peter Ivanov, Secretary of the USSR Consulate, San Francisco, in 1942, to obtain information regarding American

atomic bomb projects, Ivanov mentioned to Eltenton the names of Professor B. O. Lawrence and Dr. J. R. Oppenheimer, and another scientist. Eltenton was not sure of the third scientist's name but he believed that it was possibly Alvares. According to Eltenton, Ivanov knew of the experiments at the Radiation Laboratory at the University of California, Berkeley, and desired information concerning the work being done there. Eltenton, during the interview, admitted he had solicited Haakon Chavelier to contact Professor Oppenheimer for information. It is to be noted that Eltenton did not in any way involve Alvares in Eltenton's espionage activities. (100-214312-115, p.6)



The following background information concerning Alvarez was obtained from our previous investigations regarding him:

### Birth, Relatives

Alvarez was born June 13, 1911, in San Francisco, California — the son of Dr. Walter C. and Harriet S. Alvarez. His parents, in 1947, resided at 815 - 5th Street, S.W., Rochester, Minnesota, and his father was connected with the Mayo Clinic in that city. Alvarez has two sisters and a brother; namely, Gladys A. Archibald, Berkeley, California; Bernice A. Brownson, Rochester, Minnesota; and Robert S. Alvarez, Nashville, Termessee. He is married, his wife's name being Geraldine S. Alvarez, and he is the father of Walter S. and Jean, his son and daughter respectively.

#### Education

Alvarez attended Polytechnic High School, San Francisco, from 1924 until September, 1925, at which time he transferred to Rochester High School, Rochester, Minnesota. He graduated from the latter institution on May 31, 1928, and in that same year entered the University of

Chicago, Chicago, Illinois, from which school he received the following degrees: S.B. on March 15, 1932; S.M. on June 12, 1934; and Ph.D. on December 15, 1936. He was an honor student in physical sciences, and was a member of Phi Beta Kappa honor society, Signa Xi Scientific Society and Phi Gamma Delta Social Fraternity.

### Employment

From 1936 to the present Alvarez has been continually attached to the University of California, Berkeley, California. In addition to his affiliation with the University of California, he was employed by other institutions during the period; namely N.I.T. Radiation Laboratory, Cambridge, Massachusetts from 1940 to 1943, where he did radar research; the University of Chicago Metallurgical Laboratory from 1943 to 1944 where he was engaged in atomic research; and the Los Alamos Laboratory, Los Alamos, New Mexico, from 1944 to 1945, where he also was working on atomic research. In 1947 the Brookhaven National Laboratory, Associated Universities, Inc., Patchogue, Long Island, New York, submitted a personnel security questionnaire on Alvarez; however, although no derogatory information was developed, there is no indication that he was employed by this institution.

### Foreign Travel

Alvarez visited Mexico from April to May in either 1933 or 1934, and during the period from 1930 to 1940 he went to Canada on four or five occasions for a stay of from one to three days duration on pleasure. From June to September, 1943, he was in England on OSED business, and from July to September, 1945, he went to Japan on affairs concerning the atom bomb. In the summer of 1948 Alvarez and his family toured Europe.

LUDMIIA NIKOLAEVNA ALEXEER

The report of Special Agent William J. McCarthy, onted March 3, 1950, at New York, in the case entitled, "Mrs. Paul Ivan Alexeef, Espionage - R," contains the following information concerning her:

Investigation was conducted by the New York Office during 1942 and 1943 concerning

investigation showed that the Alexeefs resided in New York has a singer with the Don Cossack Chorus, and Indeila Alexeef devoted a great deal of time to writing and making speeches.

In connection with that investigation, Mrs. Alexeef was interviewed in early 1943 and stated she was born in Petrograd, Russia, on Angust 13. 1917; that her father had been an architect in Russia, and during the first World War he had been in the United States as a number of a Russian Committee to speed the flow of war materials to Russia. stated that as a young girl she was taken to France by her parents and attended school there. She stated that as a student in 1935 she ioined the National Labor Union of the New Generation (anti-Soviet Russian organisation). In April of 1936 she joined the Monte Carlo Ballet, and in October, 1938, as a member of the ballet she came to the United States and remained in the United States until March 25. 1939, when she returned to France. The ballet then toured Europe until October, 1939, at which time she was in Rotterdam, and due to war conditions she came to the United States from Rotterdam aboard the SS Rotterdam. arriving in New York City on October 25, 1939. During the interview Mrs. Alexeef furnished considerable information concerning the Mational Labor Union of the New Generation and the propaganda being put out by that group in the United States.

Mrs. Alexsef presently is a citizen, receiving this citizenship on November 29, 1948. The field has been advised that all investigation in connection with this matter must be given continuous investigative attention and the Bureau kept fully advised of all developments.

In the attached teletype to Albuquerque, San Francisco and New York, a deadline for the submission of reports detailing complete results of investigation by Albuquerque and San Francisco is being set for March 2h, 1950. A supplemental report from New York is to reach the Bureau by April 3, 1950.








The files of the Atomic Energy Cormission Security Office at Los Alamos, Now Hexico do not contain the results of any Europu investigations of PEPILIN, although they indicate that he was probably investigated for the Atomic Energy Commission in connection with his employment by General Electric at Schenectady, New York. In April 1948, PERLANI was being considered for employment by the University of California at Los Alamos. The Atomic Energy Commission Security Division at Los Alamos requested information concerning his clearance from the Atomic Energy Commission, Eashington D.C. 


### IRVING R. SCHIOLKY JID BEHJIVIN BEDERSON

The files of the ARC Security Office at Los Alamos, New Mexico as a member reflect that IRVING R. SCI OLIN was at Los Alamos, New Mexico as a member of the Special Engineering Detachment from about appril 5, 4944 to July 1944. Under date of May 21, 1944, PFC IRVING R. SCHOLKA and T/4 BRUARIN BEDRESON trate the following letter to the Surgeon General, Mar Department:

"In those critical times, when all of we Americans are united in fighting the evils of Fascism and Fascist Dectrines, we take time out just long enough to inquire whether or not you are carrying out one of HITLER'S (and Fascism's) Dectrines in segregating the blood plasma of Hegroes and Whites? And are you requiring that the American Red Cress, which recruits and procures the blood plasma, does not carry out this policy of segregation?"

By letter dated May 27, 1944; F.H. SCHEMRIZ, Major, Med. Adn. Corps, Blood Plasma Branch, Surgery Division, advised BEDERSON and SCHEOLKA that although there was no scientific basis for the practice of plasma segregation, there are other factors which must be considered. SCHEMRIZ stated that many



whites would object to having Negro blood injected into their veins and that although this objection might be the results of prejudice and ignorance, it nevertheless exists.

By letter dated June 5, 1914, SCI JOHN and BUDERSON again wrote to SCII LATE in parties Tollows:

"We wish to thank you for a very interesting ensure, and the frank explanation which you were so wind to give us. Since it is so unusual, we ask your permission to make it available for public consumption by releasing it to the press.

"This is not to be taken as an indication that we agree with the contents of your letter, and subscribe to the belief expressed."

By letter dated June 12, 1944 SCHALTZ declined permission for the above mentioned letters to be released to the press.


The file contained a copy of another letter from SCHLOLIA at Camp Beals, California, which was probably addressed to the Bureau of Public Relations, War Department, although the copy of the letter does not indicate to when it was addressed. This letter road as follows:

"I hereby request pormission to make available for public consumption, the enclosed two letters, as well as a third. This letter is dated 21 May 1944, and addressed to the Surgeon General's Office. It merely asks may the U.S. Army practices segregation of Megro and white blood plasma.

"I believe that publication of those letters, together with my opinions on the subject might do much to get the Surgeon General's office to discontinue its LITER-like dectrine of segregation. This would do much to prove that we are really fighting a war for democracy - in deeds as well as in theories."

The Security Office file contained a record that a censorship report reflected that in a letter to T/4 'ILLIAI SPENDIL, Box 1863, Santa Fe, New Nexico dated September 21, 1944, T/5 ERTIM COLDIAN had stated: "I am still aumiting the War Department Public Relations Office's approval for publication of certain letters."

It would appear from the above information that SPHIDLL and SCHOLKA were probably friends at Los Alamos and that SPHIDEL probably had prior knowledge of the letters set out above. ASCHIOLIC and BUDERSON wrote two of



the above montioned letters together, it seems likely that they were friends and that BIRENSGI may also have been a friend of SFINDEL.

The Security Office File at Los Alamos contained the following information concerning ALIJAM BEDESON:





while at Los Alamos WILLIAM SPINUEL was very closely associated with SALUEL ISAAC LISSMAN, MORRIS LEONARD PERLMAN, DAVID LIPKIN, NORMALFINKELSTEIN CROSS and was probably associated with IRVING R.

SCHLOLKA, BENJAMIN SELECTOR and JULIUS LEONARD SILVER, all of whom have Russian backgrounds and some Communist connections. Information concerning all of these individuals is set out elsewhere in this report.

Filliam SPINDEL was on furlough from Los Alemos from October 15, 1944, to November 4, 1944. As his home was in Brooklyn, New York, it is possible that SPINDEL made a trip back to New York at that time, and he could have

had leave shortly after November 22, 1944, but his wife was living in Albuquerque, New Mexico, at that time and it was customary for service men to make trips to Albuquerque on week ends to see their wives at that time.

EDMARD F. HAMMLL, Group Leader, CAR Division, Los Alamos, New Mexico, advised that LIPKIN was very active in the Association of Los Alamos Scientists.

Dr. LCUIS H. HEMPLIMAN, Division Leader, Health Division, advised that LIPKIN was somewhat "liberal" in his views and that he appears to be rather sympathetic towards labor and generally expresses rather definite opinions, although he never exhibits any particular interest in politics.

Dr. WRICHT H. LANGHAM, Health Division, advised that LIPKIN was rather "liberal" in his political views, somewhat along the line of a "New Deal Democrat", in that he was generally pro-labor and somewhat opposed to large corporations. LANGHAM stated that he considers LIPKIN to be entirely loyal and trustworthy, but that LIPKIN had quite often expressed a dislike for working under security regulations.

Dr. JOSEPH WILLIAM KENNEDY, Head of the Chemistry Department,

Washington University, St. Louis, Lissouri, under whom LIPKIN worked at Los Alamos, advised that he had known LIPKIN since 1937; that he knew LIPKIN disliked President TRULAN and certain senators, but he is not known to follow the Communist line of thinking in any way. KhankDY stated that at the end of the war LIPKIN was in favor of being cooperative with Russia, but at present he is in favor of a more aggressive policy toward Russia.

Ars. ROLERT SARD, 6908 Millbrook Avenue, ashington University, St. Louis, Missouri, stated that she considers LIPKIN to be loyal, but that he regrets political barriers which prevent the free interchange of scientific information between all countries.

Dr. WENDELL M. LATIMER, Chairman, Chemistry Department, University of California, Berkeley, California, advised that he disliked LIPKIN, and that although he had no reason to question LIPKIN's loyalty, he would not recommend him for classified work because of his background, namely that he is a first generation /merican of Russian-Jewish parentage.

Mr. ALLEN BLAISDELL, Director of the International House, berkeley, California, advised that LIPKIN resided there from August 1939 to June 1942. He stated that LIPKIN had been a constant source of trouble for him because of petty complaints. He stated that he had had trouble in 1940 and 1941 with Communist groups regarding the administration of the International House. During that period, he indicated, he had suspected that LIPKIN might be connected with these groups, but he was never able to substantiate this suspicion.

#### LOARIS LLCMARD FERLMAN

MO.RIS LECHARD FERIMAN was employed by the University of California, Los Alamos, New Mexico, as a chemist under DAVID LIPKIN from April 1, 1943, to January 30, 1946. He was born August 10, 1916, at Detroit, Michigan. His Tather, SAMUELAPERIMAN, was born in Russia, and his mother, EMALYPERIMAN, was born in Poland.

When FERIM N originally applied for employment at Los Alamos he listed the following references: Sam WEISSMAN, DAVID LIPKIN, and MARTIN K. WEN. Information concerning LEISSMAN and LIPKIN is set out elsewhere in this report.

K'MEN was reportedly dismissed from the DSm Project in July 19th for disclosure of "top secret information" to Mussian Consular officials. K/MEN allegedly stated at one time that he had been a

Communist all of his life. He has associated with known Communists and Russian Consular officials. K'MLN has admitted to Bureau Igents that he donated some chemical abstracts which were to be brought to Russia by ANNA LOUISE STRONG as a good will gesture to Russian scientists. He allegedly made the statement that he planned to go to Russia and pursue his work there.

The files of Confidential Informant T-2 indicate that PERLM/N may have been investigated by the Bureau as a result of his application for employment with the General Electric Company at Schenectady, New York.

The files of T-2 reflect that an investigation was conducted concerning PERIMAN at the time he was employed at Los Alamos in 1943, which investigation reflected that the files of the FBI at San Francisco contain information about one JOHN VARUMA, a possible courier or otherwise involved in the Comintern appearatus. MUMAN was reported to have been accompanied to the United States from Le Harve, France, by hiss ILSI SERLIH, who is possibly identical with ILSIE HILLE SEALIN FERIMAN, wife on accompanied to the United States indicates that ILSIE PERIMAN may have entered the United States illegally on a forged Chilean passport. ILSE SEALING was born in Poland. Her father was born in Russia and her mother in Poland.

### STRUEL ISAAC WEISSMAN

#### IRVING R. SCHACLK

The files of Confidential Informatt T-2 reflect that IRVING R. SCHMCLK: was at Los lamos, New Mexico, as a member of the Special Engineering Detachment from about /pril 3, 1944, to July 20, 1944. He was transferred from Los /lamos, New Mexico, to Camp Beale, California and was then transferred overseas about August 27, 1944, from Camp /nza, California.

Under date of may 21, 1944, Pfc. IRVING R. SCHLOLKA and T/4 BENJAMIN BEDEASON wrote the following letter to the Surgeon General, wer Department:

"In these critical times, when all of we Americans are united in fighting the evils of Fascism and Fascist Doctrines, we take time out just long enough to inquire whether or not you are carrying out one of Hitler's (and rascism's) Doctrines in segregating the blood plasma of Negroes and whites: Ind are you requiring that the American Red Cross, which recruits and procures the blood plasma, does not carry out this policy of segregation?"

By letter dated May 27, 1944, F. N. SCHWARTZ, Major, Medical Administration Corps, Blood Plasma Branch, Surgery Division, advised BLDLASON and SCHWOLAA that although there was no scientific basis for the practice of plasma segregation, there are other factors which must be considered. SCHWARTZ stated that many whites would object to have Negro blood injected into their veins and that although this objection might be the results of prejudice and ignorance, it nevertheless exists.

By letter dated June 5, 1944, they again wrote to SCH RTZ in part as follows:

frank explanation which you were so kind to give us. Since it is so unusual, we ask your permission to make it available for public consumption by releasing it to the ress.

"This is not to be taken as an indication that we agree with the contents of your letter, and subscribe to the belief expressed! By letter dated June 12, 1944, SCH. JRTZ declined permission for the grove mentioned letters to be released to the Press.

The file conteined a copy of another letter from SCHMCLKA at temp Beale, California, which was probably addressed to the Bureau of Public Relations, war Department, although the copy of the letter does not indicate to whom it was addressed. This letter read as follows:

"I hereby request permission to make available for public consumption, the enclosed two letters, as well as a third. This letter is dated 21 May 1944, and addressed to the Surgeon General's Office. It merely asks why the U.S. rmy practices segregation of Negro and white blood plasma.

"I believe that publication of these letters, together with my opinions on the subject might do much to get the Surgeon General's office to discontinue its Hitler-like doctrine of segregation. This would do much to prove that we are really fighting a war for democracy - in deeds as well as in theories."

The files of T-2 reflected that in a letter to T/4 lilliam Srindel, Box 1663, Santa Pe, New Mexico, dated September 21, 1944, T/5 IRVING SCHMOLKA had stated that "I am still awaiting the Mar Department helations Office's approval for publication of certain letters".

It would appear from the above information that SPINUEL and SCHLCLKA were probably acquaintances at Los Alamos, and that SPINUEL probably had prior knowledge of the letters set out above. As SCHLCLKA and BEDERSCN wrote two of the above mentioned letters together, it seems likely that they were friends at Los Alamos, and that BEDERSCN may also have been a friend of ILLII in SPINUEL.

#### BENJAMIN BEDERSON

According to the files of T-2, BEDERSON was in the Special Engineering Detachment, U. S. Trmy, Los Alamos, New Mexico, from about March 1944 to February 1946. He was assigned to Group X-2, which is in the division that was headed by GEORGE B. KISTI KOWSKY at that time.

Investigation conducted concerning BEDERSON in June 19th in connection with employment at Los Alamos, reflect that the files of the United States Givil Service Commission indicate that MS Father ABRAHAN BEDERSON, was a registered Communist for the years 1936 and 1937 in the 6th Assembly District, 125th Election District, Bronx County. His mother, IEAN PEDERSON, was a registered Communist for the same years in the same district. LENA BEDERSON signed a Communist nominating petition for ISIDORE BEGUN, August 10, 1939, 6th Assembly District, 130th Election District, Bronx County. ### JULIUS LECN'RD SILVER

JULIUS IEON/RD SILVER was at Los Alamos as a member of the Special Engineering Detachment, U. S. rmy, from about March 1944 to February 1946, and was assigned, at least part of that time, to Group LM-1. He was born June 15, 1923, at New York, New York. His father was born in Russia and his mother was born in Poland. In 1944 he stated that he had resided at 400 Saratoga Avenue, prooklyn, New York, since 1939. He attended Brooklyn College, brooklyn, New York, from rebruary 1940 to February 1943, majoring in Chemistry.

The files of T-2 contained the results of an investigation conducted concerning SILVER in connection with his employment at Los ilamos.

No information was available at the Albuquerque Cifice at the present time which would indicate that SILVER and WILLIAM SPINUEL were associates. However, it is pointed out that they both worked in the Chemistry Research Division at Los Alamos at the same time, and that they both attended Brooklyn College at the same time, both majoring in Chemistry.

The report of SA WILLIAM. BRANIGAN, Sen Francisco, California, deted January 31, 1947, in the CINKAD case reflects that JOSEPH
GREENSPAN, according to NED, was the main figure of a group of individuals

employed on the D.S.L. Project in the New Lork Free, all of whom were known to be sympathetic to or actual members of the Communist Farty. Included in this group, reportedly under the domination of LALLING FOR OPENIS, and JULIUS SILVER.

### Dr. JOSEPH GREENSPAN

GREENSPAN was given as a reference by WILLIAM SPINIEL at the time SPINIEL was assigned to the Los Alamos Project as a member of the Special Engineering Detachment of the U.S. Army.

according to the report of SA JOHN R. MURPHY, JR., at New York, dated March 9, 1950, in the FOOC/SE, Dr. JOSEPH GREENSPAN was employed as an instructor in the Chemistry Department at Brooklyn College, Brooklyn, New York, from 1939 to 1942. He was employed by the Rockefeller Institute, Last 66th Street and Tork / venue, New York, from 1942 to 1943 at which time he was reported to be very friendly with Dr. HARRY GRUNDFLST, a contact of fathur ADAMS. Other contacts included IRVING ROBERIS, CLIRENCE HISKLY, Dr. ELVIN KALAT, and in the /LLX' DER B. NOVIKOFF. According to T-3, of known reliability, laving ROBLETS and his wife were members of the Communist Party before 1941 end until 1944, when eccording to the Informant, they were placed on the inactive list at ROBERT's request because he occupied a very inportent position, the nature of which be would not discuss. According to the same New York report, Dr. HARRY GRUNDIEST has been active in the American Association of Scientific Workers for several years. Presently he is the International Corresponding Secretary and corresponds with scientists throughout the world. He has continuously followed the Communist Party line, and is a member of the korld Federation of Scientific Lorkers. GRUNLFEST'S contacts include LEMELIXFUARY, a brother-in-law of ISAALL H LFLALW, a defendent in the GUZLWKO case. He also has communicated with Professor R. MacND Build and NORMAN K. VL LL, both of whom were involved in the GUZLNKO case.

Confidential Informant T-4 advised on May 29, 1944, that a telephone call was made from the residence of VICTORIA STORE, 39 West 55th Street, New York City, to GRUNDFEST'S telephone number in New Jersey. It is conceivable that ARTHURA DAMS, Soviet agent and paramour of VICTORIA STORE, was in touch with GRUNDFEST at that time. It is also known in 1944 'DAS had GRUNDFEST'S telephone number in Rumson, New Jersey, listed in his personal address book.

In June 1945, it was reliably reported that GRUNDFEST had

access to the Soviet diplometic pouch.

Surveillance of GaunditST revealed the following information of possible significance:

On December 14, 1944 OKUNDELOT left Rumson, New Jersey, and went to the home of major B. FAILLER Washington, D. C. It is noted that on October 8, 1944, ZELLIER KERKELLER, wife of Major B. F. allier, was in contact with ARTHUR IDAMS, Soviet Agent, in New York City, between trains when she was en route from Bedford Hills, New York, for Lashington. Mrs. MILLER was then employed in the Naval Medical hesearch Laboratory, Bethesda, Maryland.

On December 15, 1944, GRUNDFEST came to New tork, went to the Horace Mann School, 120th Street and Broadway, and after attending a meeting, came out with one ALEX B. NOVIKORF.

On January 25, 1945, GRUNDFEST came from New Jersey to Pennsylvania Station, New York, New York, where he acted in a most peculiar manner, making eleven telephone calls, each from a different booth in the Pennsylvania Station. This could possibly be connected with the

GRUNDFEST was employed in the Climatic Research Section of Materials and Pre-Service Test Branch, Fort monmouth Signal Laboratory iron key 1, 1943, to December 23, 1944.

Personnel Security Cuestionneire completed by SiR. List.

\*\*SPINUEL, wife of VILLIA SPINUEL, reflects that she was employed from pril 29, 1943, to June 23, 1943, at the Signal Corps Ground Signal Service, mar Department, Fort monmouth, New Jersey. SARA LEW SPINUEL was a member of the Communist Party in march 1944, and it is conceivable that she may have known GRUNDFIST at Fort monmouth, New Jersey.

Confidential Informant T-5 advised that the records of the Classified Documents Room of the University of California at Los lamos reflect that SPINDEL had an access card originally signed by POTR/TZ

on September 19, 1944, and later by 5.4 MISSMIN, giving him access to all documents on Chamistry, metallurgy, and health. A further check however reflected that ILLL & STINDEL had never charged out a document from the document room in his name. T-5 made a further check of documents signed out in the name of Simural Lissmin, Divid Lirkin, and Morris Phrisin and advised that only a very few documents had been signed out in the names of any of these individuals. He stated that a great number of documents had been signed out to Dr. JUSLPH WARMANDY who was formerly the Division Leader of the Chemistry Division at Los Alamos. A list of the documents signed out to Kembelly covered thirteen pages. T-5 stated that he thought it was very likely that almost all classified documents necessary for work in the Chemistry Division had been signed out in the name of the Division Leader, and that no doubt many members of the division then had access to these classified documents.

Confidential Informant T-2 stated that he knew of no list of individuals who had white brdges during 1944 and 1945.

Files maintained by the Central Mail and Records Branch, University of California, Los Alamos, New Mexico, under the name of JOSEPH ... KENNEDY, reflected that the name of VILLIAE SPINIEL appeared on each list of colored badge personnel elgible to attend division meetings through a list dated January 8, 1945. ILLIAE SPINIEL'S name was not on the list dated January 22, 1945, or subsequent lists, which would indicate that SPINDEL was issued a white badge which would automatically entitle him to attend division meetings sometime between January 8, 1945, and January 22, 1945.

The following investigation was conducted by SA RCY I. EISCHKE concerning SARA LEW SPINDEL under the pretext that she was an applicant for a position in which the government was interested:

She stated that he occasionally came to albuquerque and spent a few hours with his wife but that she does not recall that he was ever able to stay all night or spend a week and there.

She stated that for this reason she had very little contact with LILL & SPINUEL.

Mrs. H'RDY described S'R' SPINDEL as a "brilliant but peculiar" person and explained that she considered her peculiar because of the fact that SPINDEL had no friends or associates in albuquerque. She stated that during such periods, S'R' SFINDEL was not employed and that she took her meals cut and spent nearly all of her time in her room. She stated that SPINDEL read a good deal during that period but she does not recall what sort of literature she possessed.

was located in the downstairs dining room and that 5/RA SPINDEL called or received a call from her hustand killiam SPINDEL nearly every evening. She stated that there never seemed to be anything suspicious about such calls and that the SPINDELS did not in any way attempt to be secretive in their conversation. She stated that a large percentage of the time either she or her daughter-in-law was present during such calls. Ars. HARDY stated that inasmuch as the phone was listed in her name, she is quite positive that no one made any long distance call charging it to that telephone to any place other than Los Alamos during the time that SARA SPINDEL resided there. She stated that there may have been a few times when both she and her daughter-in-law were absent from the house but that to her knowledge, neither SARA nor WILLIAM SPINDEL has received any long distance telephone call at that phone from any location other than Los Alamos.

hrs. H nDY stated that SiR' SPINDEL did not take or plan any extended visits during the time that she resided at her house and that she never indicated that her husband took or planned any trip outside of New Mexico during that period.

As set forth above, Mrs. HERDY stated that SAR' SPINDEL did not have even one friend or close associate in Albuquerque and she also stated that SPINDEL did not associate with any of the other individuals residing in the neighborhood and that she is quite sure that none of the neighbors would even recall SrINDEL.

hrs. Hindy stated that she considered Simi SPINDEL to be of good character and that she never had any reason to question her loyalty in any way.

check of old telephone directories revealed that Albuquerque telephone number 9717 was assigned to are. ERY E. HARDY at 824 worth 5th Street, in 1944.

New Lexico, advised that she is the daughter-in-law of L'RY E. HARDY and resided at 824 North 5th Street during the time that SARA SPINDEL maintained a room there. H.ZEL HARDY also stated that SARA SPINDEL obtained a room at that address sometime in the fall of 1944 and resided there continuously until an unrecalled date in the following winter when she moved to an apartment on hest Coal venue in /lbuquer-que.

She likewise was unable to furnish any exact or even approximate dates of such residence but stated that she is quite sure that SPINDEL resided in the apartment on morth 5th for a period of three or four months.

H'ZEL H'ADY furnished substantially the same information as her mother-in-law and stated that she never knew SARA or MILLIAM SAINDEL to ever make or receive any long distance telephone calls from or to any location other than Los Mamos.

She also stated that SAMA SPINDEL did not make any extended trips during that period and never gave any indication that her husband, WILLIAM SPINDEL, made or planned any such trip.

She further stated that SIM SPINDLL was very cautious about making any statement pertaining to the place at which her husband was stationed or the work he was doing at that time.

She also stated that SAMA SPINDEL did not have even one friend or associate other than her and her mother-in-law in Albuquerque during that time and that "ILLIA". SPINDEL never brought any individual to the house on any of his infrequent visits with his wife.

The 1945 and 1946 city directories for the City of /lbuquerque reflect that \!!!!! and S'RA L. SPINDEL resided at 613 kest Goal and that S'RA was employed as a clerk at the Veterans idministration facility.

She stated that one does not believe that any of the people who were employed at the hospital of that time knew any more about of hospital than she did.

Ars. Miny Kinylly, cook and cafe operator, 613 most Goal, advised that in 1945 she had her residence at that address divided into apartments and that she lived in one of the apartments and rested the other to SARA SPINUEL for a period of several months. She stated that SPINUEL resided in such apartment from sometime in the early Spring of 1945 to late Summer or early Fall of the same year. She has no record and is unable to recall the exact dates.

KINTLY stated that during part of such period S/RA SPINDEL was employed at an unrecalled place in Albuquerque and that to her knowledge only SFINEL's husband, LILLIA SPINDEL, resided with her during any of that time. She explained that LILLIA SPINDEL was stationed at Los Alamos during such period and that he usually spent his week ends with his wife but otherwise was never at the apartment.

KINTLY stated that she had very casual and infrequent contacts with either of the SPINDELs. She stated that Lrs. SPINDEL did not appear to have any close friends or associates in Albun erque or vicinity other

than her husband and that she does not recall any individual actually visiting in the SPINDEL apartment. She stated that SALL SPINDEL kept very much to herself and that she does not believe that my of the individuals who resided in neighboring houses during that period would even recell SPINDLL.



The file captioned "Vacations - Tech Area" in the possession of T-2, reflects that Mrs. AUGUSTA HATELIER, wife of Dr. EDWARD TELLER, made a trip to Chicago, Illinois, and New York, New York between November 6, 1944, and November 20, 1944. It appears that she probably traveled with her husband from Los Alamos to Chicago and from Chicago back to Los Alamos as he claimed reimbursement for one half of a bedroom to and from Chicago during the same period.

T-2 made available a file containing a memorandum dated October 16, 1944, from PEER de LILVA, Asjor, Corps of Engineers, 10, Santa Fe Branch Office to Capt. GEORGE DAVIS, Vashington Lieson Office, P. O. Box 2610, Washington, D. C. captioned "Relatives of Site"Y" Scientist in Occupied Countries". This memorandum read in part as follows:

the fact that EDWARD TELLER is of key importance to this Project, and is the head of the Theoretical Physics Division. His valuable work in the field of physics of peculiar interest to this Project is widely known, and presumably known to the Germans.

The report of S. THOMAS M. KERNUT, at Chicago, dated May 5, 1947, reflects that on April 11, 1947, Dr. EDWARD TELLER voluntarily contacted S.A. R. RULEN FAXMAN of the Chicago Office and advised that he had recently received a letter from his wife's brother, G. RBCA SCHUTZ, in Hungary, and suggested that TELLER should come to Hungary and see for himself conditions there. TELLER informed S.A. PAXMAN that this person was the only member of either his or his wire's family who has ever shown tendencies other than anti-Communist or anti-kussian.

It will be noted that TELLER did not give the name of his brother-in-law, GARBOE SCHUTZ at the time he contacted the Intelligence Office at Los Alamos, New Mexico, in October 1944, although he did give the name of another brother-in-law who was in Hungary at that time.

In Encyclopedia of World History compiled and edited by WILLIAM L. Lingle on page 115h states: "German forces of occupation in Yugoslavia were harassed increasingly by the Partisans and failed to halt the advance of the Russians who entered Belgrade October 20, 19hh. Two weeks later they were at the gate of Budapest, but the Hungarian capital resisted savagely for over two months and was not conquered until February 13, 19h5.

University of California travel vouchers reflect that Dr. LDNARD TELLER left Los Alamos on November 6, 1944, and that he was in New York City from November 11 to 13, 1944. TELLER apparently went from New York City to Princeton, New Jersey, on November 13, 1944. It is not known when he returned to New York City from Princeton, but he left New York City for Knoxville, Tennessee, on November 16, 1944. It will be noted that T-1 advised that on

Mrs. AUGUSTA H. TELLER reported that she made a true to

Chicago and New York City between November 6 and 20, 1944. The purpose of this trip is not known, but in view of the TELLER's concern about their relatives in Budapest in October 1944, and as the Russians were at the gate of Budapest in the first few days of November 1944, it is possible that she may have gone to New York City in November 1944, for the purpose of trying to obtain some information concerning these relatives. It is also possible that any such inquiries by the TELLERS may have come to the attention of MGB which caused them to contact TELLER.

No information is available to the Albuquerque Office at the present time as to the status of Thinka's relatives in Hungary.

T-1 reported that according to

for both Dr. and Mrs. TELLER have been destroyed. At that time Mrs. TELLER was working only part time. Her regular salary was \$75.00 per month. An examination of the University of California payrolls during the pertinent period reflected that Mrs. TELLER received a full check for \$75.00 for the month of November 1944. Her check for December 1944 was for only \$45.00. She received a full check for \$75.00 in January 1945. It is not know whether the time that she was away from the Project in November 1944 was deducted from her check dated December 31. 1944, or whether she also was absent on leave in December 1944. It is not considered advisable to make any specific inquiries about Mrs. TELLER at this time.

Dr. EDW'RD TELLER is presently the 'ssociate Director for Reapon Development at Los Alamos. /ccording to T-2 he is probably the top scientist at Los Alamos at the present time and has complete knowledge concerning atomic weapon development.



It was stated that this file consisted of two manila folders and contained so much material that it was not practicable to make a list of each item.
