U. S. SERVICE AND SHIPPING CORPORATION

INTERNAL SECURITY - R

Reference is made to the report of Special Agent L. J. Prater dated February 10, 1942 at New York City entitled, "World Tourists, Incorporated; Jacob Raisin, with aliases; U. S. Service and Shipping Corporation; John Hazard Reynolds, with aliases; Elizabeth Terrill Bentley, with aliases; Earl L. Spector, with alias; Registration Act, Espionage - E" New York file #7-13. There are numerous leads set forth in this report which have apparently received no investigative attention whatever. On January 16, 1944 Special Agent William Francis Morton, Jr. submitted a closing report at New York City entitled, "Jacob Raisin, with aliases; Internal Security - C" indicating that Raisin, who was the director and sole stockholder of World Tourists, Incorporated, had died on November 23, 1943 in New York City.

The Bureau file on World Tourists, Incorporated and the U. S. Service and Shipping Corporation, does not contain any information regarding the current activities of either organization. It is desired that this case be brought up to date at once and a complete report submitted showing the recent and current activities of these two affiliated concerns as well as complete data regarding their personnel. All of those who are using the services of these companies to send material to Russia should be identified and their activities developed. This, of course, applies both to individuals and various concerns about the country which may be acting as subagents for World Tourists, Incorporated. It would appear that World Tourists, Incorporated and the U. S. Service and Shipping Corporation are still in operation as on April 3, 1944 Konstantin Fedoreev, who is listed as a translator at the Russian Embassy in Washington, D. C., in answer to an inquiry made to the Embassy regarding the shipment of material to Russia, stated that this could be done through World Tourists, Incorporated, 1123 Broadway, New York City and the U. S. Service and Shipping Corporation, 212 Fifth Avenue, New York City.

The investigation of these two organizations is to be conducted primarily from an Internal Security standpoint in order that the Bureau may be apprised of the activities of these concerns and their personnel and any connections with the Communist Party, members or fronts thereof, or official Soviet representatives. Although it is desired that full intelligence information be developed in this investigation it should be kept in mind that a violation of a federal statute may be developed which will warrant prosecution, particularly the Foreign Agents

On May 5, 1944, the Bureau pointed out that this file did not contain any information regarding the current activities of the subject organizations. These Companies are known to have been used by the Russians in the shipment of material. In fact, it is known that the Russian Embassy in Washington, D.C. has recommended the use of these Companies.

On August 2, 1944, the Bureau directed attention of the New York Office to the failure to submit a report in this case and requested that a report be submitted in the near future. The Bureau has not been apprised of the inability to comply with its instructions. An explanation is desired for the failure to afford this case appropriate attention.

The instant case was assigned to Special Agent Robert H. Flatley on May 22, 1944, shortly after the letter from the Bureau was received on May 5, 1944 requesting that this case be brought up to date. It was necessary to utilize this Agent on a physical surveillance for a period of several months and for this reason he was unable to devote his investigative attention to this case. This Agent was recently transferred from Section #7 in compliance with the six months rule whereby an Agent must be given a different type of investigative activity. This case will be re-assigned and an investigative report submitted as quickly as possible.

US SERVICE AND SHIPPING CORPORATION remains active as package shipping agency, arranging for shipments of packages to Soviet Russia. President JOHN H. REYNOLDS, presently on duty with US Army, holds rank of major. Activities of US SERVICE AND SHIPPING CORPORATION presently being directed by ELIZABETH T. BENTLEY, Vice President and Secretary. Financial activities set out. Monthly average for 1943 of transfer of funds by US SERVICE AND SHIPPING CORPORATION to INTOURIST, Soviet Russia, \$3,600; for first nine months 1944, \$5,200.

DETAILS: At New York, New York:-

The title of this case is being changed to reflect the elimination of the name JACOB RAISIN, with aliases, in view of his death in 1943.

For the sake of brevity, the US SERVICE AND SHIPPING CORPORATION will, in this report, be referred to as the USS&S CORPORATION.

In an article entitled "JACOB GOLOS, Long Advocate of US-Soviet Amity, Dies Here", taken from the "Daily Worker" dated November 27th, 1943, the following excerpt appeared:

"In the past dozen years he was connected with the WORLD TOURISTS, cooperating in promoting travel to the Soviet Union. Through this agency many organized groups of teachers and professional workers went to the Soviet Union and learned of the democratic strength and progress of that great nation. This proved to be a big contribution to better understanding. Since travel has been cut off by the war, the WORLD TOURISTS have performed a fine function in organizing the sending of packages to individuals in the Soviet Union whom Americans know and want gifts and remembrances sent to. GOLOS was busy in directing this work when death overtook him."

WORLD TOURISTS, INC is presently located in Room 607, 1123 Broadway, New York City, and is engaged in selling steamship tickets and travel service throughout Mexico, Florida, Cuba, and South American points, and its principal activity consists of handling packages being shipped to the USSR.

The Directors consisted of the officers named above and CHARLES S. BANNERMAN.

The USS&S CORPORATION, located at 212 Fifth Avenue, New York City, was engaged as of June 17th, 1943 in the shipment of packages from the United States to Soviet Russia. It was described as the sole agency for the Tourist Agency of Soviet Russia and collects duties and fees for that government.

Confidential Informant T-3 furnished the following information regarding the banking activities of the USS&S CORPORATION at the Chase National Bank.

The USS&S CORPORATION has both a regular checking account and a special checking account. The special checking account, opened June 23rd, 1941, has had an average monthly balance of less than \$100. A review of the records made available by Confidential Informant T-3 reflected that the monthly average of funds transferred to the STATE BANK, Moscow, Russia, for the account of the USSR travel agency, INTOURIST, for 1943 was \$3,600 and for the first nine months in 1944 was \$5,200.

Mr. DANIEL LUXENBURG, of Spear and Company, 225 Fifth Avenue, New York City, advised that he was no longer real estate agent for the building at 212 Fifth Avenue, New York City, inasmuch as the building had recently been sold. He advised that the agent for the new owners is OMNIA PROPERTIES, INC., 30 Broad Street, New York City.

Mr. LUXEMBURG advised that he had no information regarding the present activities of the USS&S CORPORATION, which occupies office space at 212 Fifth Avenue, New York City, but stated that he knew JOHN H. REYNOLDS and advised that Mr. REYNOLDS is now a major in the United States Army and is believed to be stationed at Staten Island at the present time. He advised that he has seen nothing of a suspicious nature regarding the activities of the USS&S CORPORATION and could furnish no further information.
