ELIZABETH T. BENTLEY SECURITY INFORMANT

In a memorandum dated 10/7/54 from Assistant/Attorney General Tompkins it is pointed out that in taking testimony from persons named by Elizabeth Bentley before Federal grand juries (seeking a person who will testify after being granted immunity), there has arisen certain discrepancies between Bentley's statement and statements made by several of the subjects under oath. Tompkins requests the Eureau to arrange for an appointment with Bentley for two Departmental attorneys in order to resolve these points. We do not know the nature of the discrepancies referred to, although we have been furnished by the Department the Grand Jury testimony of William H. Taylor, who appeared 9/20/54. Taylor's testimony is voluminous, covering 111 pages, and it has been carefully studied and analyzed in connection with our voluminous file on the Nathan Gregory Silvermaster case, with the following results to date:

In his testimony Taylor lists six points which he claims show certain of Bentley's testimony is inaccurate. (In November, 1953, Taylor instituted a libel suit against the "Washington Daily News" and it appears Taylor and his attorncy have made a thorough study of Bentley's testimony, seeking possible points, no matter how small, with which to discredit her.) The points made by Taylor before the Grand Jury on their face seem to indicate small inaccuracies on Bentley's part, but, at the same time, Bentley has testified on many occasions before Congressional committees and on occasions has had to answer questions calling for answers not known first-hand to her. It is only normal that some of this information would be subject to question. Nost of the points made are somewhat insignificant and do not discredit the over-all weight of her testimony. The points made by Taylor are as follows:


Comment: Bentley in her testimony on 7/31/48 before the House Committee on Un-American Activities (HCUA) did state she learned about D-Day in advance from Ullman who had learned the date through his connections with General Hilldring's office. Bentley, in her statement to us dated 11/33/45, stated she had received information concerning the approximate scheduled date of D-Day.

Comment: It is noted that Bentley in testimony before the ECUA in July, 1948, did testify as alleged by Taylor. She was, therefore, inaccurate in her statement at that time. She has told us that she met with the Perlo group in the Spring of 1944 at the instructions of Earl Browder and that she discussed with them the paying to her of Communist Party dues.

(b)(3) (b)(e) STATUTE

Comment: Attorney General Brownell, in his speech of 11/17/53, in summarizing the contents of our summary on Harry Dexter White, sent to the White House on 2/4/46, speaking of the Perlo group stated: "The information gathered from the Perlo group was channeled through Jacob M. Golos and on to the Soviet diplomatic establishment in the same manner as outlined for the operation of the Silvermaster group." The data in our February, 1946, summary, which coincides with A.G. Brownell's statement, came from the signed statement of Bentley dated 11/30/45, wherein Bentley states that prior to Golos' death he told her that he had made contact with another group in Washington through Earl Browder. In the Spring of 1944 Browder told her of this group that Golos had been contacting and instructed her to establish contact with them, which Bentley then did.



Comment: Bentley testified on 10/21/53 before the McCarthy Committee that she never met William Taylor. She told us that it was her recollection of Taylor that he was sent to China as a Trecsury representative and was later sent to Portugal. She testified in a similar manner before the HCUA on 7/31/48. We previously have considered this seeming inconsistency on Bentley's part, but, as her information was hearsay on this point, she is unable to go back of it.

#### OBSERVATIONS:

The Bureau has a definite interest in Elizabeth Bentley. She has been interviewed on repeated occasions by Bureau agents. Interviews with her at this time to resolve these alleged discrepancies would be more productive and accurate if conducted by Bureau agents who have a background of the Silvermaster case and a familiarity with Elizabeth Bentley than would an interview by Departmental attorneys.

RECOMMENDATION: It is recommended we reply to the Department's request by pointing out to them that it would be more desirable for agents having knowledge of the Silvermaster case and Bentley to resolve these alleged discrepancies. If the Department will furnish the Bureau with a list of these discrepancies we will interview her and furnish the results to the Department. Thereafter, if the Department desires to further interview her or take her before a grand jury, we will have no objections.





Pentley has testified on 10/21/53, before the McCarthy Committee, that she never met William Taylor. In her statement to the Bureau on 11/30/45, and before the House Committee on Un-American Activities on 7/31/48, she stated she believed Taylor was in the Treasury Department and that he had gone to China and Portugal.

Each of the points raised by Taylor can seemingly be exclaimed by data available in Eureau files. However, to avoid any possible future embarrassment, each point raised should be discussed in detail with blizabeth Bentley. She should not be told that Taylor in his appearance before the Grand Jury on 9/20/54, raised these points. It should be pointed out a review of her testimony and certain of ner writings have pointed out certain variations in her story. She should be asked for her explanation for these variations on each point. Bentley should also be told that these points might be raised in an effort to discredit her, in the event she were to appear as a Government witness at any future hearings. Results of your interview should be promptly furnished to the Bureau.

Miss ELIZABETH BENTLEY was interviewed at Lafayette, Louisiana, on December 5, 1954, at which time the discrepancies pointed out by WILLIAM HENRY TAYLOR were discussed with her.

1. Second Paragraph, Referenced Letter. Miss BENTLEY advised that the information regarding a raid was received from ULIMAN but that there was no information as to the identity of the individual who was to be in charge of the raid. Miss BENTLEY advised that she recalled definitely that the raid was to be held on the Emperor's birthday and she stated that she has never referred to the raid as the Doolittle Raid, as the identity of the person to be in charge of the raid was not known at that time.

Miss BENTLEY pointed out that after WILLIAM LUDWIG ULIMAN went into the armed services in October, 1942 it was several months before he was finally sent back to the Pentagon Building where he subsequently had dealings and connections with the B-29 Program at Dayton Field. Miss BENTLEY again stated that she has never referred to the raid as the Doolittle Raid on Tokyo. In fact, she stated that as far as she can recall now the place of the raid was not known to ULIMAN at that time.

2. Paragraph 3, Referenced Letter. Miss BENTLEY, advised that the information regarding D Day came to her from WILLIAM LUDWIG ULLMAN, but that the exact date the information was received by her is not recalled. She stated that as far as she can recall now that the information was received from one to four days prior to D Day but that the information was not received in sufficient time to be of any value to the Russians.

Miss BENTLEY stated that she definitely recalls this information coming from ULIMAN, and that she recalls that he told her that he had made a bet with an individual, not identified, at the Pentagon regarding the date of D Day, and remarked to her that the individual with whom he bet did not have a chance as he, ULIMAN, knew when D Day was going to be.

Miss BENTLEY pointed out that in her book, "Out of Bondage" she states that this information was received four days prior to D Day; however, she stated that this date was selected at random in view of the fact that it was from one to four days prior to D Day that she received the information from ULIMAN.

Miss BENTLEY advised that ULLMAN at that time was cultivating a Major KODES, who was an aide to General HILLDRING at the Pentagon Building, and that he in all probability received information regarding D Day through this source.

3. Paragraph 5, Referenced Letter. Miss BENTLEY advised that she did not know the VICTOR PERLO Group prior to the death of JACOB GOLOS in November, 1943. She stated that in March, 1944, she met with PERLO, KRAMER and FITZGERALD at the home of JOHN ABT. She stated that it was also on this date that she met HARRY MAGDOFF.

Miss BENTLEY advised that when she appeared before the House Committee on Un-American Activities on July 31, 1948,

Miss BENTLEY added that she never saw a transcript of her testimony before this committee and consequently was not given a chance to make any corrections in regard to her testimony.

There still appears to be some confusion regarding the so-called Doolittle Raid on Tokyo ... (April, 1942) and the use of B-29's. For your information and assistance the Doclittle Raid in April, 1942, involved the use of sixteen B-25 bombers which took off from the U.SS. "Hornet" (naval aircraft carrier) for the Tokyo raid. The B-25 is a twin engine medium bomber in use during World War II. Obviously the B-29, s multiengined neavy bomber, used during World War II and which was not operational in April, 1942, could not have been utilized. At a later period in World War II the B-29's were operated from land bases against the Japanese mainland.

It appears that Bentley in discussing the B-29 and indicating she received this information after the death of Jacob Golos in November, 1943, could not have meant the Doolittle Raid which took place in 1942. However, in her appearance before the McCarran Committee in May, 1949, Bentley did testify that data on the Doolittle Raid on Tokyo was available to her from a company William Ludwig Ullman. The information relative to 🎿 the Doclittle Raid on Tokyo was interjected during Bentley's testimony concerning Ullman on 5-13-49. SiBentley was testifying about data re the B-29 when

Miss BENTLEY was interviewed on 12-17-54 at Lafayette, La., at which time she advised that she never received any information regarding the so-called Doolittle Raid on Tokyo in April, 1942. In fact, she stated, she never heard of the Doolittle Raid until about 1949 when she was testifying before the McCarran Committee concerning the B-29 Program. Miss BENTLEY advised that if she testified before this committee that ULLMAN had furnished her information in advance regarding a raid on Tokyo wherein the B-29s were used and the raid was known as the Doolittle Raid then this testimony is incorrect as she stated she never received any information regarding a Doolittle Raid prior to the time the raid was executed. Miss RENTLEY stated that the question, "Did you have any information respecting the Doolittle Raid on Tokyo which you transmitted as a courier?" came up during her testimony before the McCarran Committee; however. she stated she assumed that the question referred to the raid which was supposed to be conducted with B-29 Bombers in the early part of 1944.

Miss BENTLEY further related that all of her testimony before this McCarran Committee in connection with information she had received from ULLMAN was in connection with the B-29 Program.

Re Paragraph B of SAC letter No. 55-13.

Miss BENTLEY was originally developed as a Security Informant by the New York Office. She has been living in the New Orleans territory since April, 1953, and is contacted frequently by the New Orleans Office at the request of other Bureau Divisions, particularly in Espionage cases. She has been carried as a Security Informant in the New Orleans Office since October 7, 1953.

New Orleans does not have complete information concerning Miss BENTLEY's former weaknesses while she was an informant at the New York Office, however, she is constantly beset by representatives of the press, investigators of other Government agencies, congressional committies, attorneys, etc. When contacted by one of the above, she immediately contacts the liaison agent for consultation and advice. To date the New Orleans Office has been able to maintain close liaison with her and has been able to keep informed of events as they occur.

As the Bureau pointed out in Paragraph N of SAC letter 54-28, Miss BENTLEY has been under considerable mental strain. It is the observation of agents in this office contacting her that she is emotionally taunt.

To overcome this difficulty and to safeguard against possible future complications, the resident agent, at Lafayette, Louisiana (in which territory Miss BENTLEY, resides) maintains frequent contact with her and is in a position to consult with Miss BENTLEY whenever she feels she has a problem. In the past when the resident agent at Lafayette has been unavailable to consult with, Miss BENTLEY has communicated telephonically with agents known to her in the New Orleans Office.

The above tactics are being followed in an () attempt to control Miss BENTLEY's apparent difficulty.

In view of her value to the Bureau in espionage cases, she will be retained as a Security Informant UACB.

According to newspaper accounts, in testinony given before the Senate Internal Security Didocumittee on P/21 and 2/27/35, Natusow claims he believes Bentley has given false testimony. Fursuant to a request from the Eureau, the New Orleans office by steletype 2/22/35 advised that Bentley, Ir. Buth Natthews and Natuson met at a luncheon on 18/3/22. She categorically denies the accusation made by Natusom and claims she has never given julies testimony nor furnished false information to the IBI. The cald she had no discussion with Latusow on the fiving of false testimony, but recalle testing him that she needed a fob.

Instructors were issued telephonically to the El office by Inspector Ecoy on E/23/35 to locate and interview Er. Buth Watthers for information concerning any conversation the recalls during the luncheon with Matusow and Bentley on 19/3/52. Lewspaper accounts also indicate that at the dinner Katusow speaks of he claims a former roommete of his, Llewellyn Eatts, was present and may have heard some of the conversation. The MI office has been instructed to locate and interview Eatts for information concerning the Pentley maiter and also for other information concerning Matusow. The New Orleans office was telephonically instructed by Inspector Ecoy to develop from Bentley further devails on this entire matter, including any and all meetings with Matusow. Both offices were also instructed to give this matter immediate attention and to see that all leads are thoroughly and promptly covered.



Former SA Joseph M. Kelly telephonically contacted Supervisor R.J. Lamphere on the evening of 2/24/55. He stated he had just received a long-distance telephone call from Elizabeth Bentley who said she had been trying to reach the Director. She indicated she wanted to talk to someone at the Bureau who had knowledge of her current difficulties as a result of the allegations made by Harvey Matusow to the effect that she had given false testimony. Kelly explained to her that he was no longer with the Bureau and suggested she might desire to speak to me or to Supervisor Lamphere.

Elizabeth Bentley telephonically contacted Supervisor Lamphere at his residence at 8:20 p.m. on 2/24/55. indicated she had previously attempted to reach the Director and had spoken to Inspector McGuire. She said her purpose in calling Supervisor Lamphere was her desire to talk to someone who was familiar with her current troubles. She indicated she was considerably upset by Matusow's allegations and it appeared she probably had been drinking. Bentley said she is worried because she does not have a clear recollection of when she first met Matusow and does not recall meeting him on 10/3/52 at a dinner as he alleges. She does recall meeting him at a luncheon which was also attended by Dr. Ruth E. Matthews in 1952, but she does not recall the date of this luncheon. She said Dr. Ruth Mathews had telephonically / contacted her on 2/24/55 after having been interviewed by our agentsin New York City. Ruth Matthews told her the date of the luncheon was 12/4/52. Bentley said she, herself, has no records which would show when she met Matusow or under what circumstances. She is worried inasmuch as the Senate Internal Security Subcommittee has informed her she is to be subpoended in the near future. wanted to know if the FBI in New York City would have any records

SUBJECT: ELIZABETH BENTIEY

I called SAC Chiles in New Orleans at 8:10 Pk, today. I advised him of Bentley's call to the Bureau. Chiles said that Bentley had been in touch with the New Orleans Office and that a teletype has been prepared for the Bureau concerning this contact She told the New Orleans Office that she was worried about the October 3. 1952, date when she was alleged to have had dinner, with Matusow. I told Chiles to have the Agent who regularly contacts Pentley contact her again and advise her that she was being cortacted on instructions from the Bureau to find out whether she has any additional problems and to assure her that her inquiries have been forwarded to Washington. I told Chiles that he should guiet Bentley down but that he should not promise her that we will determine where she was on October 3. 1952.

I called Supervisor Tem Spencer in New York, who has handled interviews with Bentley in the past, and instructed that the New York files be checked to see whether they reflect where Bentley was on October 3, 1952. I also instructed that the files be checked to determine whether they reflect where Bertley was around December 4, 1352, which is the date indicated by a third party present as a date when Rentley and Matusow had a lunckeon with her. Spencer stated that the New York Office was already checking into this and that the Eureau will be promptly advised. Spencer also advised that upon arriving at his residence, he had found a call from Bentley to him and that he had returned the call but it had not been completed. I told him that he should make no promises to Bentley but that he should calm her down and find out just what her problems are and that he should thereupon advise the Bureau by teletype.
