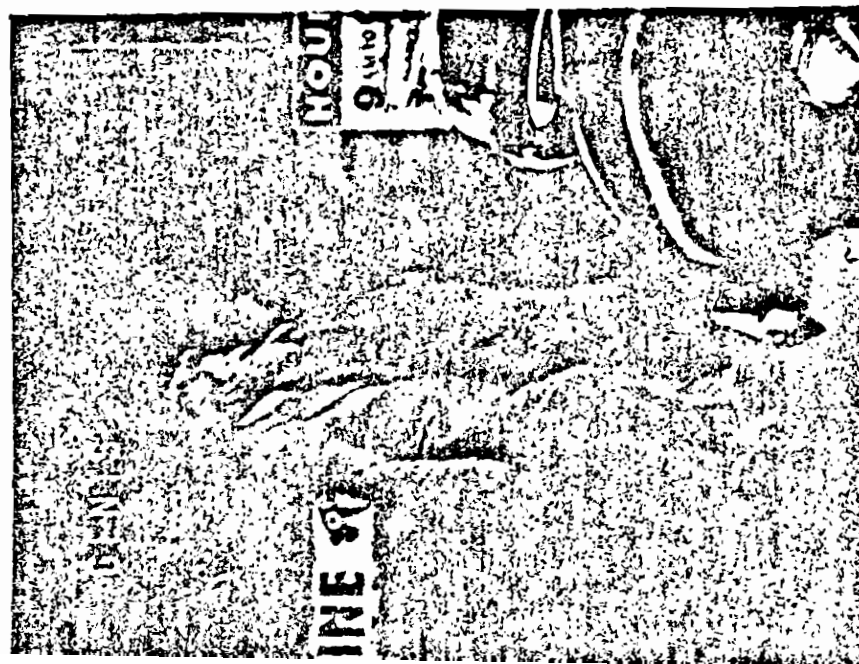

MARTIN and KATHRYN POPPER

Washington Field letter dated August 5, 1948, set forth certain comparative information between Unknown Subjects BILL and CATHERINE and MARTIN and KATHRYN POPPER. It was requested that the New York indices be searched for all addresses listed for the POPPERS, and also that the circumstances under which KATHRYN POPPER resided at 226 W. 27th Street, and 29 W. 27th Street, New York City, be ascertained.

The following pertinent information was obtained as a result of a review of the New York indices:

Confidential Informant T-1, of known reliability, advised that MARTIN POPPER, in a letter to his Draft Board dated December 29, 1943, listed his address as 39 W. 67th Street, New York City. In another letter dated July 26, 1944, MARTIN POPPER stated he was married November 6, 1943, and a child was born on June 14, 1944. The records of the Sydenham Hospital, New York City, reflect that a son, JOSEPH CHARLES POPPER, was born to MARTIN and KATHRYN TROSPER on July 14, 1944. Hospital records further reflect that KATHRYN POPPER indicated she resided at 39 W. 67th Street, New York City, for a preceding three years. In this connection it is to be noted that according to Informant GREGORY, a baby girl was born to BILL and CATHERINE in July 1944 or August 1944.

Confidential Informant T-2, of known reliability, advised that KATHRYN POPPER, in correspondence written by her on April 27, 1944, indicated she was then residing at 29 W. 27th Street, New York City.

Confidential Informant T-3, of known reliability, advised that KATHRYN POPPER in October 1942 indicated she was residing at 226 W. 27th Street, New York City, at which time she was associated with the Committee for the Care of Young Children in Wartime. T-3 further advised that the petition for incorporation filed by this organization on October 23, 1942, listed KATHRYN HILL as one of its directors.

T-1 also advised that KATHRYN POPPER'S address in January 1944 was 226 W. 27th Street, New York City. A pretext telephone call to Mrs. MARY ROONEY McGANN of the Committee for the Care of Young Children in Wartime on June 26, 1944 disclosed that KATHRYN HILL was then Mrs. MARTIN POPPER and was

residing at 39 W. 67th Street, New York City. Mrs. McGOWN further advised that KATHRYN HILL left this organization in April 1944 due to expected childbirth.

Confidential Informant T-4, of known reliability, advised that KATHRYN POPPER, in a letter written June 5, 1944, listed her address as c/o SILVERSTEIN, Mt. Airy Road, Croton, New York.

At 226 W. 27th Street, New York City, JOHN J. NELSON, Apartment Superintendent, advised that a check of the rent receipts for 1942, 1943 and 1944 reflected no record on either KATHRYN HILL, JACK HILL, KATHRYN POPPER or MARTIN POPPER. NELSON stated that this apartment building accommodates approximately 98 tenants and he had no knowledge of any other tenants with whom KATHRYN POPPER may have resided at this address.

Mr. HERMAN BOCK, Building Lessor, 226 W. 27th Street, New York City, advised that he rented out rooms and also resided at this address in 1944 and that a check of his records reflected no mention of the name KATHRYN POPPER, MARTIN POPPER or KATHRYN or JACK HILL during the year 1944 as a tenant.

On May 16, 1949, photos of MARTIN and KATHRYN POPPER were exhibited to Informant GREGORY who failed to identify either of these individuals as being BILL or CATHERINE.

HERMAN ROSOFSKY

Washington Field letter dated August 5, 1948, also requested that an indices check be made of HERMAN L. ROSOFSKY or "HY" ROSOFSKY, his wife, IRENE ROSOFSKY and IRENE POPPER, and further that a description of ROSOFSKY be obtained for comparative purposes with Unknown Subject "CHARLIE".

The indices of the New York office reflect no information identifiable with the HERMAN ROSOFSKY in question and are negative with regard to IRENE ROSOFSKY and IRENE POPPER.

The following description of ROSOFSKY was obtained from Selective Service records, New York City:

His registration card reflects HERMAN LOUIS ROSOFSKY registered from 1764 Popham Avenue, Bronx. He was born March 15, 1909 at New York City. He indicated he was self-employed as a dentist at 31 Union Square. His description was set forth as follows:

On his questionnaire dated January 9, 1941, ROSOFSKY stated his Social Security Number was 117-05-3891. He indicated he attended New York University Pre-dental for two years and Columbia University Dental School for four years. He married at New York City on March 11, 1934, and has a son, PAUL, born April 24, 1937. He enlisted in the regular army and was commissioned as a First Lieutenant, entering service on December 28, 1942. He bears Army Serial Number O-50-75-44.

Credit and Criminal records reflect no information on HERMAN ROSOFSKY.

In view of the differences in ages, it does not appear that further consideration should be given to ROSOFSKY as a possibility for Unknown Subject "CHARLIE".

JANE WHITE

The report of S. HAROLD V. KENNEDY dated January 7, 1946, at New York in the GREGORY case reflects that investigation conducted during the latter part of 1945 indicated that JANE WHITE and MARTHA STEIN were possibilities to be considered for Unknown Subject CATHERINE and further suggested that additional investigation regarding their backgrounds be conducted. The following additional investigation was conducted on JANE WHITE:

Miss MARIE MESSINA, Renting Department, Brown, Wheelock, Harris and Stevens, 14 E. 47th Street, New York City, advised that this company

has in its possession old leases covering the building located at 39½ Bank Street, New York City and that JANE WHITE occupied an apartment with Miss ROMLINE QUAY from September 1943 until September 30, 1945. Miss MESSINA advised that on her rental application Miss WHITE stated she had no business or occupation and listed her source of income as stocks and bonds. Attached to her application was a letter of reference dated June 29, 1943, from Mrs. R. A. FRANK of Orange, New Jersey, which stated that Miss ROMLINE QUAY is Mrs. FRANK'S sister and had lived in Italy with another sister, DONNA E. THERINE RISTOLI, 63 Via Bouxcelles, Rome, Italy, for many years. This letter further stated that Miss WHITE is a granddaughter of U. S. Senator LAWRENCE V. PHIPPS of Denver, Colorado, and was a cousin of Mrs. FREST GEST of Roslyn, Long Island, and Palm Beach, Florida.

Mr. NOELAN SPURRIER, Apartment Superintendent, 124 W. 75th Street, New York City, stated he has been the apartment superintendent at this address since May 1946. He advised that JANE WHITE and Miss ROMLINE QUAY, with whom she resided and who was approximately 60 years of age, moved to Bridgewater, Connecticut, approximately 15 months ago where he understood they were interested in redecorating a converted barn into apartments for displaced persons.

SPURRIER recalled that the couple resumed occupancy of their apartment at this address in August 1946 after they had returned from a trip to Italy. SPURRIER mentioned that he was able to recall the month in view of the fact that Miss WHITE'S father, an attorney in Philadelphia, telephoned SPURRIER several weeks before JANE'S return, advising him that JANE and Miss QUAY were expected and ordered the apartment redecorated. SPURRIER further advised that during her absence, Miss WHITE sublet to two women named HAMILTON and MULLHOLLAND, concerning whose current whereabouts he had no knowledge. He stated that neither JANE WHITE nor Miss QUAY were gainfully employed and it was his understanding that JANE'S father had considerable funds invested in stocks from which she received a sizeable income. He recalled that the couple did practically no entertaining, were deeply interested in music and attended Carnegie Hall recitals frequently together.

Concerning JANE WHITE'S marital status, SPURRIER stated that she is single, and to his knowledge has never been married. In this connection he recalled one instance when he jocularly raised the question of JANE'S

marital status and she replied that she had never been married and never intended to marry since she was not going to support a man.

SPURRIER described JANE WHITE as follows:

Appearance:	Hannish, dresses conservatively; always wears dresses rather than suits or sport clothes.

SPURRIER added that JANE WHITE by no stretch of the imagination could be considered a blond. He has never known her to do any typing or shorthand; has never known her to entertain male friends. He expressed the opinion that Miss WHITE was possibly of Italian descent. He concluded by stating that both women enjoyed a sound reputation and he has never known or heard of anything that would cause him to question their Americanism in any way.

Credit and criminal records were checked against JANE WHITE with negative results.

It is to be noted that previous investigation conducted, as reflected in the report of SA HAROLD V. KENNEDY dated January 7, 1946, at New York, disclosed that JANE WHITE had left for Europe in approximately December 1945.

The report of SA MAURICE J. TAYLOR dated June 14, 1948, at Washington, D. C. points out that Informant GREGORY on January 21, 1946, furnished information regarding a call to her office in New York City on January 17, 1946, at a time when the informant was not in her office, by an unidentified woman who asked for the informant. GREGORY stated that she later learned from her receptionist that the woman had stated that she was "Miss WHITE" and an old personal friend of the informant. According to information furnished by her receptionist, GREGORY further noted that this woman answered somewhat the description of CATHERINE.

In view of the fact that JANE WHITE was apparently out of the country at the time that this call was made, this would eliminate her as being the caller in question.

In the light of the information set forth regarding background and activities of JANE WHITE, further consideration of her as being CATHERINE or LUCY is not deemed warranted.

MARTHA STEIN

The following additional investigation was conducted regarding this individual:

Mr. VICTOR TARA, President, Hines and Hines, Inc., 301 W. 4th Street, New York City, advised that he purchased this real estate business in January 1946 from Mrs. HINES who is currently residing in Ridgefield, Connecticut. TARA stated that Mr. and Mrs. STEIN vacated their apartment at this address in January 1948 and moved to Roslyn Heights, Long Island.

Mr. TARA advised that there were only two apartments located at 39½ Bank Street, his own office on the street floor and that of Mrs. STEIN directly above. He stated that Mrs. STEIN has always been a housewife to his knowledge. He stated that the STEINS "throw occasionally noisy parties but have never acted in any manner inimical to the best interests of this country to his knowledge.

Mrs. GRACE FIVES, Secretary, Hines and Hines, Inc., 301 W. 4th Street, New York City, substantiated the information furnished by TARA.

Miss ESTHER PARDEE, Secretary, Francis Spencer Realtors, 151 Waverly Place, New York City, advised that this office is in possession of the old lease issued to the STEINS on December 1, 1942, and that this lease reflects the previous residence of ARTHUR STEIN as being the home of his parents at 24 W. 69th Street, New York City. His place of business was listed as "News Week" magazine, New York City.

Mr. JULES DES ROSIERS, Apartment Superintendent, 24 W. 69th Street, New York City, advised that the parents of ARTHUR STEIN have resided at this address for approximately twelve years. He stated that ARTHUR STEIN'S brother, RALPH, is a cartoonist with one of the Metropolitan newspapers and was formerly associated with the Army newspaper "Stars and Stripes" overseas. DES ROSIERS advised that the STEIN family has always enjoyed a sound reputation and were considered fine tenants.

Mr. GEORGE MURPHY, Postmaster, Roslyn Heights Post Office, Roslyn Heights, New York, advised that ARTHUR and MARTHA STEIN purchased a home at 65 Circle Lane in Roslyn Heights in approximately February 1948. He stated that he only knows the STEINS casually; that they appeared to be respectable residents of the community.

Mrs. VIRGINIA MIRABITO, 46 Circle Lane, Roslyn Heights, New York, when interviewed [REDACTED], advised that she only knows Mrs. STEIN casually as a neighbor. She stated that Mrs. STEIN has a daughter "PATTY" approximately four years old and that she spends most of her time at home with her daughter. She advised that the STEINS appeared to be an average couple and possess no un-American proclivities to her knowledge. b7E

Mrs. ARLENE LEVY, housewife, 59 Circle Lane, Roslyn Heights, New York, was contacted [REDACTED] and substantiated information furnished by Mrs. MIRABITO. b7E

Confidential Informant T-5, of unknown reliability, advised that according to information furnished by ARTHUR STEIN he learned that MARTHA was born in Boston, Massachusetts, but moved to Santa Barbara, California, with her mother as a child upon the death of her father. She passed most of her life in Santa Barbara and came to New York City for the first time in 1941, after her fiancée left California to assume employment in New York City. T-5 was unable to recall the name of her fiancée other than that his first name was GEORGE. While in New York City he recalled that MARTHA stated that she resided with her aunt and uncle, whose name is unknown to T-5. T-5 continued by stating that MARTHA'S marital plans to marry GEORGE failed to materialize as she subsequently met her husband, ARTHUR STEIN at a party given by her aunt and uncle. She later returned to Santa Barbara, then came back to New York in November 1942, at which time she was married to ARTHUR STEIN. Shortly thereafter STEIN was drafted into the Army and MARTHA accepted a clerical position in the promotion or publicity field with "News Week" magazine, her husband's employer. According to T-2, this is the only employment held by MARTHA STEIN in New York City and its duration ran from approximately 1943 until shortly before her baby was born in July 1944.

T-5 has never observed MARTHA STEIN speak or act in any manner that might be considered un-American. [REDACTED] b7d

The records of the Credit Bureau of Greater New York reflect no additional information relating to the STEINS.

The records of the Manhattan Board of Elections reflect no registration for MARTHA STEIN for the years 1948, 1947, 1946, 1945.

In 1944 MARTHA STEIN, 41 Bank Street, registered with the American Labor Party. She registered similarly in 1943, at which time she indicated her last registration was in 1941 at Santa Barbara, California. She further indicated she was employed as a clerk at 152 W. 42nd Street (the address of "News Week" magazine.)

On May 16, 1949, recent photographs of MARTHA STEIN were displayed to Informant GREGORY who failed to identify STEIN as Unknown Subject CATHERINE.

MARK and WANDA MARVIN

San Francisco letter to the Bureau dated January 26, 1949, set forth similarities in background and description between Unknown Subject CATHERINE and WANDA MARVIN. Reference letter also noted that JOSEPH KATZ, who has been identified as Unknown Subject JACK, was surveilled to the apartment of CHALLAPIN in the Fall of 1943. It was further suggested that WANDA MARVIN might be identical with the unknown woman who contacted LOUIS BLOCH in 1943 and was referred to by CHALLAPIN in conversation with BLOCH previous to her contact with BLOCH.

The New York indices reflect that Confidential Informant [redacted] advised that MARK MARVIN was formerly a director with Consumers Union, Inc., 17 Union Square, New York City, and that he resigned from this organization on February 24, 1941. b7d

During the course of an Internal Security investigation conducted by this office on IRVING LERNER in 1945, it was ascertained that LERNER was associated with MARK MARVIN in the production of documentary films and that MARVIN was a member of the League of American Writers in 1941 and editor of "New Theater" magazine in 1938.

Confidential Informant T-6, of known reliability, advised that MARK MARVIN, 412 W. 46th Street, New York City, enrolled in the Communist Party primaries in 1936.

The records of the Credit Bureau of Greater New York reflect in a report dated February 20, 1942, on MARK MARVIN and WANDA VAN BRUNT that MARK MARVIN was 35 years of age, married and living at 14 W. 52nd Street, New York City, for the past six months. Former residences were listed as 21 E. 14th Street, 50 Manhattan Avenue and 412 W. 46th Street, all New York City.

This report further reflected that MARK MARVIN was in the motion picture business and was formerly labor editor of Consumers Union of U. S., Inc., at 17 Union Square, New York City, from 1937 to 1940. His wife's employment was listed as that of a secretary with Local 802, American Federation of Labor, 1267 6th Avenue, New York City.

The New York indices reflect no additional information pertaining to MARK MARVIN which is not in the possession of the Washington Field office.

With regard to WANDA MARVIN, it should be noted that the New York indices reflect that JOSEPH KATZ was surveilled to the apartment house of WANDA MARVIN after his meeting with CHALLAPIN. Whether or not he entered the apartment of WANDA MARVIN has not been established.

On March 18, 1943, WANDA MARVIN, in a letter to the Vandam Management Corporation, 17 E. 49th Street, New York City, advised that she had been out of the United States since November 1942, and was then at her mother's, c/o Van Brunt, 709 11th Street E., Moline, Illinois. During her absence she advised that she sublet to Mr. and Mrs. MAURICE PURGALIN. In a subsequent communication she advised that her address outside of the United States was The Hotel Marie Cristina, Lerma #3 I, Mexico, D. F. This letter was written on stationery bearing the name of the Metro-Goldwyn Mayer Studios.

Telephone company records reflect that WANDA MARVIN had a telephone installed at 64 W. 55th Street, New York City, in May 1943, at which time she was employed with "Billboard" magazine, 1654 Broadway, New York City.

The records of the Consolidated Edison Company reflect that service was last connected to Apartment 2F at 64 W. 55th Street, New York City, on May 27, 1943, in the name of Mrs. MARK MARVIN. Services were previously listed to Mrs. MARK MARVIN at 14 Christopher Street.

Regarding MAURICE PURGALIN, Confidential Informant T-7, of unknown reliability, in 1941 advised that MAURICE PURGALIN of 22-54 36th Street, Astoria, Long Island, was one of several Communists active in Local 802, 1267 6th Avenue, New York City.

Miss LOIS BICK, in charge of personnel, "Billboard" Magazine, 1564 Broadway, New York City, advised that personnel records reflect that WANDA MARVIN of 64 W. 55th Street, was employed as a reporter for "Billboard" from April 12, 1943 to March 2, 1945, at which time she left due to a reduction in force. Miss BICK advised that at the time of WANDA MARVIN'S employment, employees were not required to execute an application

or furnish any background of previous experience. However, she noted that MARVIN had indicated that she had previous experience in the motion picture, music and writing fields.

ROBERT LITTLEFORD, Publisher, "Billboard" Magazine, 1654 Broadway, New York City, advised that he recalled WANDA MARVIN as a very conscientious, though not too capable, employee. LITTLEFORD stated that prior to this employment WANDA was working as a private secretary to WILLIAM FEINBERG of Local 802, a musicians' local, and he was of the impression that she had resided with FEINBERG and his wife at the time. LITTLEFORD stated that FEINBERG died several years ago. LITTLEFORD appraised WANDA MARVIN as a frail, high strung, frustrated individual who associated very little with other employees. He knew nothing of her family background and vaguely recalled that she made one trip to Illinois allegedly to visit her mother in the latter part of 1944 or 1945. He did not know if MARVIN was ever out of this country and had no knowledge of any work she ever performed for Metro-Goldwyn Mayer.

LITTLEFORD also stated that MARVIN was an efficient typist. He stated that as far as he knew WANDA was single and resided alone at 64 W. 55th Street. He did not know if she had any knowledge of any foreign languages.

Continuing LITTLEFORD stated that WANDA MARVIN wore suits and blouses quite frequently and owned a fur coat. In this connection he recalled that she had offered to obtain fur coats for one or two other girls in the office at an appreciable discount through some connection she had in the fur industry, the nature of which he was not aware.

LITTLEFORD further recalled that he had considerable Union trouble caused by what he considered to be the Communist element in the Newspaper Guild during part of the period covered by MARVIN'S employment. However, he stated that to his knowledge MARVIN disassociated herself from this element and was one of the few employees who did not engage in picketing, nor was she ever the subject of a grievance.

LITTLEFORD described WANDA MARVIN as being in her late 20's (1945), attractive looking, blond hair with auburn tinge, frail, drawn look, approximately 5' 6", 110 lbs., greenish eyes, wore high heels changing to loafers when inside the office, spoke in cultured tones.

LITTLEFORD also advised that one LARRY NIXON, an elderly man no longer with "Billboard", was very close to WANDA MARVIN in a paternal way and attempted to aid her in her work at "Billboard." He expressed assurance that NIXON would keep a confidence if contacted.

LARRY NIXON, Public Relations Representative, 292 Madison Avenue, New York City, advised that he first came into contact with WANDA MARVIN in approximately 1943 after JOSEPH CSIDL, then associated with "Billboard" magazine, sent her to NIXON for a possible news story. NIXON explained he was not connected with "Billboard" but engaged in free lance publicity work at the time, particularly among show people. NIXON continued by stating that he subsequently obtained a position with "Billboard" and he came to know WANDA MARVIN quite well through working in the same office and also residing in the same neighborhood.

NIXON related that according to WANDA MARVIN she was first married to MARK MARVIN and estimated the time to be around 1940. He stated that she and MARK spent some time in California and that her husband was at that time engaged in script writing and film production. He recalled that around the latter part of 1942 or early 1943 WANDA and MARK journeyed to Mexico in order to produce a movie short in which MARK MARVIN was interested. He stated that WANDA subsequently became estranged from her husband and either left him or obtained a divorce from him, possibly in Reno. She then came to New York City alone in search of employment, and became associated with WILLIAM FEINBERG of the Musicians' Local 802, working as his secretary. It was NIXON'S recollection that WANDA resided with FEINBERG and his wife for a period after first coming to New York City. NIXON did not know how she happened to contact FEINBERG.

After leaving Local 802 she obtained employment with "Billboard" magazine. Subsequent to this employment NIXON stated that to the best of his recollection WANDA was unemployed for a period of approximately a year or a year and a half. During part of this period he stated it was his impression that WANDA'S physical condition had become "run down" and she visited somewhere in the mid-west for a period of several months, subletting her apartment in the interim. NIXON stated he did not know who sublet the apartment. She subsequently returned and obtained employment with the Television Advertising, Inc., 118 E. 40th Street, New York City, and

is currently keeping company with HARVEY HUBBELL, the alleged owner of this business.

NIXON stated that "officially WANDA resided alone", although one KEITH ALLISON was a frequent visitor and aided her financially in the upkeep of her apartment during the period that she was unemployed. He stated that WANDA subsequently married ALLISON and is currently separated from him. NIXON advised that it is his recollection that ALLISON is a former sailor who had worked for a period in some radio parts factory. He volunteered the information that ALLISON came from Ohio and impressed him as being slightly unbalanced; "an aggressive organizer who could easily have been a Communist and the type that was fighting against the world." NIXON did not know how WANDA became acquainted with ALLISON but expressed the opinion that she probably picked him up in a bar.

Regarding WANDA, NIXON further stated that despite the fact that the union with which WANDA was affiliated at "Billboard" frequently held meetings in WANDA'S apartment during her employment with "Billboard" and that the union was Communist dominated, he did not feel that WANDA herself was Communistically inclined. He added, however, that "she could have been on the outer fringes of anything because she's so practical." In this connection he also recalled that WANDA MARVIN was well acquainted with HARRY SACHER, well known Communist Party attorney, while employed with FEINBERG, and it was his recollection that SACHER had been the attorney for Local 802. He also recalled that at a party given by WANDA in her apartment several years ago she singled out one particular woman present to NIXON and remarked in passing "She's a real Red."

It was NIXON'S belief that WANDA MARVIN attended college somewhere in the mid-west, possibly Northwestern University, but he recalled that she did not graduate.

The following description of WANDA MARVIN was obtained through observation and investigation:

On May 16, 1949, recent photographs of WANDA MARVIN were displayed to Informant GREGORY who failed to identify her as CATHERINE or any other individual known to her.

Accordingly photographs of SAMUEL SCHIEFLER were also exhibited to Informant GREGORY with negative results.

A review of the information furnished by AMADEO SABATINI concerning BILL in this case reflects there are no definite leads which can be pursued.

ELIZABETH BRITLEY, upon consideration of the background and description of BILL, states that BILL would come closest to the unknown dentist CHARLIE. Accordingly, photographs of any possible suspects for CHARLIE will be forwarded to Los Angeles for exhibition to SABATINI. However, investigation of such suspects are being reported in the file, "UNKNOWN SUBJECT, Wa Charlie, ESPIONAGE-R, GREGORY CASE," NY file 65-14778.

With reference to GEORGE REICHELSHEDER suggested by WFO letter 9/27/50 as possible suspect for BILL, it is to be noted that the contact of ALEXANDER KORAL with REICHELSHEDER occurred in 1945. REICHELSHEDER is KORAL'S brother-in-law, and his description varies in some aspects from that of BILL. Washington Heights is located in the upper part of Manhattan whereas Fort Jefferson, where REICHELSHEDER was reported to operate a stationary store with his wife, is 70 miles eastward on Long Island.

REICHELSHEDER is said to have been a tobacco salesman travelling through a territory on Long Island before starting his stationary store. Accordingly, it appears that it will be necessary to obtain a surveillance photograph. Efforts will be made to secure one and forward same to Los Angeles.

It is noted that SABATINI worked under BILL for about 4 months and he has stated that during his surveillance of KRIVITSKY for two or three months he reported the results to BILL about one or two times each week. It is requested that SABATINI be interviewed in detail regarding all of his contacts with BILL and all possible information he might recall concerning BILL be obtained.

In the event no further pertinent details concerning BILL are obtained from SABATINI, it is contemplated that upon securing and forwarding photograph of REICHELSHEDER, this case will be closed by the New York Office.

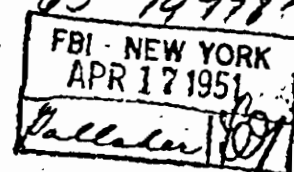

A review of the case entitled "UNSUB with Alias 'Charlie' (GREGORY CASE) ESPIONAGE - R" (NY file 65-14778) reveals that BENTLEY recalled that "Charlie" had had either a gall bladder operation or an appendix operation in 1942 or 1943. BENTLEY also recalled that in speaking to "JACK" (JOSEPH KATZ) about "Charlie", "JACK" told her "Charlie" was "a real old timer" from which BENTLEY inferred that "Charlie" might have been one of those individuals who fled from Russia following the abortive 1905 revolution.

It was noted that the description as set forth above is similar to a description of DAVID SAUL SALETAN as set forth in report of S [REDACTED] dated 3/16/59 at NY as follows: b7c

Re Minneapolis letter dated 12/20/60, captioned "CHARLES LEE aka Charles Lebedeff; SM - C", which requested the NYO to exhibit a photograph of LEE to ELIZABETH T. BENTLEY to determine whether he is identical with the subject.

The description of LEE is similar to the description of CHARLIE as furnished to BENTLEY by JOSEPH KATZ. However, there is no indication that LEE was in New York during the pertinent period and there is no indication that he is or was a dentist. In this connection, the NYO Indices were checked on LEE with negative results. The attention of the Minneapolis Office is directed to the fact that BENTLEY never met CHARLIE and she, therefore, would not be in a position to identify a photograph of him.

For your information, BENTLEY is presently residing in the territory covered by the New Haven Office. In recent years she has expressed reluctance to talk to Bureau Agents and no contact is had with her without prior authorization from the Bureau.

ELIZABETH BENTLEY has been interviewed on several occasions. She advised that in December or fall of 1942, one Julius, who was the leader of a Communist cell of engineers, was turned over to Jacob Golos to be developed in Soviet espionage. The cell of engineers, Bentley believed, was capable of development and Julius was to be the contact between Golos and the group. The first two meetings Golos had with Julius in the lower east side of NYC were held at dusk and were witnessed by Bentley at a distance from Golos' automobile. Bentley said she was told by Golos that Julius lived in Knickerbocker Village, NYC and she said that Julius was about 5'10" to 5'11", slim, and wore glasses. Photos of Julius Rosenberg were shown to Bentley but she was unable to identify Rosenberg positively as Julius.

In a signed statement 11/30/45 given to SAS T. SPENCER and JOS. M. KELLY, the following was set out:

"Another group of whose existence I became aware sometime in the early summer of 1942 was comprised of several engineers who, when I first learned of them, were located in New York City. I recall that on one occasion while I was driving through the lower East Side of the City of New York with Golos to keep a dinner engagement, he stepped the car and told me he had to meet someone. I remained in the car and saw Golos meet an individual on the street corner. I managed to get only a fleeting glimpse of the individual and recall that he was tall, thin, and wore horn rimmed eyeglasses. Golos told me that this person was one of a group of engineers, and that he had given this person my residence telephone number so that he would be able to reach Golos whenever he desired. He did not elaborate on the activities of this person and his associates nor did he ever identify any of them except that this one man to whom he gave my telephone number was referred to as 'Julius'. However, I do not believe this was his true name. I received 2 or 3 telephone calls from Julius telling me he wanted to see Golos and relayed the messages to Golos. Sometime later, probably in 1943, Julius and the others in the group proceeded to Norfolk, Va. where they secured employment of some kind, and I recall that on one occasion Golos traveled to Norfolk to see them. Approximately 6 months prior to the death of Golos, he told me that he was turning over Julius and that group to some other Russian whom he did not identify. My last contact with Julius came shortly before the death of Golos, after the latter had turned the group over to someone else. On this occasion Julius telephoned me very early in the morning and said he wanted to see Golos. Golos told me later that the reason Julius had desired to see him was that he had lost his Russian contact and wanted to enlist Golos' aid in getting reestablished. I have no further knowledge of the identity nor of the activities of this group, except that, so far as I know or have reason to believe, Golos was not receiving mail from them at any time either while they were in New York or after they moved to Norfolk. During a conversation I had with Jack, however, some time in the fall of 1944, when he and I were discussing desirable types of information to be sought, he remarked that, though he was interested primarily in political data, he was always glad to receive information, for instance, like that group of engineers down in Norfolk might secure - if they should learn something about a submarine, I would be glad to get it."
