



On 2/26/57 a physical surveillance was being held on the residence of ROSE KRYZAK, 39-65 47th Street, Sunnyside, Long Island, New York by SAS TOY J, FUSON, JR., THOMAS X. DONAHUE and JOE W. DARDEN. This surveillance was instituted at 4:35 pm.

At 8:55 pm an unknow white, female was seen to enter the above residence and she remained until 9:35 pm when she left. Upon leaving, this unknown female walked South on 47th Street to Skillman Avenue and then West on Skillman Avenue where she entered a causeway leading into the inner court of an apartment building which occupies the 4600 block on Skillman Avenue.

Because of security reasons, the subject was not followed closely into this court and when the agents entered the court, she had entered the building. An examination of the mailbox in the building revealed that one "FASTERNAK" lived in one of the wings.

On 2/27/57, a photograph of FLORENCE PASTERNAK was positively identified by SAS JOE W. DARDEN and THOMAS X. DONAHUE as being identical with the person who visited ROSE KRYZAK during the evening of 2/26/57.

The informant stated there were approximately 75 individuals present. A \$2 (contribution) was collected at the door and a collection was also taken. In addition, liquor at \$.50 per drink was sold. The informant estimated that approximately \$200 was collected from the collection and that the profit from the sale of drinks was substantial since most of those attending drank heavily.

The informant stated the collection speech was made by an individual, FNU GATES, who during the course of his speech stated he had attended other receptions of this type and that he spoke at a reception recently held in Los Angeles, California.





said that MORTON SOBELL's mother, ROSE, gave a talk in which she told of her vetec to raise money for MORTON. She said she had traveled 20,000 miles in the US and had visited Europe and Mexico attending parties of this type.



The informant stated that no mention of the CP or of CP activities was made, however, most of the discussions among those in attendance were concerned with CP affairs and these discussions were held openly. The informant said it was apparent that everyone who was in attendance assumed that anyone who was there could be trusted as being a CP member.

The informant advised that a newspaper, dated November, 1955, published by the Committee to Secure Justice for Morton Sobell, was handed out at the door as the guests were leaving. The newspaper is located in the LA serial of 100-107111.
