For the completion of your records, this is to notify you officially of the outcome of the prosecution of Harry Gold. After hearing on sentence on December 7, 1950, he was sentenced on December 9, 1950, by United States District Judge James P. McGranery, Philadelphia, Pennsylvania, to 30 years imprisonment for conspiracy to violate subsection (a), Section 32, Title 50, United States Code, in violation of Section 14, Title 50, United States Code (1946 Ed.).

On December 14, 1950, Judge McGranery amended Gold's sentence to 20 years and 223 days so as to credit Gold for the 148 days imprisonment served between the date he entered his guilty plea, July 20, 1950, and the date of sentence.



<p>GOLD identified pictures of FILIPP SIKHONOVICH SARYTCHEV as the Russian who contacted him in Philadelphia about 9/24/49. GOLD testified in the trial of ABRAHAM BROTHMAN and MIRIAM MOSKOWITZ on behalf of the prosecution, which trial resulted in convictions of both. GOLD now recounts 13 visits to BEN SMILG'S home between Thanksgiving, 1938 and February, 1941, after which date YAKOVLEV told him that he had made a mistake in the method of handling SMILG and indicated future contacts with SMILG.</p> <p style="text-align: right;">- P -</p> <p style="text-align: right;">G. as FILIPP TIKHONOVICH SARYTCHEV. He stated that he has seen this picture on several occasions since that time and, after careful study of the photograph, is now completely certain that it is a photograph of the individual who first contacted him in his Philadelphia home on Saturday evening, approximately September 24, 1949.

GOLD stated that in the latter part of July, 1949, he received a typewritten note on plain paper postmarked "Brooklyn" with the typewritten words appearing on the envelope "St. George Hotel". The note bore the handwritten signature X JOHN and the context reflected to GOLD that a representative of the Soviet Union desired to contact him. GOLD went to the appointed place on the Broadway stop of the Astoria line in late July, 1949. However, no meeting was made.

On Saturday evening, about September 24, 1949, he was visited by an individual whom he now knows to be FILIPP TIKHONOVICH SARYTCHEV. During the conversation at this time, SARYTCHEV inquired as to his testimony before the Federal Grand Jury in New York City in 1947. Instructions were given GOLD at this time for a future meeting on October 5, or 6, 1949, in the general area of the 74th Street stop of the Queens Independent Subway. This meeting was kept by GOLD and SARYTCHEV, during which time his testimony before the Federal Grand Jury was again discussed and whether or not any of his friends in Philadelphia had been questioned about him since that time. At this meeting GOLD was also advised that he should make plans for leaving the country, should such an emergency arise.

The next meeting was scheduled for October 23, 1949, outside of the ladies' entrance of a bar across the street of the 180th Street stop of the Bronx Park IRT Subway.

The meeting took place as per instructions, at which time SARYTCHEV told GOLD that for the ensuing year or two, it was contemplated that he would be used by the Soviet Union in espionage activities. Again SARYTCHEV discussed the method by which GOLD could effect an exit from this country, suggesting entry into Mexico, then to South America, and

eventually to one of the countries of Europe. The conversation of this meeting pertained to arrangements for future meetings and for recognition signals. GOLD was to come to New York late the night before the meeting and spend considerable time immediately before the appointed meeting wandering about and not staying too long in one place. He was to go past the regular meeting place one hour or so in advance and, if he observed anything of a suspicious nature, he was not to attempt to make the meeting.

For an emergency meeting, GOLD was to insert an advertisement in the Situations Wanted Section of the "New York Times" which would read, "Biochemist, age 32, M.S., desires position in industry or research. A good record of accomplishment. Quality of work principal interest." This was to indicate to the Soviets that a meeting was desired at 1:00 p.m. on the Sunday following the appearance of this ad.

On the first Sunday of December, 1949, GOLD proceeded to New York City for a regular meeting with SARYTCHEV. He waited at the prescribed meeting place for approximately twenty minutes, but was not contacted.

On the first Sunday of February, 1950, GOLD proceeded to New York City to effect another regular meeting with the Soviets' superior. He was particularly concerned at this time, in so far as Dr. CLAUS FUERS had been arrested a few days previous. GOLD was not contacted by anyone on this occasion. It was on this particular occasion, the first Sunday in February, 1950, while GOLD was waiting to be contacted, that he observed the man whom he has since identified as JULIUS ROSENBERG.

BROTHMAN AND MOSKOWITZ

HARRY GOLD testified in behalf of the prosecution in the trial of ABRAHAM BROTHMAN and MIRIAM MOSKOWITZ, appearing on the witness stand on November 15, 16, 17, and 20, 1950. United States Attorney IRVING SAYPOL who represented the Government in this trial, characterized GOLD's testimony as excellent and the basis upon which the conviction of both defendants was obtained.

Relative to his particular relationship with BROTHMAN, GOLD provided the following clarifying details:

He does not know whether BROTHMAN ever met JACOB GOLOS. However, he has a distinct impression that SHURA SWAN (ALEXANDER SVENCHANSKY) had brought BROTHMAN into contact with GOLOS.

GOLD stated that he, GOLD, had become a Soviet espionage agent for three reasons:

1. Out of gratitude to TOM BLACK for the help BLACK had extended to GOLD's family on numerous occasions and particularly for securing employment for GOLD and so keeping the GOLD family off the relief rolls during the depression.

2. GOLD had a genuine desire to bring industrial development to the Russian people.

3. To relieve the steady pressure exhibited by BLACK to get GOLD to join the Communist Party. GOLD stated he never did join the Communist Party.

GOLD explained that it was fairly simple for him to leave his job at the Pennsylvania Sugar Company in order to meet BROTHMAN, in so far as he had put in long hours of overtime at his job, so facilitating any leave he might request. He explained that when he refers to being with BROTHMAN for an extended period of time, he meant by that a three day week-end.

On one occasion in late February, 1942, BROTHMAN suggested going to some camp or resort in upstate New York. He believed that the resort referred to was Fred Brischl's Farm, which was one of BROTHMAN's favorite places.

GOLD stated that SEMENOV first mentioned BROTHMAN by name to him sometime around August, 1941. One

meeting was scheduled, at nightime SEMENOV was personally introduce BROTHMAN to GOLD. On the date of the meeting, SEMENOV advised GOLD that the meeting was called off. The next meeting occurred on September 22, 1944, which was the night of BORN HANUKKAH. At this meeting, SEMENOV told GOLD that BROTHMAN had to be home for the religious holiday that night.

With regard to the meeting that GOLD had with SEMENOV, at each meeting they would make full plans for subsequent meetings. SEMENOV would never advise GOLD prior to the meeting that the meeting was to be called off. However, GOLD would proceed to the appointed meeting place, wait about one hour, and then return home. A week later, GOLD would repeat this same procedure. If two meetings failed to materialize, GOLD was to go on the third week to an emergency meeting place previously agreed upon.

Relative to the compensation received by GOLD, GOLD explained that he received money irregularly and on the whole was reimbursed approximately sixty per cent of his total expenditures. GOLD explained that he deliberately under estimated his expenses, due to his feeling that the people of the Soviet Union were not getting full value for money being spent and furthermore, he doubted that the material turned over by him was of any particular value.

GOLD asserted that a month or two after he had appeared before the Federal Grand Jury on 1947, BROTHMAN told GOLD that he had been advised by ELIZABETH NEEDLEMAN that HELEN (ELIZABETH MINTICK) had been trapped as an espionage agent, as she had become involved with a man Russian who was a plant of either the FBI or some other intelligence agency.

At GOLD's second meeting with BROTHMAN in CHILLY's Restaurant, Columbus Circle, New York City, GOLD gave BROTHMAN a verbal list of things in which the Soviets were interested. The list included production of aviation gasoline, techniques of rubber manufacture, anything pertaining to aircraft, petroleum lubricating materials, colloidal graphite,

strategic chemicals, plus the all inclusive request of anything of military value.

With reference to MIRIAM MOSKOWITZ, GOLD explained that he never discussed his espionage activity in her presence whenever he could avoid same, as he did not trust her because of Her violent temper.

GOLD stated that he came to BROTHMAN'S firm in 1946, to replace GUS WOLLAN. GOLD said that WOLLAN was a strong Lutheran and disapproved of the illicit relationship between BROTHMAN and MOSKOWITZ. As a result of this, MOSKOWITZ was anxious for BROTHMAN to fire WOLLAN.

Mrs Abraham Brothman

GOLD also stated that he was quite fond of BROTHMAN'S wife, NAOMI, and that he too, in a somewhat passive manner, demonstrated his disapproval of MOSKOWITZ'S love affair with BROTHMAN. Consequently, MOSKOWITZ despised GOLD and resented BROTHMAN'S close relationship with him.

GOLD stated that after he testified before the Grand Jury in the Summer of 1947, he recalled a heated argument in the BROTHMAN Laboratory between ABRAHAM BROTHMAN and MIRIAM MOSKOWITZ'S brother, BENNY MOSKOWITZ, who was then employed there as a helper for HARRY GOLD. GOLD explained that the argument resulted from BENNY MOSKOWITZ'S having written a letter to the newspaper "PM", which letter was published in the "Letters to the Editor" column and was signed "BENNY MOSKOWITZ". The letter pointed out that he was employed by a very liberal organization to the extent that all of the officers of the firm were Communists. GOLD said that this was published about the third week of August, 1947.

GOLD said that he has met the MOSKOWITZ family and has had dinner in their Bayonne, New Jersey home on about two occasions. He asserted that the MOSKOWITZ parents are ardent Zionists, that they were not Communists, and that they

frequently argued with LABIE and MIRIAM on the subject of Zionism against Communism. He added that he believed that the MOSKOWITZS were liberal in their viewpoint and could best be characterized as "pink readers." GOLD asserted that the MOSKOWITZ parents were very much against MIRIAM maintaining an apartment in New York City, and inferred that they had knowledge of the relationship existing between MIRIAM and BROTHMAN.

GERTRUDE AND HARRY KOGAN

GOLD said that MIRIAM MOSKOWITZ met GERTRUDE KOGAN sometime in the early 1940's when both were employed by a Federal Agency believed to be the War Manpower Commission. At that time, HARRY KOGAN was in the Army and subsequently MOSKOWITZ shared the KOGAN apartment at 151 Eighth Avenue, New York City.

GOLD recalls that either MOSKOWITZ told him or he had overheard her speaking with BROTHMAN that GERTRUDE KOGAN was making circumspect inquiries as to MIRIAM'S political inclinations. Finally, MOSKOWITZ pointed out that all concerned were quite happy to learn that the KOGANS were also members of the Communist Party.

GOLD stated that he resided in the KOGAN apartment from June, 1946 through August, 1946, while GERTRUDE KOGAN was at her parents place in Ellenville, New York. GOLD said he shared the rent with MIRIAM, that he occupied the daybed in the living room, that MIRIAM occupied one of the bedrooms, and that LABIE SCHEINMAN (GERTRUDE'S brother) occupied the other room.

MOSKOWITZ hated LABIE SCHEINMAN, according to GOLD, and SCHEINMAN felt the same way about MOSKOWITZ. SCHEINMAN was then about 20 years old and GOLD believed he was attending law school. SCHEINMAN left the KOGAN home early in the summer to go up to Ellenville and from that time on throughout the summer, BROTHMAN began spending his nights there in open cohabitation with MIRIAM MOSKOWITZ.

GOLD asserted that in the latter part of 1941 and throughout 1942, he made numerous telephone calls to BROTHMAN and on frequent occasions spoke with WEBER. He said that WEBER knew him as ~~FRANK KESSLER~~.

GOLD stated that he first met WEBER personally in January or February of 1943 in Grand Central Station. WEBER, on this occasion, was accompanied by BROTHMAN and on introduction to him, WEBER said to GOLD, "Shake the hand that shook the hand". GOLD explained that he was convinced in his own mind that WEBER was referring to a meeting held the previous month between GOLD, BROTHMAN, and SEMEN SEMENOV at the Hotel Lincoln, New York City. GOLD said that BROTHMAN had obviously told WEBER about the meeting. Consequently, the peculiar greeting from WEBER.

GOLD said that in the Fall of 1942, he had a conversation with BROTHMAN, wherein BROTHMAN demonstrated his happiness in that WEBER had agreed to join the Communist Party. GOLD pointed out that he never learned anything more of this and could never determine whether or not there was any truth in BROTHMAN'S statement.

GOLD asserted that WEBER and BROTHMAN were very close during the early 1940's and he feels sure, although he has nothing to prove his assumption, that BROTHMAN told WEBER of GOLD'S connection with the Soviets and their meeting with SEMENOV and of the award by the Soviets of the Order of the Red Star. Relative to the last item, GOLD pointed out that BROTHMAN turned this around and designated himself as the recipient.

Sometime in early 1943, GOLD said that he discussed with SEMENOV the advisability of recruiting WEBER into espionage work. He explained that he felt that such could be accomplished wholly upon a monetary basis which was given further substance in BROTHMAN'S comments that WEBER was politically acceptable.

GOLD stated that he is not certain of the name of his contact in the Soviet service. He believes that he wrote a report for SEMENOV relative to WEBER, recommending that he be recruited and used in place of BROTHMAN. GOLD pointed out that about that time, SEMENOV had demonstrated an ill will toward BROTHMAN. GOLD said that he has no knowledge whether or not the Soviets ever took any action in recruiting WEBER.

ANATOLI ANTONOVICH YAKOVLEV

A photograph of ANATOLI JACOB YAKOVLEV was exhibited to HARRY GOLD without comment other than the question, "Did he know the individual?" GOLD spontaneously replied, "This is YAKOVLEV," indicating that it was the photograph of his Soviet contact JOHN. GOLD was then advised that this was a photograph of ANATOLI JACOB YAKOVLEV. He evidenced considerable interest in the picture and, after a closer study, advised that this was not a photograph of JOHN but was a very close physical resemblance. GOLD replied that YAKOVLEV had told him that he had at least two brothers, one of whom had been killed in the war.

It is to be noted that the photograph of ANATOLI JACOB YAKOVLEV resembles the still photographs of ANATOLI ANTONOVICH YAKOVLEV and that GOLD was originally unable to effect an identification of JOHN from these still photographs. GOLD actually had made the identification from the motion pictures.

BENJAMIN SMILG

GOLD recounted thirteen specific instances wherein he met BEN SMILG at the SMILG home in Cincinnati, Ohio. The first meeting was on Thanksgiving Day, 1938, and the last meeting occurred in February, 1941. Throughout all these meetings, GOLD'S purpose was to re-activate SMILG in Soviet espionage, as GOLD was advised that SMILG had been so engaged throughout the middle 1930's with one STANISLAV SHUMOVSKY. GOLD was unsuccessful in his mission but, however, was of the firm conviction that SMILG was thoroughly cognizant of GOLD'S purpose.

In March, 1951, GOLD was advised by SEMENOV that they had made a mistake in the handling of SMILG and that perhaps they should have been tougher with SMILG. Furthermore, GOLD asserted SEMENOV indicated strongly that someone of tougher character would handle SMILG in the future.

~~DAVID SMILG~~

GOLD stated that he became fairly well acquainted with DAVID SMILG, BENJAMIN'S younger brother, during his contact with the SMILG family from 1938 to 1941. He stated that he recalls one occasion when he made a recommendation to his Soviet superior that he believed that DAVID SMILG would be a more rewarding contact to the Soviets than BENJAMIN SMILG. GOLD explained that his main purpose in such a recommendation was to "take the heat off" in his consistent failures in establishing a productive relationship with BENJAMIN SMILG. Furthermore, it was GOLD'S opinion that DAVID was much more sympathetic to the Soviet's cause than was his older brother, BENJAMIN, and that, being young and introspective, he was easily led and finally, because of his resentment to his brother BENJAMIN'S complete domination in the family group.

Photographs of the following individuals were exhibited to HARRY GOLD. However, he stated that he did not know any of these individuals, either by picture or by name and knew nothing about them.

Report Special Agent Joseph C. Walsh, dated 12/20/50, at New York City.

It is noted that referenced report, which is designated "Administrative," sets forth information which, for the most part, is of a substantive rather than an administrative nature. Accordingly, it is desired that this report be rewritten and that only administrative information be placed in the Administrative section.

On Page 2 it is stated at the bottom of the page that during a meeting with Filipp Tikhonovich Sarytchev, the latter told Gold "that for the ensuing year or two, it was contemplated that he would be used by the Soviet Union in espionage activities." It appears from the report of Special Agent John J. O'Brien, dated December 9, 1950, regarding Sarytchev, which sets forth the details of the meetings between Gold and Sarytchev, that on the occasion in question Sarytchev told Gold that it was not contemplated that Gold would be used for Soviet espionage during the ensuing year or two.

In Paragraph 3, Page 3, of referenced report, the name of Klaus Fuchs is misspelled Clem Fuchs.


The last paragraph on Page 3 mentions that Gold testified against Abraham Brothman and Miriam Mookowitz, and the first paragraph on Page 4 reads "Relative to his particular relationship with Brothman, Gold provided the following clarifying details:" It is not possible to determine whether the information that follows was testified to by Gold during the Brothman trial, was furnished to Agents during interview, or resulted from a combination of his testimony and interview. It is desired that this be clarified.

The last paragraph on Page 9 mentions thirteen meetings between Gold and Benjamin Smilg. In this connection it is stated, "Throughout all these meetings, Gold's purpose was to reactivate Smilg in Soviet espionage, as Gold was advised that Smilg had been so engaged throughout the middle 1930's with one Stanislaus Rumanovsky." From a review of the report of Special Agent Joseph C. Walsh, dated December 11, 1950, at New York, in the Smilg matter, which report set forth the details of the thirteen meetings with Smilg as recalled by Gold, it does not appear that Gold was ever specifically advised that Smilg had been

engaged in espionage with Shumovsky. It would seem that the only basis for such a deduction would be Gold's statement that in March or April, 1940, he delivered a letter from "Stan" to Smilg, which letter he read and which, in effect, stated that Smilg should give Gold information as he had previously given it to "Stan." If this is the basis for the statement in the report it is believed preferable that the exact statement of Gold be reported rather than the deduction.

On Page 10 the name of Sergei Kournakoff is misspelled.

Included in the list of persons whose photographs were shown to Harry Gold, as reflected on Pages 10 and 11, appears the name Ribaer. The full name of this individual should be set forth.





"THE COURT: Mr. Gold, do you care to make a statement?

"MR. GOLD: If Your Honor please--

"THE COURT: You may move to the bar of the Court, if you will.

"MR. GOLD: I shall be very brief.

"There are just four points, and, with one exception, all of them have been very adequately set forth in this court on the 7th of December.

I am making note of them now, because they represent matters which have been uppermost in my mind for the past few months.

"First, nothing has served to bring me to a realization of the terrible mistake that I have made as this one fact, the appointment by this Court of Mr. Hamilton and Mr. Ballard as my counsel. These men have worked incredibly hard and faithfully in my behalf, and in the face of severe personal criticism and even invective, and they have done this, not for the reason that they condoned my crime, but because they believe that as a basic part of our law I was entitled to the best legal representation available.

"Second, I am fully aware that I have received the most scrupulously fair trial and treatment that could be desired, and this has been not only in this Court, but has been the case with the F.B.I., with the other agencies of the Justice Department, and with the authorities at the various prisons where I have been lodged, both here and in New York. Most certainly this could never have happened in the Soviet Union or in any of the countries dominated by it.

"Third, the most tormenting of all thoughts concerns the fact that those who meant so much to me have been the worst besmirched by my deeds.

I refer here to this country, to my family and friends, to my former classmates at Xavier University, and to the Jesuits there, and to the people at the Heart Station of the Philadelphia General Hospital. There is a puny inadequacy about any words telling how deep and horrible is my remorse.

"Fourth, and very last, I have tried to make the greatest possible amends by disclosing every phase of my espionage activities, by identifying all of the persons involved, and by revealing every last scrap, shred, and particle of evidence.

"Your Honor, I have finished."



On the 5th of December, 1950, Federal Judge JAMES P. McGRANERY sentenced HARRY GOLD to serve a period of thirty years in a Federal penitentiary. On December 14, 1950, Federal Judge McGRANERY issued an order suspending GOLD's sentence to 29 years and 223 days. GOLD was given credit for having served 142 days in custody since his plea of guilty on July 20, 1950. There were no fines imposed in connection with this sentence.

The case, itself, presents certain aggravating circumstances, these being the fact that on July 31, 1947, HARRY GOLD, in an appearance before a Federal Grand Jury in New York in connection with an espionage matter, testified that an individual by the name of JACOB GOLOS asked him to secure certain blueprints from one ABRAHAM BROTHMAN. Actually, GOLD never met or did he know JACOB GOLOS. Likewise, the circumstances under which he met ABRAHAM BROTHMAN were contrary to those which he testified in July, 1947.

Again, GOLD in May of 1950, in various interviews conducted prior to his confession of May 22, 1950, steadfastly denied knowing or ever having met EMIL JULIUS KLAUS FUCHS, the convicted British atom scientist.

In the initial admission of guilt by GOLD, he maintained that during the period 1938-1940, while he was attending Xavier University in Cincinnati, he was not involved in any espionage activity of any kind. During that period, GOLD was actually attempting to recruit into Soviet espionage an aeronautical engineer employed at nearby Wright Field at Dayton, Ohio. In the initial statement furnished by GOLD May 22, 1950, he again spoke of his relationship with JACOB GOLOS which had never existed.

GOLD, during the immediate period following his arrest on May 23, 1950, gave detailed descriptions relative to four unknown American contacts of his in the Rochester, Syracuse and Buffalo areas of New York. In actuality, there were not four unknown American contacts, but one which was subsequently identified.

During the period of questioning prior to GOLD's arrest and continuing long thereafter, he steadfastly denied having received any financial assistance from the Soviets. Investigation and re-interviews of GOLD resulted in his ultimate admission that he had received varying sums of money to defray his expenses in connection with his espionage activities.

There are no known mitigating circumstances relative to the crime for which GOLD was sentenced. However, it should be noted that GOLD, at interviews conducted at regular periods following his incarceration, furnished detailed information relative to his espionage activities. He



LOYALTY OF GOVERNMENT EMPLOYEE

PURPOSE:

To inform you of the status of the loyalty investigation regarding the above-named employee.

BACKGROUND:

A full field loyalty investigation was instituted by the Bureau regarding the above-named individual on July 31, 1950, the basis of the investigation being that Harry Gold, confessed Soviet Espionage Agent, during the period from the Fall of 1938 until sometime in 1939 or 1940 contacted Smilg on the orders of his, Gold's, superiors to secure information to be transmitted to the Soviet Government. The loyalty investigation as such was completed on September 26, 1950, but due to the fact that an Espionage investigation was being conducted simultaneously regarding the employee, numerous leads were set forth in the Espionage investigation which would have to be reported in a Loyalty investigation in order that the Loyalty Board would have a complete and thorough picture of Gold's allegations, and Smilg's denials, as well as a verification of the allegations and denials.

The Espionage investigation is still continuing and several important interviews including another interview with the employee, are outstanding.

STATUS:

Pending.

RECOMMENDATION:

It is recommended that the loyalty case regarding the employee be placed in a pending inactive status until the completion of the Espionage investigation.

TIKHONOVICH SARYTCHEV. He stated that he has made a careful study of the photograph, is now completely certain that it is a photograph of the individual who first contacted him at his Philadelphia home on Saturday evening, approximately September 24, 1949.

GOLD stated that in the latter part of July, 1949, he received a typewritten note on plain paper postmarked "Brooklyn" with the typewritten words appearing on the envelope "St. George Hotel". The note bore the handwritten signature "JOHN" and the context reflected to GOLD that a representative of the Soviet Union desired to contact him. GOLD went to the appointed place on the Broadway stop of the Astoria line in late July, 1949. However, no meeting was made.

On Saturday evening, about September 24, 1949, he was visited by an individual whom he now knows to be FILIPP TIKHONOVICH SARYTCHEV. During the conversation at this time, SARYTCHEV inquired as to his testimony before the Federal Grand Jury in New York City in 1947. Instructions were given GOLD at this time for a future meeting on October 5, or 6, 1949, in the general area of the 74th Street stop of the Queens Independent Subway. This meeting was kept by GOLD and SARYTCHEV, during which time his testimony before the Federal Grand Jury was again discussed and whether or not any of his friends in Philadelphia had been questioned about him since that time. At this meeting GOLD was also advised that he should make plans for leaving the country, should such an emergency arise.

The next meeting was scheduled for October 23, 1949, outside of the ladies' entrance of a bar across the street of the 180th Street stop of the Bronx Park IRT Subway.

The meeting took place as per instructions at which time SARYTCHEV told GOLD that for the ensuing year and two, it was not contemplated that he would be used by the Soviet Union in espionage activities. Again SARYTCHEV discussed the method by which GOLD could effect an exit from this country, suggesting entry into Mexico, then to South America, and

eventually to one of the countries of Europe. The further conversation of this meeting pertained to arrangements for future meetings and for recognition signals. GOLD was to come to New York late the night before the meeting and spend considerable time immediately before the appointed meeting time wandering about and not staying too long in one place. He was to go past the regular meeting place one hour or so in advance and, if he observed anything of a suspicious nature, he was not to attempt to make the meeting.

For an emergency meeting, GOLD was to insert an advertisement in the Situations Wanted Section of the "New York Times" which would read, "Biochemist, age 32, M.S., desires position in industry or research. A good record of accomplishment. Quality of work principal interest". This was to indicate to the Soviets that a meeting was desired at 1:00 p.m. on the Sunday following the appearance of this ad.

On the first Sunday of December, 1949, GOLD proceeded to New York City for a regular meeting with SARYTCHEV. He waited at the prescribed meeting place for approximately twenty minutes, but was not contacted.

On the first Sunday of February, 1950, GOLD proceeded to New York City to effect another regular meeting with the Soviet superior. He was particularly concerned at this time, in so far as Dr. KLAUS FUCHS had been arrested a few days previous. GOLD was not contacted by anyone on this occasion. It was on this particular occasion, the first Sunday in February, 1950, while GOLD was waiting to be contacted, that he observed the man whom he has since identified as JULIUS ROSENBERG.

HARRY GOLD testified in behalf of the prosecution in the trial of ABRAHAM BROTHMAN and MIRIAM MOSKOWITZ, appearing on the witness stand on November 15, 17, and 20, 1950. United States Attorney IRVING SAYPOL, who represented the Government in this trial, characterized GOLD'S testimony as excellent and the basis upon which the conviction of both defendants was obtained.

BENJAMIN SMILG

GOLD recounted thirteen specific instances wherein he met BEN SMILG at the SMILG home in Cincinnati, Ohio. The first meeting was on Thanksgiving Day, 1938, and the last meeting occurred in February, 1941. In relation to this particular mission, in 1938, GOLD was advised to enter a university in Cincinnati and would then be placed in contact with an important Government official who in fact was BEN SMILG. GOLD said that both of his Soviet-superiors "FRED" and SEMEN SEMENOV had told him that SMILG had given material to the Soviets in the past and that SMILG had been in contact with STANISLAW SHUMOVSAY, to whom SMILG had given the aforementioned material. GOLD was unsuccessful in his mission with SMILG, however, he said that he was of the firm conviction that SMILG was thoroughly cognizant of his (GOLD'S) purpose in contacting him.

In March, 1941, GOLD was advised by SEMENOV that they had made a mistake in the handling of SMILG and that perhaps they should have been tougher with SMILG. Furthermore, GOLD asserted SEMENOV indicated strongly that someone of tougher character would handle SMILG in the future.

DAVID SMILG

GOLD stated that he became fairly well acquainted with DAVID SMILG, BENJAMIN'S younger brother, during his contact with the SMILG family from 1938 to 1941. He stated that he recalls one occasion when he made a recommendation to his Soviet superior that he believed that DAVID SMILG would be a more rewarding contact to the Soviets than BENJAMIN SMILG. GOLD explained that his main purpose in such a recommendation was to "take the heat off" in his consistent failures in establishing a productive relationship with BENJAMIN SMILG. Furthermore, it was GOLD'S opinion that DAVID was much more sympathetic to the Soviet's cause than was his older brother, BENJAMIN, and that, being young and introspective, he was easily led and finally, because of his resentment to his brother BENJAMIN'S complete domination in the family group.

In preparation for his testimony in the BROTHMAN-MOSKOWITZ trial and relative to his particular relationship with BROTHMAN, GOLD provided the following clarifying details to the interviewing agents:

He does not know whether BROTHMAN ever met JACOB GOLOS. However, he has a distinct impression that SHURA SWAN (ALEXANDER SVENCHANSKY) had brought BROTHMAN into contact with GOLOS.

GOLD stated that he, GOLD, had become a Soviet espionage agent for three reasons:

1. Out of gratitude to TOM BLACK for the help BLACK had extended to GOLD'S family on numerous occasions and particularly for securing employment for GOLD and so keeping the GOLD family off the relief rolls during the depression.

2. GOLD had a genuine desire to bring industrial development to the Russian people.

3. To relieve the steady pressure exhibited by BLACK to get GOLD to join the Communist Party. GOLD stated he never did join the Communist Party.

GOLD explained that it was fairly simple for him to leave his job at the Pennsylvania Sugar Company in order to meet BROTHMAN. In so far as he had put in long hours of overtime at his job, so facilitating any leave he might request. He explained that when he refers to being with BROTHMAN for an extended period of time, he meant by that a three day week-end.

On one occasion in late February, 1942, BROTHMAN suggested going to some camp or resort in upstate New York. He believed that the resort referred to was FRED BRIEHL'S Farm, which was one of BROTHMAN'S favorite places.

GOLD stated that SEMENOV first mentioned BROTHMAN by name to him sometime around August, 1941. One

meeting was scheduled at which time SEMENOV was to personally introduce BROTHMAN to GOLD. On the date of the meeting, SEMENOV advised GOLD that the meeting was called off.

The next meeting occurred on September 29, 1941, which was the night of Rosh Hashana. At this meeting, SEMENOV told GOLD that BROTHMAN had to be home for the religious holiday that night.

With regard to the meetings that GOLD had with SEMENOV, at each meeting they would make full plans for subsequent meetings. SEMENOV would never advise GOLD prior to the meeting that the meeting was to be called off. However, GOLD would proceed to the appointed meeting place, wait about one hour, and then return home. A week later, GOLD would repeat this same procedure. If two meetings failed to materialize, GOLD was to go on the third week to an emergency meeting place previously agreed upon.

Relative to the compensation received by GOLD, GOLD explained that he received money irregularly and on the whole was reimbursed approximately sixty per cent of his total expenditures. GOLD explained that he deliberately under estimated his expenses, due to his feeling that the people of the Soviet Union were not getting full value for money being spent and furthermore, he doubted that the material turned over by him was of any particular value.

GOLD asserted that a month or two after he had appeared before the Federal Grand Jury in 1947, BROTHMAN told GOLD that he had been advised by GIBBY NEEDLEMAN that HELEN [ELIZABETH BENTLEY] had been trapped as an espionage agent, as she had become involved with a white Russian who was a plant of either the FBI or some other intelligence agency.

At GOLD's second meeting with BROTHMAN in Child's Restaurant, Columbus Circle, New York City, GOLD gave BROTHMAN a verbal list of things in which the Soviets were interested. The list included production of aviation gasoline, techniques of rubber manufacture, anything pertaining to aircraft, petroleum lubricating materials, colloidal graphite,

strategic chemicals, plus the all inclusive request of anything of military value.

With reference to MIRIAM MOSKOWITZ, GOLD explained that he never discussed his espionage activity in her presence whenever he could avoid same, as he distrusted her because of her violent temper.

GOLD stated that he came to BROTHMAN'S firm in 1946, to replace GUS WOLLAN. GOLD said that WOLLAN was a strong Lutheran and disapproved of the illicit relationship between BROTHMAN and MOSKOWITZ. As a result of this, MOSKOWITZ was anxious for BROTHMAN to fire WOLLAN.

GOLD also stated that he was quite fond of BROTHMAN'S wife, NAOMI, and that he too, in a somewhat passive manner, demonstrated his disapproval of MOSKOWITZ'S love affair with BROTHMAN. Consequently, MOSKOWITZ despised GOLD and resented BROTHMAN'S close relationship with him.

GOLD stated that after he testified before the Grand Jury in the Summer of 1947, he recalled a heated argument in the BROTHMAN Laboratory between ABRAHAM BROTHMAN and MIRIAM MOSKOWITZ'S brother, BENNY MOSKOWITZ, who was then employed there as a helper for HARRY GOLD. GOLD explained that the argument resulted from BENNY MOSKOWITZ'S having written a letter to the newspaper "PM", which letter was published in the "Letters to the Editor" column and was signed "BENNY MOSKOWITZ". The letter pointed out that he was employed by a very liberal organization to the extent that all of the officers of the firm were Communists. GOLD said that this was published about the third week of August, 1947.

GOLD said that he has met the MOSKOWITZ parents and has had dinner in their Bayonne, New Jersey home on about two occasions. He asserted that the MOSKOWITZ parents are ardent Zionists, that they were not Communists, and that they

frequently argued with ABE and MIRIAM on the subject of Zionism against COMMUNISM. He added that he believed that the MOSKOWITZES were liberal in their viewpoint and could best be characterized as "PM readers". GOLD asserted that the MOSKOWITZ parents were very much against MIRIAM maintaining an apartment in New York City, and inferred that they had knowledge of the relationship existing between MIRIAM and BROTHMAN.

GERTRUDE AND HARRY KOGAN

GOLD said that MIRIAM MOSKOWITZ met GERTRUDE KOGAN sometime in the early 1940's when both were employed by a Federal Agency believed to be the War Manpower Commission. At that time, HARRY KOGAN was in the Army and subsequently MOSKOWITZ shared the KOGAN apartment at 151 Eighth Avenue, New York City.

GOLD recalls that either MOSKOWITZ told him or he had overheard her speaking with BROTHMAN that GERTRUDE KOGAN was making circumspect inquiries as to MIRIAM'S political inclinations. Finally, MOSKOWITZ pointed out that all concerned were quite happy to learn that the KOGANS were also members of the Communist Party.

GOLD stated that he resided in the KOGAN apartment from June, 1946 through August, 1946, while GERTRUDE KOGAN was at her parents' place in Ellenville, New York. GOLD said he shared the rent with MIRIAM, that he occupied the daybed in the living room, that MIRIAM occupied one of the bedrooms, and that LABIE SCHEINMAN (GERTRUDE'S brother) occupied the other room.

MOSKOWITZ hated LABIE SCHEINMAN according to GOLD, and SCHEINMAN felt the same way about MOSKOWITZ. SCHEINMAN was then about 20 years old and GOLD believes he was attending law school. SCHEINMAN left the KOGAN home early in the Summer to go up to Ellenville and from that time on, throughout the Summer, BROTHMAN began spending his nights there in open cohabitation with MIRIAM MOSKOWITZ.

ARTHUR PHINEAS WEBER

GOLD asserted that in the latter part of 1941 and throughout 1942, he made numerous telephone calls to BROTHMAN and on frequent occasions spoke with WEBER. He said that WEBER knew him as FRANK HESSLER.

GOLD stated that he first met WEBER personally in January or February of 1943, in Grand Central Station. WEBER, on this occasion, was accompanied by BROTHMAN and on introduction to him, WEBER said to GOLD, "Shake the hand that shook the hand". GOLD explained that he was convinced in his own mind that WEBER was referring to a meeting held the previous month between GOLD, BROTHMAN, and SEMEN SEMENOV at the Hotel Lincoln, New York City. GOLD said that BROTHMAN had obviously told WEBER about the meeting. Consequently, the peculiar greeting from WEBER.

GOLD said that in the Fall of 1942, he had a conversation with BROTHMAN, wherein BROTHMAN demonstrated his happiness in that WEBER had agreed to join the Communist Party. GOLD pointed out that he never learned anything more of this and could never determine whether or not there was any truth in BROTHMAN'S statement.

GOLD asserted that WEBER and BROTHMAN were very close during the early 1940's and he feels sure, although he has nothing to prove his assumption, that BROTHMAN told WEBER of GOLD'S connection with the Soviets and their meeting with SEMENOV and of the award by the Soviets of the Order of the Red Star. Relative to the last item, GOLD pointed out that BROTHMAN turned this around and designated himself as the recipient.

Sometime in early 1943, GOLD said that he discussed with SEMENOV the advisability of recruiting WEBER into espionage work. He explained that he felt that such could be accomplished wholly upon a monetary basis which was given further substance in BROTHMAN'S comments that WEBER was politically acceptable.

GOLD stated that he is not certain but he believes that he wrote a report for SEMENOV relative to WEBER, recommending that he be recruited and case is placed of BROTHMAN. GOLD pointed out that about that time, SEMENOV had demonstrated an ill will toward BROTHMAN. GOLD said that he has no knowledge whether or not the Soviets ever took any action in recruiting WEBER.

ANATOLI ANTONOVICH YAKOVLEV

A photograph of ANATOLI JACOB IAKOVLEV was exhibited to HARRY GOLD without comment other than the question did he know the individual. GOLD spontaneously replied, "This is YAKOVLEV", indicating that it was the photograph of his Soviet contact JOHN. GOLD was then advised that this was a photograph of ANATOLI JACOB IAKOVLEV. He evidenced considerable interest in the picture and, after a closer study, advised that this was not a photograph of JOHN but was a very close physical resemblance. GOLD replied that YAKOVLEV had told him that he had at least two brothers, one of whom had been killed in the war.

It is to be noted that the photograph of ANATOLI JACOB IAKOVLEV resembles the still photographs of ANATOLI ANTONOVICH YAKOVLEV and that GOLD was originally unable to effect an identification of JOHN from these still photographs. GOLD actually had made the identification from the motion pictures.

Photographs of the following individuals were exhibited to HARRY GOLD. However, he stated that he did not know any of these individuals, either by picture or by name and knew nothing about them.



PURPOSE:

To recommend that the Bureau not become involved in Harry Gold's dealings with the International News Service regarding the publication of Gold's espionage activities, and that the Department be informed of these dealings because of their probable effect on pending cases.

DETAILS:

On January 16, 1951, Harry Gold advised that his attorney, John Hamilton, had been contacted by International News Service representatives concerning the possibility of publishing the story of Gold's activity as soon as possible while it was still newsworthy. Gold said that he agreed to this and that on January 16, Hamilton was to meet Bob Considine, INS feature writer, at which time Hamilton was going to turn over to Considine all of his files in the Gold matter. (65-57449-763)

On January 27, Gold advised that he had learned from Hamilton that the latter had conferred for twelve hours with Considine on January 17, after which Considine took most of Hamilton's files concerning Gold to New York City. He further stated that he had signed and returned to Hamilton an agreement with INS whereby Gold was to be paid \$5,000 for use of the material and $\frac{1}{2}$ of the proceeds of any sums that might be paid by other publications for the articles. The contract reserved to Gold the book and movie rights. Gold said that the balance of any money realized after the payment of certain obligations would be donated to the American Heart Association. (New York tel January 27, 1951)

On February 6, 1951, Gold advised that he had received the contract from INS which specified that he prepare full and complete information on his activities which INS would submit "in final form to proper authorities for clearance." The contract stipulated that if such clearance was not forthcoming, the contract would be nullified. It was also stipulated that Gold should be available at any time for interview by a writer or writers who

would assist him. In this latter connection, New York advised that the Deputy Warden of the prison had stated that Gold would not be permitted to have such visitors and that he would have to be removed in the custody of the United States Marshal to some other place for that purpose.

Gold said he intended to inquire of USA Saypol whether arrangements could be made for the proposed interviews by INS writers. He suggested that a Bureau Agent be present during such interviews to preclude the possibility of jeopardizing Bureau investigations. He offered to make available to the Bureau his contract with INS and his correspondence with Hamilton on this subject.

The New York Office expressed the belief that it was extremely undesirable for these articles to appear prior to the Rosenberg trial. New York did not accept Gold's contract with INS or his correspondence with Hamilton because of the possibility such action might result in charges of censorship being leveled against the Bureau should it become known to INS.

Basically, of course, the business dealings of Harry Gold are not the concern of the Bureau. These particular dealings however, will in all probability, have the effect of jeopardizing Bureau cases either now pending trial or which might be brought to trial in the future.

RECOMMENDATION:

It is recommended that the Bureau not have an Agent present during any interviews of Harry Gold by INS representatives, not accept his contract with INS or his correspondence with Hamilton on the matter, and not accept or review the manuscript of Gold's story to INS.

Attached for approval is a teletype so instructing the New York and Philadelphia Offices.

It is further recommended that the Department be advised of Gold's dealings with INS.

Attached for your approval is an appropriate memorandum to the Department.

HARRY GOLD, WAS, ESP - R. REMYTEL TWENTY SEVENTH LAST. GOLD RECEIVED CONTRACT TODAY FROM INS SPECIFYING THAT HE PREPARE FULL AND COMPLETE INFO ON HIS ESPIONAGE ACTIVITIES AND THAT INS WOULD SUBMIT THE PROPOSES STORIES "IN FINAL FORM TO PROPER AUTHORITIES FOR CLEARANCE", AND THAT IF SUCH CLEARANCE WAS NOT AVAILABLE, THE CONTRACT WOULD BE NULLIFIED. OTHER STIPULATIONS OF THE CONTRACT INCLUDED THE AGREEMENT THAT HE BE AVAILABLE AT ANY TIME FOR INTERVIEW BY A "WRITER OR WRITERS" WHO WOULD ASSIST HIM. DEPUTY WARDEN GODFREY, NYC PRISON, BEING AWARE OF AFOREMENTIONED CONTRACT, STATED THAT GOLD WOULD NOT BE PERMITTED SUCH VISITORS, THAT HE WOULD HAVE TO BE REMOVED IN THE CUSTODY OF THE US MARSHAL TO SOME OTHER PLACE FOR THAT PURPOSE. GOLD SAID HE WOULD WRITE TO HIS ATTORNEY, JOHN HAMILTON, TODAY AND ADVISE HIM OF ABOVE. FURTHER, THAT HE WOULD INQUIRE OF USA SAYPOL IF ARRANGEMENTS COULD BE MADE FOR PROPOSED INTERVIEWS BY INS WRITERS. GOLD ALSO SUGGESTED THAT A BUREAU AGENT BE PRESENT DURING THESE INTERVIEWS TO PRECLUDE THE POSSIBILITIES OF JEOPARDIZING BUREAU INVESTIGATIONS.
