These newspapers, literature and press releases issued by the NCSJRC, 1050 6th Avenue, New York City, reflect that subject has been travelling throughout the country appearing at meetings and rallies sponsored by the NCSJRC. On June 18, and June 19, 1953, the "Daily Worker" reported that she had been in Washington, D. C., and participated in the rallies sponsored by the NCSJRC to secure a new trial from the Supreme Court or to secure clemency from the President of the United States for the ROSENBERGS.

The "Daily Worker" for August 14, 1953, on page 2, column 5, contains an announcement that subject would give a report of her recent visit with her imprisoned husband, MORTON SOBELL, when she speaks at the Bronx ROSENBERG meeting at Hunts Point Palace, 163rd Street and Southern Boulevard, on Wednesday, August 19. Article stated subject had just returned from a nationwide speaking tour and a visit with her husband in Alcatraz on a 30 year sentence as a result of his conviction in the ROSENBERG case. The meeting, which takes place exactly two months after the execution of JULIUS and ETHEL ROSENBERG, is being sponsored by the Bronx ROSENBERG Committee.

[redacted] of known reliability, advised that subject was a guest speaker of a meeting of the St. Louis Committee to Secure Justice in the ROSENBERG case which was held on June 9, 1953, at 5522 Waterman Avenue, St. Louis, Missouri. Informant advised that she spoke in behalf of her husband and the ROSENBERGS and related the story of the ROSENBERG trial in which her husband was involved.

[redacted] of known reliability, advised that the St. Louis Committee to Secure Justice in the ROSENBERG Case has been controlled by the Communist Party and Communist Party sympathizers in St. Louis, Missouri.

MAX KLITCHER, who testified for the government in the case against the ROSENBERGS and SOBELL, has advised that MORTON SOBELL, and he so testified, had been a member of the Communist Party when KLITCHER and SOBELL were employed in the Navy Department in Washington, D. C., from 1939 to 1940.

A review of the files of the NYO reflects no further information of pertinent interest in this case. This file reflects a continuous activity by the subject in the affairs of the National Committee to Secure Justice in the Rosenberg Case.

On 7/21/53 [redacted] advised that HELEN SOBELL attended a meeting of the Rosenberg Committee that was held at the Park Manor, 607 Southwestern Avenue, Los Angeles. [redacted]

[redacted] reflected that she was still living at 500 W. 137 St. and was still employed by the National Committee to Secure Justice in the Rosenberg Case, located at 1050 Sixth Ave., NYC. b7E

It is noted that there was formed on 10/11/53 the National Rosenberg-Sobell Committee. It is believed that this committee will be the successor to the National Committee to Secure Justice in the Rosenberg Case. This committee has its office at 1050 Sixth Avenue in the same space occupied by the Rosenberg Committee. Until such time as the National Committee to Secure Justice in the Rosenberg Case is terminated and until such time as the documentary evidence is secured showing that HELEN SOBELL is now working for the National Rosenberg-Sobell Committee, her employment will be considered to be the National Committee to Secure Justice in the Rosenberg Case.

The activities of the subject in connection with the National Committee to Secure Justice in the Rosenberg Case and the National Rosenberg-Sobell Committee case will be reported in those cases.

INFORMATION CONCERNING NATIONAL COMMITTEE
TO SECURE JUSTICE IN THE ROSENBERG CASE, was:
National Rosenberg-Sobell Committee, National
Committee to Secure Justice For Morton Sobell
in the Rosenberg Case U

JULIUS and ETHEL ROSENBERG and MORTON SOBELL were convicted in the United States District Court, Southern District of New York, on March 29, 1951 of conspiracy to commit espionage on behalf of the Soviet Union. JULIUS and ETHEL ROSENBERG were sentenced to death, and MORTON SOBELL was sentenced to a term of 30 years. U

[redacted] both of known reliability, advised that the National Committee to Secure Justice in the Rosenberg Case was formed on January 2, 1952. The claim of this Committee was that the ROSENBERGS were convicted because they were Jews and because of their political beliefs. The aim of this Committee was to secure a new trial or clemency for the ROSENBERGS. The ROSENBERGS were executed at Sing Sing Prison, Ossining, New York, on June 19, 1953. U b7D

On October 13, 1953 [redacted] of known reliability, advised that a National Conference of the Committee was held in Chicago on October 10 and 11, 1953 and that the National Rosenberg-Sobell Committee was formed on October 11, 1953. U b7D

[redacted] both of known reliability, advised in December, 1953 that the Committee, during December, 1953, took the name of the National Committee to Secure Justice for Morton Sobell in the Rosenberg Case. U b7D

[redacted] On May 7, 1954 [redacted] of known reliability, advised U b7D

that the purposes of the Committee were to raise money for SOBELL to obtain a re-trial and to have him removed from Alcatraz to some other penitentiary.

ACTIVITIES OF HELEN SOBELL

[redacted] advised that HELEN SOBELL addressed a meeting sponsored by the National Committee to Secure Justice in the Rosenberg Case (NCSJRC) which was held on June 16, 1953 at the Park Manor, 607 South Western Avenue, Los Angeles, California. b7D

[redacted] advised on August 5, 1953 that a Memorial Meeting was held on July 23, 1953 in the City Terrace Cultural Center, 3875 City Terrace Drive, Los Angeles. This meeting was sponsored by the City Terrace Club of the Independent Progressive Party and was a memorial meeting for JACOB SOLOMON, deceased. N.Y. b7D

The IWO has been designated by the Attorney General of the United States pursuant to Executive Order 10450. U

[REDACTED] advised on August 18, 1953 that he had attended an Eastern Seaboard Conference of the MCSJRC which had been held on Sunday, August 16, 1953 at the Hotel Ansonia, 75th Street and Broadway, New York. Informant stated that the meeting had been called for 10:00 am. It was very slow in coming to order. About 125 people were in attendance at this meeting. U

Chairman of the Meeting, [REDACTED] of the National Committee, and [REDACTED] of the "National Guardian" were also speakers at this affair. Informant advised that many resolutions and amendments were submitted to this meeting outlining how to carry on the case of MORTON SOBELL and the fund raising for that purpose. It was undecided as to whether the MCSJRC should continue to use the name of the Committee to Secure Justice in the Rosenberg Case or to adopt the name of MORTON SOBELL for the Committee. U

Another plan which was offered was whether the Committee should continue to use the ROSENBERG children to gain sympathy or whether they should drop the ROSENBERG children and use the SOBELL children. Informant advised that HELEN SOBELL addressed this meeting making a plea for her husband. U

The 1949 report of the California Committee on Un-American Activities cited the "National Guardian" as a publication launched in New York in 1948, aiming at national circulation, which they found to be from its inception notoriously STALINIST in its staff, writers, management and content. (1949 report of the California Senate Fact Finding Committee on Un-American Activities, page 394.) U

On September 21, 1953 [redacted] advised that he had attended a rally sponsored by the NCSJRC held on September 16, 1953 at Randalls Island, New York City. Informant advised that Mrs. HELEN SOBELL made a speech on behalf of her husband that lasted about a half hour. She read her speech from a prepared text. She struck the human note repeatedly as she read excerpts of letters which MORTON SOBELL had written to his wife from his cell at Alcatraz.

The excerpts consisted of firm and repeated declarations of his innocence, inquiries about the well being and health of his children, his wife and his parents and expressions of gratitude to the NCSJRC for their efforts to free him from a cruel and unjust sentence.

HELEN SOBELL made the special point in her address that not only was her husband "innocent" but that he was entitled by common humanity to request the authorities to transfer him from the Federal Penitentiary at Alcatraz to a place of detention on the Eastern Seaboard. If this was done, SOBELL would be able to see his children at reasonable intervals and to consult with his New York Attorneys in preparation for an appeal from his 30 year sentence and for a new trial.

[redacted] of known reliability, advised on October 9, 1953 that he had attended the meeting of the NCSJRC held at Randalls Island on September 16, 1953. This informant advised that there were about 3,000 people present at this meeting and that Mrs. SOBELL addressed the meeting. She spoke on behalf of her husband and asked the audience to buy the book, "Never Lose Faith" by the ROSENBERGS, which was selling for fifty cents a copy.

Informants advised that a conference was held on October 10, 1953 at 410 South Michigan Avenue, Chicago, Illinois. This conference was sponsored by the Chicago Committee to Secure Justice in the Rosenberg Case.

Informants advised that on October 10 and 11, 1953 the MCSJRC had called a National Conference on the ROSENBERG-SOBELL Case and that the Rosenberg Dedication Meeting at which HERB SOBELL spoke was held at 8:30 pm on October 10, 1953. U

[redacted] of known reliability, advised that HELEN SOBELL had been scheduled to address a meeting on January 13, 1954 to be held at the home of [redacted].

Later this informant advised that this meeting was called off because of bad weather.

[redacted] of known reliability, advised that this meeting, which was to be held on January 4, 1954, was called off because of bad weather and that Mrs. SOBELL had been scheduled as a speaker.

[redacted] of known reliability, advised that HELEN SOBELL visited her husband at Alcatraz on December 29 and 31, 1953 and January 4 and 5, 1954.

The "San Francisco News," a daily newspaper, in its issue of January 6, 1954 contained the announcement that HELEN SOBELL met members of the press in the offices of her husband's Attorney BENJAMIN DREYFUS, 57 Post Street, San Francisco. She stated that her mission was to get the Supreme Court to set aside the verdict against her husband and that she had the

backing and support of two Nobel prize winners, namely, Dr. HAROLD C. UREY, who helped to develop the Atomic Bomb, and Dr. LINUS C. PAULING of Cal. Tech. She stated that she is interested in having people know that justice is possible, although the Supreme Court is not susceptible to pressure. She stated that three Supreme Court Justices, BLACK, DOUGLAS and FRANKFURTER have an inclination in the direction of a re-trial and only a fourth justice was necessary to get a re-trial.

The "Peoples Daily World", a West Coast Communist newspaper in its issue of January 11, 1954 contained an article in which Mrs. SOBELL is quoted as stating that her husband has taken strength from the growing number of Americans who have supported the fight for his vindication. D.C.

The article relates that Mrs. SOBELL stated that her husband feels very strongly that the question of Alcatraz is an example of what has happened to him; that her husband charges that he has been placed in the toughest of all Federal Prisons because he refuses to talk.

She added that he was not complaining about this treatment in Alcatraz but merely about the political fact of his presence there.

[redacted] of known reliability, advised that the National Council of the Arts, Sciences and Professions conducted a panel at Steinway Hall, 113 West 57th Street, New York City, on January 30, 1954. This panel was held from 2:30 p.m. to 4:30 p.m. and was entitled "Human Welfare versus McCarthyism." HELEN SOBELL spoke at this meeting on behalf of her husband.

(Congressional Committee on Un-American Activities, Review of the Scientific and Cultural Conference for World Peace arranged by the National Council of the Arts, Sciences, and Professions and held in New York City on March 25, 26 and 27, 1949, House Report No. 1954, April 26, 1950 (originally released April 19, 1949), p.2)" U [redacted] b7D

[redacted] of known reliability, advised on April 19, 1954 that the Civil Rights Congress had an eighth anniversary dinner on April 9, 1954 at Yugoslav Hall, New York City.

The Civil Rights Congress has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

[redacted] HELEN SOBELL addressed this dinner, at which about three hundred were in attendance. She spoke about her husband and stated that he was not put to death as were the ROSENBERGS; but the FBI retrieved for him a living death in Alcatraz. She asked for continuation of this fight to obtain his freedom. She mentioned that she was going to visit him shortly and would tell him that he is not the forgotten man and that you will fight for his freedom because you think he is innocent.

[redacted] of known reliability, advised that the Washington Height's Branch of the Rosenberg-Sobell Committee had scheduled a party to be held at 593 Riverside Drive, apartment 5-D, New York City, but because of the illness in the family occupying this apartment, the party was changed to the 13th Assembly District Quarters of the American Labor Party, 3410 Broadway, New York City. About thirty people were present.

Mrs. SOBELL addressed this party, speaking in a very low soft spoken voice. She stated that she and her husband felt as though they had been given a special privilege during her last visit to Alcatraz because they were placed three seats away from a guard whereas previously they had been seated right next to him. She stated they could not touch one another because they were separated by a small rectangular window. She stated they picked up their telephones and tried to say all the things which were important only to two married people. She advised that one of the things which her husband asked her was "what did the Committee do (for his benefit) besides committeeing?" She said that her husband has earned about \$100. for his year's work at Alcatraz which he contributed to the Rosenberg-Sobell Committee. She stated she was only permitted to visit him twice during her last visit whereas on previous visits she had seen him three or four times. She stated this depressed her husband and herself very much.

Mrs. SOBELL stated that after her visits to her husband, she visited the warden and asked him about having MORTON transferred from Alcatraz, which was only for the most hardened criminals. The warden told her that he had no jurisdiction over such matters, that SOBELL was assigned there by the Director of Federal Prisons.

Mrs. SOBELL stated that her husband's only crime is that he will not confess to a crime for which he has already been tried and convicted. She stated that it was not the physical torture which break men in Alcatraz, but a mental torture of a rigid routine which drives the inmates out of their minds. She stated that it was imperative to get her husband out of Alcatraz now.

Mrs. SOBELL stated that people cannot forget the sacrifices of the ROSENBERGS, and her husband is a living reminder of what must be done in memory of those two who went to their deaths. She then asked for contributions to the Committee, and about \$80. was collected.

The "Guide to Subversive Organizations and Publications", dated May 14, 1951, prepared and released by the Committee on Un-American Activities, U.S. House of Representatives, Washington, D.C., contains the following concerning the American Labor Party:

"American Labor Party"

1. "For years, the Communists have put forth the greatest efforts to capture the entire American Labor Party throughout New York State. They succeeded in capturing the Manhattan and Brooklyn sections of the American Labor Party, but outside of New York City they have been unable to win control." (Special Committee on Un-American Activities, Report, March 29, 1944, Page 78.)

The August 14, 1953 edition of the "Daily Worker" on page two, column five, contains an announcement that subject would give a report of her recent visit with her husband, MR. TON SOBELL, when she speaks at the Bronx Rosenberg meeting at Hunts-point-Palace, 163rd Street and Southern Boulevard, Bronx, on Wednesday, August 13th. The article continued by stating that the subject had returned from a nation-wide speaking tour and visit with her husband. The meeting is two months since the execution of the ROSENBERGS and is sponsored by the Bronx Rosenberg Committee.

The "Daily Worker" issue of January 6, 1954, on page eight, column two under a Detroit, January 5th dateline, contains an announcement of a meeting to be held on Friday, January 8, 1954 at 8:30 p.m. at 3119 Fenkell, near Wildemere, Detroit, Michigan. HELEN SOBELL was scheduled to report on her holiday visit in Alcatraz with her husband.

The "Daily Worker" issue of January 22, 1954, page eight, column two, contains an announcement of a brunch to be held on Sunday, January 24, 1954 at 11:30 p.m. at the Hotel Manhattan Towers, Broadway and 76th Street. The "Daily Worker" announced that HELEN SOBELL would give a report on SOBELL'S life at Alcatraz and will describe his thoughts in connection with the nationwide campaign in his behalf.

The "Daily Worker" issue of April 2, 1954, on page eight, column one, contains a picture of the subject with the following notation: Mrs. HELEN SOBELL will greet the Civil Rights Congress 8th Anniversary Dinner Friday, April 9, 7 p.m. Yugoslav Hall, 405 West 41st Street.

The "Daily Worker" of April 9, 1954, on page eight, column one, contains a further announcement of the Civil Rights Congress Dinner which will honor WILLIAM L. PATTERSON. HELEN SOBELL was listed as one of the persons who will honor PATTERSON.

The "Daily Worker" of April 9, 1954, page three, column two, contains a further announcement of the Anniversary Dinner of the Civil Rights Congress with the additional announcement that HARRY SACHER will be one of the speakers as will be Mrs. HELEN SOBELL.

The "Daily Worker" of April 30, 1954, on page one, columns one and two, contains an announcement that the May Day rally will be held on May 1st at Union Square, New York. Mrs. HELEN SOBELL is listed as one of the persons who will address this rally.

The "Daily Worker" in its issue of May 3, 1954, page one, columns two, three, four, and five, contains an article by ABNER W. BERRY entitled "Union Sq. Resounds with Call for A-Ban" which details the activities of the meeting held from 6 to 8 p.m. on May 1st at Union Square. This meeting was sponsored by the United May Day Committee, which has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

Copies of this letter reportedly were made available at what the informant described as "the Sobell Committee's find-raising Mexican dinner" at 3431 10th Place, S.E., Washington, D.C., on the evening of November 20, 1954. In this article it was stated that the wife of imprisoned scientist MORTON SOBELL disclosed yesterday that FBI agents had visited SOBELL in Alcatraz and implied that he would receive leniency if he would say he is guilty and that ETHEL and JULIUS ROSENBERG were guilty. The article continued that Mrs. SOBELL stated she had written a demand to J. EDGAR HOOVER that FBI agents stop harassing her husband. A copy of the aforementioned letter signed "Mrs. Morton Sobell" was set forth under the caption "Mrs. Sobell's Letter of Protest to the FBI".

JULIUS and ETHEL ROSENBERG and MORTON SOBELL were convicted of conspiracy to commit espionage in behalf of the Soviet Union on March 29, 1951 in United States District Court, Southern District of New York, and on April 5, 1951 JULIUS and ETHEL ROSENBERG were sentenced to death and MORTON SOBELL to thirty years imprisonment. JULIUS and ETHEL ROSENBERG were legally executed at Sing Sing Prison, Ossining, New York, on June 19, 1953 and MORTON SOBELL is currently serving his sentence at the United States Penitentiary, Alcatraz, California.

Both the LACSJRC and the LACSJMS were, from their inception, dominated and controlled by the LACCP through the assignment of CP members to work on the Committees and to direct the activities of the Committees. In March, 1955 critical discussion by CP members was that the LACSJMS should be reactivated and revitalized in a more aggressive way than it was in the past, and that its activities should be expanded in terms of securing maximum mobilization of forces to insure attainment of its objectives. There is an active youth committee known as the Youth Committee for Morton Sobell (YCMS) or slight variations thereof which is sponsored by the Parent Committee and staffed and supported by forces from the Labor Youth League (LYL) which is also working on the SOBELL issue.

Subject's husband, MORTON SOBELL, was convicted along with JULIUS and ETHEL ROSENBERG in the United States District Court of the Southern District of New York, on 3/29/51 of conspiracy to commit espionage in behalf of the Soviet Union. On 4/5/51, JULIUS and ETHEL ROSENBERG were sentenced to death and MORTON SOBELL to thirty years imprisonment. JULIUS and ETHEL ROSENBERG were legally executed 6/19/53 at Sing Sing Prison, Ossining, New York, and MORTON SOBELL is currently serving his sentence at the US Penitentiary, Alcatraz California.

"Daily Workers" from 1952 to date reflect that subject [REDACTED] travelled throughout the US, denouncing the government for the execution of the ROSENBERGS and the imprisonment of her husband.

Subject was with her husband in Mexico, in 1950, living under an assumed name when arrested by Mexican Security Police, and deported to the US. DAVID GREEN GLASS self-admitted Soviet Espionage Agent advised in 1950 that JULIUS ROSENBERG had told him to flee to Mexico to avoid arrest in the US.

Subject has been uncooperative with the US Government concerning her knowledge of CP matters and the ROSENBERG network.

RECOMMENDATION:

OK DETCOM

Subject fails with item 1, (D) of SAC letter 55-30 in view of her background, current activities in denouncing US Government. Further, her utilization of an alias coupled with the flight to Mexico indicates at least a knowledge and acquiescence of her husband's espionage activities in behalf of the Soviet Union. Retain on S.I.

"I want you to have the enclosed reproductions of the works of Picasso and Hugo Gellert. I believe that these artists have captured the heroism of the Rosenbergs and of my husband, Morton Sobell."

"Your response to this letter will determine how quickly my husband will be free. I know that you will do all that you can."

The "Daily Worker" of June 17, 1955, on page three, column one, contained an article stating that Mrs. MORTON SOBELL had spoken the previous evening before an audience

in Carnegie Hall, New York City, at a meeting of the Committee to Secure Justice for Morton Sobell, and read a letter addressed to President EISENHOWER.

The article continued that in her letter dated June 11, 1955, Mrs. SOBELL stated that no witness ever testified that her husband had given or received secret material and that the one witness on whose testimony her husband was convicted was an admitted perjurer. She further stated that five other witnesses are now proven to have committed perjury. The letter asked the President to "Set my husband Free."

The "National Guardian" of June 27, 1955, on page five, contains a photograph captioned "Two Years After Black Friday." The photo depicts HELEN SOBELL dropping a rose on the graves of ETHEL and JULIUS ROSENBERG at Pinelawn Cemetery, Long Island, New York, on Sunday, June 19, 1955.
