I have told us that letters are frequently sent to you by extremists who make that charge. How do you answer them, very briefly what do you say?

S: Most of these letters are anonymous letters. They can't be answered, they aren't meant to be answered.

W: One last quick question, do you believe that when all the facts become known to those like yourself who still feel justice was not served that they'll then agree with Judge KAUFMAN who said when passing sentence "It's not in my power to forgive you, only the Lord can find mercy for what you have done"?

S: I believe that this applies more to what was done to my husband and to ETHEL and JULIUS ROSENBERG. I think that only the Lord will find mercy for what has been done to them.

W: Thank you for coming on "Nightbeat". When the ROSENBERGS were sentenced to their death and MORTON SOBELL to 30 years in Alcatraz, most of the world was convinced and indeed still are that traitors had been apprehended, and that a danger to our security had been removed. To a skeptical minority the sentences were what they've termed a monstrous injustice. HELEN SOBELL, as MORTON SOBELL's wife, is one of this minority. She has put her cause now to establish what she calls my husband's complete and utter innocence. Next week the Supreme Court of the United States is expected to rule on the SOBELL appeal to determine if he was properly convicted.

On March 6, 1957, T-1 advised that HELEN SOBELL spoke at a meeting of the Los Angeles Sobell

Committee on Friday, February 22, 1957, which was held at the Embassy Auditorium, Ninth and Grand Streets, Los Angeles, California. On this occasion, she read a letter from her husband MORTON SOBELL thanking the people for their help in his behalf.

T-1 advised on March 6, 1957, that HELEN SOBELL attended a meeting of the Los Angeles Sobell Committee on February 26, 1957, at 903 North Mariposa Avenue, Los Angeles, California, and showed a documentary film to the group entitled, "Was Justice Done?"

On April 11, 1957, T-2 advised that on April 10, 1957, HELEN SOBELL attended a meeting of the Lower East Side Committee To Secure Justice For Morton Sobell at 189 Second Avenue, New York, New York. Mrs. SOBELL spoke about her husband's case, stressed the need for funds, and described conditions at Alcatraz. She also discussed incidents surrounding the arrest of MORTON SOBELL and encouraged each of those in attendance at the meeting to help in the fight for justice for her husband.

On April 30, 1957, T-3 advised that HELEN SOBELL attended a meeting at 8321 Tahona Drive, Silver Spring, Maryland, where she again discussed her husband's case. At the meeting a four page mimeographed "Appeal to the President", which was to be filled out and sent to EISENHOWER requesting him to exercise executive clemency on behalf of her husband.

On June 3, 1957, T-4 advised that on May 26, 1957, the Committee To Secure Justice For Morton Sobell sponsored a boat ride to Bear Mountain, New York, from New York City. This informant indicated

that a documentary film, "Was Justice Done?" was shown aboard Hudson River Day Line, and Mrs. HELEN SOBELL addressed the group and thanked them for their help.

On June 7, 1957, T-5 advised that the subject attended a social on June 2, 1957, at 116 University Place, New York, New York, arising out of the National Socialist Workers Party Convention held in New York City from May 31 to June 2, 1957.

On April 17, 1957, T-6 advised that the subject attended a meeting of the Lower East Side Committee To Secure Justice For Morton Sobell at 189 Second Avenue, New York, New York, on April 10, 1957, at which time HELEN SOBELL analyzed for the group the thinking behind the accusations leveled against her husband by the prosecution. A film entitled, "Was Justice Done?" was also shown to the group, and thereafter Mrs. SOBELL emphasized the need for additional funds to aid in the fight to free her husband.

On June 10, 1957, T-7 advised that on June 7, 1957, HELEN SOBELL attended a meeting sponsored by the Socialist Workers Party at 205 South 13th Street, Philadelphia, Pennsylvania. Mrs. SOBELL discussed her husband's kidnapping from Mexico, present conditions at Alcatraz and appealed for help.

The Socialist Workers Party has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

On August 7, 1957, T-8 advised that HELEN SOBELL attended a meeting of the Isabel Gonzalez Community Club of the Communist Party at 3115 Minnesota Street, Los Angeles, California, on August 1, 1957.

At this meeting HELEN SOBELL said that she had left New York on July 6, 1957, and had in the interim been to Vancouver, Seattle, San Francisco, Sacramento, Fresno and Denver.

Mrs. SOBELL also indicated that she had talked to the editor of the "Denver" Post and that the "Post" supported her in her present campaign to free her husband. She also said that the Fisherman's Union in Seattle welcomed her as did the warehousemen in Fresno, California.

Mrs. SOBELL also said that MORTON SOBELL never took the witness stand during his trial because if he had invoked the 5th Amendment, it would have reflected unfavorably upon him because of the hysteria of the times, and on the other hand not to have invoked it would have reflected unfavorably upon JULIUS and ETHEL ROSENBERG, who had

On August 1, 1957, T-9 and T-10 advised that on July 29, 1957, Mrs. HELEN SOBELL attended a meeting of the Bay Area Council of Sobell Committees held at 1418 Brown Avenue, Fresno, California, where Mrs. SOBELL again discussed the arrest, trial, and present incarceration of her husband, MORTON SOBELL. At this time, she made a plea for \$10,000 to carry on the case and prove her husband's innocence.

T-1 advised on August 12, 1957, that on August 6, 1957, HELEN SOBELL attended a Steering Committee meeting of the Los Angeles Sobell Committee at 468 North Western Avenue, Los Angeles, California, at which time a discussion was had concerning the amicus curiae brief, which was to be filed with the United States Supreme Court in connection with her husband's appeal.

On August 14, 1957, T-11 advised that HELEN SOBELL was a guest at a cocktail party in her

honor at 2112 Willington Avenue, Compton, California, on August 11, 1957. Again, at this party Mrs. SOBELL presented a resume of the pertinent facts surrounding her husband's arrest, trial and conviction. She also expressed hope for a retrial of this case.

On August 20, 1957, T-2 advised that on August 19, 1957, HELEN SOBELL attended a meeting of the New York City Sobell Committee held at 940 Broadway, New York, New York. At this time, she recounted her experiences on her recent trip to see her husband at Alcatraz Federal Penitentiary.

She related that she departed New York July 6, 1957, and arrived at Denver, Colorado, in the evening. There she spoke at a gathering at the University of Colorado and was also interviewed by the editor of the Denver "Post". The editor promised HELEN SOBELL that the paper would support the SOBELL plan whenever possible. Mrs. SOBELL also said that in Denver she met several people connected with the American Civil Liberties Union.

From there, she journeyed to San Francisco and spoke at several meetings there as well as at Stockton, Fresno and the Bay Area around San Francisco. Mrs. SOBELL stated that the reception was good on all occasions and that friends in San Francisco had promised to raise at least \$3,000 for the SOBELL office and \$3,000 for their local activities.

According to Mrs. SOBELL, she also journeyed to Vancouver, British Columbia, where she spoke at a few meetings. The American Civil Liberties Union was preparing a brief to be disseminated throughout Canada on behalf of MORTON SOBELL. In Seattle, Washington, according to the subject, she appeared on two television programs and one radio show.

On October 21, 1957, T-12 advised that the subject attended a meeting sponsored by the Chicago Sobell Committee at 1357 East Madison Park, Chicago, Illinois, on September 20, 1957, where she again spoke on the problem of her husband's arrest, conviction and appeal for the United States Supreme Court.

On September 30, 1957, T-13 advised that HELEN SOBELL attended a meeting sponsored by the Chicago Sobell Committee at 5010 West Jarlath Avenue in Skokie, Illinois, on September 21, 1957, where she again spoke on her husband's efforts to obtain freedom.

On December 24, 1957, T-14 advised that on December 17, 1957, HELEN SOBELL's mother-in-law, ROSE SOBELL attended a meeting at 117 Brooks Avenue, Ocean Park, California, where she discussed the plight of her son, MORTON SOBELL, and of the work that her daughter-in-law, HELEN had spoken before many groups and of the support they are winning from the various meetings they appear at.

On January 10, 1958, T-1 advised that on December 28, 1957, at 1283 South Redondo Boulevard, Los Angeles, California, HELEN SOBELL appeared and spoke of her visit to various cities throughout the United States in connection with the MORTON SOBELL case and of how the various committees throughout the country are functioning.

On January 21, 1958, T-2 advised of a welcome home party for HELEN SOBELL on January 17, 1958, held at 940 Broadway, New York, New York. Mrs. SOBELL spoke of her recent trip to San Francisco to see her husband.

AMICUS CURIAE BRIEF

The "National Guardian" of August 5, 1957, on page four, carries a news item relating to the case of MORTON SOBELL, which bears the caption, "Based On Recent Court Decisions Hope Is High For Sobell Review".

This article describes the trial of MORTON SOBELL, as well as his arrest and conviction. It also describes the progress made in connection with the various appeals to the United States Supreme Court, and points out an amicus curiae brief would accompany MORTON SOBELL's third appeal to the United States Supreme Court since his conviction in 1951. A copy of this brief appears as an advertisement along with this story.

This advertisement and brief reads as follows:

"YOU CAN HELP TAKE THE SOBELL CASE TO THE SUPREME COURT."

"By signing the Amicus Brief below, you inform the U.S. Supreme Court of the deep interest that you share with many thousands of Americans in seeing justice done for Morton Sobell."

"By giving a financial contribution with your signature, you provide the necessary funds for carrying Sobell's appeal to the Supreme Court."

"Will you act now--for Sobell--for Justice--for America?"

On December 5, 1957, the "Daily Worker", a former east coast Communist newspaper, at column four, page three, carries an item entitled, "New Drive Launched To Free Morton Sobell", which generally recounts the information furnished by T-15.

U.S. SUPREME COURT ACTION IN MORTON SOBELL'S APPEALS

The New York Times, in its issue of November 13, 1957, at Page 16, Column 3, reports in a news item captioned: "High Court Bars 8th Sobell Plea" that on October 28, 1957 the U.S. Supreme Court rejected a SOBELL petition asking that the tribunal reverse itself and grant a review of his conviction.

The same news item reports that on November 12, 1957 MORTON SOBELL lost two more appeals to the U.S. Supreme Court from his thirty-year sentence for wartime espionage. The court refused to act on allegations by SOBELL that he had been kidnapped by United States agents and illegally brought back to face espionage charges, and that his conviction was "steepled" in fraud and tainted by false and perjured evidence.

The items continues by reporting that this was the eighth time applications on SOBELL's behalf had been turned down. The court disposed of SOBELL's appeals in a brief order that noted only that the Justices would not act on them.

The story also indicates that the tribunal did permit the filing of a "friend of the court" brief urging a review of SOBELL's case.

"The New York Times" in its issue of January 7, 1958, at Page 30, reports that "Sobell Loses 9th Plea". The story states that the U.S. Supreme Court rejected on January 6, 1958 another effort by MORTON SOBELL to win a review of his conviction.

This story discloses that SOBELL had petitioned the high tribunal to reconsider its November 12 refusal to hear his case. The petition was denied without comment, making it the ninth time applications on SOBELL's behalf had been turned down by the U.S. Supreme Court.

APPENDIX

The "Guide to Subversive Organizations and Publications", dated January 2, 1957, prepared and released by the Committee on Un-American Activities, United States House of Representatives, Washington, D.C., contains the following:

NATIONAL COMMITTEE TO SECURE JUSTICE FOR MORTON SOBELL IN THE ROSENBERG CASE

Following the execution of atomic spies Ethel and Julius Rosenberg in June, 1953, the Communist campaign assumed a different emphasis. Its major effort centered upon Morton Sobell, the Rosenbergs' codefendant.

The National Committee to Secure Justice in the Rosenberg Case--a Communist front which has been conducting the campaign in the United States--was reconstituted as the National Rosenberg-Sobell Committee at a conference in Chicago in October 1953 and then as the National Committee to Secure Justice for Morton Sobell in the Rosenberg Case.

National headquarters remained at 1050 6th Avenue, New York City. Co-chairmen of the newest organization were Daniel Marshall and Joseph Brainin.



This is to advise that the writer heard part of the Steve Allison Radio Show last night and that Allison interviewed Mrs. Morton Sobell, who made several remarks about the FBI and the Morton Sobell case. As you probably know, Allison has a local radio program which is broadcast nightly from the Peking Restaurant, 711 19th Street, Northwest, and is heard over Radio Station WWDC. It is an interview-type program devoted to controversial individuals and subjects.

I don't recall the details of the interview. But Mrs. Sobell made several statements to the effect that the FBI kidnapped her husband while he was on vacation in Mexico and brought him back to stand trial, that his lawyer advised him not to take the stand at the trial because of the hysteria arising from the Rosenberg case, that he made a big mistake in not testifying, and that she is determined to prove her husband's innocence. This is being submitted for the information of the Bureau.

# Society Exacts Only Retribution Under Present Plan, Group Told

By James Carberry  
Staff Reporter

A medical researcher suggested here yesterday that criminals under death sentences be allowed to sign their lives over to science for painless experiments. The idea was presented at a criminology section meeting of the American Association for the Advancement of Science by Dr. Jack Kevorkian of Pontiac, Mich.

Kevorkian described his plan as a new method of execution in a paper called "Capital Punishment or Capital Gain?"

As it stands now, Kevorkian said, society gains little from executing the criminal except to exact retribution. Under "judicial euthanasia," he said, Dr. Kevorkian both the condemned and society would benefit.

He explained that at the time set for the execution, the condemned man would be anesthetized, never to regain consciousness. Scientists could then use the living body for research—for example, surgery to learn the workings of the human mind.

When the experiment was over—in a few hours, possibly several months—the human guinea pig would be put to death by an overdose of the anesthetic.

"It seems to me that to die under smoothly induced anesthesia is preferable to having bullets rip through the chest, experience the momentary choking or snapping of the neck, to experience the heat and the shock of an electrical charge or perhaps to experience the suffocating effect of convulsions induced by cyanide gas," he said.

Shortly after Kevorkian began reading his paper, a neatly-dressed woman in green tattered and pitched out of her chair. She later returned to her seat and after the discussion was ended identified herself as Helen Sobell, wife of Morton Sobell. Her husband is serving 30 years in Alcatraz prison for conspiring with Julius and Ethel Rosenberg to get U. S. atomic secrets for the Soviet Union. The Rosenbergs both died in the electric chair for their crime.

Mrs. Sobell told the group one harmful side effect of capital punishment is that it inflicts undeserved suffering on the friends and relatives of the executed person.

Kevorkian, who describes himself as a free-lance researcher, read a letter from a man awaiting electrocution in the Ohio State prison. In it, the man said he would prefer being killed in an experiment to going to the electric chair.

On the other hand, Kevorkian said, "society would lose nothing and gain everything." He said thousands of animals are now destroyed in experiments to find out information about humans which might be disclosed in a single human brain operation.

Kevorkian, a crew-cut, 30-year-old physician, noted that many medical men have been compelled to risk their lives testing their own ideas on themselves.

"A single living human body would offer invaluable opportunities to study the effects of controversial drugs as well as hazards and techniques involved in new diagnostic and surgical procedures which men dare not try on any human body under any clinical circumstances," the doctor said.

The "Guide to Subversive Organizations and Publications," revised and published as of January 2, 1957, prepared and released by the Committee on Un-American Activities, United States House of Representatives, Washington, D.C., contains the following concerning the NCSJMS:

"1. Following the execution of atomic spies Ethel and Julius Rosenberg in June, 1953, the 'Communist campaign assumed a different emphasis. Its major effort centered upon Morton Sobell,' the Rosenbergs' codefendant. The National Committee to Secure Justice in the Rosenberg Case--a Communist front which had been conducting the campaign in the United States--was reconstituted as the National Rosenberg-Sobell Committee at a conference in Chicago in October 1953 and then as the National Committee to Secure Justice for Morton Sobell in the Rosenberg Case. National headquarters remained at 1050 6th Avenue, New York City. Co-chairmen of the newest organization were Daniel Marshall and Joseph Brainin.

A confidential source advised on September 29, 1958, that the Young Socialist Alliance (YSA) was formed at a meeting held October 1, 1957, at New York City, by individuals who were members of the elements formerly comprising the Young Socialist Forum in New York City. The Young Socialist Forum had been comprised of youth of various left socialist tendencies, particularly followers of the Socialist Workers Party (SWP).

The Statement of Principle, set forth in the YSA Constitution, stated that the YSA: 1. Favored the abolition of our present capitalistic system; 2. Advocated the replacement of this system by a socialist system; 3. Formally resolved to direct its activities toward bringing about this transition.

The stated purpose of the YSA, as set forth in the Constitution, was to bring together all young socialists in a broad, militant, independent, democratic organization.

The above source advised that the membership of the YSA, after a series of minority resignations, has become comprised almost exclusively of SWP members who follow the SIF line in YSA policies.

The headquarters of the YSA are located at 144 2nd Ave., New York City.

The SWP has been designated by the Attorney General of the United States pursuant to Executive Order 10450.



Morton Sobell was convicted of espionage in 1951 as a part of the Rosenberg espionage case and is presently serving a thirty-year sentence in the Federal penitentiary at Atlanta, Georgia. After his incarceration, the communists formed the National Committee to Secure Justice for Morton Sobell (NCSJS). The main purpose of this committee is to secure Sobell's release, a reduction of his sentence, or a new trial. Helen Sobell, Morton Sobell's wife and a Security Index subject of our New York Office, has been utilized exclusively by the NCSJS in furthering its programs. She has traveled throughout the United States and parts of Canada soliciting financial assistance for the NCSJS and securing petitions and resolutions urging the release of her husband.

She has appeared before numerous legitimate civic organizations and in some instances, has won their support. She persuaded Steve Allen, the TV personality, to support her efforts on behalf of her husband.

Recently in Phoenix, Arizona, Helen Sobell was successful in persuading the Executive Committee of the Phoenix Council of Ministers to pass a resolution on behalf of her husband. The danger here goes far beyond the mere signing of the resolution since it can be expected these ministers, convinced that an injustice has been done in Morton Sobell's case, will mention this fact to their congregations. Thus, a great many people will be influenced by Helen Sobell's propaganda inasmuch as the average person places considerable reliance on a statement made by his minister.

In order to counteract the propaganda this woman is spreading, I recommend the following courses of action:

identities of civic groups she is scheduled to contact. We could arrange through our friends in the newspaper field to have the local press in the towns where Helen Sobell is to appear give publicity to the fact she will be there and run a true account of the Sobell case. This will alert the civic groups involved and would diminish the effectiveness of Helen Sobell's work. This could be done in such a manner that ~~our~~ interests in the matter would not be revealed.

[REDACTED] Helen Sobell would appear in a certain city before a particular civic group. He could also furnish the true facts of the Sobell case, which is a matter of public record to his contact.

The local civic organization would like to have all of the facts before it made a decision and that he would be glad to provide them with the true facts of the Morton Sobell case. It is felt that many bona fide civic organizations, if they were in possession of all the facts, would not endorse Helen Sobell's activities on behalf of her husband. This would be a most effective method of capitalizing Helen Sobell's activities and the FBI would never be brought into the picture.

I have discussed both of the methods outlined above with Mr. Wick of the Crime Records Division and he was of the opinion that both of the afore-mentioned methods could be arranged through appropriate contacts. It would depend upon the particular situation as to which method we would use.

ACTION:

If you approve, we will use the above-mentioned approaches in the future when we have knowledge of Helen Sobell's itinerary and the identity of civic groups she will address. A separate memorandum will be prepared on each situation.

The Bureau plans to take steps to counteract the continued limited success of Helen Sobell among certain legitimate civic organizations and groups in furtherance of captioned organization's aims to assist her husband, Morton Sobell. It is felt effective steps can be taken to neutralize her work through certain Bureau contacts if her future itinerary and groups she plans to contact are made known to the Bureau in sufficient time to take positive action.

New York as office of origin in both captioned matter and the security investigation of Helen Sobell, New York file 100-109849, should remain particularly alert to Sobell's future travels throughout the United States on behalf of captioned organization. New York should consider giving specific assignments to confidential informants who may be in a position to develop the desired data. Promptly notify the Bureau whenever her itinerary becomes known and thereafter set out specific leads to interested offices to discreetly ascertain additional details of her plans, particularly the identities of legitimate groups she plans to contact. The success of this program depends entirely upon the prompt development and transmittal to the Bureau of Sobell's future itinerary so that effective countermeasures can be instituted.

Los Angeles should consider utilizing [REDACTED] and other informants within limits of security in furtherance of this operation. It is noted Sobell planned to return to Los Angeles during the period 10/24-26/59 and has been concentrating her efforts in the Los Angeles area during recent months.

Each office should transmit promptly whenever the necessary information is obtained.

Los Angeles airtel 10/29/59 advised Helen Sobell, wife of Morton Sobell convicted in the Rosenberg case, was interviewed on the Dan Lundberg TV Show, Los Angeles, on 10/25/59. Topic of program was "Should Prisoners be Allowed Connubial Visits?" She gave a two-minute summary of husband's trial and conviction and then took affirmative position regarding connubial visits. (Earlier this year she had written Bennett of Bureau of Prisons requesting such visits but Bennett denied her request.) She answered questions on topic from panel, one member of which was A. L. Hirsh, American Civil Liberties Union attorney. Hirsh attempted to question her on husband's case, but Lundberg objected and restricted program to announced topic.

On 10/28/59 taped interview of Mrs. Sobell presented on TV news program of Lew Irwin, Los Angeles. Irwin announced he was giving her a chance to tell her side of issue. Mrs. Sobell stated her husband convicted in atmosphere of "McCarthyism" and then rehashed all the old claims of her husband being brutally kidnaped from Mexico, etc., stating it had been arranged by "FBI and Roy Cohn." Irwin noted he had received number of phone calls regarding his comments on Sobell case the previous evening and thanked those who called, stating "it helps."

Los Angeles airtel 10/30/59 advised Los Angeles Sobell Committee (LASC) is attempting to purchase copies of Lundberg's and Irwin's shows. On 10/29/59 Irwin told LASC organizer his job appeared in jeopardy as result of Mrs. Sobell's appearance but he would go ahead and back Irwin. LASC appears National Sobell Committee intends producing record for Christmas season with Helen Sobell telling her story on one side and Miss Vanzetti, sister of Vanzetti of the famous Sacco-Vanzetti case, speaking in Italian on the other side. Jacket of record would contain a translation of Miss Vanzetti's talk.

Briefs indicate that Lundberg and Irwin have in the past utilized their programs to air controversial issues similar to the Sobell case.

A. Appeals

On January 14, 1959, [REDACTED] furnished a

copy of the January, 1959, mimeographed letter on the letterhead of the Chicago SOBELL Committee. It was related in this letter that almost 100 eminent Chicagoans had sent an appeal to President EISENHOWER on behalf of MORTON SOBELL during December, 1958.

The letter went on to report that a copy of the appeal had been sent to United States Pardon Attorney REED COZART, with whom the subject, her mother-in-law, ROSE SOBELL, and Attorney MARSHALL PERLIN had an unprecedented and unexpected meeting.

[REDACTED] on March 4, 1959, furnished a newsletter printed on the letterhead stationery of the Chicago SOBELL Committee, 20 West Jackson Boulevard, Room 1301, Chicago, Illinois, which was dated March 1, 1959.

This letter reflected that HELEN SOBELL had addressed a recent party held by the Chicago SOBELL Committee and reported on activity in widely separated parts of America. The newsletter further revealed that an independent letter signed by a group of eminent Americans was being sent to noted individuals through the country asking that they participate in a Commission of Inquiry to state objectively the ROSENBERG - SOBELL Case.

B. Publicity

The June 23, 1959, issue of the "Morning Freiheit", on page two, columns one and two, contained an article entitled, "Big Mass Meeting Demands Freedom for Morton Sobell." This article stated that on June 19, 1959, more than 1200 people, at a meeting in Webster Hall in New York City, unanimously supported the demand that MORTON SOBELL, who has been languishing behind bars for nine years already, of a thirty year jail sentence should be freed.

The article went on to state that "On Helen Sobell's appeal for contributions for the 'Committee to Secure Justice for Morton Sobell', the audience contributed generously so that it could continue the fight for immediate liberation." U

According to the informant, a letter from HELEN SOBELL was read at this meeting in which she told of a very successful trip to Vancouver, British Columbia, during which she had an hour long radio interview on the Canadian Broadcasting Company. The letter went on to state that the interview had been taped and that SOBELL hoped it would be broadcasted throughout the country. U b7d

[redacted] advised on May 28, 1959, that on May 22, 1959, HELEN SOBELL appeared on the radio program of LOU HAHN over station WBCB, Levittown, Pennsylvania. According to the informant, HAHN interviewed the subject who attacked government witnesses HARRY GOLD and MAX ELTICHER. U b7d

On page three of the October 26, 1959, issue of the "National Guardian" there appeared a feature article entitled, "An Interview with HELEN SOBELL, If Every Guardian Reader Sent a Letter ...." in which the writer reported that in view of the easing of national tensions, HELEN SOBELL was hopeful of her husband's release from prison. The article recounted the efforts of HELEN SOBELL to secure a conjugal visit with MORTON SOBELL and of her visiting members of Congress in order to obtain support for her husband's case. The article stated that HELEN SOBELL would appear on the DAN LUNDBERG television interviewing program in Los Angeles on October 25, 1959, and added that a nation-wide campaign of letters to the President was planned for the holiday season. -U
