On 11/13/63, the above captioned Subject appeared as a guest on the Ira Blue Show over KGO Radio, San Francisco, California, originating from the Hungry I, a night club located at 599 Jackson. The program began with the narrator, IRA BLUE, presenting a brief summary of the MORTON SOBELL case. He then introduced HELEN SOBELL and the following is a transcript of the interview:

BLUE: "In 1950, MORTON SOBELL was apprehended and brought to trial - not until 1951. He spent how long in prison before he was brought to trial, Mrs. SOBELL?"

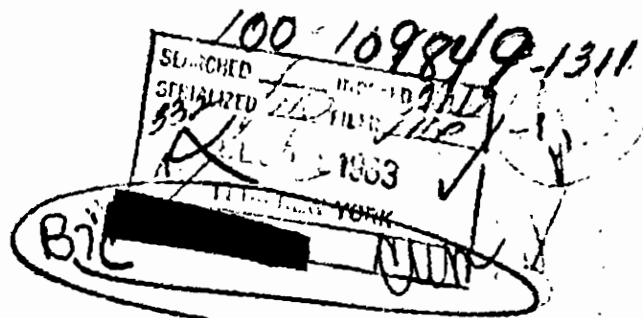
SOBELL: "Some eight months."

BLUE: "Some eight months. That would mean that he has spent from 1950 to the present time incarcerated."

SOBELL: "This is the 14th year."

BLUE: "This is the 14th year. The charges against MORTON SOBELL were as follows: He was not charged with being a traitor. He was not charged with treason. I'm trying to give this information to you without any feelings one way or the other, although by necessity, I think everyone has feelings one way or the other. The charges were conspiracy to commit espionage, due to his association with Mr. and Mrs. ROSENBERG, who were later found guilty and executed for espionage, the only execution, I believe, to ever take place in peace time in the history of the United States. Mr. SOBELL's accuser, the one witness against him,

was a witness named MAX ELITCHER, who admitted to perjury prior to the trial and during the trial in that he failed to declare he was a member of the Communist Party in a prior affidavit - I think in 1947. The judge, Federal Judge KAUFFMAN, instructed the jury that if they believed MAX ELITCHER's testimony, they were to find Mr. SOBELL guilty. If they did not believe ELITCHER's testimony, they were to acquit MORTON SOBELL. The jury chose to believe MAX ELITCHER's testimony and the judge then proceeded to, as we say in the jargon of the court, throw the book at MORTON SOBELL, sentencing him to a term of 30 years in prison for having conspired - having been found guilty of conspiring to commit espionage. It was later on stated, or stated at that time, there was no indication that anything MORTON SOBELL did did harm to the United States, however, he was part of a conspiracy which they believed was harmful to the country. Mr. SOBELL served six of his 14 years in prison in Alcatraz, a very honourous, terrible prison. He was eligible for parole in 1962, and the current move on the part of Mrs. SOBELL is to have her husband freed to return to normal life because the justification for imprisonment is rehabilitation rather than punishment, as we see it, and many people feel, although America is a believer in punishment as well as rehabilitation, so therein lies a great deal of difference between me and a lot of other people. I would like to know, Mrs. SOBELL, what kind of a husband and father was MORTON SOBELL prior to his involvement with the government?"

SOBELL: "My husband was an excellent father and excellent husband and as far as his mother and his sisters were concerned, too, he has always been a very good human being. He is also an intelligent, educated and a gifted person."

BLUE: "Didn't he hold a position of rather great importance at the Reeves Instrument Company at the time of his difficulty?"

SOBELL: "Yes, my husband is a very fine engineer. It is a fact, of course, that he is a completely innocent man, that he has never committed any kind of espionage or conspiracy against our country but on the contrary, has done many socially useful and productive things, even in prison. He has continued to try and find a meaning in life while he was in Alcatraz he did work that was useful and in Atlanta too. He did the engineering work at the million-dollar prison plant there. He has, in fact, a great aptitude in engineering. He has continued his studies."

BLUE: "Does he hold an engineering degree?"

SOBELL: "Yes, my husband has a Master's Degree in engineering from the University of Michigan. He was offered a fellowship there but refused during the time of the war because, as he wrote the dean at the time, he felt he could make a greater contribution to our country by working in the field and he would do war work, as we both did during that time."

BLUE: "Well, Mrs. SOBELL, I was particularly interested in your statement that in view of the fact that a jury of his peers, as you know we are a country of laws, found him guilty of a charge for which he found himself on trial. What I am interested in is the value to society of this man or the fault of society, in keeping him in prison for this length of time and whether, if he gets out of prison, what he will do and what plans there are for him in the event he is released on a parole basis. After all, I don't think you are trying to get a commutation of sentence, are you?"

SOBELL: "Well, I understand your position completely with respect to the question of innocence. I happen to know...."

BLUE: "Well, you happen to feel, in other words, that your position is one that you fear closer than I am."

SOBELL: "And....." (Blue interrupts)

BLUE: "I admire you for standing on your two feet in saying that and I would certainly consider it wrong if you did otherwise but has your plans in the event - can you offer the court certain characterizations of safety? Have opportunities been offered your husband to become a normal productive citizen in the event he is released?"

SOBELL: "The criteria that is set up by the parole board for release are that a person have employment offered to him; that he has a stable home situation into which to move and that there be someone who will act as his parole advisor - a member of society who has the competence to take on this kind of a responsibility. We have, in fact, full employment waiting for MORTON. The Social Action Director of the Union of American Hebrew Congregation - Rabi (Unitelli) has offered to be the parole adviser for my husband and I think that you will understand that there is no question but that we, who are his family, will not only be willing, but eager to have him home again. The

BLUE: "Well that pretty well covers it."

He was offered a fellowship there but refused during the time of the war because, as he wrote the dean at the time, he felt he could make a greater contribution to our country by working in the field and he would do war work, as we both did during that time."

BLUE: "Well, Mrs. SOBELL, I was particularly interested in your statement that in view of the fact that a jury of his peers, as you know we are a country of laws, found him guilty of a charge for which he found himself on trial. What I am interested in is the value to society of this man or the fault of society, in keeping him in prison for this length of time and whether, if he gets out of prison, what he will do and what plans there are for him in the event he is released on a parole basis. After all, I don't think you are trying to get a commutation of sentence, are you?"

SOBELL: "Well, I understand your position completely with respect to the question of innocence. I happen to know...."

BLUE: "Well, you happen to feel, in other words, that your position is one that you fear closer than I am."

SOBELL: "And....." (Blue interrupts)

BLUE: "I admire you for standing on your two feet in saying that and I would certainly consider it wrong if you did otherwise but has your plans in the event - can you offer the court certain characterizations of safety? Have opportunities been offered your husband to become a normal productive citizen in the event he is released?"

SOBELL: "The criteria that is set up by the parole board for release are that a person have employment offered to him; that he has a stable home situation into which to move and that there be someone who will act as his parole advisor - a member of society who has the competence to take on this kind of a responsibility. We have, in fact, full employment waiting for MORTON. The Social Action Director of the Union of American Hebrew Congregation - Rabi (Unitelli) has offered to be the parole adviser for my husband and I think that you will understand that there is no question but that we, who are his family, will not only be willing, but eager to have him home again. The

The "Guide to Subversive Organizations", revised, December 1, 1961, pp.43-44, describes this committee as follows:

"The Citizens Committee to Preserve American Freedoms * * * specializes in propaganda aimed at abolishing the Committee on Un-American Activities and discrediting the Federal Bureau of Investigation. Created in Los Angeles in 1952, the front organization is run by FRANK WILKINSON, an identified Communist who recently resumed the full-time, paid post of executive secretary after approximately a year's leave of absence to assist in a similar campaign by another front in New York City, the Emergency Civil Liberties Committee.

"When the Committee on Un-American Activities held hearings in Los Angeles, September 2-5, 1958, to inquire into the nature of the Party's recent reorganization in California, the Citizens Committee to Preserve American Freedoms sponsored a series of public meetings to protest the hearings and the very existence of the Committee. Communists subpoenaed as witnesses were guests of honor.

"At this time, leaders of the party's Southern California District, were mobilizing Communists in the area for participation in an intensified campaign to abolish this committee of Congress. How the Citizens Committee to Preserve American Freedoms served the party in this effort was revealed by (Communist Party) District Chairman DOROTHY HEALEY in a report to the party's Southern California District Council on September 21, 1958. Mrs. HEALEY declared that the party preferred public protest meetings to be held by the Citizens Committee to Preserve American Freedoms rather than under party auspices because Communists could attend without danger of being exposed as members of the party. She also noted that Communists scheduled as congressional committee witnesses could not appear beforehand at openly Communist rallies without creating the impression that the party was conspiring with witnesses to withhold information from the committee."

The stand of the Committee is no longer for Parole, but rather that MORTON SOBELL is not guilty, and should have complete freedom. There is going to be a citizens petition around the country. There will be a kit and a message by MORTON SOBELL, and very important people. It is suggested that JULIA SAMUELS be contacted in Baltimore to activate the people in Baltimore. "We hope that in the context of the many sermons and public statements today sounding the alarm at events in our time we will be better able to get across to the public and meaning of a case of injustice and cruelty to an individual. For 14 years MORTON SOBELL has been subjected to the harshest punishments available, through Alcatraz, through Atlanta, and now that his health has been impaired, at the Prison Medical Center in Springfield, Missouri. The freeing of MORTON SOBELL at last, coupled with the righting of other injustices plaguing us all, must be a prime subject of concern for our new President, and we urge everyone to call this to his attention."

"On Feb. 22, 1964 I attended a program at the home of DAVID GOLDBERG, 400 Fountain St., New Haven, Conn. This gathering was for the purpose of raising funds to carry on MORTON SOBELL's quest for release from prison. JOHN MARSALKA introduced DAVID GOLDBERG as the prime mover of the 'Committee for Social Action', who rose and read a short poem by CLARENCE DARROW. This poem said in effect that people cannot expect perfect justice but must keep trying to attain it if not for themselves then for other.

"A 30 minute film was shown depicting interviews with several persons who all invariably stated that the 30 year sentence was all out proportion. This film was made by professionals who we were led to believe all donated their services.

"HELEN SOBELL was then introduced and spoke for about an hour telling the circumstances surrounding her husband's arrest, that is the immediate circumstances. She described the effect on her son who is now 14½ years old but it was very noticeable to me that she didn't go into SOBELL's life previous to his arrest, [REDACTED]

A source advised on August 19, 1953, that the Los Angeles Sobell Committee is the Los Angeles, California, affiliate of captioned organization.

Following the execution of atomic spies ETHEL and JULIUS ROSENBERG in June, 1953, the "Communist campaign assumed a different emphasis. Its major effort centered upon MORTON SOBELL," the ROSENBERGS' codefendant. The National Committee to Secure Justice in the Rosenberg case - a Communist front which had been conducting the campaign in the United States - was reconstituted as the National Rosenberg-Sobell Committee at a conference in Chicago in October, 1953 and "then as the National Committee to Secure Justice for Morton Sobell in the Rosenberg Case."

("Guide to Subversive Organizations and Publications" dated December 1, 1961, issued by the House Committee on Un-American Activities, page 116.)

In September, 1954, the name "National Committee to Secure Justice for Morton Sobell" appeared on literature issued by the Committee. In March, 1955, the current name, "Committee to Secure Justice for Morton Sobell," first appeared on literature issued by the Committee.

The Address Telephone Directory for the Borough of Manhattan, New York City, as published by the New York Telephone Company on April 16, 1963, lists the "Committee to Secure Justice for Morton Sobell" as being located at 940 Broadway, New York, New York.

Three thousand signatures on petitions to free Morton Sobell, victim of the 1951 Mc Carthy-hysteria, were presented to his wife, Helen Sobell, at a big meeting at Cooper Union, on Thursday evening, April 23rd. Sobell has been behind bars for fourteen years on a 30 year sentence. The almost one thousand people gave an ovation to the appeal by Mrs. Sobell, (whose two children were seated on the platform), that they continue to collect thousands of signatures in this country, and abroad, demanding the liberation of her husband and the father of his two children.

Mr. Marshall Perlin, chief Sobell defense lawyer, in a powerful speech, related that on his last visit to his client, a short time ago, at the Springfield Jail, in Missouri, he found Sobell in better health. He pointed out that Sobell categorically refused to make any concessions whatsoever in conjunction with the fight to free himself - and that the only condition for his liberation is a full pardon and lifting of the charges that he participated in espionage against the land of his birth - the United States.

Powerful speeches were also delivered by: the famous intellectual, Prof. Fred. Rodell, of Yale University, who demanded that Roy Cohn now fill Morton Sobell's jail cell; Dr. B. Dunham, who pointed out that the conscience of America must be aroused by the frightful injustice of keeping an innocent peace-fighter in jail on the basis of a Mc Carthy-false-accusation of espionage.

Chairlady Donna Allen read telegrams from the famous authors and humanists, Bertrand Russell, Arnold Wesser, author of "Chips With Everything"; Robert Bolt, author of "A Man For All Seasons"; and from the president of Local #142, Longshoremen's Union, in Hawaii, who demanded the liberation of Morton Sobell in the name of the 22,000 members of his union.

The assemblage unanimously adopted a resolution to continue the fight for the complete liberation of Morton Sobell.

The Sobell Committee held a mass rally at Cooper Union on April 24, 1964. There were between 400-500 people present. [REDACTED] present at the rally were HELEN SOBELL, MARK SOBELL, SYDNEY SOBELL, [REDACTED] B7D

The theme of the rally was SOBELL's innocence.

DONNA ALLEN, from Washington D.C., was the chairman. Mrs ALLEN indicated that the government killed the ROSENBERGS, therefore, how can they free SOBELL. She pointed out that the prosecuting attorney at the trial, ROY COHN, is presently on trial himself for fraud and perjury.

MARSHALL PERLIN followed Mrs ALLEN. Mr PERLIN reviewed the trial, pointing out the kidnapping from Mexico, the only witness, a perjurer, who connected SOBELL with the ROSENBERGS. Mr PERLIN indicated that the government told SOBELL plead guilty and they would be easy on him.

BARROWS DUNHAM followed MARSHALL PERLIN. His theme was a good government is one in which it allows its citizens to think unthinkable things.

PHIL OKES, a folksinger, followed Mr DUNHAM. "You are living in the free world, in the free world you must stay" is a sample line from his songs.

A source advised on August 19, 1963, that the Los Angeles Sobell Committee is the Los Angeles, California, affiliate of captioned organization. U

Following the execution of atomic spies ETHEL and JULIUS ROSENBERG in June, 1953, the "Communist campaign assumed a different emphasis. Its major effort centered upon MORTON SOBELL," the ROSENBERGS' codefendant. The National Committee to Secure Justice in the Rosenberg case - a Communist front which had been conducting the campaign in the United States - was reconstituted as the National Rosenberg-Sobell Committee at a conference in Chicago in October, 1953 and "then as the National Committee to Secure Justice for Morton Sobell in the Rosenberg Case." U
