New Spy Suspect Held; FBI Says Meeting Was Here

NEW YORK, July 18 (UP)—A 32-year-old New York engineer was jailed in \$100,000 bail today as the fourth American to face the death penalty as a member of a Communist atomic spy ring.

The FBI believed Julius Rosenberg, a father of two young sons, was the paymaster for Americans recruited by Soviet officials to steal A-bomb plans during World War II.

The FBI said that Rosenberg met David Greenglass, also charged as an atomic spy, in Albuquerque, N. M., in June, 1945 as a part of the network to obtain atomic secrets for the Russians.

Rosenberg, described by FBI Director J. Edgar Hoover as a Communist sympathizer who wanted to "do-something to directly help Russia," was arrested last night in his 11th floor lower east side Manhattan apartment. He and his wife Ethel, 34, had just finished supper and were preparing to put their sons, Michael, 7, and Robert, 3, to bed.

The FBI said the accused spy was still active in the ring as recently as May 23. One of his last acts was to warn former Army Sergeant Greenglass to get out of the country and give him a stack of \$20 bills, the FBI said.

Too Late

But the warning was too late. Greenglass was arrested in New York on June 16 before he could get away.

FBI Director Hoover described Rosenberg as "another important link" in the atomic spy ring which began crumbling last January when the British arrested and convicted Dr. Klaus E. J. Fuchs

on a spy charge. It was indicated still more arrests will be made.

From Fuchs, the trail of pilfered atomic secrets ran to Philadelphia Biochemist Harry Gold, former Army Sgt. David Greenglass of New York, and Chemist Alfred Dean Slack of Syracuse, N. Y. All were arrested within the last two months. All face the death penalty.

Rosenberg, fired as a civilian army signal corps inspector in 1945 because it was believed he was a card-carrying Communist, was arraigned within 1½ hours after his arrest on charges of conspiracy to commit espionage.

High Bail

Federal Judge John F. X. McGohey set the high bail and scheduled a hearing for July 31. Immanuel H. Bloch, an attorney hired by Rosenberg's wife, said the accused spy would plead "not guilty."

Mrs. Rosenberg staunchly defended her husband, owner of the Pitt Machine Products Co., an enterprise he purchased after he was fired by the Army.

Rosenberg recruited Greenglass, who worked at the atomic bomb center at Los Alamos, N. M., to steal atomic information for the Russians, the FBI said, and gave him "specific instructions" as to the type of information Russia desired on the A-bomb.

He "made himself available to Soviet espionage agents so he could do the work he felt he was slated for," Hoover said in a Washington statement.

Met in Albuquerque

The FBI said Rosenberg started working early in 1945 with Greenglass and Gold, indicted as a go-between between Soviet agents and Fuchs, now serving 14 years in a London prison.

In June 1945, Rosenberg gave Gold an irregularly-cut jello box top as a means of identifying Gold to Greenglass. The device was cut in half and the pieces were matched in Albuquerque, where the two met.

Gold gave Greenglass \$500 on this occasion from Anatoli A. Yakovlev, Soviet vice consul in New York at the time, the FBI said.

It was believed Rosenberg faded from the picture after this, but contacted Greenglass last spring after the arrest of Fuchs and Gold and gave him more

money and warned him to leave the country, the FBI said.

Rosenberg's wife told reporters today that she is a sister of Greenglass, the man her husband is accused of recruiting.

She denied that her husband was a Communist party member, although membership in the party was given as the reason for his dismissal from a civilian job with the Army Signal Corps during World War II.

JACK CHANEY, Manager of the Franciscan Hotel, advised that all the records of the hotel previous to January 1946 have been destroyed. He stated that there was no method available at that hotel to verify the residence of RUTH and DAVID GREENGLASS at that hotel in November 1944.

Mr. CHANEY stated that he has been the manager of the Franciscan Hotel since January 1945 and that he personally was not acquainted with either RUTH or DAVID GREENGLASS. He also stated there was no persons residing or employed at the Franciscan Hotel, who were residing there or employed there during the year 1944.

GEORGE STEVENS, Assistant Manager, El Fidel Hotel, made available the records of the El Fidel Hotel for November and December 1944. These records failed to reflect RUTH or DAVID GREENGLASS as having registered at the El Fidel hotel during the pertinent period. Mr. STEVENS also made a thorough check of the cash accounts of the El Fidel Hotel for November and December 1944 and these records also failed to reflect RUTH and DAVID GREENGLASS ever resided there.

For the information of the New York Office there are being enclosed herewith postal photographs of both the Franciscan and El Fidel Hotels in Albuquerque, New Mexico.

The Franciscan Hotel is a seven-story building located on the corner of East Central Avenue and North 6th Street. The hotel contains approximately 170 rooms, is of Spanish type architecture, and contains an automobile storage place running directly off the hotel lobby.

The El Fidel Hotel is a five-story structure located on North 5th and West Copper Avenue. The El Fidel Hotel has located in it on North 5th Street the Continental Bus Company office and depot. The hotel is situated approximately in the center of the business section of Albuquerque, New Mexico. The

Accused A-Spy's Sister Held in Espionage Case

WASHINGTON, Aug. 11 (AP)—The FBI today made a seventh arrest in connection with its roundup of Americans accused of aiding the leak of atom bomb secrets to Russia.

The Justice Department announced that FBI agents have taken into custody Mrs. Ethel Greenglass Rosenberg, 34, in New York City.

She is the wife of Julius Rosenberg and the sister of David Greenglass, both arrested last month on charges of obtaining highly classified atomic information for the Soviet Union.

FBI Director J. Edgar Hoover said that Mrs. Rosenberg, the mother of two children, is charged with conspiring with her husband and others to recruit her brother, David Greenglass, into the alleged spy ring.

Greenglass has been charged with giving atomic secrets to Julius Rosenberg and to Harry Gold, Philadelphia chemist, while Greenglass was stationed at the Los Alamos a-bomb project as a soldier in 1945.

The FBI has charged that Greenglass passed the secrets to Gold in Albuquerque, N. M., in 1945. Greenglass was indicted by a New Mexico Federal grand jury in Santa Fe.

Gold, the first American to be arrested in the roundup, is alleged to have worked with two top Soviet agents in this country and with Dr. Klaus Fuchs, the imprisoned British atomic scientist, in channeling atomic information to the Soviets.

Of those already arrested, five, including Mrs. Rosenberg, have been charged with espionage or espionage conspiracy.

Two others have been indicted on charges of attempting to obstruct justice by making up a false story for Gold to tell a Federal grand jury which investigated subversion in the United States in 1947.

Rebulet to New York dated 8/8/50.

On 8/15/50 the writer discussed the information and observations set forth in bulet together with its enclosures with U. S. Attorney EVERETT M. GRANTHAM. It was explained to Mr. GRANTHAM that the Bureau assumed the position that questions as to the use of "classified" or possible "classified" information and evidence in any forthcoming trial was a matter which must be ironed out between the Criminal Division of the Department, the U. S. Attorney and the Atomic Energy Commission. He agreed that this was the proper procedure and that he would be governed by any instructions issued by the Criminal Division of the Department.

He was apprised in substance of the information appearing in referenced communication and reiterated his previous statement that with reference to the so called "classified" matter, it was his intention in any possible future proceedings handled by him to place appropriate witnesses on the stand who would be able to testify that the subject DAVID GREENGLASS had given information defined as "high explosive lens-mold" to ROSENBERG and GOLD without questioning into the nature and details of this information. Thereafter it was his intention to utilize an appropriate representative of the AEC to testify that the information pertaining to the "high explosive lens mold" was "classified" and then object to any testimony pertaining to the nature of this information or to its details. He was of the opinion that U. S. District Judge CARL HATCH would not permit either the prosecution or the defense to go into the details of this information other than above set forth.

With reference to the indictment of additional subjects concerned in this and collateral investigations in the District of New Mexico, he stated that in the event the Department so desired he would be very happy to arrange with the U. S. District Judge CARL HATCH for the Federal Grand Jury to be called back for a special session to "consider further matters "pertaining to this

Niels Bohr is arriving at Los Alamos Thursday, December 30th. He will be accompanied by his son, Aage. For reasons of security it was decided that Dr. Bohr should not use his own name in this country and he has been provided with an alias, together with all necessary substantiating papers. The alias is Nielslas Baker. Dr. Bohr's son's name is James Baker and he is referred to as Jim.

The information that Bohr is at Los Alamos is secret information and must be guarded as securely as, for instance, the purpose of our project and the status of our work. It is therefore important that Bohr be addressed as Baker and that the information as to his identity be restricted to those who are entitled to have classified information. In the special case which may arise of non-staff members who recognize Bohr, it will of course be necessary to inform them of the contents of this memorandum.

Group Leaders are responsible for seeing that these suggestions are carried out, and are requested to have the staff members in their groups sign on the attached sheet. This memorandum and the signature sheet should then be returned to the Director's office.

According to more recent and more reliable information, Bohr's presence in this country is already quite widely known. For this reason the only point which we can conceal is his connection with this project or his presence at Los Alamos. Bohr will use his own name in any dealings he may have which are not related to this project, but while he is here, and in any matters connected with the project, he must be known only as Baker.

On September 8, 1950 I advised Mr. RALPH CARLISLE SMITH, ENX Assistant Director for Classification and Security, Los Alamos Scientific Laboratory, University of California, Los Alamos, New Mexico, that the matter of what information of a possible classified nature was to be disclosed at the trial of this case was to be resolved by the Atomic Energy Commission and the Criminal Division of the Department of Justice or the United States Attorneys' Offices. I advised him that the Bureau had advised the Criminal Division of the Department and the interested United States Attorneys of this fact and had suggested that it would undoubtedly be desirable to have this matter resolved well in advance of any trial.

Los Alamos Easy Pickings For Spy, Says Greenglass

NEW YORK, March 14—(AP)—A confessed spy for Russia says it was easy to take American secrets from the Los Alamos, N. M., atomic bomb project during wartime.

This is the opinion of David Greenglass, 29, who as an Army sergeant was stationed at Los Alamos in 1944.

Greenglass testified in Federal court at the trial of his sister, Mrs. Ethel Rosenberg, 35, her electrical engineer husband Julius, 32, and radar expert Morton Sobell, 33.

Greenglass' statement about the ease of taking Los Alamos secrets was made late yesterday in cross-examination. Today the cross-examination continued.

The Rosenbergs and Sobell are charged with conspiring to spy for Russia in wartime—an offense for which they could be sentenced to death.

Greenglass has confessed to taking secrets from Los Alamos and giving them to a Soviet spy ring. He now is awaiting sentence on a guilty plea.

Just Asked Questions

Often smiling, Greenglass told Federal Judge Irving R. Kaufman and a jury that he obtained information at Los Alamos just by wandering around the super-secret project and asking seemingly innocuous questions.

He also said he occasionally eavesdropped on scientists' conversations.

During one such occasion, he said, he heard a discussion of "implosion," a vital factor in atom-bomb construction. Implosion is a bursting inward in contrast to the outward burst of an explosion.

Another time, Greenglass said, he just walked into a laboratory and picked up a piece of material from a table. The man working

with it, the witness continued, wore a "white badge" to indicate he had access to top-secret information.

Greenglass said he asked the man:

"Oh, that's an interesting piece of material, interestingly machined. What's the idea?"

Tricky-Like

"Tricky-like, huh?" interrupted Defense Attorney Emanuel Bloch.

The witness said his question was intended to be tricky, and added: "The white badge man told me that was a source of neutrons"

Greenglass said he never was "frisked" in coming and going from the plant but that "security police checked packages."

"I didn't take any blueprints or sketches out of Los Alamos because I relied on my memory," Greenglass said. "I got information outside of my official duties as a machinist from various people."

This date, he testified, he passed to the Rosenbergs.

Tells of Quarrels

The defense sought today to show that a series of business quarrels prompted Greenglass to testify against Julius Rosenberg.

In cross examination of Greenglass, Bloch brought out that while Rosenberg and Greenglass were partners in the Pitt Machine Products Co., Inc., in New York from the autumn of 1947 until the fall of 1948, the two had numerous bitter quarrels over the conduct of the business. Once they had to be separated to prevent them from coming to blows.

Bloch obtained an admission from Greenglass that he "never got a nickel" for his 25 shares of

A-Bomb Secrets Went to Russia, Gold Testifies

NEW YORK, Mar. 15 (AP)—Confessed spy Harry Gold testified today that valuable atom bomb secrets stolen by a spy ring in the United States in 1945 were "sent immediately to the Soviet Union."

He said this information was given him by Anatoli Yakovlev, who was a Russian vice consul in New York at the time.

Gold said he himself turned over to Yakovlev secrets which he obtained in furtive meetings in the United States with Dr. Klaus Fuchs and former Army Sgt. David Greenglass.

Gold, Philadelphia biochemist serving a 30-year sentence on a plea of guilty to spying for Russia, was a witness in the federal court trial of three persons accused as Russian spies.

Believed to Have Fled

They are Julius Rosenberg, 34, an electrical engineer; Rosenberg's wife, Ethel, 35, and radar expert Morton Sobell.

Yakovlev also was indicted in the case but has not been found and is believed to have fled to Russia.

Fuchs, a top British atomic scientist, has been imprisoned in England as a spy for Russia. Greenglass has pleaded guilty here to espionage and is awaiting sentence.

Gold told of meeting the British master spy at Cambridge, Mass.,

in Jan., 1945, and in Santa Fe, N. M., on June 2, 1945.

He said that on one trip under "orders" from Yakovlev he acquired information from Fuchs in Santa Fe and Greenglass in Albuquerque, N. M. Both Fuchs and Greenglass were working on the Los Alamos, N. M., atom project.

Gold said he turned the information over to Yakovlev. Two weeks later he met Yakovlev again.

Very Valuable

"Yakovlev told me, Gold said, "that the information I had given him two weeks before had been sent immediately to the Soviet Union."

"He said the information I received from Greenglass was extremely excellent and very valuable."

Gold said Greenglass gave him names of some persons at Los Alamos who "would make likely recruits" for espionage.

"I cut him very short indeed," said Gold. "I told him such procedure was hazardous, extremely foolhardy."

Gold Tells of Getting A-Secrets for Russia

NEW YORK, March 15—(INS)—Harry Gold, 40-year-old confessed spy, admitted in Federal Court today he engaged in atomic bomb espionage work with Dr. Klaus Fuchs and Anatoli H. Yakovlev in behalf of the Soviet Union.

Dr. Fuchs, a British scientist, pleaded guilty of espionage and is now serving a 15-year sentence in England. Yakovlev, former Soviet vice consul in New York, has disappeared behind the Iron Curtain.

Gold, who described himself as a biochemist, was a star witness for the government at the trial of Julius Rosenberg, his wife, Ethel, and Morton Sobell, who are accused of conspiring with the Klaus Fuchs ring to steal America's atomic secrets.

Gold has pleaded guilty and is under 30 years sentence.

Testifying calmly, Gold said Yakovlev, whom he first knew as "John," became his "superior" in the spy ring and that Dr. Fuchs frequently gave him secret information to turn over to Yakovlev.

Contacted Greenglass

Gold said he frequently left his home in Philadelphia to go to other places to obtain confidential information from "Americans," which he would pass on to Yakovlev.

Testimony already has been given that Gold himself obtained information about the Los Alamos (N. M.) atomic bomb project from David Greenglass, a former Army sergeant, and paid him the sum of \$500, in Albuquerque, N. M., in June, 1945. Rosenberg had recruited Greenglass into the spy ring.

Gold said he paid various sums of money to his spy "contacts."

"Where did you get the money for this?" asked Judge Irving R. Kaufman.

"The money was given to me by Yakovlev," replied the witness.

Gold testified he was born in Berne, Switzerland, Dec. 12, 1910,

and came to the United States in July 1914.

He worked for the Philadelphia Sugar Co. for 17 years — from 1929 to 1946 — and took specialized courses at the University of Pennsylvania, Xavier University in Cincinnati and elsewhere. He said he was naturalized in 1922.

Gold said he first met Yakovlev in front of a New York restaurant in March 1944.

Gold stated: "As a result of my conversation with Yakovlev on that occasion I continued my espionage work for the Soviet Union. He became my superior."

The witness said he had been engaged in espionage for the Soviet Union "from the spring of 1935 up to the time of my arrest in Philadelphia in May 1950."

Greenglass had obtained considerable atomic information in his work at Los Alamos.

Mrs. Greenglass yesterday gave a complete recital of how the brother-in-law, Rosenberg, and his wife, allegedly prevailed upon Greenglass to reveal data.

Mrs. Greenglass, mother of two young children, told the federal court jury that she had wanted at one time to expose the whole espionage setup to the Federal Bureau of Investigation but had a change of heart.

Spies Rushed Data to Russia, Gold Testifies

NEW YORK, March 16 (AP)—The defense in the nation's first atom spy trial today declined to cross-examine confessed spy Harry Gold and he was excused from the witness stand in Federal Court.

After hearing two other witnesses briefly, the court adjourned until Tuesday. The prosecution announced it was expecting witnesses from "distant places." That apparently was the reason for the long weekend recess.

Judge Irving R. Kaufman commented the trial was proceeding more rapidly than was expected and that the case might go to the jury the week after next.

Dr. George Bernhardt, a physician acquainted with some of the defendants, became the eighth witness.

Gold testified yesterday to meetings in the United States with Dr. Klaus Fuchs, British atomic scientist who since had been imprisoned as a spy.

Gold, serving a 30-year sentence as a confessed spy, said he gave atomic secrets to Anatoli Yakovlev, a Russian vice consul in New York, who told him they were delivered immediately to Soviet Russia.

Dr. Bernhardt testified that Julius Rosenberg, 34, a defendant, asked him in May, 1950, what type of injections were needed to go to Mexico.

He said Rosenberg told him: "It's not for me. It's for a friend of mine."

Dr. Bernhardt was followed on the stand by William Danziger, 33, a classmate of Rosenberg and Morton Sobell, 33, another defendant, at City College of New York.

Danziger said he visited Sobell on June 20 and found him and his family packing valises. He said Sobell told him they were going on a vacation to Mexico.

The witness said he later re-

ceived two letters from Sobell and that both bore return addresses in names other than Sobell.

On trial with Rosenberg and Sobell is Rosenberg's wife, Ethel, 35.

They are accused of conspiracy to spy for Russia during wartime, and could be sentenced to death if convicted.

Sent to Russia
Gold, testifying for the prosecution, said that "very valuable" atom bomb secrets filched by a spy ring in the United States in 1945 were "sent immediately" to Russia.

The witness said he was told this by Yakovlev, who was a Soviet vice consul in New York at the time.

Gold said he gave Yakovlev secrets which he had obtained at secret meetings in the United States with Dr. Fuchs, a leading British atomic scientist, and David Greenglass, who was an Army sergeant at the Los Alamos, N. M. atomic bomb project.

Gold testified that he met Fuchs at Cambridge, Mass., in January, 1945, and at Santa Fe, N. M., on June 2, 1945.

Turned Over to Yakovlev
The information obtained on the trip was turned over to Yakovlev, Gold testified. Relating that he met Yakovlev again two weeks later, Gold declared:

"Yakovlev told me that the information *** had been sent immediately to the Soviet Union. He said the information I received from Greenglass was extremely excellent and very valuable."
