On the cover of this address book was written "Property of RUTH PRINZ, 254 Rivington Street, New York City". Below that was written "Pvt. D. GREENGLASS, CO3, 1st. Ordnance Training Reg't., Aberdeen, Md."

The following names appeared in a small telephone number book which was found in the GREENGLASS apartment:

E & E SCHWARTZ, 128 Hyde Park Boulevard, c/o E. SHAGAN, Dre 0413; FERNIE SCHWARTZ GR 5-7456; M. SCHWARTZ, 33 Montgomery, BR 5-8314.

Also found in the GREENGLASS apartment was a list of names and addresses on two pieces of paper, which included the name "MIRIAM SCHWARTZ".

There was no record in the New York indices concerning 134 Prospect Place, Brooklyn or 33 Montgomery.

The following listing was contained in the current Manhattan Address Telephone Directory: MIRIAM SCHWARTZ, 33 Montgomery Street, New York City, telephone GR 5-8314.

The current Brooklyn Address Telephone Directory contained no listing for SCHWARTZ, 134 Prospect Place, Brooklyn.

Mr. L. SCATURRO, Apartment A2, 134 Prospect Place, Brooklyn, superintendent of the residence building located at this address for the past five years, advised that nobody by the name of SCHWARTZ resided here. Mr. SCATURRO stated that he knows everybody residing at this address but does not recall anybody by the name SCHWARTZ.

It was noted that there is no listing for the name SCHWARTZ on the mail boxes at this address.
