On January 3, 1946 Informant advised that BROTHMAN was in contact with one FRED BRIEHL, a well-known Communist in the New York City area. On January 16, 1946 BILL ERCADER, brother of EARL BROWDER, former Secretary of the COMMUNIST PARTI, USA, was in contact with BROTH-MAN's office regarding his new enterprise, "Distributors Guide". Informant has also advised on several occasions that BROTILIAN has been in touch with several persons believed to be members of the COMMUNIST PARTY in New York City.

In view of the above information it is recommended that the services of Confidential Informant NYT-343 be continued.

Confidential Informant GREGORI believes one FRANK COE, of Treasury Department, furnished information to SILVERMASTERS sometimes via HARRY D. WHITE. Recalls also that NORMAN BURSLER (ph.), an attorney in Anti-Trust Division of Justice Department, furnished material to HELEN SILVERMASTER. "New York World-Telegram" article, 1-29-46, attacked excessive charges on packages sent to Russia via U. S. SERVICE & SHIPPING CORP. and WORLD TOURISTS. Did not name Informant or JOHN H. REYNOLDS. ANTORG has demanded copy of contract between U. S. SERVICE & SHIPPING and INTOURIST; not furnished to date. Additional photos of Bussian diplomatic personnel displayed to GREGORY with negative results.

ABRAHAM BRUTHMAN's activities appear to be of business pature

Re: ABRAHAM BROTHMAN

The following investigation of the activities of ABRAHAM BROTHMAN covering the period from January 7 to February 4, 1946, is reported by Special Agent Francis D. O'Brien.

Confidential Informant NYT 343, whose identity is known to the Bureau, and who has observed the activities of BROTHMAN over a period of time, has advised that BROTHMAN has continued to work in his place of employment for the past month, with the exception of one week in January, which was believed to be January 7 to January 14, at which time BROTHMAN is reported to have been a guest of FRED BRIEHL, at his home in Kingston, New York. BRIEHL is a well-known Communist in the NewYork area.

In conjunction with BROTHMAN's activities of a business nature, Confidential Informant NYT 343 reported that BROTHMAN held a conference with a Mr. BOWEN of the BOWEN ENGINEERING COMPANY, Garwood, NewJersey, at which time BROTHMAN advised BOWEN that he was developing resins for the Chinese Government.

This same informant advised on February 4, 1946 that BROTHMAN indicated that he was desirous of publishing some articles on work in the chemical field and that he had contacted Mr. OLIVE of the McGRAW HILL PUBLISHING COMPANY in connection with this publication.

From this same informant, it was learned that a Mr. LUDWIG MUSET held a conference with BROTHMAN and during this conference, BROTHMAN indicated that he felt he had developed a polemerization method that could be petented.

On January 16, 1946, Confidential Informant NTT 343 observed that BILL BROWDER, brother of EARL BROWDER, former Secretary of the Communist Party, USA, had been in touch with BROTHMAN's office in an attempt to interest them in his new pamphlet entitled, "Distributors Guide". This same informant has advised that BROTHMAN might possibly be attempting to do some technical work for the KAISER CORPORATION inasmuch as an official of that company had requested BROTHMAN's secretary to furnish the official with a biography of ABRAHAM BROTHMAN.

Confidential Informant NYT 343 has advised that on January 22, 1945, one MILLY conferred with MIRIAM MARKOWITZ, secretary to ABRAHAM .
BROTHMAN, and asked her if she were doing anything to better herself as a

e Communist Party member, stating that she has removed herself from the struggle. Continuing, MILLY told MIRIAN that she had no excuse now, inasmuch as she did not have to worry about her boss. (Apparently refers to BROTHMAN.) MILLY told MIRIAN that she should arrange her work so that she could go to the club and help out on the picket lines and also to do something in her community to let the people know what is going on and to combat the Christian frontists. MIRIAN agreed with MILLY and she promised that she would shortly be back in the field. Further investigation of the activities of MIRIAN MARKOWITZ is to be conducted and will be reported in the near future.

A mail cover has been placed on the business house of ABRAHAM BROTHMAN, 114 East 32 Street, New York City, and it appears that most of the mail received by the firm has been from legitimate business contacts. However, on January 22, 1946, a letter was addressed to ABRAHAM BROTHMAN ASSOCIATES, 114 East 32 Street, from the "MUSIC ROCM", 129 West 44 Street, New York City. The "MUSIC ROCM" is owned and operated by ERIC BERNAY and there is an active investigation being conducted in the New York Pield Division on ERIC BERNAY. The character of this case is Internal Security-Re


On Jamary 24 at 4:35 p.m. an incoming unanswered call was reported. On the same date at 7 p.m. confidential informant GREGORY spoke to RAY. OREOGRY told RAY not to be alarmed at anything she might see in the newspapers in the next few days. She told RAY the NEW YORK WORLD TELEGRAM had investigated WORLD TOURISTS. GREGORY said that as far as she could see this story would not involve either RAY or herself, and added that she saw it coming, but could do nothing about it. It was also stated by GREGORY that BERDANSKY is ain the middle" and has been complaining to GREGORY that he got into something that he knew nothing about. RAY and GREGORY made a date for dinner on January 31 and agreed to meet at 7 p.m. at CHUMMEY'S restaurant. RAY was to be accompanied at this time by her husband.

On January 31 at 9:30 a.m. RAY left her residence and proceeded to her place of employment, where she entered at 10 a.m. She left this address at 1:15 p.m. with an unknown woman believed to be a fellow employee. They had lunch at the Famous Sea Food House, 651 Third Avenue and at 2:05 p.m. they returned to the NFCL offices. The unknown womanmentioned above, with whom RAY ELSON had lunch on January 31, was believed to be the same woman that she had lunch with on January 29, and whose description is set forth above.

RAY left the NFCL offices at 5:55 p.m. and returned directly to her residence. At 7 p.m. she respected, accompanied by her husband. They proceeded to CHUMLEY'S restaurant, 86 Beaver Street, where they spent the evening with confidential informant GREGORY.

Re: Confidential Informant GREGORY

The following is being dictated by Special Agents Thomas G. Spencer and Joseph M. Kelly:

On January 22, 1946 Confidential Informant GREGORI telephonically advised that she had just received a call from HOUIS BERDARSKY at WORLD TOURISTS, INC., indicating that NELSON FRANK of the NEW YORK WORLD TELEGRAM had been to the office of WORLD TOURISTS, INC. attempting to get some information relative to the manner in which packages were shipped to Russia by this company. It also appeared that FRANK had interrogated BERDANSKY concerning the amount of duties that were charged on these particular shipments and a great deal of information relative to the manner in which the entire business of package shipments to Russia is carried on by this corporation.

BERDANSKI informed FRANK that U. S. SERVICE & SHIPPING CORP.
actually held a contract for the shipment of these packages to Russia and
that WORLD TOURISTS, INC. merely acted as exclusive agents for the Metropolitan New York area for U. S. SERVICE & SHIPPING CORP.

It also appears that at the conclusion of the interview between FRANK and BERDANSKY, FRANK intimated that he was going to write an expose concerning what he termed the excessive duties, insurance rates and handling charges imposed on packages sent from this country to Russia and gave the impression that the article would be highly critical.

Subsequently, Confidential Informant GREGORY again communicated with the New York Office and advised that she had received a telephone call from NELSON FRANK on that day and that he asked her several questions relative to the firm's business along the same lines as described above. He also intimated to GREGORY that he was desirous of seeing her concerning this matter, and told her he was making an effort to ascertain all possible facts bearing. On the package business between this country and the U.S.S.R.

According to information supplied by Confidential Informant NYT-337, whose identity is known to the Bureau, Informant GREGORY, on Jamuary 22, 1946, communicated with C. E. BANNERMAN of the law firm of CIARK, CARR & ELLIS, which handles the legal matters for U. S. SERVICE & SHIPPING CORP. and explained NELSON FRANK's interest in the affairs of both WORLD TOURISTS, INC. and U. S. SERVICE & SHIPPING CORP. According to Informant NYT-337, BANNERMAN informed GREGORY that there was nothing that he could do and that if the newspaper people desired to interview her and subsequently print a story regarding both corporations there was nothing that could be done about this.

The following day NELSON FRANK appeared at the office of Confidential Informant GREGORI and asked her a large number of questions concerning the operations of the firm; mainly they dealt with customs, insurance rates, inspection, packing and handling fees which the American chipper would have to pay to send packages to Russia. According to Informant GREGORI, FRANK obviously had done considerable investigating along this line and already possessed the information that WORLD TOURISTS, INC. had been incorporated originally in 1927 by three members of the Central Committee of the Communist Party, namely, JOSEPH R. ERODSEY, ROBERT WIENER and ALKIANDER TRACHTENBERG.

FRANK also told informant that he had learned one JOHN H. REVNOLDS was presently president of the U. S. SERVICE & SHIPPING CORP., asked her for some identifying data concerning RETNOLDS, and also if he were a Communist, to which informant replied that he was not a party member. This line of questioning was pursued further by FRANK who then asked informant if she is or ever has been a Communist Party member and she replied emphatically in the negative. He then requested informant to make available the books and records of U. S. SERVICE & SHIPPING CORP. to him, but this request was refused.

It was the impression gained by the informant during this conference with FRANK that the latter's article would be very critical of the charges which have to be paid by a package shipper and that the firm as well as the U.S.S.R. would probably appear in a bad light.

Although FRANK appeared to have considerable knowledge of the corporate structure of both WORLD TOURISTS, INC. and U. S. SERVICE & SHIPPING CORP., he did not in any way indicate that he knew or suspected that 75% of the original investment in U. S. SERVICE & SHIPPING CORP. was made by the Communist Party and neither the name of EARL BROWDER nor of LEM HARRIS was mentioned. After being told by informant that RETNOLDS was not a party member, FRANK asked no further questions about him, but did indicate that he knew REYNOLDS was presently on active duty with the U. S. Army.

After the above information had been received by the Agents from the informant, it was decided that it would be advisable if the informant immediately contacted EARL BROWDER and told him of the imminent publicity concerning her firm. It was felt that this move by her would further ingratiate her with BROWDER and when the plan was discussed with her she agreed that it would have a good effect on him.

That same day Informant GREGORY did, in fact, meet BROWDER at Grand Central Terminal and told him of the visits received by BERDANSKY and herself. According to ber, he was not at all excited about the prospect and told her "You are receiving your first public beptism of fire." Nothing further believed pertinent accoursed during this conference between informant and BROWDER.

On January 24, 1946 Special Agents Francis D. O'Brien and Thomas G. Spencer met informant for a brief time and discussed with her in detail the events which had been previously reported by her on the telephone.

On January 30, 1946 Informant GREGORY was interviewed by Special Agents Thomas G. Spencer and Joseph M. Kelly and in discussing generally the SILVERMASTERS and the people who were associated with them during the time she was active in Russian espionage activities, she recalled one individual who was associated with the SILVERMASTER crowd who she had failed to mention at the time the signed statement of November 30, 1945 was taken. She stated that this individual is FRANK COK who, at the time she first became aware of his identity, was in the U.S. Treasury Department, though his exact title or position was not known to ber. COE was, to the informant's recollection, in South America on some mission for the Treasury Department during all but two months of the time that she know that he was in contact with the SILVERMASTERS. It was also her recollection that COE was communicating directly from South America with the SILVERMASTERS in Washington, D. C. and sending them reports and other information that he gathered while in Latin America.

The informant also stated that she is of the opinion that COE also sent information to HARRY WHITE in Washington, D. C. and while COE was in South America and also believes that he made information available to WHITE while he, COE, was in the United States. She further believes that the information supplied by COE to WHITE eventually was turned over to the SILVERMASTER group.

She could not recall definitely having seen any material that she could identify as having originated with COE, but did state that the information supplied by him in these personal communications would be digested and turned over to her for transmittal to her superiors. Informant's recollection of the type of information supplied by COE is vague, except that it was economic data and she said that he was relatively unimportant to the group.

On January 29, 1946 there appeared in the NEW YORK WORLD TELEGRAY an article entitled "Russia Tariff on Relief Food Curbs U.S.A.", written by

MELSON FRANK. By letter on that date the Bureau was supplied with copies of this article. It is to be noted that the names of informant, JOHN H. REINOLDS, and U. S. SERVICE & SHIPPING CORP. were not mentioned in the write-up, although mention was made of WORLD TOURISTS, INC. and its original incorporation by Communist Party members.

On that same date Informant GREGORY telephonically advised the New York Office that she had been greatly relieved to see that the article was not as detailed as it might have been and further that she had telephonically discussed it with Lieutenant Colonel REYNOIDS who was also pleased that the newspaper story was brist and omitted their names.

On January 31, 1946 informant telephonically advised Special Agent Nelly that she had just received a telephone call from one ISIDOR NEEDELMAN who had described himself as an attorney for the ANTORG TRADING CORP., and who requested that she furnish him a copy of the contract between U. S. SERVICE & SHIPPING CORP. and INTOURIST. Informant asked the reason for the request and was told by NEEDELMAN that it was routine matter and that, as everyone knew, AMTORG is in charge of all commercial relations between this country and the U.S.S.R. Informant declined to furnish the desired copy and asked NEEDELMAN why he had not requested INTOURIST, Moscow to furnish a copy of the contract. He gave no direct answer to this, but repeated his request, which again was refused and he abruptly ended the conversation.

On February 1, 1946 Informant CHEGORY advised Special Agents Spencer and Kelly that shortly after NEEDHLMAN had concluded the telephone conversation above described on the previous day, she had received a call from one ALAPOV, who identified himself as the secretary of ANTORG. Informant continued that AGAPOV summarily repeated the demand made earlier by NEEDELMAN for a copy of the contract and was very curt and demanding in his tone. Informant asked him the reason for his request and he answered along the same lines as had REEDELMAN. When asked why he did not request INTOURIST, Moscow to furnish him the paper he said that procedure would entail delay of two or three months and that it was imperative that he have this copy in 24 hours.

Informant remonstrated with him and he reminded her that AMTORG allocates all shipping space on vessels between this country and the U.S.S.R.; that naturally packages handled by her firm could not move if proper space were not provided and very plainly threatened that if the copy of the contract he had requested were not forthcoming within 24 hours U.S. SERVICE & SHIPPING CORP. might well find itself without any shipping space. After AJAPOV became specially belligerent, informant reminded him that her firm was a corporation, and that she necessarily would have to confer with.

Colonel RETNOIDS before she could give him a definite answer and told him it would be several days before a decision could be reached. He finally agreed to give her 3 or 4 days to produce the contract.

After this conversation, according to informent, she discussed the request in detail with Colonel REYNOLDS, who has been confined to his home by illness, and learned that his reaction was to reject the request from AMTORG and to dispatch a strong cable to INTOURIST, Moscow protesting the request and asking why AMTORG should be entitled to a copy of contract.

With respect to the contract existing between INTOURIST and the U. S. SERVICE & SHIPPING CORP., it will be recalled that this agreement was originally entered into in March, 1941 for a period of 2 years; that relations continued after the expiration date for some months on the same terms, and that finally in October, 1945, after prolonged discussions between informant and AL (GROMOV), the latter promised to secure an extension of it. Five days after he made this promise to the informant the firm received a cable from INTOURIST, Moscow extending the contract under the original terms until October 31, 1946.

GOIOS, Colonel REYNOLDS and GREGORY all had been summoned to the Russian Consulate in New York City on different occasions to discuss the agreement; and although no outright demand was ever made by the Consulate officials that the contract be terminated, it was the informant's distinct impression that its existence was not looked upon favorably by the Consulate. She said that on GOIOS' instructions she and Colonel REYNOLDS always told the Consulate officials as little as possible about the contractual terms and the volume of profits of the business.

It will be recalled that information has previously been supplied to the Bureau in the case entitled "SODAC, New York City; ESPIONAGE - R", relative to the interest displayed in this contract by PAVEL MIKHAILOV, former Acting Consul General in New York City; CHARLES RECHT, attorney for the New York Consulate, and the AMALGAMATED BANK OF NEW YORK.

Informant stated that since her recollection of FRANK COE's association with the SILVERMASTER group she had gone over in her mind all of the people that she knew or had reason to believe were connected in some way with the Russian Intelligence group while she was actively participating in it. She stated that she now recalls that one NORMAN BURSIER (phonetic) was connected with the SILVERMASTER group.

She stated that on one of the occasions when she was talking to

HELEN SILVERMASTER in Washington, D. C., HELEN told her that she had been seeing BURSLER quite frequently and felt that because of BURSLER's connection with the Anti-Trust Division of the Department of Justice he might be a good person to bring into the group. On her return to New York City she discussed this matter with GOLOS who stated that he was somewhat skeptical of BURSLER and felt that he might possibly be a "plant", but that if the SILVERMASTERS were favorably impressed and trusted him that the SILVERMASTER group might deal directly with BURSLER and, of course, to furnish the informant with any information that he was able to supply.

Subsequently Informant GREGORY told HELEN SILVERMASTER of GOLOS! epinion in this situation and HELEN SILVERMASTER arranged to obtain the information from him.

Informant subsequently learned that BURSLER was assigned to the New York Office of the Anti-Trust Division and was concerned with the investigation of German cartels. It also appears that shortly after BURSLER first became known to the informant he was inducted into the U.S. Army, but was released after a short time because of some physical defect and again took up his position with the Anti-Trust Division of the Department. Sometime in the summer of 1944 HELEN SILVERMASTER turned over to the informant a quantity of material and the informant noticed that some of this material contained information relative to German cartels. She indicated to HELEN that she knew the source of this particular material, meaning, of course, BURSLER, and HELEN SILVERMASTER acknowledged that it came from this individual.

The informant is unable to recall that she received any other information that she could definitely ascribe to BURSLER and it will be recalled that some few months later she disassociated/irom the SILVERMASTER group. Informant advised that she has never met BURSLER and has no information as to his background or otherwise that would assist in further identifying him.

Also on the occasion of this interview it was learned that the informant had dined the preceding evening with JOSEPH and RAY ELSON, and in accordance with instructions, had again mentioned that she was spending a good deal of time with her dentist. The ELSONS then began a discussion of their present dental treatment and informant learned that their dentist, whom neither named, was a former employer of Mrs. ELSON and apparently maintains a rather large office inasmuch as there are four or five other dentists associated with him in what appears to be a semi-cooperative or profit-sharing enterprise. Further, that this former employer had been doing

their work for some years, and that although he was now very successful and charged high fees for his work, he continued to treat them because they had always paid him promptly when he was struggling to build up a practice and apparently appreciated their earlier patronage. Both JOSEPH and RAY KISON want so far as to display to informant the results of the dental treatment they are presently receiving and informant stated conclusively that there was no question but that they were, in fact, being treated by a dentist.

In order to foreclose any doubt, informant remarked to JOSEPH BLSON that it would have been much more economical for him if he had received dental care while in the Army. BLSON agreed that he could have been treated without charge, but said that Army dentists were too careless, their work for the most part was poor, and that he had decided to have his work done by a competent man. Informant was unable to learn from them if their dentist was a Communist Party member, but RAY mentioned that he was a good type.

While JOSEPH ELSON was temporarily absent from the company of his wife and informant, the latter learned that RAY was greatly worried at the present time because of the investigation being conducted by the Committee on Un-American Activities of the House of Representatives, particularly as it affects the FEDERATION FOR CONSTITUTIONAL LIBERTIES, her present employer. She said that the FEDERATION had desired to place her in an important position in the group, it wanted her to do contact work on its behalf, which endeavor naturally would result in some publicity and that she had refused because she did not want to become at all conspicuous in its operations and wanted to avoid all public attention as far as possible.

She seemed very concerned about the prospect of the files of the FEDERATION being seized by the Committee and was in a generally nervous condition. Informant told her of the telephone call she had received from AMTORG relative to their desire for a copy of the existing contract between that company and IMTOURIST, but no significant comment was forthcoming from RAI.

A recent photograph of Dr. A. B. WEINSTEIN obtained by Agents of this office during a surveillance of him was exhibited to the informant; however, she was unable to identify him.

Under date of January 28, 1946 the Washington Field Division supplied the New York Office with additional photographs of Russian diplomatic

RE: ABRAHAE BROTHMAN

The following investigation of the activities of ABRAHAM RHOTHMAN GOVERING the period from February 5, 1946 to February 19, 1946, is reported by Special Agent FRANCIS D. O'BRIKH:

Confidential informant MYT-363, who is in a position to observe PROTHER's sotivities, has advised that ENOTHER continues to go to his place of business daily, and has noted the following information concerning ENOTHER's activities:

BROTHMAN, socording to the informant, has been in close touch with BERMAND O. MODPHAN, an Associate Professor in Mathematics at Colmebia University. The informant advised that on February 7, 1946, PROTHMAN held a conference with KOOPMAN, at which time they agreed to meet in KOOPMAN's room in the King's Crown Hotel, h20 West 116th Street, Men York City, at 3:30 P.M. on February 13, 1946.

At 3:30 P.H. on February 13, 1946, Special Agent LAWRENCE W.
SPILLARE and reporting agent were present in the lobby of the King's Crown Rotel, h70 West 116th Street, New York City, at which time BROTHMAN entered the botel and was heard to make inquiry for Professor KOOPMAN. The clerk replied that Professor KOOPMAN was in room 512. BROTHMAN then entered the elevator and proceeded to the fifth floor.

On February 18, 1946, it was accertained through Er. MATHY T. ARRAS, Assistant Manager, King's Crown Hotel, that BRUNARD O. KOOPHAN had registered at the hotel on February 11, 1946, and had given his address as 1305 Cleveland Street, Alexandria, Virginia. According to Hr. ADRAS, KOOPHAN is a Professor at Columbia University and has registered at the hotel for a duration of several days at a time during the past two months. Wr. ARRAS also stated that Professor KOOPHAN desired to obtain permanent residence at the King's Crown Hotel.

On February 18, 1916, Mr. PHILLIP M. HAYDEN, Secretary, Columbia University, New York City, advised that the biography that Columbia University has on EXEMAND O. KOOPMAN reflects that KOOPMAN was born in Paris, France, January 1900, exact date not known, and that he was a citizen of the United States, source of citizenship not given. KOOPMAN graduated from Harvard University in 1971, and received a P.h.D. from that University in 1976. He has been a member of the faculty at Columbia University since 1978, at which

time be was appointed Assistant Professor of Bath-eaties, holding this position until 1940, at which time he was appointed an Associate Professor in Mathematics.

In Farch of 1944, Professor NOOFMAR obtained a leave of absence to go to Harvard University where it was believed he was to work on some type of work for the United States Government, (this information not confirmed, but was a statement made by Mr. HAYLER, which he stated was his belief).

On December 31, 1945, Professor ROOFEAR returned to Columbia University and has been active on the staff since that time.

On February 18, 1946, confidential informant NTT-343 advised that Professor NOFMAN held a conference with ADE BROTHERS, and during the conference told RESTRIAR that he had broken down the differential equation problem and that he would neet BROTHMAN for dinner at the Faculty Flub, Columbia University, and show the problem to him.

The following activities of the associates of ABRIGH ERCIHUAN in his Luboratory were reported by confidential informant hIT-343:

In Tebruary 9, 1946, JULES ECONTEN, an associate of RESTRIAN, reported to PRETENAN that he had been to Sashington, L. C., and that he had seen the President's Bousing Flan and had talked with the Housing Expeditor. In conjunction with this information, the informant advised that on February 14, 1946, KURUEIYM was in touch with one ORAN COLD, at which time KONCIDER indicated that he desired to be placed on the New York City Housing Authority and that there were two non-paying jobs wasant, and that he, koncilled, felt that his name should be put forward on the basis of his CIO and ALP connections and being in the housing business.

It is to be noted that JULES MERCHIER is a key figure in the Communist Party in New York City and is-the subject of an active case file spittled JULES EGREBEN; INTEREST, SECURITY - C.*

The following is being dictated by Epecial Agents THOMAS O. EPENCER and JOSEPH N. EELLY and represents the results of conversations with confidential informant GRECORY for the period February 11, 1946 to February 19, 1946.

On February 15, 1946 informant advised that in accordance with instructions earlier given to her by Colenel JOHN He REINCLES, she telephonically communicated with EARL HOURDER at the latter's office on February 11, 1946 and made an appointment to see him that day. The purpose of this meeting was to extend an invitation to BROWDER and his wife to be dinner guests at the REINCLE' apartment on February 18, 1946; the purpose of this invitation to the BROWDER was so that REINCLES might secure ERONDER's advice on the subject of a proposed expansion of the U. B. EREVICE & HUPPING FORP, and also to request ERONDER to do some errands if his proposed trip to Russia materializes. According to the informant BROWDER gladly accepted this invitation and arrangements were made for informant to meet him on Fifth Avenus and A3rd Street on February 18, 1946 and accompany him to the REYNOLDS home at 825 Fifth Avenus, New York City.

No other information believed pertinent was developed by informat on the occasion of this conversation with BROWDER.

During the course of this same interview confidential inforcant GRECORY made available to the Agents a miscographed bulletin
entitled, "APPEAL OF MARL BROWDER TO THE NATIONAL COMMITTEE C.P.U.S.A.
against the DECISION OF THE NATIONAL BOARD OF FEBRUARY 5th, 1946 FOR
HIS EXPULITION. It was noted that the envelope in which this pamphletwas mailed to the informant bore the return address of M. E. BRANCE,
38 Fest 9th Street, New York, New York, and was postmarked at the West
43rd Street station.

Special Agent FREDERICK C. ZINCK, of the New York Field Division, who is familiar with the activities of HILIAM BROWDER, advised that N. E. BUNCH is known to him as one of the aliance used by BILLIAM BROWDER, brother of EARL REDWINER, and that 38 west 9th Estrect is known to him as the present residence of WILLIAM BROWDER. The informant was somewhat mystified by the name and accreas of the sender on the envelope but did recall that the telephone for the BROWDER summer home, near Hourse, New York, was listed under the name of E. E. ERANCH, and she said she had always assumed this was a friend of the family. Also on this conssion informant made available an issue of

Colonel RETWOINS, it was suggested to the informent that she attempt to develop in conversation with ENDWIN what assurances, if any, he has received from Russian authorities that he will be granted a Russian visa in the event his United States passport is granted. It was also requested that she attempt to learn if possible who was underwriting the expenses of this proposed trip and further, what the real object of the trip is. Informant was likewise requested to attempt to learn who, if anyone, planned to accompany ENDWINK and the anticipated duration of his stay in Russia.

On February 19, 1946 informent GRENCH on interview adwised that in accordance with the plane made earlier, she had accorpanied MAHL ER WINE to the REMOUNT apartment on the evening of Febtwo hours. Informent reported that BROWDER was consulted by Colonel

remarked that he imagined the FBI thought he had the secret of the atom bomb in his pocket and further, that he was probably thought to be identical with ARTHUM ADARSIM, alleged Soviet app, whose setivities have been publicised in the Thew Tork Journal incricans.

Informant learned in addition that if BROWLEE secures his passport and necessary visas he plans to go abroad securing in March, 1945 and to remain out of the country for a month or so. He did not indicate directly the exact object of his trip to Russia, but insinuated that he had a definite idea of the person whom he wanted to see over there. According to the informant ERNEDER did not even indicate if his trip was in connection with Party affairs or was on commercial business, but informant is definitely of the opinion that BROWDER is going mainly to attempt to regain favor of the immer councils in Noscow.

There was also some discussion between BROHDER and RETHOLIS as to the reason for the former's expulsion from the Party and BROWDER placed most of the blace on WILLIAM 2. FORTER and indicated that the present ruling clique of the Party was too stupid to realize that the United States was adaptable only to modified Communism, such as BROHDER favored during the war.

RITHOIDS asked BROWDER if the latter would be able to take care of some matters for him with respect to the U. S. SERVICE & WRIPPING CORP. while in Moscow and BROWDER enthusiastically replied that he would be glad to do anything along this line that he could. It was agreed that there would be a further conference between the two, in the event BROWDER's trip materialises.

During the general discussion RENGLES asked BROWDER if he had any Russian contacts in the United States and BROWDER replied that he had no contact with the Russians except where matters of Party policy were concerned; according to informent he then quickly explained that of course he meant the COMMUNIST PARTY headquarters in downtown New Tork City. It was the informant's opinion, however, that BROWDER, who was drinking considerably during the evening, probably was accurate in his first statement when he indicated that he did in fact have some Russian contact in this country. In the general discousion which resulted after REYNOLDS asked the reason for BROWDER's expulsion from the Party, BROWDER related the following sequence of events, which is believed to be of interest generally.

He stated it was his opinion that William 2. FISTER had made arrangements through DIGSEPFE BERTI and AMBRICIO DORINI, Italian Communists, who for a time were associated with L'Unite del Populo, for them through underground sources in Italy to contact JACCOES DUCLOS, prominent French Communist and that the latter would prepare a bitter public denunciation of BRIVDER, thereby gaining considerable prestige and possibly evershedowing MADRICE THORES, another prominent French Communist. It apparently was EXDEDIR's idea that DUCL'S could be influenced to take this action by suggestions that he would become the most prominent Communist in France, with FORTER to assure the . position held by ERNADER, and that the two leaders would work in close harmony. Informant was unable to conclude if this series of events as marrated by BHOHDER were strictly a matter of conjecture with him or whether they were based at least partly on fact. It would, however, from the above remarks made by BROWDER, seem to be his opinion that the DUCIUS attack on him was not Moscow inspired but rather the result of comiving between PUCLUS and MILLIAM 2. PATER.

Informant was also able to learn during the dinner that BROWDER is having 40,000 copies of his "defense" printed and distributed generally to COMMINIST PARTY members and further, that RARRO KWITH, who has been his secretary for some years, recently resigned because he "couldn't stand the pressure any longer". BROWDER told informant that insofar as he knew SMITH was unemployed at the present time.

Informant reported in addition that during the evening there was considerable discussion between REYNILIS and BRINDER as to the current articles in the press relative to the round-up of alleged Russian uples in Canada, and that both agreed such newspaper stories were probably for the purpose of discrediting Russia and that what action had been taken by the Canadian authorities was undoubtedly traceable to the difficulties between Secretary of State BINGES and Foreign Commissar WILITIT at the conference of freign ministers and, more lately, the dispute between ANDREI VISHIBSKI and ERHEST BEVIES.



A complete description of NYZDELMAE, however, has been furnished to ORECONY, and she is unable to identify this man as anyone show she has ever known or seen. Inasmuch as no photograph of him is presently available it is not believed possible that ORFOORT sould identify him arong the persons involved in instant case and accordingly no further action is being taken with respect to RESTRIMAN.
