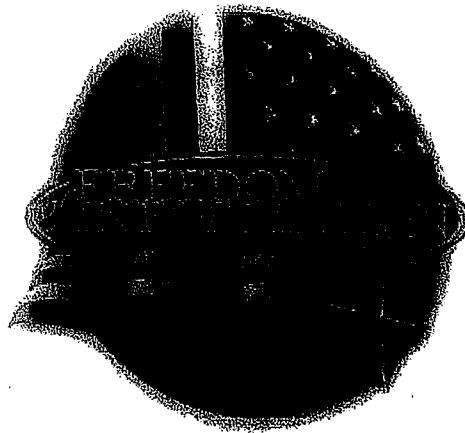

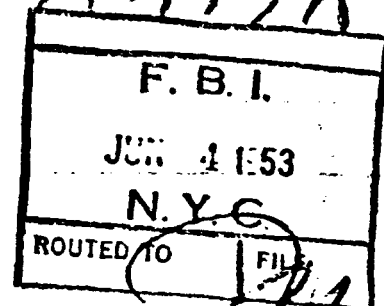

7:50 AM Bob, Jimmy, and Dick, children of Judge Kaufman, made exit from 1105 Park Ave., NYC, and boarded the school bus of the Riverdale Country School. The bus then proceeded to the Riverdale Country School, Bronx, with agents in car behind keeping bus under close observation. cc: JET

8:35 PM Upon arrival at the Riverdale Country School, a private school with private grounds, the children proceeded with their school activities, and when not in class or other school activity in the custody of an instructor, they were under observation by agents. cc: JET

4:15 PM Agents left. Children in custody of their parents and entire family under observation by other agents. cc: JET
