DETAILS:

Reference teletype to the Bureau and San Francisco sets out the following information furnished by Mrs. **THOMAS HAPGOOD**, 550 East Alameda Street, Santa Fe, New Mexico:

Mrs. **HAPGOOD** stated that one **ELSBETH R. GRANT**, who rents a small apartment from Mrs. **HAPGOOD** had been contacted on three separate occasions by a man whom Mrs. **HAPGOOD** later identified as **JOSEPH ROTBLAT**, a scientist employed at the DSM Project. The last contact was on July 22, 1944, and on this occasion **ROTBLAT** asked permission to use Mrs. **HAPGOOD**'s phone to call a taxi. At this time **GRANT** asked Mrs. **HAPGOOD** not to mention the fact that **ROTBLAT** had contacted her since he was employed at Los Alamos and it was against the rules for him to contact anyone in Santa Fe.
