FOOCASE, ESP-R. DR. EDWARD H. CORSON REINTERVIEWED BY NEW YORK OFFICE TODAY AT HIS SPECIFIC REQUEST. CORSON MADE MANY DISJOINTED IRRATIONAL STATEMENTS RE HIS PERSONAL STATUS RESULTING FROM HIS OFFER OF HELP TO FUCHS AND HIS LETTER TO COCKROFT IN ENGLAND. COMPLAINED HE IS BEING UNDULY PENALIZED BY U.S. GOVERNMENT. EXPRESSED IRRITATION AT STATE DEPARTMENT FOR TAKING HIS PASSPORT. BELIEVES BUREAU INFORMED STATE DEPARTMENT OF HIS INTENTION TO TRAVEL TO PARIS MAY THREE LAST, THUS CAUSING LOSS OF PASSPORT. MADE VEILED THREATS TO DO SOME "MUD SLINGING" OF HIS OWN THROUGH RELEASE OF "STORY" GIVEN BY CORSON TO EDITOR OF LONDON DAILY MAIL IMMEDIATELY AFTER FUCHS ARREST. CLAIMS STORY NOT PUBLISHED AND SAID HE DID NOT KNOW HOW LONG HE COULD SUPPRESS THIS "STORY". CORSON WAS AS VAGUE ON THIS POINT AS ON OTHERS MENTIONED BY HIM AND GAVE NO INDICATION OF CONTENTS OF "STORY". OCCASIONALLY DURING INTERVIEW CORSON ASKED IF THE STATE DEPARTMENT WOULD BE HAPPIER IF HE COMMITTED SUICIDE SINCE THEY /STATE DEPARTMENT/ SEEMED BENT ON WRECKING HIS LIFE. THINKS POSSIBLY BUREAU HAS BASED PRESENT INTEREST IN HIM ON INFO FURNISHED BUREAU-S CINCINNATI OFFICE BY HIS NOW ESTRANGED WIFE OR HIS IN-LAWS. CORSON THREATENED TO WITHHOLD FURTHER "COOPERATION" IN VIEW OF "SHABBY TREATMENT" GIVEN HIM. CORSON WAS ADVISED BUREAU HAD NO JURISDICTION OVER PASSPORT MATTERS. LETTER FOLLOWS.

Reference is made to your letter dated April 25, 1950, advising that no record could be located concerning Fuchs' reported presence at Montreal, Canada, on November 22 and 23, 1945, for the purpose of attending a scientific meeting.

Information has been received that Professor Philip Wallace, head of the Mathematics Department, McGill University, has indicated that he had been acquainted with Fuchs. It was reported that Wallace had been connected with the atomic program in Canada during World War II and apparently had met Fuchs in connection with this work. It is possible, therefore, that Wallace may be able to furnish information concerning the presence of Fuchs in Canada in November, 1945.

Fred Mullen of United Press came by. I gave him a copy of the Director's speech.

He stated that in the British Parliament today some individuals, who were not identified, raised a point with the Home Secretary to the effect that it would be distasteful for a foreign intelligence agency to come to England to interview a British subject. Ede, the Home Secretary, replied this was the first time this was necessary, that permission had been granted the FBI to interview Fuchs only on the condition Fuchs agreed to be interviewed and then the interview would be in the presence of British officials and carried on in accordance with British customs, that this was the first time in history where a crime such as Fuchs committed had occurred which justified a change in procedure.

Mullen wondered if there were any crumbs that could be thrown out which would justify his writing a speculative story as to whether we will interview Fuchs, whether we are sending one or two officials to England to interview Fuchs, or anything else along these lines; if there are, he would like to do a story on a speculative basis.

I told Fred this was something I knew very little about as the Director was handling it personally. I would be glad to ask him about it.
