SA Donald F. O'Donnell ascertained from Mrs. Helen Loring, State Board of Education, Concord, N.H. that ROBERT BLOOM HILLENBRAND was employed as teacher of English, French, History and Physics at Andover, N.H. high school during the 1945-46 school year. He received a salary of \$1,500.

The writer ascertained from Mrs. Loring that Heineman did not return to Andover for the 1946-47 school year and that he was not teaching in New Hampshire.

Mrs. Donald McCormack, wife of the superintendent of the Andover-Hillsboro school district, advised Heineman did not return to Andover during the 46-47 year. He left Andover for his permanent address in Cambridge, Mass. (144 Lakeview Ave) in June requesting a substantial increase in salary. He apparently felt the school board would become desperate enough to meet his demands, but when his salary requirements were not met he requested recommendations be forwarded to the Harvard placement Bureau in mid-August. The McCormacks have no information as to his present whereabouts.

Los Angeles letter to the Bureau dated Oct. 8, 1954, reports the interview of PAT SHERR, was on June 17, 1954 by Special Agents EDWARD H. MACKENZIE and REX ELLIS.

The letter furnishes the following information concerning the interview:

"Mrs. SHERR advised that when she went to Cambridge, Mass. in 1938, she became a member of the CP there and was assigned to a club, the name of which she does not recall. She stated the club met at the homes of the various members in the Court Square area of Cambridge. She was unable to recall who recruited her into the Party, but stated it may have been one HY GORDON, a Mass. Institute of Technology student, who was the organizer and who gave her the indoctrination lecture.

"She stated she was a member of the CP in Cambridge from about November 1938 to April 1941, at which time she dropped out because she had become disillusioned with the CP and all it stood for. She advised she recalls the following persons as members of her CP group in Cambridge: ROBERT HEINEMAN, CRYSTAL HEINEMAN, LUCY MARTIN, RHODA ALDRICH, HY GORDON, NORMAN LEVINSON and NORMA GROSSENBACH. She stated she is hazy in regard to the spelling of the above names, and she was unable to further identify these persons except to state that ROBERT HEINEMAN and HY GORDON were students at MIT, LUCY MARTIN was the wife of a professor at MIT, and RHODA ALDRICH was a housewife.

"Mrs. SHERR stated she has had no contact with these persons since 1949 and does not know where they are residing at the present time.

"Mrs. SHERR stated she is presently opposed to the CP and its philosophy and is willing to do anything to assist the U. S. against Communism.. She stated she has no liking for the Soviet Union and is absolutely loyal to the U. S."

that HEINEMAN was a member of the Cambridge CP group during
approximately 1938-1940 and was never in Syracuse, New York.

[redacted] said KRISTEL thereafter, about ten years ago, married ALBERT HOLZER, [redacted] and they now live in Putney, Vermont. They moved there, from Hyde Park (Boston), Mass., where Mr. HOLZER had had a business. b7c

[redacted] said KRISTEL HOLZER has gone to East Germany many times and [redacted] wonders if this is some form of communist activity perhaps. [redacted] said [redacted] was bringing this out because KRISTEL HOLZER still wanted to make another trip but [redacted] believed her husband had refused to let her go this time. [redacted] said KRISTEL'S father is still in East Germany and she visits, when there, her brother KLAUS FUCHS said to be married to a top Communist there. [redacted] said KRISTEL HOLZER is about 51 years old and was born in Germany. b7c
