Reurlet December 20, 1949.

On December 30, 1949 SA LESTER O. GALLAHER of this office conducted investigation at 386 Fourth Avenue, New York City. At that address Mr. BOURNE, elevator starter, advised that the entire 15th floor of the building is occupied by the American Jewish Committee. It is noted that the building directory lists the names of a number of individuals all of whom are apparently employees of the American Jewish Committee, and also indicates that the American Jewish Yearbook is published at this address.

Concerning the American Jewish Committee, [REDACTED] New York, who should be carried as a confidential informant, advised SA FREDERICK T. HOULIHAN on February 18, 1947 that the American Jewish Committee is an old and established organization of outstanding persons of the Jewish faith, and is extremely reputable and could in no way be considered a Communist front organization or as an organization which might be in any way influenced by the CP. [REDACTED] pointed out that such outstanding persons as JOSEPH E. PROSKAUER, IRVING LEHMAN and HENRY MORGENTHAU were members of the committee. It is to be noted that [REDACTED] who furnished this information, [REDACTED] and is very active among Jewish philanthropic organizations throughout the city of New York. b7d

In October, 1944 a report was received from the Office of Strategic Services concerning the American Jewish Committee. It read in part as follows:

"In sharp opposition to the American Jewish Congress stands the American Jewish Committee, whose leadership comprises the upper stratum of assimilated American Jews and is opposed to Jewish nationalism. The American Jewish Committee, whose headquarters are in New York, publishes a bimonthly magazine, the 'Contemporary Jewish Record'..."

"Although the 'Contemporary Jewish Record' reflects the assimilationist and non-Zionist flavor of the American Jewish Committee, which supports the Jewish settlement in Palestine as a haven of refuge but not as a nationalist political venture, the magazine attempts to present objectively all important events of Jewish life, opening its columns upon occasion to Zionists. Since withdrawing from the American Jewish Conference in October, 1943 over the issue of a Jewish commonwealth in Palestine, the American Jewish Committee has also been distributing to its members a monthly organizational bulletin 'The Committee Reporter', outlining the

In referenced Boston letter to Director, on page 8,  
subject identifies CRYSTAL HEINEMAN as attending CP meetings  
at Syracuse, New York, during 1945.

A review of Boston file 100-19075, entitled  
"KRISTEL FUCHS HEINEMAN, was," reflects that CRYSTAL HEINEMAN  
was a member of the CP group at Cambridge, Massachusetts,  
along with LUCY MARTIN during 1938-1941.

LUCY DODGE GRAY MARTIN advised on September 19,  
1956 that when she advised August 5 and 6, 1956 that HEINEMAN  
was a CP member at Syracuse, New York, she was in error, and  
that HEINEMAN was a member of the Cambridge CP group during  
approximately 1938-1940 and was never in Syracuse, New York.
