For the information of the Albany Office, the above-captioned individual is the sister of KLAUS FUCHS, the British atomic scientist who furnished information to the Russians and was prosecuted by the British.

On April 29, 1964, an individual gave

[REDACTED] said that the sister of KLAUS FUCHS, who is now in East Germany, had first married ROBERT HEINEMAN, Jewish, who lived in Cambridge, Mass. HEINEMAN claimed she became mentally deranged and she was placed in a mental hospital and he thereafter divorced her.

[REDACTED] KRISTEL about ten years ago married ALBERT HOLZER, [REDACTED] and they now live in Putney, Vermont. They moved there from Hyde Park (Boston), Mass., where Mr. HOLZER had a business. [REDACTED] KRISTEL HOLZER has gone to East Germany many times [REDACTED] wonders if this is some form of communist activity perhaps. [REDACTED] was bringing this out because KRISTEL HOLZER still wanted to make another trip but [REDACTED] her husband had refused to let her go this time. [REDACTED] KRISTEL's father is still in East Germany and she visits when there her brother, KLAUS FUCHS, said to be married to a top communist there. [REDACTED] KRISTEL HOLZER is about 51 years old and was born in Germany.

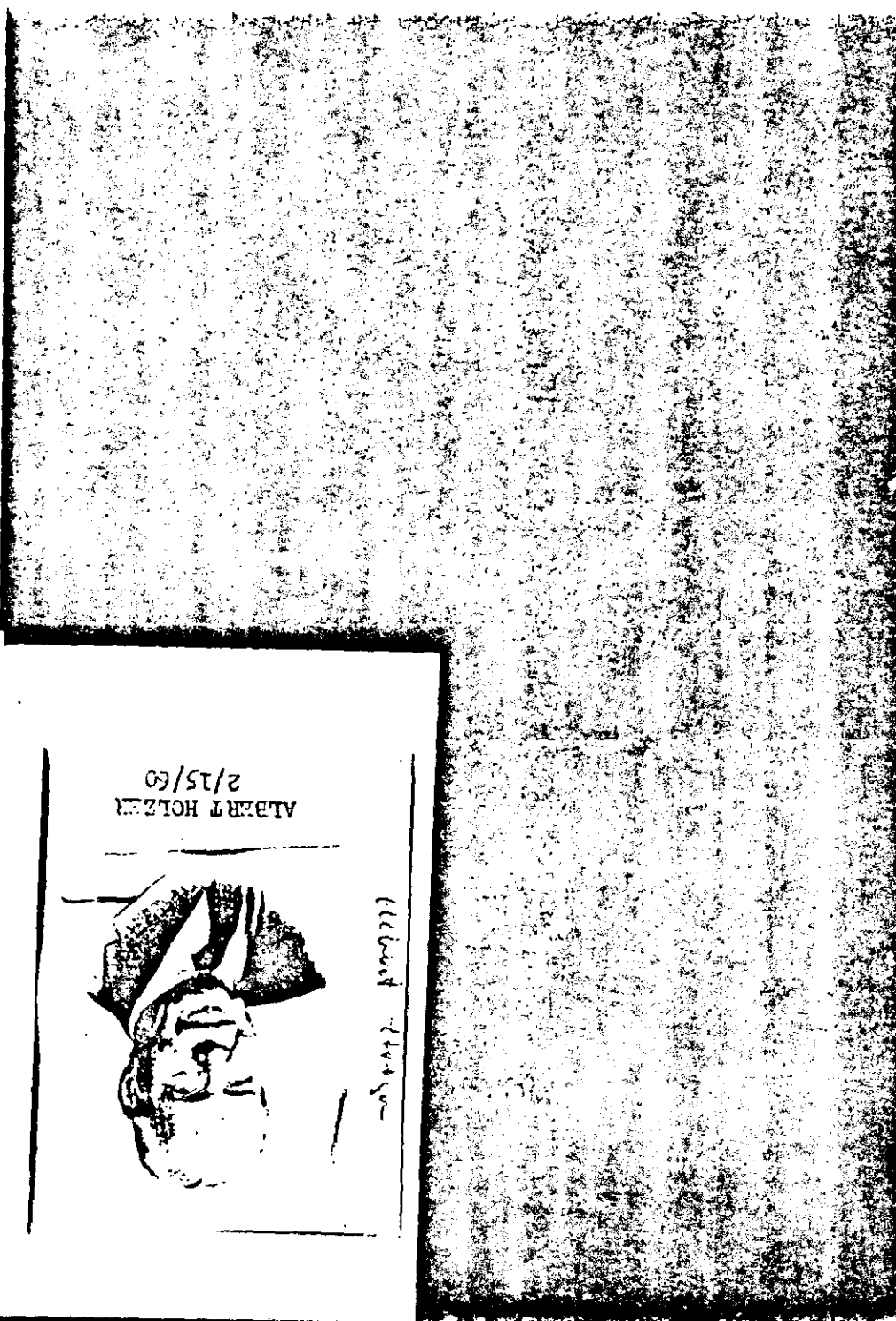

In that letter, information is set out that the subject's marriage to ALBERT HOLZER occurred approximately 10 years ago following the subject's divorce from ROBERT HEINEMAN, who claimed the subject was mentally deranged and placed in a mental hospital.

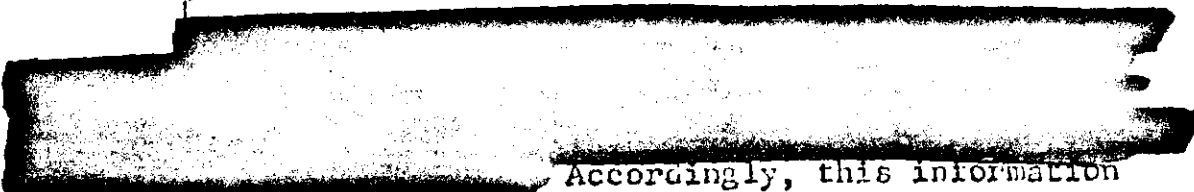
